The Allen Parish Police Jury met in regular session at the Police Jury Administration Building and via Zoom, Oberlin, Louisiana, July 06, 2020 at the hour of 6:30 pm.

Motion by Mr. Ardoin seconded by Mr. Fontenot and carried to go into session.

The Lord's Prayer was said followed by the Pledge of Allegiance.

Motion by Mr. Ardoin seconded by Mr. Courville and carried to accept the minutes of the meeting held on June 1, 2020.

The Finance Committee had the following recommendations:

- 1) Approve to purchase a riding mower for \$2,300.00 from Tractor Supply to maintain the Ward 5 Solid Waste yard.
- 2) Approve to pay Cotton's Heating & Cooling \$7,525.00 for an AC unit for the LSU Ag Ext Office.
- 3) Approve to pay Basic Supply \$2,190.64 for the installation of the Courthouse Sewer Lift Station.
- 4) Approve to purchase turbo & injectors \$4,336.62 for a Kubota tractor for RD1.
- 5) Approve to pay Air Compressors Direct \$2,749.99 for a truck mount air compressor for RD5.
- 6) Approve to purchase a new trailer from C. F's Welding Service for \$9,995.00 for RD4.
- 7) Approve to pay Oberlin Building Supply \$2,025.32 for floor materials for the LSU Ag building.

# RESOLUTION 6497

A resolution confirming an election date change pursuant to proclamation of the Governor; establishing a new date to canvass the returns of the election; and providing for other matters in connection therewith.

WHEREAS, the Police Jury of the Parish of Allen, State of Louisiana (the "Governing Authority"), acting as the governing authority of Road District No. 2 of the Parish of Allen, State of Louisiana (the "District"), heretofore called for an election to be held on Saturday, May 9, 2020; and

WHEREAS, the Governor issued Proclamation Number 28 JBE 2020 on March 13, 2020 and Proclamation Number 46 JBE 2020 on April 14, 2020 (said Proclamations, with any supplements or modifications, herein the "Executive Order"), to reschedule elections due to the Statewide State of Emergency caused by COVID-19;

NOW, THEREFORE, BE IT RESOLVED by the Police Jury of the Parish of Allen, State of Louisiana (the "Governing Authority"), acting as the governing authority of Road District No. 2 of the Parish of Allen, State of Louisiana (the "District"), that:

SECTION 1. This Governing Authority acknowledges the change in the election date, pursuant to the Executive Order, from May 9, 2020 to August 15, 2020.

SECTION 2. This Governing Authority shall meet at its regular meeting place, the Police Jury Room of the Courthouse, 602 Court Street, Oberlin, Louisiana, on TUESDAY, SEPTEMBER 8, 2020, at SIX-THIRTY O'CLOCK (6:30) P.M., and shall examine and canvass the returns and declare the result of the said special election.

SECTION 3. All provisions of the election call resolution previously adopted by this Governing Authority, other than the change in the election date and the canvass date, shall remain in full force and effect.

SECTION 4. The President and/or Secretary-Treasurer of the Governing Authority are further authorized, empowered and directed to take any and all further action required by State and/or Federal authorities to conduct the election.
