

POLICE JURY MEETING – September 7, 2021

The Allen Parish Police Jury met in regular session at the Police Jury Administration Building, Oberlin, Louisiana, September 7, 2021 at the hour of 6:30 p.m.

Present: Tony Hebert, Allen Courville, John Strother, Chad Sanders, and Creig Vizena.

Motion by Mr. Strother seconded by Mr. Vizena and carried to go into session.

The Lord's Prayer was said followed by the Pledge of Allegiance.

Motion by Mr. Vizena seconded by Mr. Courville and carried to accept the minutes of the meeting held August 2, 2021.

The Finance Committee had the following recommendations:

- 1) Approve to pay Doggett Machinery \$1,624.32 for cutting edges for a grader for RD3.
- 2) Approve to pay Grundy Land Management \$4,500.00 to clear west lot of down trees, stumps and loose debris by Ag Ext.
- 3) Approve to pay AFI Construction \$2,225.00 for the gate at the Solid Waste site in Oberlin.
- 4) Approve to pay Ted Savant with Diamond S Construction \$6,500.00 for dirt work on Jeeter Parker Road.

Motion by Mr. Strother seconded by Mr. Sanders and carried to accept the recommendations of the Finance Committee.

The Road Committee had the following recommendations:

1. Approve a JSA with the City of Oakdale for grass cutting, pothole patching, and trash pickup for the month of September 2021.
2. Approve a JSA with the Allen Parish School Board for manpower, labor, and equipment for following bus turnarounds
  - 738 Townson Road in Fairview School District
  - 321 Hanchey Road in Fairview School District
  - Payne Road in the Oakdale School District

Motion by Mr. Courville seconded by Mr. Sanders and carried for the purchasing agent to take necessary action for fuel, materials, and supplies for the month.

Motion by Mr. Vizena seconded by Mr. Courville and carried to approve a 2-year MOU with Ag. Extension Office for expenses.

Motion by Mr. Vizena seconded by Mr. Courville and carried to adopt resolution for the Northwest Allen Parish Waterworks District to refinance a USDA loan.

Motion by Mr. Courville seconded by Mr. Vizena and carried to authorize a resolution for the annual CIP for the Airport.

Motion by Mr. Vizena seconded by Mr. Courville and carried to hire David Landry part time for Solid Waste for \$13.76 per hour contingent upon meeting hiring requirements.

Motion by Mr. Courville seconded by Mr. Vizena and carried to hire Leonard Sulak, Jr. full time for RD2 at \$12.72 per hour contingent upon meeting hiring requirements.

Motion by Mr. Vizena seconded by Mr. Courville and carried to advertise for RFQ for Environment Services for Drainage Improvement Project.

Recognized Ms. Sonnier to present the monthly inmate report. Expenses for the month of August 2021 totaled \$12,812.37. We are under budget \$4,487.63 for the month and \$68,637.49 for the year. Currently there are 70 Parish and 10 DOC.

Recognized Mr. Johnson for report on the airport.
