

POLICE JURY MEETING – November 2, 2020

The Allen Parish Police Jury met in regular session at the Police Jury Administration Building, Oberlin, Louisiana, November 2, 2020 at the hour of 6:30 p.m.

Present: Anthony Hebert, Allen Courville, John Strother, Ruffin George, Jr., Creig Vizena, Chad Sanders, Heath Ardoin.

Motion by Mr. Sanders seconded by Mr. Strother and carried to go into session.

The Lord's Prayer was said followed by the Pledge of Allegiance.

Motion by Mr. Vizena seconded by Mr. Ardoin and carried to accept the meetings held October 5th, 12th, and 22nd, 2020.

The Finance Committee had the following recommendations:

1. Approve to pay Lake Charles Copy \$6,500.00 for a copier for the office to replace the one damaged by Hurricane Delta.
2. Approve to pay Goldman Equipment \$1,540.64 to repair a storm damaged tractor for Ward 1.
3. Approve to pay Goldman Equipment \$1,681.04 to repair a storm damaged tractor for Ward 1.
4. Approve to pay Service Lumber \$2,080.00 to pay for 2 18x20 metal covers for waste tire storage at RD1 Solid Waste site.

Motion by Mr. George seconded by Mr. Ardoin and carried to accept the recommendations of the Finance Committee.

The Road Committee had the following recommendations:

1. Approve a JSA with the City of Oakdale for grass cutting, pothole patching and trash pickup for the month of November 2020.
2. Approve a JSA with the Allen Parish School Board for manpower, labor and equipment to
 - Fill holes on Elizabeth High's playground and softball field.
 - Repair bus turnaround off North Black Extension.
 - Repair bus turnaround on Braxton Road off of JJ Storer Road.
 - Repair bus turnaround at 115 Attale Fontenot Road.
 - Repair bus turnaround at 375 Smokey Savant Road.

Motion by Mr. Ardoin seconded by Mr. Vizena and carried to accept the recommendations of the Road Committee.

Motion by Mr. Vizena seconded by Mr. Ardoin and carried for the purchasing agent to take necessary action for fuel, materials, and supplies for the month.

Motion by Mr. Sanders seconded by Mr. Vizena and carried to reappoint Carl Ritter to the Allen Parish Ward 3 Fire District 2 Board for a 5-year period.

Motion by Mr. Vizena seconded by Mr. Courville and carried to advertise for 6 months bids.

Motion by Mr. Ardoin seconded by Mr. Courville and carried to hire Jamie McDaniel part-time for Solid Waste/Road Crew at \$12.98.

Discussed awarding building repair bids. Decision was made to postpone for 2 weeks to give bidders more time and the roofing line item is being separated from this bid.

Recognized Mrs. Sonnier to present the monthly inmate report. Expenses for the month of October 2020 totaled \$12,529.84. We are under budget \$4,770.16 for the month and \$60,399.83 for the year. Currently there are 57 Parish and 8 DOC.

Recognized Mr. Joel Johnson for report on the airport. Mr. Johnson stated that fuel sales had increased for October.

Motion by Mr. Vizena seconded by Mr. Ardoin and carried to add item to the agenda:

1. Award bid for new roof for the Police Jury Administration Building.

Motion by Mr. Vizena seconded by Mr. Courville and carried to accept the bid from MorCore Roofing, LLC for \$32,700.00.

Motion by Mr. George seconded by Mr. Courville and carried to adjourn the meeting.
