TAX INFORMATION & PAYMENTS

Treasurer, Laura Ellery-Somers

Summer taxes paid to the Charter TOWNSHIP of Alpena's Treasurer are due July 1, 2020 - September 14, 2020 without interest. After September 14, 2020, a 1 % interest charge per month will be added to the base tax. March 1, 2021 is the last day taxes are payable to the Alpena TOWNSHIP Treasurer before being returned as delinquent to the Alpena COUNTY Treasurer. After March 1, 2021 taxes are payable to the Alpena COUNTY Treasurer.



Payments can be made by check or money order payable to Alpena Township Treasurer. **DO NOT MAIL CASH** and **DO NOT PUT CASH IN THE DROP BOX**. Cash payments are accepted in the Treasurer's Office.

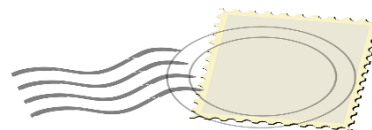
Credit/Debit card payments can be made in the office or on the township's website. www.alpenatownship.com. There is a fee for credit/debit card users.

Due to COVID-19, we encourage you to make Tax payments by mail or by using the drop box located in the parking lot for your convenience. Please include the top portion of the tax bill with your payment. Your cancelled check will serve as your receipt.

POSTMARKS

NOTE: The Township does **NOT** accept postmarks. The date the payment is received by the Township Treasurer is the date the payment will be processed. Please allow sufficient time for delivery of your payment.

MORTGAGE LENDER

If you have an escrow account with your mortgage company, it is your responsibility to confirm that they paid your taxes. Please retain your tax bill for your records.

DEFERMENT OF PROPERTY TAXES

An owner may file a completed **deferral** of **property tax** form with their township treasurer by September 15, or the time the tax would otherwise become subject to interest or a late penalty charge for late payment, whichever is later. Examples to qualify are listed below.

- **Seniors - 62 years of age or older.**
- **Paraplegics or quadriplegics.**
- **Eligible servicepersons, veterans, or widows/widowers.**
- **The blind.**
- **The totally and permanently disabled.**
