ADOPTION OF AGENDA

K. Szymanski made a **motion, supported** by C. LeFebvre to adopt the agenda as presented as well as add the following: under Old Business: 1) By-Laws. *Motion passed unanimously.*

PUBLIC MEETING PARTICIPATION RULES

CASE

Case #P-01-09: N & R Enterprises requested a **site plan review** for a commercial cold storage building. Property is located at 0 Hamilton Road, parts of Parcel No.'s 012-010-000-301-04 and 012-010-000-301-06, in a B-2 zone district.

Rich McTaggart and Nathan Engstrom of N & R Enterprises were present to discuss this case along with Michelle Styma, representing Mannig, the sellers.

F. Sterns made a **motion** to grant the SITE PLAN REVIEW, **supported** by K. Szymanski. Reasons for granting Case #P-01-09 are contingent upon:

- a. Fits with the long term Master Plan
- b. Hours of Operation will be 7:00 a.m. to 7:00 p.m.
- c. Agrees to plant cedar trees on the north side of their property ten (10) feet from the line
- d. They have received split approval

Review Comprehensive Plan: The plan does not need a major rewrite. The main subject is "Future Land Use". F. Brink will talk to Supervisor Twite about her and building inspector Les Klimaszewski attending a meeting to discuss what input they might have from the public regarding the plan.

Discussion on Outdoor Wood Burning Furnaces/Possible Rezone on Walter, off M-32: The Commission all agreed that rezoning might not be a good idea at this time. A wood burner cannot be used in a platted subdivision and changing the zoning would not change this fact. The subject property in question is located on Walter Street, just off of M-32.
