Revisions to current Policies & Procedures

Existing Policy

5.18 Time Cards

All completed time cards for non-exempt employees shall be submitted to the Clerk on the day following the end of each pay period. Time cards will be signed by both the employee and the employee's department head.

Recommendation to UPDATE

5.18 Time Cards

All non-exempt employees shall submit timesheets to the Clerk on the day following the end of each pay period. Fire Department staff without direct access to a Township computer when performing work shall download the Time Clock Plus (TCP) application (or such other timekeeping application as the Township may require) on their personal cellular devices for time keeping and Chief shall promptly review and submit the accurate payroll to the Clerk no later than 1 day following the end of the payroll period.

CONTRACT FOR INTERIM FIRE CHIEF SERVICES

CHARTER TOWNSHIP OF ALPENA

This contract is between the Charter Township of Alpena ("the Township"), a Michigan municipal corporation, with an address of 4385 US-23 North, Alpena, Michigan 49707, and Andrew Pless ("the Interim Fire Chief"), with an address of _______, for Interim Fire Chief services.

- 1. <u>Interim Fire Chief Services.</u> The Interim Fire Chief is retained by the Township pursuant to this contract as an independent contractor to perform, on an interim basis, all the services that have been customarily performed by the Charter Township of Alpena Fire Chief, and to perform such services in accordance with the applicable local, state of Michigan, and federal statutes, codes, ordinances, rules, regulations, standards, and requirements.
- 2. <u>Contract Term; Termination.</u> The Interim Fire Chief will begin providing such services on August 1, 2024, and will continue providing such services until either the Township or the Interim Fire Chief terminates this contract. Either party may terminate this contract by providing the other party with a minimum of seven (7) days' prior written notice of the intention to terminate this contract.
- 3. <u>Compensation.</u> The Township will pay the Interim Fire Chief \$60.00 per hour for performing such services. The parties agree that such hourly rate will be the sole source of compensation for such services, and that the Interim Fire Chief shall not receive any other type of compensation or benefits, including, without limitation, any health, retirement plan benefits, or paid vacation or time off. The Interim Fire Chief shall not be entitled to any remuneration, benefits, or expenses other than as specifically provided for in this contract or as otherwise subsequently authorized by the Township.
- 4. <u>Insurance.</u> The Township will provide the Interim Fire Chief with insurance coverage and legal defense through the Township's insurance carrier as long as the Interim Fire Chief was acting within the scope of his authority as the Interim Fire Chief. The Township, in concert with its insurance carrier, may, in its sole discretion, compromise, settle, and pay any claim against the Interim Fire Chief before or after the commencement of a civil action. The Interim Fire Chief will cooperate with the Township and its insurance carrier by providing his best efforts to assist in defending any such claim.
- 5. <u>Return of Materials.</u> The Interim Fire Chief acknowledges and agrees that all files, records, products, equipment, keys, credit cards, and other materials used in connection with the Township Fire Department shall remain the property of the Township, and that, upon termination of this contract, the Interim Fire Chief shall promptly return such items to the Township.
- 6. <u>Independent Contractor.</u> The Interim Fire Chief agrees to perform such services hereunder solely as an independent contractor. The parties recognize that this contract does not create any actual or apparent agency, partnership, franchise, or relationship of employer and employee between the parties. The Interim Fire Chief is not authorized to enter into or commit the Township to any agreements, and the Interim Fire Chief shall not represent himself as the agent or legal representative of the Township. The Township shall not be liable for taxes, Worker's Compensation, unemployment insurance, employers' liability, employer's FICA, social security, withholding tax, or other taxes or

withholding for or on behalf of the Interim Fire Chief or any other person consulted or employed by the Interim Fire Chief in performing services under this contract.


7. **General Terms.** This contract represents the entire agreement between the parties. This contract may not be amended, changed, or supplemented in any way except by written agreement signed by both parties. This contract shall be governed and construed in accordance with the laws of the state of Michigan. Any notices to either party under this contract shall be in writing and delivered by hand or sent by nationally recognized messenger service, or by registered or certified mail, return receipt requested, to the address set forth above or to such other address as that party may hereafter designate by notice. Notice shall be effective when received. The waiver by either party of a breach or violation of this contract shall not constitute a waiver of any subsequent or other breach or violation.
