Roll call found present: Supervisor Twite, Clerk Dubey, Treasurer Diamond and Trustees: Baker, Mischley and Schuelke. Trustee Dunckel was abosent. Attorney James Florip was also present.

Adoption of Agenda: It was moved by Treasurer Diamond, seconded by Trustee Baker to adopt the agenda as presented and add the following items: Under New Business: Designate Fire Prevention Week, Purchase Glove & Helmets as budgeted for fire departments and talk about consolidation of Fire Departments. Motion carried by unanimous vote.

Public Comment: Andrea Dutcher, Kaye Ogger and Elizabeth Litzner addressed the board concerning the invasive species phragmites. This is a species that kills all other plant life and can grow to be twelve feet tall. The species is found in the Misery Bay, El Cajon Beach and Isaccson Bay. They hoped the supervisor could contact someone from the Conservancy or NEMCOG. Supervisor Twite said she would contact Rick Duell from NEMCOG and he in turn could contact someone from the Conservancy.

Rezoning Case P-04-12: Gerald and Audrey Compeau requested parcels: 013-023-000-050 and 013-023-000-060 be rezoned from One Family Residential (R-1) to General Business (B-2). Properties are located on US-23 North. The Townships Planning & Zoning Commission made a motion to recommend to the Alpena Township Board of Trustees to not rezone the property to B-2, but rather rezone to R-3 as R-3 is compatible with the present zoning and the Future Land Use Plan. Upon the recommendation of Townships Attorney Florip, it was moved by Trustee Mischley, seconded by Clerk Dubey to refer the case back to the Planning & Zoning Commission, due to the fact the hearing was to R-3. The new CM200 radios come with a 2-year warranty on parts and labor. Board members questioned the amount of radios needed for the DPW. The supervisor will check with the DPW Director and see if this is correct, if correct the upgrade will be done.

Generator Hook Up: One bid was received from Omega Electric & Sign Company in the amount of \$2426.00. Tower Contract Update: Attorney Florip will make a recommendation to the board in the near future.

Fire Prevention Week: The supervisor designated October 7th through October 13th, 2012, as fire prevention week. Open houses will be provided at each station.

Purchase of Gloves and Helmets: It was moved by Trustee Mischley, seconded by Treasurer Diamond to purchase 6 Bullard PX Helmets and 7 Dragon Fire Gooves for a total cost of \$1504.65 from Great Lakes Fire and Safety Equipment. Consolidation of Fire Departments with City: None of the board members were in favor of consolidating the townships fire departments with the City fire Department. The board agreed to continue to work on cooperative efforts such as the ambulance transfers, mutual aid and the M-32 facility.
