Baker's dedication to the Alpena Township Board of Trustees with his contribution to the community of service of over twenty (20) years. Resolution declared adopted by unanimous roll call vote. Twite presented certificates and helmet arches to the four who completed firefighter I and Firefighter II classes through the Alpena Combat Readiness Training Center according to the State of Michigan requirements.

Public Comment: The following residents addressed the board concerning the enforcement of the Townships Blight Ordinance. Individuals who spoke were: Larry Clark, Steve Plowman, Karen Hill, Linda Hudson, Pete Wilson and Donald Duval. Herbert Palmer and Donald Beam complimented the township board on what they have done on enforcing the ordinance and areas that have been cleaned up.

Minutes: It was moved by Treasurer Diamond, seconded by Trustee Schuelke to approve the minutes of the meeting held on May 6, 2013, as presented in typed form. Motion carried by unanimous vote.

Correspondence: It was moved by Treasurer Diamond, seconded by Trustee Schuelke to receive and file the following correspondence: Alpena Township - Financial Statement, Planning Commission - Minutes - May 13, 2013, Department of Licensing and regulatory Affairs - Building Official Classification and Donald Beam - Letter to MDNR - Issuance of Firewood Permit. Motion carried by unanimous vote.

Old Business: Supervisor Twite informed the board that the foreclosed properties are not yet available. Will be brought back when the time is right.

Opt-Out Health Insurance - SB7: It was moved by Trustee Mischley, seconded by Trustee Schuelke to Opt-Out of the law which specifies that all of the provisions will apply for any insurance plan contract that began on or after January 1, 2012. The basic description of the law is no public employer may pay more than \$15,000 for health insurance for family coverage, \$11,000 for an individual and spouse, and \$5,500 for any individual. These hard caps are effective for the calculations for the 2012 calendar year. On January 1st of each year thereafter, those cap rates will be adjusted by the health care inflation index that is calculated by the federal government. If the board decides to go with the hard cap or the 80% 20% the employees would be required to pay a portion of their premiums. Board figured out the costs to the employees by using both calculations. It was noted that some government units in the area opted out of this program. Board considered the fact that the employees have not received any increases in pay for the last three years and have opted to not receive any increase for the nest three years. Motion carried by majority vote. Yeas: Twite, Mischley, Diamond, Dubey and Schuelke. Nays: Fournier.

MTA Workshop (Frankenmuth - June 27, 2013): No interest.

Principles of Governance: It was moved by Clerk Dubey, seconded by Trustee Fournier to adopt the Principles of Governance to maintain the highest standards and traditions of Michigan Townships.
