### Urban Archery Hunting Permit Application – Town-owned Property

Urban Archery (Bow hunting) shall be permitted within the Town of Altavista and on Town owned property when discharging an arrow from a bow for the purposes of deer hunting within the Town of Altavista town limits during the Urban Archery Season, the Early Archery Season, the General Firearms Deer Season or during the Late Archery Season, as designated in regulations set forth by the Virginia Department of Game and Inland Fisheries (VDGIF), and on town owned property outside town limits during, the Early Archery Season, the General Firearms Deer Season or during the Late Archery Season, as designated in regulations set forth by the Virginia Department of Game and Inland Fisheries (VDGIF), under the following conditions:

1. Except for target shooting, discharge of archery equipment is not permitted within one hundred (100) feet of any dwelling except with written consent of the owner of said structure.
2. No hunting on private property without written permission from the landowner which must be carried on the person at all times when hunting.
3. No person shall discharge a bow from, over or across any street, sidewalk, alley, roadway, or public land or public place within Town limits or toward any building or dwelling in such a manner that an arrow may strike it.
4. Except for target shooting, archery equipment can only be discharged from elevated stands unless written permission to hunt from the ground is given by the property owner.
5. Hunters must register and sign a release at Town Hall, with the Town Manager or designee, to hunt on Town-owned property.
6. Safety harnesses are required at all times, while hunting from tree stands on town owned property.
7. In addition to the Urban Archery Season, archery deer hunting is also allowed in the Early Archery season and the General Firearms Deer Season.

I hereby absolve the Town of Altavista of all liability for my person while engaged in hunting on Town owned property.

I attest the above information is true and agree to comply with all regulations of bow hunting on Town owned property. A copy of a valid Driver's License and Virginia Hunting License is required with the application.
