The snowflakes average \$325.00 which would come to about \$24,700.


If we can purchase when they have their buy 2 get 1 free sale this would drop the price to about \$225.00 per snowflake, a considerable savings.



Re: Ridgeway Avenue Drainage discussion at Town work session Feb 26

Background

- Homeowners complain of wet conditions
- Exposed and deteriorating storm pipe on private property

Analysis

- Surveyed storm system and topography for the area
- Existing street runoff sheet flows onto 1827 Ridgeway Avenue (Mitchell) property and is not contained in an existing storm system.
- Existing storm sewer conveys storm water from Town ROW into storm system on private property.
- No existing easement for storm system on private property
- Existing storm sewer is adequately sized for the 10 year (typical VDOT) flows.
- Exposed and deteriorating pipe should be remediated

Proposals

 Both options utilize 18" Reinforced Concrete Pipe which is the standard minimum diameter and typical material for VDOT storm pipes.

- Option 1-Remove existing pipe on private property and replace with new pipe on newly granted storm drainage easement. Option 1B replaces additional pipe within ROW.
 - a. Would require property owner to sign easement on private property. Town would be responsible for maintenance of storm pipe.
 - b. Could require another easement on downstream Collando property below pipe discharge down to Town property.
 - c. Would most likely result in the removal of 48" oak along existing pipe and other minor trees/shrubs in the area. Mr. Mitchell has indicated to Town staff that he understands that this tree would not survive any construction in the area. Cost of oak removal is not figured into the estimates but is estimated to be in excess of \$3000.
 - d. Estimate includes 80 If of concrete driveway replacement on private property. Depending on proposed pipe alignment, this cost could increase or decrease.
- Option 2-Remove existing pipe on private property and replace with new pipe on within ROW down to Bedford Avenue. Option 2B replaces additional pipe within ROW.
 - a. Option 2 is dependent upon the ability to connect into the existing storm inlet on the northwest corner of Ridgeway Avenue and Bedford Avenue. If the existing waterline in Ridgeway Avenue is significantly lower than expected, this design would need to be modified resulting in cost increases.
 - b. Option 2 includes connecting to a storm system that is not standard as the stormwater flows at an angle of greater than 90 degrees at the inlet on Bedford Avenue. VDOT approval for this connection may be required.
 - c. Both Option construction estimates may be reduced by revising the curb & gutter/pavement transition.
 - d. Both Options require relocation of the existing water service at 1827 Ridgeway if the existing storm grate inlet is removed/replaced.

Recommended Option

- Engineer recommends implementing Option 1B, replacement of the existing storm sewer system within private property and Town ROW.
- Option 1 is estimated to be less construction costs than Option 2.
- Option 1B will remove some storm runoff from discharging onto private property and will contain this runoff in a Town storm sewer system.
- Option 1B is recommended to replace deteriorating and substandard Town storm sewer pipe and inlets within Town ROW.

Summer Intern in Police Department

Bin Yang, a student at Altavista Combined School, has contacted the police department about the possibility of him completing a summer internship. I met with Yang in person and was really impressed with him. He is interested in a career in law enforcement and wants to learn as much as he can about it.

Yang would have an opportunity to shadow police officers and learn what they do on a daily basis. I would also assign him a project. There are lots of surplus/old items stored in the fire house. I would ask that he catalog and organize the items to have them ready for destruction or auction.

This internship would last from June 3, 2019 through July 12, 2019. (6 weeks) It would encompass 20-30 hours per week, however the schedule would be flexible. I would propose that we pay Yang a stipend of \$100/week to offset some of his expenses. He would be required to sign an internship agreement which states the town can terminate the agreement at any time for any reason. It would also be a liability release for him while with officers and performing any task under the direction of the Police Department.

ITEM TITLE:

Staunton River Regional Industrial Facility Authority (RFIA) funding

DESCRIPTION:

Altavista is a charter member of the Staunton River Regional Facilities Authority (RIFA) along with the Town of Hurt, Pittsylvania County and the City of Danville. The RIFA formation was recently approved by the Commonwealth of Virginia and the organizational meeting was held February 8, 2019.

Previously, Town Council approved the Staunton River Cost and Revenue Sharing Agreement associated with the RIFA. This document addresses the funding of the RIFA; in "Section 8. – Initial Contributions" each member locality is required to provide financial resources equal to their Member Share, as outlined in the document. The Town of Altavista has a Member Share of 23% and accordingly is obligated for \$23,000 of the Initial Contribution amount of \$100,000, which is now due. The other localities Member Shares are: Town of Hurt (4%); Pittsylvania County (50%); and City of Danville (23%).

Staff has provided \$25,000 in the proposed FY2020 Budget for our share of any "Option Fee" for property associated with the RIFA. The RIFA will be working with the owners of the Southern Virginia Multimodal Park (SVMP) in regard to the final Development and Option Agreement.

BUDGET/FUNDING:

FY2019 Budget Amendment of \$23,000 (unexpended funds in the Economic Development budget can be utilized for this payment.

FY2020 Draft Budget has \$25,000 for RIFA purposes.

POTENTIAL ACTION/PROPOSED MOTION:

Approve the use of existing Economic Development funds budgeted in the FY2019 Budget for payment of the \$23,000 RIFA Initial Contribution.

<u>Section 8. - Initial Contributions</u>. The Member Localities hereby acknowledge the initial contributions to the Authority as follows:

All other contributions from a Member Locality to the Authority shall be acknowledged by the Treasurer of the Authority, who shall update the respective Member Shares of the Member Localities.

Section 9. - Sharing of Machinery and Tools Tax Revenues. Once one or more industries or businesses have located within any Authority Facility, the Host Locality will begin to realize tax revenues from such industries or businesses for machinery and tools tax. The Host Locality alone shall determine the rate at which machinery and tools are taxed and the due date of such taxes. The Host Locality agrees that subject to Section 16 below, upon receipt of machinery and tools tax remitted by an industry or business located within an Authority Facility, the Host Locality shall appropriate the total of taxes so received, pay the same to each of the Non-Host Localities according to the respective Member Share, and retain the remaining amount.

Section 10. - Sharing of Real Property and Personal Property Tax Revenue. Once one or more industries or businesses have located within any Authority Facility or purchased real property in any Authority Facility, the Host Locality will begin to realize tax revenues from such industries or businesses for real property and personal property. The Host Locality alone shall determine the rate at which real and personal property is taxed and the due date of such taxes. The Host Locality agrees that subject to Section 16 below, upon receipt of such real property taxes, personal property taxes or both remitted by an industry or business located within an Authority Facility, the Host Locality shall appropriate the total of taxes so received, pay the same to each of the Non-Host Localities according to the respective Member Share, and retain the remaining amount.

<u>Section 11. - Sharing of Miscellaneous Tax Revenues</u>. Once one or more industries or businesses have located within any Authority Facility, the Host Locality will begin to realize
