Diapers and Wipes

Revised 2/19/2025

Contingent upon available funding, ACDJFS will issue diapers and wipes to eligible families. Eligible families will receive a box of diapers and 3 packages of wipes for each child under three years old needing diapers/wipes in the household. Please indicate what size you would like. Sizes available are preemie through size 7.

Eligibility

- 1. Must be a resident of Athens County; and
- 2. Meet TANF/PRC eligibility; and
- 3. Not have an outstanding fraud overpayment; and
- 4. Have child under three years old in need; and
- 5. Total household income must be at or below 200% of the federal poverty guidelines.

Time Frame

This is a once per year benefit, contingent upon supplies and funding.

Procedure for Application

The attached ACDFS Diapers & Wipes Application will be used to determine eligibility. SPC will enter information into spreadsheet located on SharePoint. An approval or denial letter will be issued. Application and approval/denial letter will be scanned into participant's file. Original applications with the copy of the approval/denial letter will be forwarded to the fiscal department. PRC reporting tool will be completed by fiscal.
