### BUILDING PERMITS\*

*\*Depending on the complexity of the project, additional permits may be required for subcontractors or other phases of construction.*

The City of Bella Vista determines the valuation of construction using the International Code Council's *Building Valuation Data Table*. The valuation method of calculating permit fees includes, but is not necessarily limited to, both new residential and commercial construction, additions, as well as accessory structures including workshops, storage buildings, decks, ramps, stairs, roofs over decks or porches, screened decks converted to sunrooms, carports, pergolas, gazebos, conversion of carports to garages, covered and open docks, boathouses or enclosure thereof. *Please ask Staff to determine if your project will be calculated using the valuation method.*

The valuation table is published every six months to provide an up-to-date average construction cost per square foot based on Occupancy and Construction Type. A copy of the table is available from the Building Division office or at the ICC's website at [www.iccsafe.org](http://www.iccsafe.org). After valuation is determined, the following table is used to calculate permit fees.

Total Valuation	Fee
\$3,000 or less	\$25.00
\$3,001 - \$15,000	\$25.00 for the first \$3,000 plus \$5.00 for each additional thousand or fraction thereof rounded to the nearest thousand.
\$15,001 - \$50,000	\$85.00 for the first \$15,000 plus \$5.00 for each additional thousand or fraction thereof rounded to the nearest thousand.
\$50,001 - \$100,000	\$260.00 for the first \$50,000 plus \$4.00 for each additional thousand or fraction thereof rounded to the nearest thousand.
\$100,001 - \$500,000	\$460.00 for the first \$100,000 plus \$3.00 for each additional thousand or fraction thereof rounded to the nearest thousand.
\$500,001 and up	\$1660.00 for the first \$500,000 plus \$2.00 for each additional thousand or fraction thereof rounded to the nearest thousand.

Systems permits must be obtained for new residential and commercial construction and in other circumstances when the construction will involve alterations to the systems. Systems permits are subject to a minimum permit but may be greater depending on the scope of the system changes.
