The Permit Application must be completely filled out and signed by an authorized company representative. The completed application may be submitted for consideration by fax to 479-876-1205 or emailed to the contacts listed at the bottom of this page. When emailing the Permit Application, please address multiple recipients listed below as a guarantee the City of Bella Vista Street Department has received your application.

For bores or parallel lines in the Right of Way, the permitting process may be completed entirely by fax or email if all information is supplied on the signed application, a map/sketch/drawing is provided with the proposed locations and the fees/bond requirements have been met.

**Please mark bore locations in PINK marking paint with a dot on the edge of the roadway on each side indicating the exact location of the bore.

Open Street Cut requests will require additional information. Permit Applications will be reviewed and approved/rejected on a case by case basis depending on the individual circumstances. If a permit is issued for an Open Street Cut, necessary street repairs will be based on the Street Classification in the Bella Vista Master Street Plan. Detailed specifications for repairs are available for your reference.
