Hatsephi Kushman – 7526 Thelma Avenue – He states no one is answering the citizens' questions tonight, they're just talking. It's not fair, Mayor Fair. The Board is not being progressive. Address that please.

Michael Ruff – 4313 Rickey Drive – Why has Bel-Ridge had the police department all these years with no money and now you're wanting to get rid of it after receiving COVID relief funds, etc.? We're not getting the truth.

Rebecca Cogshell – 3015 Wheaton – I'm speaking about a house that's located on the cusp of Bel-Ridge and unincorporated St. Louis County, concerning the 5 to 6 cars parking in the yard, furniture sitting in front yard, etc. I'm tired of calling St. Louis County, couldn't get through. Can this Board get through to St. Louis County for assistance?
