# CITIZEN PARTICIPATION

**Elvis Fantroy** --- Parking problem on Werder Drive – no response or participation from Normandy Police. Discussion held regarding all the parking violations. Resident Fantroy makes a formal complaint to Bel-Ridge and Normandy Police for help. Next course of action will be to the Attorney General.

Alderman Robinson asks if better research is being done on ownership of properties on Werder. Public Works Directors describes what actions have been taken thus far to rectify the problem. Further discussion held between Board, Sgt Sanders and residents.

**Darryl Robinson** --- I have a couple of questions. What did you men when you said "amend the agenda" and how is it that we continue to rent properties in the strip mall and can't find owners to pay their business taxes to the City of Bel-Ridge?

Another thing --- where did the engineer that did the streets assessment come from? Board replies: 24:1. Discussion held.

Rebecca Cogshell --- Can we do Airbnb? The point is --- on Kendale, big trucks trying to get in the backyard and you can't tell me this is not a business. Discussion held.

Discussion held regarding commercial building inspector's duties and his recent performance.

Reassignment of 2021, 2022 Community Development Block Grant (CDBG) Applications — City Attorney states this is the time where a specific motion and vote needs to occur for the grants. Motion to designate Maybelle Avenue to receive 2021 and 2022 CDBG grants made by Alderman Robinson and seconded by Alderman Watts, an all-in favor vote received.

2023 Community Development Block Grant (CDBG) Application --- City Attorney states a specific motion and vote needs to occur for the 2023 grant. Motion to designate Maybelle Avenue to receive 2023 CDBG grant made by Alderman Robinson and seconded by Alderman Watts, an all-favor vote received.

Dinner @ Londa's – Failure to file 2022 Liquor License --- Discussion held to what steps need to be taken to rectify the failure of obtaining a liquor

license. City Hall to issue notification – a show cause – as to why she does not have a liquor license with the City of Bel-Ridge, including a scheduled hearing date.

Review of No Parking Ordinance for Werder Drive --- Problem with snow removal on Werder as well as cars parked on both sides of the street. A solution is needed for this parking problem. Sgt Sanders suggests parking on one side of the street and reducing places to park would get derelict vehicles off the street. Discussion held. City Attorney to work with Public Works Director to send letters to residents regarding derelict vehicles.

**2023 Annual Budget** --- City Accountant to attend the next working session. She will prepare the budget. Next working session scheduled Thursday, December 15.

**Review of 2023 Employee Salary Increases** --- Discussion held, ordinance needs to be passed. City Attorney to work with City Clerk for presentation at next working session.

2023 Purchase/Lease of Five (5) Police Vehicles --- Will cars remain in the name of Bel-Ridge? Also, Normandy needs to tell Bel-Ridge the amount needed allocated for these new police vehicles. Discussion held. Sgt Sanders speaks on the current stock of available vehicles.
