# CITY OF BEL-RIDGE BOARD OF ALDERMAN MEETING MINUTES TUESDAY, FEBRUARY 7, 2023 6:00 PM

One hundred fifty (150) wheels and converters were stolen from him. He stated, "I can't continue to lose more at night than I make in the day. And my business was opened in 1947 and I know you don't want this board to be the reason Carson closes." Discussion held.

## **BOARD COMMENTS**

Alderman Watts states Home Depot has donated One thousand dollars (\$1,000.00) worth of new Christmas lights to the City of Bel-Ridge and 2 pallets have been delivered.

Mayor Fair states the basement needs cleaning out. He knows someone who will come and get the old computers at no charge. City attorney states city staff authorized to service computers and should be the one to wipe the computers clean.

Alderman Robinson states residents are moving in Bel-Ridge and saying they haven't received trash pick-up information. Discussion held to start informing residents of City of Bel-Ridge ordinances. It is recommended city staff send letters to all residents.

Residents ask when a code enforcement officer will be hired? Board states this matter will be further discussed at working session. City clerk recommends Alderman introduce themselves to new residents in their wards and work with city staff to correct problems and to follow ordinances of the city.

Alderman Tope – Suggests putting stickers on residents' doors that needs inspections/occupancy permits.
