## Untable Approval of 2018 Minutes for March 14 and August 14

Mayor requests motion to approve the 2018 minutes of 3/14/18 and 8/14/18. Alderman Brown motioned to un-table and Alderman Abernathy seconded. Discussion held regarding the minutes. Alderman Tope states the minutes contain criminal acts – regarding falsifying of records. The minutes are not what the Board on in the past. Bill 1351 is different than the bill that was signed. Board has turbulent discussion regarding alteration of documents. Alderman Tope states the signed bill in the Code Book was not voted on by the Board. Chief Harris is questioned by Alderman Tope about having an employee who testified falsely under oath during a deposition about Bill 1351, which was not signed by the Board. Alderman Ruff motioned to stop discussion and table regarding approval of 3/14/18 and 8/14/18 minutes. Alderman Nelson seconded the motion.

Voice vote on the motion to stop discussion and table approval of 3/14/18 and 8/14/18 minutes were 4 in favor and 2 opposed. Motion passed.

#### **NEW BUSINESS**

#### **Homestead Bids**

One bid on 2914 Hammond was received from Darion Green. Discussion held regarding the program and process. Alderman Brown motioned to approve bid received for 2914 Hammond. Alderman Ruff seconded the motion.

Voice vote on the motion to approve bid on 2914 Hammond carried unanimously.

Three bids on 8610 Wales were received by the City. The highest bidder was Darryl Robinson. Discussion held regarding the process. Alderman Ruff motioned to table this item. Alderman Nelson seconded the motion.

Voice vote on the motion to table the bids for 8610 Wales were 4 in favor/2 opposed.

## Approval for City Clerk to Be Member Rep Contact with MOPERM

Mayor requests a motion to approve the City Clerk to be the MOPERM contact for the City, removing Alderman Tope as the contact person. Alderman Brown motioned to approve the City Clerk to become MOPERM contact. Alderman Abernathy seconded the motion.

## **Discussion of Attorney General Letter About Coplaint**

Mayor asks for update concerning a resident's complaint to the Attorney General regarding a sewer lateral application. City Clerk talks to the current state of the complaint. Inspector Winston explains the situation to the Board. Complainant requests refund of application fee. Alderman Brown motioned to deny return of application fee to the complainant. Motion was seconded by Alderman Nelson.

Voice vote on the motion to deny return of application fee to the complainant carried unanimously.

## Discuss and Approve New Software for City Hall

City Clerk and Police Chief speaks to software needs and bids. Bid from Elliott were disbursed. Board asks questions, discussion held. City Clerk to contact additional vendors. Alderman Ruff motioned to approve Elliott bid. Alderman Abernathy seconded the motion.

Voice vote to approve Elliott bid carried unanimously.

Alderman Ruff motioned to table new software for the City. Alderman Nelson seconded the motion.

Voice vote to table carried unanimously.

# Approval of Bill No. 1371 Authorizing Contract Between City and Landmark Dodge Chysler

Chief Harris explains the contract. Already approved, no additional cars, just need the ordinance. Alderman Tope asks if police has to go to Kansas City to get the cars. Chief responds not unless City wants to pay the delivery fees. Alderman Russell motioned to first read by caption only. Alderman Ruff seconded motion.

Second read by caption only by Attorney Martin. Bill # 1371 now Ordinance 2019-01 establishing contract between City and Landmark Dodge Chrylser.

# Approval of County Academy Training Payment - Police Department

Chief Harris is asking to pay County Academy, which is paid every year. Beginning January 1, 2019, it's \$150 per officer -- \$2400 for the year. Alderman Russell asks if it comes out of Prop P. Chief Harris states it comes out of the training funds and is currently sufficient. Alderman Russell motions to approve County Academy Training payment. Alderman Ruff seconded the motion.

Voice vote to approve payment to County Academy Training was 4 yes/2 no. Motion passed.

## Approval of Employee Contract – Police Department

Chief Harris states it's common for police chiefs and assistant police chiefs to have a contract with the City. Alderman Tope states this is highly irregular with a new mayor. Discussion among Board regarding length of the contract. City Attorney speaks to the fact the contract is not unusual, contract is proper. Alderman Brown motions to approve employee contract. Alderman Ruff seconded the motion.

Tommy Tabb – Thanked everyone and the workers for the work on St. Henry Lane. Streets are not completely finished so parking is messed up. I received a ticket for parking in my yard and was not told to move car back after the street was repaired. Detective Strong and Police Department will handle ticket.

**Houssein Al-Eidan** – Tried to sell the property, was unsuccessful. Looking into opening a food place. Topic to be put on a future agenda for further discussion. Alderman Ruff asks if he's running a business from his personal residence.

**Jerome Robinson** – Cats in the neighborhood continue to tear up everything and destroy property. Alderman Russell suggest calling Animal Control. Mr. Robinson also states police officers harass residents and aren't professional.

**Julia Anderson** -- Questioned extra paychecks received by Alderman Russell, Alderman Brown and Alderman Ruff. City Clerk answered questions. Ms. Anderson stated there is established nepotism.

**Darryl** -- Spoke on St. Henry Street and the problems there, tickets received and lack of communication during the entire process. He stated there is a problem in the cul-de-sac that needs looking at/inspected.

**David Janowski** – He has opposition to cameras in the park as it violates privacy. Mayor states it's a public park and they're there for vandalism and such.
