The overall goal is to have it out to bid by end of July and we'd like to be back here end of August or September meeting with contract recommendation.

**Public Hearing for the Allocation of 2020 and 2021 CDBG Grant Funds** --- City Clerk states St. Louis County said we have to have another public hearing for the 2020 CDBG Grant Funds due to possible conflict of interest. City Clerk also states we need to address the 2021 CDBG Grant Funds also at the same time, as St. Louis County says no late applications. Discussion held as to possible dates. July 22 chosen as date for public hearing meeting for 2020 and 2021 CDBG Grants. Thirty-eight thousand one hundred dollars (\$38,100.00) per year is the amount of the grants.
