COMMITTEE REPORTS

Police Department – Chief Harris --- Chief Harris reports seat belt violation activity. There have been 46 citations issued. Detective Strong reports on gun violence activity, which the department is currently monitoring. These cases are going straight for federal charges, trying to keep neighborhoods safe. The department is also monitoring trespassing and burglary heavily. Chief Harris states DWI enforcement will occur during the Independence Day holiday. Police presence will be thick throughout the City July 3rd through July 10th.

Public Works – Cary Herndon --- Director Cary Herndon reports they have cut 10-15 trees out on 3400 Springdale Avenue and it looks good. Cary also distributed packets with price estimates for the salt bend that is needed. An audit by D&R is upcoming. Discussion held regarding the salt bend.

Parks – Alderman Abernathy --- Alderman Abernathy requests her title be changed to Parks and Recreation. She also states the last day of school is June 26 and the school would like an outing in the park. There will be no cost to Bel-Ridge. There will be 100 students, 10 teachers and volunteers. They are bringing their own lunch. Alderman Abernathy asks for a \$500 budget for the park clean up. The fraternity will do the cleaning. Public Works Director recommends paining the picnic tables/bathrooms. Clean up not will not cost \$500.

OPEN TO THE PUBLICE

Julia Anderson – Resident questions whether the computers that were issued to previous board members have been returned. Detective Strong states he spoke to those former members and two were returned. One stated theirs was broken and discarded. Resident asks if they are responsible for the costs? Ms. Anderson states the Code Book states board member terms are one year. Terms will be checked for clarification. Resident states a car has been parked on Natural Bridge for 3 months with no license plates and no tickets were issued. Police only comes around day before Board Meeting.

Manson Graves – Question to Chief Harris: What is a police report and what is it used for? If a police report is filed fraudulently, what is the penalty? Chief responds that if a false police report

is filed, what is the recourse? Discussion held. Alderman Tope requests resident to file a formal complaint.

Darryl Robinson – Addresses demolition of house on Hanley Road that has been previously worked on. How much is needed to complete demolition of the house. Also, can we get no trespass signs? Detective Strong addresses the issue.

Beyond Housing -- Ms. Spencer, Beyond Housing representative and Bel-Ridge resident, speaks about the Homestead Project. Bel-Ridge has 13 properties, which may be purchased for \$27.00. Bel-Ridge can sell, auction, however you decide, the properties.

Code Enforcement – Ms. Spencer stated that municipalities are merging together for code enforcement services. People can apply for training and will become certified.

Health Insurance --- municipalities have come together and merged for health insurance to lower the costs to employees.

Mary Mans -- In light of the mass shooting in Virginia, the cameras need to be reactivated. We spent \$40,000 and need to be used, should not be a though. Discussion held. Alderman Tope states City has a system that is being used. Resident throws microphone down.

Rebecca Cogshell – Ms. Cogshell reads document regarding appointment of Planning and Zoning members, dated July 17, 2014. Resident also talks about Ameren UE's responsibility to keep grass cut in their section of the street behind her resident. Director Cary Herndon states he has called Ameren UE and put in a complaint. Still not cut. Mayor directs him to contact Ameren UE again.
