DISCUSSION 8645 NATURAL BRIDGE

Chief Harris addresses Board, explaining owner is using this address as an Air Bed and Breakfast. There is no Business License on file. Owner is complaining that Officers are sitting behind building. Chief states there have been on going issues at this address and have

instructed his Officers to watch for illegal activity. Chief Harris asked the Attorney Warren if he could get a Cease and Desist letter.

DISCUSSION ON CITY HALL HOURS

Since the City is without a City Clerk it was suggested we could close City Hall on Fridays. There were questions about other municipalities and their hours. Questions then came up about Court Hours and the Police Clerk hours. The Board suggested we do some research with other agencies and talk about this at a later date.

APPROVAL OF RESOLUTION 2019-B-MUNICIPAL PARK GRANT COMMISSION PLANNING GRANT APPLICATION

Alderman Abernathy spoke about getting help with the grants. Spoke with Mr. Seely. Also have someone come out and speak directly to the board with any questions.

DISCUSSION OF MAYOR PERFORMANCE

Mayor using City money to buy personal items. A lot of people shouting out from the audience. Much arguing between Board members, Mayor and the Alderman. Member in audience asked if we can move on to the business topics. Mayor agreed.

APPROVAL OF BILL 1375-AN ORDINANCE ADDING SECTION 355.210 TO CHAPTER 355, PROHIBITING THE OVERNIGHT PARKING OR THE STORING OF WORKING VEHICLES, BACKHOES, TRAILERS, TOW TRUCKS AND COMMERCIAL TRUCKS IN PUBLIC VIEW WITHIN 200 FEET OF RIGHT OF WAY.

Board was given an updated ordinance. On the Agenda it shows section number 355.190. The correction was made to 355.210. Copies were made and handed out to the Board members during the meeting. Motion was made by Ms. Russell. Second was by Mr. Ruff.

DISCUSSION OF SECTION 117.040 PROHIBITED ACTS-BEL-RIDGE CODE

Mr. Tope brings up Mr. Ruff doing work on Mary Mark. Mr. Ruff says it was an emergency situation. Mr. Ruff states it was approved by Mayor before any work was done.

OPEN TO THE PUBLIC

Tammy Gilbert- 4319 Rickey Ln. – Doing day care in her home for the past 11 years. The state of Missouri says she now needs approval from the City of Bel-Ridge. Board says she must have a commercial inspection from Mr. Winston and pass approval from the fire department. Board will approve if she passes all inspections.

Henry and Sandra Citchen- 8610 Natural Bridge-Questioning the ordinance/Bill number 1375-wants to know where to park her vehicles without getting tickets as she has in the past.

Darryl Robinson- 3737 St. Henry- Wants to know when the construction will be finished on St. Henry. Mr. Winston says the bricks on St. Henry will be removed on the 9th. Also wants the minutes from 02-05-2018. Again, wants to see the minutes. Again, Cindy explains she is trying to catch up since AJ's departure. She expects them to be complete by the April meeting. Mr. Robinson then comments on City Hall hours, wants to know why we are hiring a full time person when we are asking to cut down to 4 days a week.

Jerome Robinson- 3422 Maybelle Dr. – Received call from attorney, was very vague on any details. Mr. Tope goes off the subject and starts talking about "everything is a secret". No knowledge of "Closed meeting". Mr. Robinson then speaks about the trash in the neighborhood and what is being done. Chief states every Monday the Officers check addresses. People either get a letter or a summons.

Marcell Agnew-8917 Higginson Dr. – States she likes to come to the meetings, however there is way too much arguing. Not in best interest of City. Too much speaking out of turn. No order.

Julia Anderson 3319 Werder- Wants to speak to attorney. Wants Attorney to ask Mr. Ruff if he ever excepted money (Ward 1). Then ask Chief Harris if he was the one who collected that money. The attorney explains he does not have authority to ask questions during the meeting. Ms. Anderson then directed the questions to the Mayor. The Mayor stated he would like to know. Chief says he has no clue as to what she is talking about. Speaks about how the is a "subcommittee" within the board. Spoke about compensation "some" board members receive, who has access to building, what minutes are not on file. Spoke about how the Chief got in office, was incorrect, should have been thru the new Mayor.

Natalie G. 8974 Torchlamp Ln. – Talks to Board about the Homestead program. Interested in the property at 9156 Loganberry. She has been waiting 3 months for an answer. Did not understand "what houses were on the list"? Mr. Tope says attorney should look into this so the City could get this property sold. Mr. Tope then stated he checked the County web sight and 9156 Loganberry is not owned by the City of Bel-Ridge.

DISCUSSION OF WHISTLEBLOWERS

Mr. Robinson (resident) says the meeting cannot be over until the discussion of whistleblowers is discussed. Mayor says they are not going to talk more about this, that the board already talked about issues.

A motion was made by Mr. Brown to adjourn the meeting, a second was made by Ms. Russell All were in favor.
