CITIZEN PARTICIPATION

Harriet White --- I have lived here for over 50 years. Piggybacking to what Ms. Cogshell said, we don't know who lives in what houses. So many cars in driveways/on the street. Trash is not being picked up because trash trucks can't get through. Discussion was held as to possible solutions.

Barbara Thompson – Why don't we have anyone spraying anymore? Mosquitos are so big. City Clerk is to investigate resuming services for spraying as the County is the responsible party for spraying and we would pay for their services

Deanna Bonner – I have lived at 3137 Thelma since 1997. This year has been terrible. Have called the police. Basketball hoops all over my property. Their parents are unapproachable. Children repeatedly say to me "this isn't your driveway". What can be done? Discussion held – police intervention and non-remedies discussed. Resident complaints to be looked int promptly.

Alderman Robinson asks why there is a sign on the old Sista's Resale business. The previous owner states that person has not been before the Board yet and should not have put the sign up.

POLICE DEPARTMENT

Chief Sanders makes the following report for September 1 – October 1, 2023: 515 calls for service, 51 summons/tickets, 60 reports.

Chief Sanders discusses the change of the non-emergency police number from 314-889-2341 to 636-529-8210. The reason for the change is that the 314-889-2341 number was originally for police dispatchers but the number got out to the public and was misused. The public now complains that they call the police, and no one shows up. Chief Sanders recommends calling 911 and you will be properly routed to an appropriate dispatcher. Discussion held.

Chief Sanders discusses the insurance invoice for Bel-Ridge vehicles given to the city clerk.

Traffic enforcement: REJIS was hacked, and Normandy was not writing tickets for anyone. It was a regional issue, and everyone was impacted.
