#### BUSINESS AGENDA FIRST READING OF AN ORDINANCE AMENDING CHAPTER 22, SECTION 22.24 AREA, HEIGHT, BULK, AND PLACEMENT REGULATIONS

Ryan explained regulations for the O-1 Office Zone District in Chapter 22, Section 22.24 Area, Height, Bulk, and Placement Regulations, Schedule of Regulations lists a maximum building height at 30 feet but only allows a single story. Planning Commission has submitted an amendment modifying the language to permit a second story within the current height limit of 30 feet, as is allowed in every other Zone District. At the meeting held November 29, 2017 the Planning Commission held a public hearing and recommended approval of modifications to the language

updating the number of stories from "1" to "2" in the O-1 Office Zone District. This change will not modify the current allowable maximum building height of 30 feet.

A copy of the ordinance in its entirety is available for review at the Village of Beverly Hills Administration office.

#### **MANAGER'S REPORT**

**Fire Truck Update** – Public Safety Administration completed the specification review for the new mini pumper and pumper truck as authorized by Council. An order form was submitted prior to the end of the 2017 calendar year to lock in the 2017 prices. Village Administration will be presenting the financing options to Council at the next meeting. We are waiting on some final numbers as to our reserve amounts before finalizing the financing. Based on current estimates we will likely pay in full for the mini pumper, saving about \$5,200, and use the remaining balance as a down payment on the pumper truck, financing the remainder for a period of 5-7 years.

**Long Term Disability Plan** – With the approval of the PSO contract earlier this year, both the PSO Union and the Village agreed to continue working on a long term disability plan to cover Public Safety Officers in the Defined Contribution (DC) plan. This issue was brought to the Village's attention after the implementation of the DC plan for new hires. There was a significant gap in duty disability coverage for employees in a traditional pension, or Defined Benefit (DB) plan and those in a DC plan. This was particularly true for employees who had not served many years and had not built up significant savings in their DC accounts. It was not the intent of the Village to have such a disparity in disability coverage between employees. It took a period of time, but the Village was able to work with our insurance agency IBEX and obtain a Long Term Disability Plan for the Public Safety Department that the PSO Union agreed with. Benefits would be coordinated with other benefits, but would provide covered employees with a guaranteed monthly income and Cost of Living Adjustments for own occupation disabilities until age 65. Premiums for this were very reasonable and ended up being more than offset by savings IBEX and Village Administration were able to obtain on dental and life insurance coverage through renegotiating these benefits.

**FOIA Appeals** – Council has been copied on requests for an appeal of proclaimed denials of material under the Freedom of Information Act. These requests are in regard to documents of an

investigation by the Public Safety Department. Village Administration has turned the matter over to Village Attorney Ryan for his input and he is working with the Public Safety Department to respond. There is a process by which an individual who is denied public documents can appeal their denial to the Village Council. In this instance, Village Administration does not believe that there is a denial of any documents as the documents requested do not exist and/or the requests are not for documents but are interrogatory. Ryan is corresponding with the applicant and Village Administration and Public Safety will respond as advised.

#### ORDINANCE NO.

## AN ORDINANCE TO AMEND CHAPTER 22 OF THE MUNICIPAL CODE OF THE VILLAGE OF BEVERLY HILLS.

The Village of Beverly Hills Ordains:

Section 1.01. That the Zoning Ordinance No. 216, as amended, Chapter 22 of the Municipal Code, Section 22.24, Schedule of Regulations, is hereby amended to read as follows:

O-1 Office Zone District, Maximum Building Height in Stories - 2.

All other regulations remain the same.

Section 2.01. REPEALER. All other Ordinances and/or Resolutions inconsistent with the provisions of this Ordinance are, to the extent of such inconsistency, hereby repealed. The adoption of the above Ordinance does not affect or impair any act done since committed or right accrued or acquired or liability, penalty, forfeiture or punishment incurred prior to the time enforced, prosecuted or inflicted.

Section 3.01. SEVERABILITY. Should any section, clause or paragraph of this Ordinance be declared by a court of competent jurisdiction to be invalid, the same will not affect the validity of the Ordinance as a whole or part thereof other than the part declared to be invalid.

Section 4.01. SAVINGS CLAUSE. The passage of this Ordinance does not affect or impair any act done, committed or right accrued or acquired or liability, penalty, forfeiture or punishment incurred prior to the time enforced, prosecuted or inflicted.

Section 5.01. PENALTY. Any person violating any of the provisions of this Ordinance shall be guilty of a civil infraction, and upon a finding or admission of responsibility, shall be fined no less than five hundred dollars (\$500.00) for each such offense, or such fine in the discretion of the court, together with the costs of such prosecution. Each day that a violation of this Ordinance continues shall be a separate offense.

Section 6.01. EFFECTIVE DATE. Public Hearings having been held by the Planning Commission on November 29, 2107 and the Village Council on January 2, 2018, the provisions of this Ordinance shall take effect twenty (20) days after its publication in the Observer and Eccentric, a newspaper circulated within said Village.

With the creation of the Great Lakes Water Authority a program was established to assist residential customers who have issues paying their water bills; the Water Residential Assistance Program (WRAP). The WRAP program allows eligible participants to enroll to maintain water services and begin repaying past due balances. Eligible participants can also apply for up to \$1000 per year in assistance, water audits for residents who consistently use more water than average and up to \$1000 to help with minor plumbing repairs. To qualify, residents must be at 150% or less of the federal poverty level and meet other eligibility requirements.

As a participant in the WRAP program the Village would also agree to forego shutoffs for enrolled residents who maintain their participation, forego placing past due balances onto tax bills and waive penalties for active participants.

The WRAP program is operated and administered by the Wayne Metro Community Action Agency (CA Alliance Agency). Eligibility determinations are made by CA Alliance. Many of the Village's fellow members of SOCWA have signed up and are currently participating in the WRAP program. Village Administration has reviewed the participation requirements of the WRAP and does not find them to be unreasonable. Should any Village residents be eligible and interested in participating in the program then I believe it to be in the Village's best interest to move forward with the WRAP program.

There are some inconsistencies regarding the implementation date in the document provided by the Community Action Alliance. The Village had previously agreed to participate in WRAP through CA Alliance and Oakland Livingston Human Services Agency (OLHSA) through March 31, 2017. This agreement should be retroactive to April 1, 2017 to ensure that any eligible participants can receive benefits for bills for the entire period in which the Village has been an active participant.

Village Administration recommends a resolution approving of and authorizing the Village Manager to sign the Memorandum of Agreement between the Village of Beverly Hills and the Wayne Metro Community Action Agency (CA Alliance) for participation in the Water Residential Assistance Program effective April 1, 2017.

**Project:** The Water Residential Assistance Program ("WRAP") is a universal service delivery model to help residential customers of the Great Lakes Water Authority access bill assistance, water conservation measures, and navigate resources and supports on a pathway toward self-sufficiency.

**Duration: OLHSA ("CA Alliance")** is entering into a Memorandum of Agreement with the **Village of Beverly Hills, a Michigan municipal corporation,** ("**Wholesale Customer" or** "**City**") effective April 1, 2017 until parties agree to terminate the agreement with 30 days' written notice pertaining to the WRAP program (the Project) operated by the CA and Wayne Metro Community Action Agency (Project Administrator).

#### Village agrees to:

- Understand and accept the WRAP Universal Service Delivery Model design. (Attached hereto as Attachment A and made a part of this Agreement.)
- Provide to WRAP CA Alliance Agency a main point of contact who will be responsible for:
  - Receiving and reviewing reports of enrolled WRAP residents on regular basis.
  - Receiving and responding to CA Alliance questions regarding individual WRAP residential customer cases on an as needed basis.
  - Acting as liaison to Wholesale Customer billing department regarding payments made by CA Alliance.
  - Attending WRAP Wholesale Customer meetings held by CA Alliance.
- For those WRAP residents who enroll with arrearage/past due amounts, Wholesale Customer will:
  - Freeze arrearages for 12 months or until a resident exits from WRAP program.
  - Waive penalties for WRAP participants.
  - Stop pending shutoffs once resident appointment confirmation is received from CA Alliance to Wholesale Customer.

- For Residents for whom water has been shut off, it is understood by both parties that Resident is solely responsible for payment of applicable turn on/turn off fees.
- Exempting from tax rolls. Provide CA with taxes due date (Semi-Annual, Annual)
- Other protocols as deemed mutually agreeable in writing between both parties:
- Provide CA Alliance access, to past customer billing history, previous or current enrollment in payment plans, previous or current enrollment in Wholesale assistance plans, and/or customer alerts.
- Engage with CA Alliance in shared WRAP marketing and outreach activities to residential customers in Wholesale Customer's community.

#### Oakland Livingston Human Service Agency Agrees to:

- Provide a Single Service Point of Entry for GLWA regional resident to the WRAP Program; all calls will be processed through a dedicated telephone number-(313) 386-WRAP (9727) and via online Program Request Form.
- Pre-screen WRAP applicants for program eligibility and schedule residents for intake appointments based on pre-screening at time of call.
- Schedule intake appointments at CA Alliance Service Center accessible to residents.
- Inform and secure resident agreement of WRAP Program expectations and responsibilities via WRAP Client Contract.
- Provide an appeal process. (SEE ATTACHMENT A)
- Refer eligible residents with water usage at or above 120% of normal usage for Home Water Conservation audit. Conduct Home Water Audit and perform minor home plumbing repairs eligible within scope of project. Homeowners Only
- Provide a main point of contact to the Wholesale Customer who will be responsible for:
  - Providing reports of enrolled WRAP residents on a regular basis.
  - Reporting to Wholesale Customer at mutually agreed upon intervals on payment status of enrolled WRAP residential customers via electronic report.
  - Sending batched bill credit payments (based on \$25 per month) monthly and arrearage payments (bi-annually) to Wholesale Customer by the 21<sup>st</sup> day of the month for enrolled residents verified as in good standing with WRAP. Payment information will include: name, address, and account number.
  - Providing reports of WRAP residents who exit and/or are terminated from the program.
  - Acting as liaison to Wholesale Customer regarding the WRAP Program.

- Engaging with Wholesale Customer in shared marketing and outreach activities around WRAP to residential customers.
- Collect and maintain program data, including but not limited to:
  - Scheduled appointments of residents residing in Wholesale Customer Community.
  - Status of enrolled residents in WRAP from Wholesale Customer Community receiving bill payment assistance and home water conservation audits.
  - Reconciliation of total assistance paid to Wholesale Customer including bill payment plan assistance, amount of arrearages paid (total and average).
  - Number of households assisted.

**Hold Harmless**: To the fullest extent permitted by law, the Parties agrees to indemnify, defend, pay on behalf of, and save harmless the other Party, and its elected and appointed officials, shareholders, officers, consultants, agents, volunteers and employees from and against all loss or expense (including costs and attorney's fees) by reason of liability imposed by law upon the parties or its elected and appointed officials, consultants, agents, volunteers and employees for damages, arising out of or in consequence of the performance of this Agreement, to the extent due to the negligence of the other party.

**Notices**: All notices, requests, demands or other communications hereunder shall be in writing and deemed given (a) when delivered personally or on the day said communication is sent by registered or certified mail, return receipt requested, postage prepaid, or (c) on the next business day after notice is sent by facsimile, electronic mail or pdf, or (d) on the day said communication is deposited with a nationally recognized overnight courier service, as the case may be, as follows:

**Termination**: This agreement shall be in effect from December 1, 2017 until either party agrees to terminate with 30 days written notice.

Should either party issue Notice of Termination, both parties agree that residents enrolled in WRAP prior and up to the date of written notice will continue to receive WRAP assistance until the first 12 months of resident enrollment is completed or resident termination.

**Modifications**: This MOA may be amended upon written approval of the parties at any time. No agent of the City shall have power to revoke, alter, enlarge or relax the stipulations or requirements of this Agreement, without the prior formal written authorization to do so, by ordinance, resolution or official action of the City.

**Venue and Choice of Law:** The Parties concur that any dispute concerning the interpretation of this Agreement shall be brought in the applicable state court located in the County of Wayne, Michigan, and that Michigan law shall control.

**Counterparts**: This Agreement may be executed and delivered in any number of counterparts, each of which so executed and delivered shall be deemed to be an original and all of which shall constitute one and the same instrument. A party may deliver executed signature pages to this Agreement by facsimile transmission or

electronic mail to the other party, which facsimile or electronic copies shall be deemed to be an original executed signature page binding on the party that so delivered the executed signature page by facsimile or electronic mail.

**Severability:** If any term or portion of this Agreement, or the application thereof, to any person or circumstance shall, to any extent, judicially be determined to be invalid or unenforceable, the remainder of this Agreement, or the application of such term or provision to persons or circumstances other than those as to which it is invalid or unenforceable, shall not be affected thereby, and each provision of this Agreement shall be valid and enforceable to the fullest extent permitted by law.

#### Attachment A

#### Water Residential Assistance Program (WRAP) Components

#### Residential Assistance- Water Bill Payment Plan

- Maximum assistance per resident- \$1,000 annually
  - Water bill payment plan assistance consists of \$300 annual bill credit (\$25 per month for 12 months) for residents who are verified as staying current on regular bill payments (per billing cycles).
  - Up to \$700 annually in assistance for past due/ arrearage amounts. Arrearages will be paid in two installments:
    - At 6 months of successful payment history, up to \$350(50%) will be applied
    - At 12 months of successful payment, up to \$350 (second 50%) can be applied.
  - Additional assistance via other CA Alliance funding sources may be leveraged with WRAP based on client eligibility and fund availability.
  - On-going case management will be provided to ensure client success in the WRAP program and to build other self-sufficiency supports.
  - Wholesale customers (i.e. City municipalities billing for GLWA water and/or sewer) will be engaged in regular communication and processing with CA Alliance agencies to monitor customer success in the WRAP program and track payment history.
  - Participants can remain in the program for up to 24 months. Participants must re-apply annually.
  - Participants who have been terminated from the program may request an appeal within 10 days of notification of termination. Participants may be granted an appeal if extenuating circumstances exist and the participant is able to pay the past due monthly charges (minus arrears at the time of enrollment) within 30 days of the appeal decision. Review and decision is at the discretion of the CA Alliance. Notice of the decision will be provided to Wholesale Customer. CA Alliance will request review of the customer's account after 30 days to determine whether bill has been paid to current date. If bill has been paid, customer will be allowed to remain in WRAP.

#### Residential Assistance- Home Water Audit Conservation

- Households presenting at intake with documented water usage above 120% of average usage will be referred for a Home Water Conservation audit, as performed by CA Alliance.
- Households can receive up to \$1,000 per household for water conservation and minor home plumbing repairs annually.
- Conservation measures and simple leak repairs will be completed during the Home Water Audit. Minor Home Repair and toilet replacement will be referred for a Minor Home Repair visit. Minor Plumbing Repairs will be completed by licensed plumbers following all applicable permitting laws.
- Eligible WRAP measures may include: Faucet aerators
  - o Spigot protectors

- o Low-flow toilets
- o Low-flow showerheads
- o Leaking faucets (indoor / outdoor)
- Hose bib leaks (outdoor)
- Pipe joint leaks (if easily accessible)
- Items not covered through WRAP:
- Emergency Repairs
- Plumbing that involves sewer/wastewater work
- Garbage disposals
- Dish washing machines
- Washing machines
- Repairs behind walls or underground
- Repairs in areas that pose a risk to contractors due to environmental hazards or structural deficiencies

#### WRAP Resident Eligibility Guidelines:

- Income-eligibility at 150% FPL or below based on 90 day look back from date of application.
- Bill must be in client/"tenant" name. Address must match client I.D.
- Proof of homeownership; If renter, lease must indicate tenant responsible for water\*
- Must have income source.
- Account holder must attend appointment.
- Shut off notice is not required.
- Bill does not have to be past due.
- For bill plan assistance, client participation in other education/trainings is not mandatory.
- Subsidized housing participants are eligible for assistance.

\* Eligibility may be based on non-owner occupied registration with Wholesale Customer community.


**Re:** Purchase of Alexis Mini Pumper

As directed by the Village Council, Village Administration and the Public Safety Department have been investigating options for various fire vehicles due to the condition of the current pumper truck. As Council will recall, there was significant discussion about this matter during 2017 with the directive being given to Administration to procure an appropriate pumper truck and mini pumper for the Village. In the interim, the Public Safety Department has been working with the chosen supplier, Alexis, on the acquisition of a mini-pumper.

Before Council for review and consideration is a purchase agreement for a new Alexis minipumper. Village Administration is recommending payment in cash for this piece of equipment. The Village currently has around \$290,000 in reserves for fire equipment. The total purchase price of this vehicle is \$301,775.00. This includes a reduction of \$5,181 for payment in cash. The remaining portion of the purchase price will come from the \$75,000 budgeted from Public Safety for FY 2017-18 for the fire truck reserve.

Attached for your review are copies of the invoice and purchase agreement as well as specifications and a diagram of the new apparatus. Public Safety Administration has spent a significant amount of time with Alexis in the design of this truck so that it meets our needs and will be compatible with existing water supplies, other vehicles and officer training not only in the Village by in our mutual-aid communities.

**Recommended Resolution** ... be it resolved that the Village Council approve and authorize the Village manager to execute the invoice and purchase agreement for a 2017 Alexis mini-pumper as presented for use by the Beverly Hills Public Safety Department in the amount of \$301,775.00. Funds for this purchase are available in the Village's Fire Truck Reserve Fund in Fund 401 – Capital Projects as well as fund 205-900-978.00.







**Re:** Purchase of Sutphen Pumper Truck

As directed by the Village Council in 2017 Village Administration and the Public Safety Department have been working on the procurement of a pumper truck to replace the existing pumper truck. The current pumper truck is a 1999 Freightliner model and has suffered a number of equipment and tank failures in the last two years. The significant amount of time this truck has spent out of service for repairs has placed an additional burden on the only other fire apparatus, the ladder truck.

After discussion and approval by Council last year the Public Safety Department has been working on the procurement of a pumper truck with the Sutphen Corporation. Specifications and a diagram of the apparatus as designed and approved by the Public Safety Department have been included for your review. The price for this 2017 Sutphen Pumper Truck is **\$620,441.00.** 

Village Administration has reviewed the financing options available and is recommending making a down payment of \$15,640.29. This will reduce the purchase price to \$604,801.11. This amount will be financed with Sutphen for a period of seven (7) years at an interest rate of 3.49%. Annual payments will be \$98,860.38 with the first payment due on February 15, 2019. These payments will overlap by two fiscal years on the current payments for the ladder truck. The final payment for the ladder truck will be made in October of 2019.

As the Village has been putting aside \$75,000 annually for the fire truck reserve the additional payment will not place a significant strain on the budget. Village Administration will recommend ceasing putting further funds into a fire truck reserve until at least the last payment has been made on the ladder truck.

An attached resolution for the financing of the pumper truck has been included for review and consideration by Council. Village Administration recommends approval of the attached resolution and recommends Council authorize the Village Manager to execute the attached Purchase Agreement for a 2018 Sutphen Pumper Truck in the amount of \$620,441.00. Funds for this purchase are available in Fund 205-900-978.00.

### Village of Beverly Hills Resolution

Whereas, the Village of Beverly Hills has determined that a true and very real need exists for the acquisition of the Sutphen Class A Pumper described in the Lease-Purchase Agreement presented to this meeting; and has further determined that the Sutphen Class A Pumper will be used solely for essential governmental functions and not for private business use, and

Whereas, the Village of Beverly Hills has taken the necessary steps, including any legal bidding requirements, under applicable law to arrange for the acquisition of such equipment.

Be it resolved, by the Village of Beverly Hills Council that the terms of said Lease Purchase Agreement and Escrow Agreement are in the best interest of the Village of Beverly Hills for the acquisition of such equipment, and the Village of Beverly Hills Council designates and authorizes Village Manager, Chris Wilson to enter, execute and deliver, and to witness (or attest), respectively, a seven year Lease Purchase Agreement and Escrow Agreement with Leasing 2, Inc. as well as any related documents necessary to the consummation of the transactions contemplated by the Lease-Purchase Agreement and Escrow Agreement. Such agreement is to finance the purchase of Sutphen Class A Pumper in the amount of \$604,801.11 purchased from Apollo Fire Equipment Company.







### VILLAGE MANAGER'S REPORT CHRIS D. WILSON JANUARY 12, 2018

**SOCRRA Facility Update** – Significant progress on the MRF facility on Coolidge has been made. As of January 10<sup>th</sup> the facility was able to reopen to haulers for recycling material. SOCRRA is hopeful to reopen the site to the general public later this month. Saturday drop off service for electronics recycling will continue through the month of January. SOCRRA has continued to experience an increase of around 20% in recycling volume with the implementation of the new recycling carts. We are also beginning to see decreases in our volumes of trash in communities where recycling volumes are increasing.

**Office Closed** – Village Offices will be closed on Monday, January 15<sup>th</sup> in observance of Dr. Martin Luther King, Jr. Day. Trash services will not be interrupted.

**Passport Processing** – I have attached for your review the 2017 numbers for passport applications by the Village. The number of 443 is down significantly from the highs of 2014 where we were processing nearly 1000 applications a year. We currently have six (6) employees that are trained and capable of processing passport applications. With this number of eligible staff and this current level of demand the passport processing operations have become more sustainable.

**Christmas Tree Chipping** – Christmas Tree collection will continue the week of January 15<sup>th</sup>. Please place your unwrapped trees, free of tinsel or ornaments, at the curb for collection.

**Smartest Community Ranking** – Job Placement website Zippia recently conducted a study of the smartest communities over 10,000 population in Michigan. Of the 93 communities that were analyzed, the Village of Beverly Hills ranked #2 amongst the smartest communities. We were only bested by our neighbors, the City of Birmingham.

**Strategy Session** – As decided at the last Council meeting, there will be an annual strategy session of the Council and Village Administration on Tuesday, January 30<sup>th</sup> at 6:00 PM in the Village Council Chambers. Council members who have not already done so are encouraged to get the items they would like included in this meeting to President Mooney.

- <u>SCAM ALERT a helpful tip</u>:

Don't Pay with iTunes Gift Cards - Attorney General Bill Schuette wants you to know how to protect yourself from the iTunes gift card scam impacting Michigan consumers. The scam occurs when a caller demands immediate payment with an iTunes gift card for things such as taxes, hospital bills, bail money, debt collection, and utility bills. The Alert educates Michigan consumers about this scam and includes tips on how to spot, stop, and report the scam.

Demands for you to pay right away for taxes, hospital or utility bills, bail money, or to settle a debt are common. Criminals make up all kinds of reasons for why you owe money. The goal is the same: to steal from you.

Con artists using this ploy will ask for an untraceable form of payment, like wiring money, sending cash, or a pre-loaded money or gift card. The iTunes gift card is the payment method of choice right now for many criminals.

What you need to know:

When someone catches you off guard and hits your panic button, it is hard to think straight. Criminals know this, and hope you will focus on the worse-case scenario they are painting and not on your common sense. Remember this: iTunes gift cards can be used ONLY to buy Apple goods and services at an Apple store. They are not a way to use Apple Pay.

Why iTunes gift cards? A gift card is like cash. It is a quick, convenient, and untraceable way for scammers to get money. Even when victims realize they've been scammed, there's usually no way to reverse the transaction or return the funds. Many may recognize the iTunes name but do not understand how iTunes gift cards work. This is especially true for older targets, which is what criminals count on. Even the more tech-savvy have purchased iTunes cards for payment when they confuse them with Apple Pay. iTunes gift cards and Apple Pay are not the same. Apple Pay is a mobile payment and digital wallet service that lets users pay with an iPhone, Apple Watch, or iPad.

• SPOT IT:

You are asked to pay with iTunes.

Someone calls instilling panic and urgency—your grandchild is going to jail; you will be arrested for past due taxes; or your utilities will be turned off in hours—unless you immediately buy iTunes gift cards then share the 16-digit code with the caller to make your payment. You apply for a loan and to prove your credit worthiness, you are asked for an advance fee to be paid right away with iTunes gift cards. A caller tells you that an iTunes gift card is the way you use Apple Pay.

• STOP IT:

Don't pay anyone with a gift card.

If you're not shopping at the iTunes store, you should not be paying with an iTunes gift card. Never give the numbers on the back of your iTunes gift card to someone you do not know. If anyone asks you to pay with an iTunes gift card, report them right away to Apple 800-275-2273 or contact Apple Support online, and the Federal Trade Commission Complaint Assistant.

#### **Community:**

In Michigan, more people die from drug overdoses than car crashes. For decades, police officers have been on the front lines of the war on drugs. To disrupt an ever-increasing supply chain, police officers often find themselves arresting drug addicts as much, if not more so, than drug dealers and traffickers. Meanwhile, heroin and opioid addiction has become a severe public health concern in the United States, destroying and often ending lives. Opioids are one of the oldest known forms of pain relief in the world and is now regulated by the federal Controlled Substances Act, most opioids are only available by prescription. This has had far reaching consequences to persons obtaining opioid prescriptions for pain relief. Given their close chemical relationship to heroin, abuse of prescription opioids can lead to users transitioning to heroin.

The Michigan State Police (MSP) has partnered with the Police Assisted Addiction and Recovery Initiative (PAARI) to assist individuals who wish to find treatment for dependency and addiction to heroin and prescription opioids. The Police Assisted Addiction and Recovery Initiative (PAARI) is a nonprofit organization whose mission is to support police departments with implementing similar programs that foster a dialogue around the unique opportunity for law enforcement to take direct action against the disease of drug addiction in their communities. The MSP has implemented the nationally renowned Angel Program, aimed at bringing law enforcement, community volunteers and individuals seeking assistance together to reduce dependency with heroin and prescription opioids in Michigan.

People can walk into a MSP post during regular business hours and ask for assistance through the Angel Program without the fear of arrest or investigation. If an individual is accepted into the Angel Program, the individual will be guided through a professional substance abuse assessment and intake process to ensure proper treatment placement. An "Angel" volunteer, who is a member of the local community, will be present to support the individual during the process and to provide transportation to the identified treatment facility.

The MSP now has the Angel Program available at all 30 of its posts in Michigan. The MSP posts are open 8 a.m. to 4 p.m. Monday through Friday for individuals looking for assistance through the Angel Program. Supervisor Schmitt called the meeting to order at 7:30 p.m. at the Township Hall.

#### Supervisor's Report

Schmitt commented the January meeting will start at 7:00 p.m., so there is plenty of time to work on the budget. Schmitt noted the Board of Review met on the 12th for the last time of the year to handle poverty's and technical corrections.

Schmitt commented there are new accounting standards for OPEB, which in Southfield Township means retiree health insurance. Southfield Township will be required to have an annual actuary study.

Schmitt mentioned the Township may be able, if the Board so choses, to transfer the OPEB funds to a Health Care Savings Account to be used by the only eligible recipient and her husband until the fund is depleted. If the individual dies before the fund is depleted the balance would go to her heirs but would not be tax free. Schmitt added this would allow the Township to discontinue all OPEB obligations, future actuaries' reports, reviews and budget considerations and could potentially produce no adverse consequences to the Township. Schmitt noted the Board will be kept informed. Schmitt added the information has been sent to our attorney for review and a response has not been received.

Schmitt noted Thursday is Treasurer Mooney's birthday.

#### **Clerk's Report**

Tischler stated 941 dog licenses have been purchased compared to 919 last year and 65 cat licenses have been issued compared to 41 last year. 2018 dog and cat tags are now available.
