# REVIEW AND CONSIDER DECLARATION OF A STATE OF EMERGENCY IN THE VILLAGE OF BEVERLY HILLS

Chapter 9 of the Village Municipal Code provides the framework for the establishment of the Beverly Hills Office of Emergency Services to address emergency and disaster situations within the Village.

The intent of this ordinance is to "...establish and organization that will insure the complete and efficient utilization of all municipal resources during periods of emergency and disaster."

State of Michigan Executive Order 2020-04 established a State of Emergency to address the outbreak of the COVID-19 Virus in the State of Michigan. Given the impact of COVID-19 on the Village of Beverly Hills and in accordance with Executive Order 2020-04 and pursuant to Chapter 9, section 9.50 (b)2 of the Beverly Hills Municipal Code the Village Manager will be activating the Beverly Hills Emergency Operations Plan effective noon, March 17<sup>th</sup>, 2020.

Motion by Abboud, second by Mooney, be it resolved, the Village of Beverly Hills authorize the Establishment of the Emergency Services Forces for the Village of Beverly Hills effective immediately and appoints the Village Manager to the position of Director of Emergency Services Forces. Be it further resolved that the Council approve the establishment of the Beverly Hills Office of Emergency Services consisting of the following positions:

- Coordinator Kristin Rutkowski, Assistant Village Manager/Village Clerk
- Assistant Coordinator for Public Safety Richard Torongeau, Public Safety Director
- Assistant Coordinator for Finance Sheila McCarthy, Finance Director
- Assistant Coordinator for Clerk Peggy Linkswiler, Treasurer/Human Resources
- Assistant Coordinator for Public Services Karrie Marsh, Assistant to the Village Manager
- Assistant Coordinator for Building Services Erin LaPere, Planning and Zoning Administrator

Approval of this activation of the Emergency Operations Plan and establishment of the Office of Emergency Services will allow the Manager to appropriate to expend funds and procure equipment and services necessary to address the emergency situation and any powers authorized by this ordinance. Nothing in the order shall subvert the authority of the Village Council.

The Manager shall continue to report to and obtain authorization for all activities enacted under this order as soon as is reasonably possible. The Coordinator and all Assistant Coordinators shall report all activities to and obtain all necessary approvals from the Village Manager/Director of Beverly Hills Emergency Services Forces as soon as is reasonable possible.

This Emergency Operations Plan will remain in effect until the emergency situation created by the COVID-19 outbreak is mitigated and this order is rescinded.

REVIEW AND CONSIDER REQUEST FROM MARIAN HIGH SCHOOL TO HOLD ANNUAL WALK-A-THON ON FRIDAY, MAY 8, 2020

Village administration received a request from Marian High School asking for permission to hold its annual Walk-a-thon in the Village of Beverly Hills on Friday, May 8, 2020. A map of the proposed route was included in the packet.

# PROCLAMATION RECOGNIZING APRIL 2020 AS CHILD ABUSE PREVENTION AND AWARENESS MONTH

Motion by Nunez, second by Mooney, be it proclaimed, whereas, abuse and neglect are suffered by children in our communities, regardless of age, race, gender, or economic situation;

Whereas, one in ten children will be sexually abused before the age of 18;

Whereas, this reported maltreatment is only a portion of the overall problem threatening our children, for so many cases go unreported, and today's technology has brough with it a new and dangerous form of child endangerment – the online predator;

Whereas, the devastating consequences of physical and emotion abuse of our children affects the community as a whole and finding solutions needs to be attended to by the community as a whole; and

Whereas, CARE House of Oakland County works to break the cycle of child abuse and neglect; provides a protective circle of light and hope for a better life; advocates for the safety and protection of children; and partners with community organizations and agencies to offer programs and services aimed at preventing child abuse.

Now, therefore, be it proclaimed, that the Village of Beverly Hills, County of Oakland, State of Michigan, do hereby recognize April 2020 as Child Abuse Prevention and Awareness Month in the Village of Beverly Hills, and call on our residents, community agencies, organizations, and businesses to increase their participation in efforts to prevent the abuse of our children, thereby strengthening and protecting the community in while we live.

# REVIEW AND CONSIDER REQUEST FOR SITE PLAN APPROVAL FOR 31201 SOUTHFIELD ROAD, MARKET FRESH VESTIBULE ENCLOSURE

The Village received a request for site plan approval for Market Fresh, 31201 Southfield Road, to construct a vestibule enclosure at the existing front entranceway. The proposal details an addition at the storefront that will be a glass enclosure of the existing paved walkway/entrance. Additionally, the proposal would replace the existing cloth canopy along Southfield Road side of the building with a steel canopy and a partial restriping of the pedestrian walkways and parking spaces near the entrance to direct pedestrians to the relocated doors. A copy of the application and plans are attached.

The plans have been reviewed by the Fire Marshal, Village Engineer, and Planning Consultant. The Fire Marshal noted the need to relocate the existing Knox Box and the applicant has indicated they will comply with Public Safety requirements on that matter. Given the limited scope of the changes to the existing site the Village Engineer found no concerns with the proposal, as submitted. The Planning Consultant's review letter is attached. As noted, the request meets applicable sections of the Village Ordinance and the applicant confirmed no new lighting or plantings were proposed with this project.

At their meeting held February 26, 2020, the Planning Commission reviewed the plans and made a recommendation for Village Council to approve with two conditions. First, that the plans depict rooftop equipment and enclosures. Second, that if ownership of the existing retaining wall along a portion of the western property line is determined to be Market Fresh, the wall be expanded to six feet in height to provide screening of the alleyway. There was discussion regarding alley maintenance and the consensus was a dumpster enclosure was not feasible in the alley to maintain free and clear access, especially for emergency vehicles. A copy of the meeting minutes is attached.

The Village has received revised plans depicting the rooftop equipment. The plans note the existing parapet wall is 10 feet, 5 5/8 inches above the roof deck and that the new equipment will be placed within that existing screened area (see sheet A-100). Upon confirmation that the retaining wall is on the Market Fresh property, the Village Engineer reviewed the existing site conditions and the wall expansion recommended by Planning Commission. He concluded that expansion of that wall would create sight distance and circulation issues for pedestrian and vehicular traffic in that area. He also noted that should this wall be required by the Village, we may be held liable for any negative impacts that result from the obstruction to the intersection between alley, Market Fresh parking lot, and nursing home parking lot. Therefore, he recommends no changes to the existing retaining wall.

Administration met with representatives from Market Fresh on March 12, 2020 to discuss the ongoing storage of debris, pallets, and similar materials in the alleyway. Market Fresh has submitted conceptual drawings of a proposed enclosure and is working with their architect to finalize a design for formal submittal. This project would require site plan review and approval prior to construction.

The architect, Victor Saroki, and owner, Johnny Karmo, answered questions from Council.

Motion by Mueller, second by Abboud, the Village Council approves of the site plan dated March 6, 2020 as submitted for the vestibule enclosure and canopy at Market Fresh, 31201 Southfield Road.

# REVIEW AND CONSIDER REQUEST FROM MICHIGAN BEER GROWLER COMPANY TO AMEND AGREEMENT WITH THE VILLAGE OF BEVERLY HILLS

The Village received a written request from Janae Condit, owner of Michigan Beer Growler Company (MBGCo) located at 31221 Southfield Rd, to modify the agreement with the Village to expand hours of operation, capacity, and concept. In 2014, the Village approved a voluntary agreement proposed by MBGCo as part of the approval of the liquor license to sell beer and wine

at the establishment. In 2018, the Village approved a modification to the hours of operation. The current agreement with the Village is as follows:

- 1. Hours of Operation: Monday 3pm 9pm; Tuesday through Thursday 11am 9pm; Friday and Saturday 11am 10pm; and Sunday Noon 6pm.
- 2. Classification: MBGCo will not change the classification of the license from a Tavern licence to a full Class C license.
- 3. Capacity: MBGCo will not increase its seating capacity from 20 persons.
- 4. Concept: MBGCo will not change its concept without prior approval of the Village.

As detailed in her request, MBGCo is seeking to modify its hours of operation, capacity, and concept to accommodate the addition of a coffee and ice cream shop, Michigan Coffee and Creamery, at the vacant neighboring tenant space. This business would maintain a separate exterior entrance, but would also be connected via interior doors to the Michigan Beer Growler. In addition to the new business, the intention is to permit additional space and seating for MBGCo patrons. This expansion does not require her to modify her license with the Michigan Liquor Control Commission. She has noted that there is ongoing negotiations between the landlord and herself as well as between the landlord and the former tenant that will need to be resolved before this project can proceed. She is requesting Village Council approve an amendment to the agreement in anticipation of positive resolution on those matters. In addition to approval of the amendment to the agreement with the Village, she will need approval from the County Health Department, building and trade permits, and sign permits for any new signage.

The proposed modifications to the agreement with the Village is as follows:

- 1. Hours of Operation: Daily: 7am 10pm.
- 2. UNCHANGED Classification: MBGCo will not change the classification of the license from a Tavern licence to a full Class C license.
- 3. Capacity: MBGCo will not increase its seating capacity from 45 persons.
- 4. Concept: MBGCo concept will change to include the Michigan Coffee and Creamery business as described in letter dated March 11, 2020.

The proposed use as coffee and ice cream shop is allowable in the B – Business District and as an interior change to an existing site, this change in tenant does not necessitate formal site plan review and approval. Copies of meeting minutes from prior agreement approvals for this matter and a proposed layout were provided to Council.

Janae Condit, owner, answered questions from Council.

Motion by Abboud, second by Mueller, be it resolved that the Village of Beverly Hills Council approves the amendment to the agreement with Michigan Beer Growler Company, owner Janae Condit, for expanded hours of operation, seating capacity, and change in concept for the existing business located at 31221 Southfield Road.

WHEREAS, on November 2, 2010, the electors for the Village of Beverly Hills approved an amendment to Section 9.1 of the Village of Beverly Hills Charter to authorize the Village Council to have the power to levy and collect taxes in an amount not to exceed 12.9184 mills; and

WHEREAS, the Charter amendment adopted by the electors for the Village of Beverly Hills contained a 10 year limitation to expire in 2021; and

WHEREAS, the Village Council seeks to renew that same millage rate by a Charter amendment proposed to the Village electors for a new 10 year period from 2021 to 2031, but including 0.32 mills for capital park improvements/replacements for village wide parks.

NOW, THEREFORE, the following Resolution was offered by Mooney and seconded by Abboud, that the following Charter amendment be voted upon by the qualified electors of the Village of Beverly Hills at the November General election on Tuesday, November 3, 2020.

# **BALLOT PROPOSAL**

1. Shall Section 9.1 of the Charter of the Village of Beverly Hills be amended to read as follows:

## POWER TO TAX

The Village shall have the power to levy and collect taxes for municipal purposes. The general ad valorem tax levy shall not exceed 12.9184 mills, times the taxable value of all real and personal property, subject to taxation in the Village, exclusive of any levies authorized by general statute to be made beyond Charter tax limitations, for a period of ten (10) years 2021 to 2031 inclusive. This 12.9184 millage authorization shall include the following components specifically dedicated to the operation of the Village:

- a) 9.9 mills for public safety/police/fire operations;
- b) 1.88 mills for general administrative purposes;
- c) 0.8184 mills for Baldwin library services;

d) 0.32 mills for capital park improvements/replacements for village wide parks.

It is estimated that the renewal of 9.9 mills for public safety/police/fire will raise approximately \$6,288,904.00 when first levied in 2021;

It is estimated that the reduction of the prior millage for general administrative purposes to 1.88 mills will raise approximately \$1,194,238.00 when first levied in 2021;

It is estimated that the reduction of the prior millage for Baldwin library services to 0.8184 mills will raise approximately \$519,874.00 when first levied in 2021; and

It is estimated a new park millage for capital park improvements/replacements for village wide parks will raise approximately \$203,274.00 when first levied in 2021.

Upon expiration of this renewed millage on June 30, 2031, the maximum allowed under Charter millage rate will revert to 11.00 mills for municipal purposes.

In Local Roads there are various adjustments to approximate actuals expected. In the Capital fund there is an adjustment for crity dam right spillway seawall investigation

### MANAGER'S REPORT

**Coronavirus PSA** – In response to the coronavirus situation, the Village issued the following Public Service Announcement on the afternoon of Thursday, March 11<sup>th</sup>:

As coronavirus, or COVID-19, begins to have a greater impact in our region, please be assured that the Village of Beverly Hills is dedicated to maintaining the safety and wellbeing of our residents, business community, and visitors. The Village is committed to working with school, county, state, and federal partners to help prevent the spread of coronavirus.

The coronavirus is thought to spread mainly from person-to-person between people who are in close contact with one another (within about 6 feet) and through respiratory droplets produced when an infected person coughs or sneezes. The Center for Disease Control (CDC) recommends avoiding close contact with people who are sick and putting distance between yourself and other people to prevent the spread of germs.

To promote allowing distance between individuals, the Village of Beverly Hills encourages people to mail in water bill payments, building permit applications, and other forms or payments to the Village Office instead of visiting the office in person. There is an option to sign up for direct water bill payment using the form <a href="here">here</a>. A drop box is located outside of the Village Office for your convenience as well. For property owners whose current water bills are due March 23, 2020, the Village will accept payments until March 30, 2020 without penalty. The Village is implementing on-line payments and will announce when that feature is available.

Public meetings will occur as scheduled until further notice. The Village will post proper notices should any public meetings be rescheduled or canceled in the future. A public hearing for a rezoning request is currently scheduled for Wednesday, March 25<sup>th</sup> at Greenfield Elementary. Current protocol regarding large public gatherings would not allow this meeting to be held today.

Due to the National Basketball Association's decision on March 11, 2020 to suspend the season, the Village of Beverly Hills Night at the Pistons Game scheduled for March 29, 2020 has been postponed. We will provide more information regarding refunds or a new date as that information becomes available.

At the time this release was published, two confirmed cases of COVID-19 have been reported in southeastern Michigan, including one case in Oakland County. The Village of Beverly Hills continues to follow recommendations provided by the Oakland County Health Division (OCHD), Michigan Department of Health and Human Services (MDHHS), and the Center for Disease Control (CDC) to prepare for and prevent the spread of the disease.

Steps you can take to protect yourself:

- Wash your hands often with soap and water for at least 20 seconds especially after you have been in a public place, or after blowing your nose, coughing, or sneezing.
- If soap and water are not readily available, use a hand sanitizer that contains at least 60% alcohol. Cover all surfaces of your hands and rub them together until they feel dry.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Avoid close contact with people who are sick
- Put distance between yourself and other people if COVID-19 is spreading in your community.
- Stay home if you are sick, except to get medical care.

The Village is committed to keeping our residents safe and informed. Please be aware that this is a developing issue which may change rapidly, and we will continue to share updates along the way.

Obviously, this remains a fluid and ongoing situation. The Village is maintaining communication with other local governments, Birmingham Public Schools as well as county and state government in addressing this situation. Village Administration has also been in contact with NEXT regarding their operations. I will update Council at the meeting on Tuesday as I am sure there will be multiple developments by then.

**Trash Collection** – Car Trucking has advised the Village that due to coronavirus outbreak concerns; all trash should be bagged when placed in cannisters at the curb for collection. Collectors are being prohibited from reaching into trash cans to collect loose or unbagged refuse. Please make sure all trash is bagged so that it can be safety collected disposed of.

Census 2020 – Residents should begin receiving information via mail with instructions for filling out the 2020 Census forms. These official Census Bureau mailings will include detailed information and a Census ID for completing the Census online.

**Yard Waste** – Curbside yard waste collection will begin the week of Monday, April 6<sup>th</sup>. Prior to the commencement of curbside yard waste collection, residents may take up to ten (10) bags of yard waste to the SOCRRA facility on Coolidge at 14 Mile.

**Public Hearing Postponed** – The public hearing to receive comments on the proposed rezoning of two lots on Lahser Road that was scheduled to take place at the March 25, 2020 Planning Commission meeting will be postponed until further notice. The regular Planning Commission meeting will take place at its normal location in the Council Chamber on March 25<sup>th</sup>.

# VILLAGE MANAGER'S REPORT CHRIS D. WILSON APRIL 2, 2020

**Village Operations During COVID-19 Outbreak –** There have been many changes to Village operations in response to the COVID-19 outbreak. A summary of operations at this time is as follows:

- Village Hall remains closed to the general public. Certain members of Village staff are
  present Monday-Friday. All calls are being answered and returned. Village staffing levels
  have been modified to allow essential Village services to be carried out while limiting
  unnecessary contact between Village employees and the public. All Village staff reporting
  to the Village Hall are temperature screened daily.
- Trash and recycling collection will continue as regularly scheduled. Curbside yard waste collection will begin on Monday, April 6<sup>th</sup>. All trash for curbside collection should be bagged. The SOCRRA facility on Coolidge remains closed to the general public at this time.
- Water bills will continue to be issued and payments collected. All late penalties are being waived through the end of May. No residences are being shut off for nonpayment until further notice. Payments may be mailed in or dropped in the drop box outside the doors of the Village Hall. Arrangement are being made to begin accepting on-line payments.
- Building permits are being accepted and are being issued for essential work only. Per
  the State of Michigan, only construction projects that are "...necessary to maintain and
  improve the safety, sanitation and essential operations of a resident" are being allowed
  at this time. Non-essential projects will not be permitted or inspected and should be
  postponed until further notice.
- Beverly Park remains open, however social distancing guidelines remain in place. Playground equipment is closed as are the basketball courts, tennis courts, volleyball courts, adult playground equipment and pavilion. The trail is still open for walking.
- Public Works employees are continuing to report to work and address all necessary issues as required. Village Administration has met with Comeau and staffing levels are being modified by Comeau to complete all work and maintain safety for their employees. All employees will remain on call at all times to respond to emergencies.
- Passport applications are not being processed until further notice.

- Reservations for the Beverly Park Pavilion are not being issued at this time. Those with
  reservations for the pavilion should not attempt to hold their events until the Stay Home
  Order is removed. It is the intent of the Village to offer full refunds to those whose existing
  reservations are impacted by the Stay Home Order.
- Planning Commission and ZBA meetings for April have been cancelled. Should regular public meetings for these bodies not be possible in May we will purse the use of a teleconference meetings if necessary.

**FY 2020-21 Budget –** A draft copy of the FY 2020-21 budget will be provided prior to the meeting. Village Administration is continuing to work on putting the most up-to-date information in the budget document.

**2020 Census** – A quick reminder to all Village residents to complete your Census application as soon as possible. As of April 3, the Village had a 63% response rate to the Census. This is a higher rate than Oakland County or the Sate of Michigan. Let's keep it going.

**Essential vs Non-Essential –** The Village has received a lot of inquires about what is considered "essential" vs "non-essential" with regards to services, trips, projects, etc. The Office of the Attorney General has offered guidance with regards to construction and residential services that "essential" means "...necessary to maintain and improve the safety, sanitation and essential operations of a residence." This is the standard we are using at this time and until more specific guidance is provided. Per this standard, we would interpret the mowing of the grass to be essential as well as repairs to plumbing, HVAC systems and roofing repairs. General landscape projects, remodeling, and exterior decoration projects would not be essential and should be postponed until further notice.

**Public Safety-First Responders –** I can't really express fully in words the appreciation for our Public Safety Officers during this period. The Officers and Administrators of the Department have been working literally non-stop over the last few weeks to respond to the needs of the Village and assist our surrounding communities. Their workload and exposure will unfortunately only increase over the next few weeks. All of my respect, gratitude and appreciation to them and their families during this time.

# Beverly Hills Public Safety Activity Report March 13-27, 2020

- The Governor has declared us to stay home and safe. Please take this order seriously as many things are happening and we are trying to stop the spread of the virus.
- The Public Safety Department is open 24/7 and we are here for the citizens of this Village. We are taking all calls and walk in traffic. There is a phone in the lobby and you may be asked to hold on the line and give your report to an officer. Officers are keeping a 6ft social distance between the residents and themselves. Officers are responding to medicals and you may see Officers with mask, gloves and classes. This is all part of trying to contain the virus. As first responders we are responsible for your health and welfare. Just as you are responsible for you own health and welfare. None of these measures are personnel, they are professional until the crisis blows over. We have established a protocol along with the Oakland County Medical Board. Homeland Security, CDC and our partners to secure a safe environment for our employees and citizens. There are many news cast and social Medias sites to understand the severity of this virus. Please follow the Villages website and information as we have continued to send those websites and info through social media and Gov/delivery. Be safe, stay home.
- Remember to lock your car and house doors.
- Do not leave valuables inside your car. Do not leave your keys in your car.
- Report suspicious activity.
- Check your battery in your smoke and carbon monoxide detectors.
- A smoke detector should be installed in every room of your home and a carbon monoxide detector should be installed on every floor.
- Have your chimney and furnace serviced to ensure it is functioning properly.
- Do not leave space heaters unattended.
- Be careful as children are out and about in the streets on bikes, walking and playing.

# **Face Mask Scam: Shopping Online**

Scammers love to take advantage of our fears, and the spread of a new disease like coronavirus is downright scary. As you strive to keep yourself and loved ones healthy, be sure to watch out for counterfeit face masks and other scams.

<u>How the Scam Works</u>: You want to buy a face mask to help protect yourself – or family – from coronavirus. But so many other people had the same idea! Masks are sold out in your local stores and even from top Amazon sellers. So instead, you turn to purchasing masks from an online shop you don't know.

Unfortunately, phony online stores abound – especially when an item is in high demand. Some sites may take your money and send you low-quality or counterfeit masks. Others,

may never deliver anything all. In the worst cases, these sites are actually a way to steal your personal and credit card information, opening you up to identity theft.

Face masks may be the first phony product to crop up in the coronavirus outbreak, but it's likely not the last. During the Ebola outbreak, The promotion of unapproved and fraudulent remedies was so prevalent that the US government advised consumers to steer clear of these drugs. It's likely that scammers will use the coronavirus as another chance to market products falsely claiming to cure the disease.

# **Watch Out Coronavirus Cons:**

Keep the following tips in mind when looking for face masks or other ways to protect yourself from the coronavirus.

Be savvy about product claims. While wearing a face mask may seem like an easy way to stop coronavirus from spreading, the Centers for Disease Control does not actually recommend it for the general public. Be sure to evaluate claims of any medical product before buying. Especially watch out for products claiming to offer a "miracle cure" for a range of ailments.

Only buy from reputable stores and websites. The best way to avoid getting scammed is to buy them directly from a seller you know and trust. Check BBB.org to see what other consumers' experiences have been.

Be sure the online store has working contact info. If a company seems legitimate but you aren't familiar with it, be extra careful with your personal information. Before offering up your name, address, and credit card information, make sure the company is legitimate. A real street address, a working customer service number, a positive BBB Business Profile... these are just a few of the things to be looking out for to determine if a company is legitimate.

Check with your doctor before buying. If you're tempted to buy an unproven health product or one with questionable claims, check with your doctor or other health care professional first.


For more than 30 years, Jamian has

# RCOC receives six federal safety grants

The Road Commission for Oakland County (RCOC) in late December was notified it will receive six federal "safety" road-funding grants, totaling more than \$1.4 million, that will enable six roadimprovement projects in 2021.

The federal Local Safety Program provides funds for local road projects that are intended to address areas where there have been a concentration of serious-injury and fatal vehicle crashes or projects that include specific types of road-safety improvements.

"Safety is the Road Commission's top priority, and the receipt of these grants confirms that our project-selection and design processes are focused on the safety of the road-system users," stated RCOC Managing Director Dennis Kolar. "Every step of our processes is driven by concern for the safety of our customers."

The six RCOC projects that received safety grants are:

- · Construct a roundabout at the intersection of Sashabaw and Oakhill roads on the Brandon Twp./Independence Twp. border. Grant amount: \$600,000. Estimated project cost: \$1.5 million.
- · Apply a high-friction surface treatment on three curves on Clarkston Road between Thistle Valley Lane and Pine Tree Road in Orion Twp. Estimated grant amount: \$273,069. Estimated project cost: \$303,411.
- · Apply a high-friction surface treatment on a large curve on Baldwin Road west of the Baldwin/Indianwood/Coats round about on the Orion Twp./Independence Twp. border. Estimated grant amount: \$166,673. Estimated cost: \$185,193.
- Upgrade traffic signals at 45 intersections by installing reflective backplates on the signal heads (a total of 396 signal heads). Estimated grant amount: \$176,040. Estimated project cost: \$195,600. CONT'D ON PAGE 4 — SEE SAFETY


# RCOC has purchased \$11 million in federal \$ from rural road commissions

The Road Commission for Oakland County (RCOC) has led the way in Michigan in terms of purchasing federal road funding from rural counties.

Over four years, RCOC has purchased nearly \$11 million from northern Michigan counties. The funding was purchased at either 75 percent or 80 percent of its value.

"For the rural counties, using federal road funding is a difficult and expensive undertaking because there are so many hoops to jump through," explained RCOC Managing Director Dennis Kolar, who has been behind the agency's push to purchase the federal dollars.

"This is a win/win for both parties - we



get additional funding and the rural counties receive state funding in exchange for the federal dollars that they can use with far fewer strings attached."

The state Legislature enacted a law in 2016 that allowed county road agencies to "sell" federal funding to each other. To date, RCOC has been the most aggressive agency to pursue this option in the state.

By the end of 2020, RCOC will have resurfaced approximately 12 segments of rural paved roads with the purchased federal funds. Because the funds were originally designated for use in "rural" areas, RCOC must use the funds on roads in the part of the county that is officially designated as outside of the urbanized area.

"As long as there are road commissions willing to sell their federal funding, we will consider purchasing it," Kolar said. "We can always put it to good use."

# RCOC nabs \$12 million in federal grants to upgrade Traffic Operations Center

The Road Commission for Oakland County (RCOC) was notified recently that it has been awarded more than \$12 million in federal Congestion Mitigation and Air Quality Improvement Program (CMAQ) grants primarily to be used to operate and upgrade its Traffic Operations Center (TOC).

The six grants will be available in fiscal years 2021, 2022 and 2023. The TOC is the nerve center for RCOC's state-of-the-art "smart" traffic-signal system, known as FAST-TRAC (Faster and Safer Travel Through Traffic Routing & Advanced Controls). FAST-TRAC uses vehicle-detection technology to monitor traffic at approximately 850 signalized intersections and to adjust the signal timing at those intersections in real time to best accommodate the traffic present.

The FAST-TRAC system has been documented by third-party organizations (MSU and U of M) to reduce congestion and improve safety. It is one of the largest such systems in the nation and

was the first adaptive traffic-signal system for arterial roads in the nation. At the TOC, RCOC engineers can monitor and control all the FAST-TRAC intersections including watching many of them on live video feeds that come into the center.

"The FAST-TRAC system uses the latest technology to most efficiently manage traffic," explained RCOC Chairman Greg Jamian. "This is an example of how we are using technology to enhance the tasks we have always done. RCOC is recognized both nationally and internationally as a leader among local road agencies in deploying the latest technology."

In addition to helping to fund the operation and maintenance of the TOC, some of the funding will be used to help pay for the cost of constructing a new TOC, which will be built at RCOC's Waterford Township facility, likely in late 2022 or early 2023. The current TOC is located in leased space in the Oakland County Information Technology Building.

# Mild winter could mean savings — if so, will go into paved road surfaces

The winter of 2019-2020 has been fairly mild compared to past winters – and that may mean a windfall for roads in the county.

Because the winter has been fairly mild, the Road Commission for Oakland County (RCOC) has spent less money salting and plowing the roads than in recent past years. That means there will likely be money left over in the RCOC winter budget — though it's too early to tell for sure.

But if there is money left over, RCOC Managing Director Dennis Kolar notes it will be put directly into the road surfaces. "Any money left over from the winter will be used to resurface additional paved roads this summer," Kolar said. "We have always said any time we have extra money, it will go right into improving the condition of our roads."

Kolar noted it will still be a couple of months before the agency is able to close the books on the winter season and know for sure if there is money left over and, if so, how much. "At this point, it looks like there is likely to be money left over," he observed. "But, we've also had major storms in April in the past, and such a storm would definitely impact the winter budget."

# Coronavirus not expected to delay projects

While the full impact of the coronavirus on Oakland County is not yet known, at this point, Road Commission for Oakland County (RCOC) officials do not expect the virus will result in the delay of any 2020 road-construction projects.

"So far, our projects are moving ahead on schedule," noted RCOC Managing Director Dennis Kolar. "We currently see no reason for that to change, though, of course, the situation remains very fluid."

# RCOC continues to be a leader in connected infrastructure

When they think of the Road Commission for Oakland County (RCOC), many people think of patching potholes, plowing snow, grading gravel roads or repaving roads. However, since the early 1990s, there's been another, much highertech aspect of the agency as well.

### **NOT JUST PAVEMENT**

These days, RCOC is highly involved in the "connected-vehicle" world, which involves vehicles talking to each other and to the infrastructure, as well as in the "smart" technology world in order to improve motorist safety, convenience and efficiency. "This technology is the future of transportation and mobility," explained RCOC Managing Director Dennis Kolar.

When it comes to connected-vehicle technology, RCOC has a long history of working with automotive and technology companies to test the latest hardware and software. This has ranged from working with the Michigan Department of Transportation (MDOT) to make trafficsignal phase and timing (SPaT) data available to auto manufacturers and suppliers (so vehicles can receive data about the signals before arriving at the intersection) to using the latest technology to ensure RCOC traffic signals operate as efficiently as possible.

"We have an open door policy and are very supportive of emerging technology testing," noted RCOC Signal Systems Engineer Ahmad Jawad, who oversees RCOC transportation-technology initiatives.

### A HISTORY OF INNOVATION

Since the early 1990s, RCOC has been on the cutting edge of traffic-signal technology, having launched the first "smart" traffic-signal system in the nation in 1992. The system uses vehicle-detection technology to monitor traffic flow and patterns and automatically adjust signal timing in real time to most efficiently meet traffic demands.

Though first introduced nearly 30 years ago (with 28 signals in Troy), the system remains one of the largest in the nation and has continually evolved to keep pace with rapidly changing technologies. A key element of the system is its ability to coordinate signals along entire corridors. It does this by connecting the entire system to the agency's Traffic Operations Center (TOC).

The latest advancement to the system has been updating the way this connection occurs. From the start, this connection was done through hard-wire telephone lines,

which have always been problematic.

They would periodically go down, and RCOC would be at the mercy of the phone company to repair them, often meaning long waits until the lines could be restored. Additionally, following major road-construction projects, there was always a long wait for the system to return to operational status.

Consequently, RCOC hired a consultant to study alternatives to the phone lines. The consultant reviewed multiple potential technologies and concluded a public/private partnership with a cellular-technology provider would be the best alternative. As a result, the decision was made to partner with AT&T to create an RCOC-specific cellular network to connect the signal system.

### A NEW MODEL

The outcome was 850 RCOC signals were connected to the TOC by a private cellular network operated by AT&T. "From the start," Jawad explained, "the objectives were to improve the communications reliability of the signal system, lower the costs, reduce the amount of staff time dedicated to addressing communications issues and ensure the system's readiness to connect to connected/autonomous vehicles and smart cities."

Additionally, since the installation of the new communications network, RCOC has deployed almost 100 closed-circuit television cameras at RCOC intersections, which provide live video feeds of the intersections to the TOC. This allows RCOC engineers to monitor the intersections in real time. An additional 100 cam-

eras are in the works.

"The new communications network is capable of bringing multiple data streams to the TOC," Jawad said. "We are positioning ourselves for the future growth in this space."

This initiative also aligns with RCOC's mission. "RCOC seeks to provide the safest, most efficient road system at the lowest cost," Jawad explained. "We have also always sought to be a national leader in the use of technology to enhance operations. These twin goals led the agency to create one of the largest adaptive trafficsignal systems in the nation in the first place and drive us to continually seek ways to improve the system."

# RCOC closes buildings to public due to virus

As of March 17, the Road Commission for Oakland County (RCOC) closed all of its buildings to the public for the short term to reduce the likelihood of exposure — for both employees and the public — to the coronavirus/COVID-19.

Jamian said, "we are a national leader in terms of 'smart' roads and connected vehicles. My goal is that we not only meet the demands of today, but that we also are positioned to meet the demands of the future."

Jamian also was appointed by his fellow road commissioners as the RCOC representative on the Oakland County Parks and Recreation Board.

Road Commission Board member Ron Fowkes was elected the Board vice chairman. Fowkes has served on the RCOC Board since 2011.

A resident of the Village of Milford, he has frequently advocated for better roads in Oakland County. Fowkes served on the Milford Village Council from 1999 through 2006, including as its president in 2003.

The third member of the RCOC Board is Andrea LaLonde. A resident of Clawson, LaLonde is an employee of the Operating Engineers 324 of Michigan, where she has worked for 12 years. She joined the RCOC Board in January 2019.

RCOC Board members are appointed by the Oakland County Board of Commissioners and serve for staggered, six-year terms.

# What you need to know about coronavirus disease 2019 (COVID-19)

# What is coronavirus disease 2019 (COVID-19)?

Coronavirus disease 2019 (COVID-19) is a respiratory illness that can spread from person to person. The virus that causes COVID-19 is a novel coronavirus that was first identified during an investigation into an outbreak in Wuhan, China.

# Can people in the U.S. get COVID-19?

Yes. COVID-19 is spreading from person to person in parts of the United States. Risk of infection with COVID-19 is higher for people who are close contacts of someone known to have COVID-19, for example healthcare workers, or household members. Other people at higher risk for infection are those who live in or have recently been in an area with ongoing spread of COVID-19. Learn more about places with ongoing spread at <a href="https://www.cdc.gov/coronavirus/2019-ncov/about/transmission.html#geographic">html#geographic</a>.

# Have there been cases of COVID-19 in the U.S.?

Yes. The first case of COVID-19 in the United States was reported on January 21, 2020. The current count of cases of COVID-19 in the United States is available on CDC's webpage at <a href="https://www.cdc.gov/coronavirus/2019-ncov/cases-in-us.html">https://www.cdc.gov/coronavirus/2019-ncov/cases-in-us.html</a>.

# How does COVID-19 spread?

The virus that causes COVID-19 probably emerged from an animal source, but is now spreading from person to person. The virus is thought to spread mainly between people who are in close contact with one another (within about 6 feet) through respiratory droplets produced when an infected person coughs or sneezes. It also may be possible that a person can get COVID-19 by touching a surface or object that has the virus on it and then touching their own mouth, nose, or possibly their eyes, but this is not thought to be the main way the virus spreads. # What are the symptoms of COVID-19?

Patients with COVID-19 have had mild to severe respiratory illness with symptoms of

- fever
- cough
- · shortness of breath



# What are severe complications from this virus?

Some patients have pneumonia in both lungs, multi-organ failure and in some cases death.

# How can I help protect myself?

People can help protect themselves from respiratory illness with everyday preventive actions.

- · Avoid close contact with people who are sick.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Wash your hands often with soap and water for at least 20 seconds. Use an alcohol-based hand sanitizer that contains at least 60% alcohol if soap and water are not available.

# If you are sick, to keep from spreading respiratory illness to others, you should

- Stay home when you are sick.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
- Clean and disinfect frequently touched objects and surfaces.

# What should I do if I recently traveled from an area with ongoing spread of COVID-19?

If you have traveled from an affected area, there may be restrictions on your movements for up to 2 weeks. If you develop symptoms during that period (fever, cough, trouble breathing), seek medical advice. Call the office of your health care provider before you go, and tell them about your travel and your symptoms. They will give you instructions on how to get care without exposing other people to your illness. While sick, avoid contact with people, don't go out and delay any travel to reduce the possibility of spreading illness to others.

# Is there a vaccine?

There is currently no vaccine to protect against COVID-19. The best way to prevent infection is to take everyday preventive actions, like avoiding close contact with people who are sick and washing your hands often.

# Is there a treatment?

There is no specific antiviral treatment for COVID-19. People with COVID-19 can seek medical care to help relieve symptoms.
