REVIEW AND CONSIDER AGREEMENT FOR CARES ACT DISTRIBUTION BETWEEN OAKLAND COUNTY AND VILLAGE OF BEVERLY HILLS

On the agenda for Council's review and consideration was an agreement with Oakland County for the distribution of Cares Act funding. Oakland County has allocated around \$30 million of Cares Act funding for local units of government to reimburse for expenses related to the COVID-19 pandemic. The Village is eligible for up to \$246,755.71 in funding through this program. Village Administration met with representatives of Oakland County to review the program. The Village will likely be submitting for reimbursement for eligible Public Safety payroll expenses for the month of June, plus any additional expenses that would be under our maximum allotment.

Mr. Ryan has reviewed this document and found it to be in order conditional to Administration and Council understanding the terms under Section 3. Village Administration has reviewed the terms of this section and is comfortable recommending approval.

MANAGER'S REPORT

13 Mile Road Update – Paving and construction work on 13 Mile has been completed. Between now and Monday, November 2nd the contractor will be making final pavement markings and returning traffic signals to their normal location and operation. The road will be open to two-way traffic by the morning of Monday, November 2nd. The Road Commission will continue to monitor traffic signals for their timing and efficiency with the new road layout and make adjustments in

the next two weeks as necessary. The Village would like to thank everyone for the patience and cooperation during this project.

Virtual Meetings Rules – As discussed at the last Council meeting, the State has approved legislation allowing virtual meetings of public bodies through the end of his calendar year, and virtual attendance at public meetings under certain conditions in calendar year 2021. Local communities are in the process of developing regulations around virtual meetings to address this new legislation. In discussion with Mr. Ryan there are still some terms and sections of the law that are still being reviewed and clarified. Mr. Ryan will work with Administration to prepare a set of rules for the Village for review and consideration by the meeting of November 17th.

Organizational Meeting – As a reminder, Council has set an Organizational Meeting for Tuesday, November 10th at 7:30 for the purpose of swearing in newly elected Councilmembers and selecting a President and President Pro-Tem. Should the election not be certified by the evening of November the 10th, the Organizational Meeting will be postponed to Monday, November 16th.

Diversifying Village Investments – One of the items noted in our last audit was the amount of cash the Village had invested at Comerica Bank. The auditors suggested that the Village diversify some of our investment holdings. Finance Director McCarthy has investigated rates at local banks and recommends purchasing CD's from Flagstar Bank and Mi Bank at this time. All investments are reported in quarterly financial statements.

Office Closed – Village Offices will be closed on Wednesday, November 11th for Veterans Day. Trash collection will not be interrupted.

Sewer Backup Claims – MMRMA is reviewing the claims that have been submitted to the Village and will be following up with residents directly.

COUNCIL COMMENTS

George encouraged people to vote in the election. He thanked Nunez for his service to the Village.

Hrydziusko thanked Nunez, Mueller, and Mooney for their dedicated service to the Village.

Mueller expressed his sympathy to Mooney family and Abboud family for recent deaths in the families. He stated he appreciated Nunez's persistence on Council and said his ideas will not be lost. He thanked the residents for the last four years and said it was a pleasure and privilege to work for the residents.

Nunez expressed his appreciation to the people in Beverly Hills. He thanked the residents and hopes he helped them in some way. He advised everyone to look at the water/sewer issue methodically and not to jump to conclusions.

Mooney expressed his sympathy to the family of Bob Walsh. He spoke about the election and stated all the candidates are good people. He talked about Mr. Nunez's vision for the Village and assured him it will go forward if the millage passes. Mooney said it is an honor and a privilege to sit behind the Council desk. He commended each council member individually for their work and skills. He thanked past presidents Pugh and Koss. He thanked Wilson and Torongeau for their work for the Village. He encouraged everyone to allow for a bit more humor.

Re: *Village of Beverly Hills/Rules to Govern Virtual Meetings*

Dear Mr. Wilson:

After the Michigan Supreme Court's decision earlier this month invalidating the Governor's Covid-related executive orders issued after April 30, uncertainty resulted over whether municipal boards and commissions may continue to hold electronic, remote participation meetings while the pandemic goes on. The State Legislature and Governor solved that – at least temporarily – by enacting and signing into law 2020 PA 228 (copy attached) amending the Open Meetings Act to allow municipal boards and commissions to hold electronic meetings, and establishing conditions, limitations, and procedures for electronic meetings.

The amended OMA does several things: (i) It validates all electronic meetings held since March, (ii) Allows local boards and commissions to continue to hold electronic meetings through the end of this calendar year, (iii) It authorizes remote meetings to be held during 2021 only to accommodate members absent due to military duty, a medical condition, or a statewide or local state of emergency or disaster, and (iv) After 2021, allows remote participation by board and commission members only for military duty.

For the most part, electronic meetings must be conducted similar to the way they were conducted under the prior executive orders of the Governor. But the amended OMA sets forth various additional notice and procedural requirements for electronic meetings. Among the requirements is that absent board and commission members participating remotely must announce the municipality and state where the member is remotely participating from. This disclosure must be made part of the meeting minutes.

Also, a public body with an official internet presence (i.e., a website) must post advance notice of an electronic meeting on its website where it can be accessed by the public at least 18 hours prior to the meeting. Meeting agendas must also be available and accessible to the public on the internet at least 2 hours before the meeting.

The amended OMA requires a public body to establish procedures to govern electronic meetings. Therefore, I offer the attached proposed Village Council Resolution to amend the

Village's current Rules and Order of Procedure to add rules for electronic meetings. These rules, as drafted, closely track the statutory provisions and procedures of the amended OMA. In addition, please note that the last rule proposed to be added will cover all the Village's other boards and commissions by applying these same Electronic Meetings rules to them.

I recommend that the proposed Resolution to adopt the Rules be adopted at the Council's next meeting.

VILLAGE OF BEVERLY HILLS, MICHIGAN

RESOLUTION TO ADOPT RULES FOR ELECTRONIC MEETINGS

WHEREAS, the Michigan Open Meetings Act, MCL 15.261 et seq. was recently amended by the adoption of Public Act 228 of 2020 to permit the remote attendance by members of a public body using telephonic or video conferencing means; and

WHEREAS, the Village Council desires to continue to meet and conduct the public business of the Village in a manner that permits both the general public and members of the Village Council and other Village boards and commissions subject to the Open Meetings Act to participate by electronic means.

THEREFORE, IT IS RESOLVED by the Beverly Hills Village Council that its Rules and Order of Procedure are hereby amended to add the following provisions:

ELECTRONIC MEETINGS

Rule 1. ELECTRONIC MEETINGS AUTHORIZED

The Village Council may meet and conduct its meetings, in whole or in part, by electronic means using telephone conferencing or video conferencing technology without regard to physical place and physical presence requirements, in accordance with Section 3a of the Open Meetings Act, MCL 15.263a, as amended, through December 31, 2020.

Beginning January 1, 2021 through December 31, 2021, Village Council meetings may be held, in whole or in part, by electronic means using telephone conferencing or video conferencing technology due to circumstances requiring accommodation of any Village Councilmember absent because of military duty, a medical condition, or when a declared statewide or local state of emergency or state of disaster exists and the personal health or safety of members of the public or public body would be at risk if the meeting were held in person. As used in these Rules, the term “medical condition” means an illness, injury, disability, or other health-related condition, including the quarantine or isolation of a Village Councilmember to minimize the spread of a contagious disease.

Beginning January 1, 2022 members of the Village Council may participate by electronic means in Village Council meetings only to accommodate their absence due to military duty.

Rule 2. CONDUCT OF ELECTRONIC MEETINGS

An electronic meeting of the Village Council will be conducted in a manner that permits two-way communication so that members of the Council can hear and be heard by one another, and so that public participants can hear members of the Village Council and be heard by both the Council and other public participants. The Village may use technology to facilitate typed public comments submitted by members of the public participating in the electronically-held meeting that shall be read to or shared with members of the Village Council and other participants.

As permitted by the Open Meetings Act, a physical place is not required for an electronically-held meeting. Members of the Village Council and members of the public participating electronically in a meeting that occurs in a physical place are considered present and in attendance at the meeting for all purposes. For a meeting at which Village Councilmembers are physically absent due to military duty or a medical condition and who are being accommodated by remote participation, all other Village Councilmembers must be physically present at the meeting to be able to participate.

In addition to any other notice required by the Open Meetings Act, advance notice of an electronically-held meeting shall be posted on a portion of the Village's website that is fully accessible to the public. The public notice must be included on either the home page or a separate webpage dedicated to public notices for non-regularly scheduled or electronically-held public meetings that is accessible through a prominent and conspicuous link on the Village's website home page that clearly describes its purpose for public notification of non-regularly scheduled or electronically-held public meetings. Any scheduled meeting of the Village Council may be held as an electronic meeting as permitted by the Open Meetings Act if a notice consistent with this Rule is posted at least 18 hours before the meeting begins. Any notice of the meeting of the Village Council held electronically must clearly contain all of the following:

- (a) Why the Village Council is meeting electronically;
- (b) How members of the public may participate in the meeting electronically (if a telephone number, internet address or both are required to participate, that information must be provided in the notice);
- (c) How members of the public may contact members of the Village Council to provide input or ask questions on any business that will come before the Council at the meeting; and
- (d) How persons with disabilities may participate in the meeting.

If an agenda exists for an electronically held meeting of the Village Council, the Village shall, on a portion of its website that is fully accessible to the public make the agenda of the meeting available to the public at least 2 hours before the meeting begins. This publication of the meeting agenda does not prohibit subsequent amendment of the agenda at the meeting.

A member of the general public is not required to register or otherwise provide his or her name or other information or otherwise fulfill a condition precedent to attend an electronically-held meeting, other than mechanisms established and required by the Village necessary to permit the individual to participate in a public comment period of the meeting.

Members of the general public otherwise participating in an electronically-held meeting of the Village Council are excluded from participation in a closed session of the Village Council that is held electronically provided that the closed session is convened and held in compliance with the requirements of the Open Meetings Act applicable to closed sessions.

Rule 3. AGENDA FOR REGULAR BUSINESS MEETINGS; ELECTRONIC MEETINGS

The order of business for all meetings of the Village Council conducted electronically and held during through December 31, 2020, and held beginning January 1, 2021 through December 31, 2021 for Village Council meetings held, in whole or in part, by electronic means using telephone conferencing or video conferencing technology when a declared statewide or local state of emergency or state of disaster exists shall be as follows: Roll Call/Call to Order; Pledge of Allegiance; Approval of Agenda; Community Announcements; Public Comment – Items Not On the Agenda; Consent Agenda; Business Agenda; Public Comment; Village Manager Report; Council Comments; and Adjournment. The order of business outlined in this paragraph is not applicable when electronic means is used to accommodate the absence of individual Village Council members due to military duty or a medical condition.

Rule 4. PUBLIC COMMENTS

During Village Council meetings conducted electronically, members of the public attending the meeting, once recognized by the chair, shall identify themselves for the record and indicate the municipality where they reside.

Rule 5. COUNCILMEMBER ATTENDANCE BY PHONE/VIDEO

A member of the Village Council who anticipates being absent from a meeting due to the circumstances set forth in the Open Meetings Act and these Rules may request accommodation of their absence to permit their remote participation in and voting on Council business by two-way telephonic or video conferencing communication. A Village Councilmember who desires to attend a meeting by telephonic or video conferencing shall inform the Village Manager, or the Village Manager's designee, at least 24 hours before the meeting to permit any necessary technology to be put in place to accommodate participation of the absent member. Village Councilmembers attending a meeting by telephone or video conferencing may fully participate in the meeting, including voting and attendance in any closed session of the Village Council. A Councilmember participating by telephonic or video conferencing is not permitted to chair the meeting unless all Council members are participating by telephone or video conferencing.

Any member of the Village Council attending a meeting remotely must publicly announce at the outset of the meeting (which shall be included in meeting minutes) that the member is attending the meeting remotely. If the member is attending the meeting remotely for a purpose other than for military duty, the member's announcement must identify the member's physical location by stating the city, village, or township and the state from which the member is attending the meeting remotely.

Rule 6. OTHER BOARDS AND COMMISSIONS

All other Village boards and commissions and the members thereof are governed by and shall conform to the provisions contained in these Rules setting forth the requirements and procedures by which absent members and the public may remotely participate in meetings electronically by telephone or video conferencing. In the event of any conflict between these rules and the bylaws or procedural rules of the other board or commission, this Rule is controlling authority.

ENROLLED SENATE BILL No. 1108

AN ACT to amend 1976 PA 267, entitled "An act to require certain meetings of certain public bodies to be open to the public; to require notice and the keeping of minutes of meetings; to provide for enforcement; to provide for invalidation of governmental decisions under certain circumstances; to provide penalties; and to repeal certain acts and parts of acts," by amending section 3 (MCL 15.263), as amended by 2018 PA 485, and by adding section 3a.

The People of the State of Michigan enact:

Sec. 3. (1) All meetings of a public body must be open to the public and must be held in a place available to the general public. All persons must be permitted to attend any meeting except as otherwise provided in this act. The right of a person to attend a meeting of a public body includes the right to tape-record, to videotape, to broadcast live on radio, and to telecast live on television the proceedings of a public body at a public meeting. The exercise of this right does not depend on the prior approval of the public body. However, a public body may establish reasonable rules and regulations in order to minimize the possibility of disrupting the meeting.

(2) All decisions of a public body must be made at a meeting open to the public. For purposes of any meeting subject to this section, except a meeting of any state legislative body at which a formal vote is taken, the public body shall, subject to section 3a, establish the following procedures to accommodate the absence of any member of the public body due to military duty, a medical condition, or a statewide or local state of emergency or state of disaster declared pursuant to law or charter by the governor or a local official or local governing body that would risk the personal health or safety of members of the public or the public body if the meeting were held in person:

(a) Procedures by which the absent member may participate in, and vote on, business before the public body, including, but not limited to, procedures that provide for both of the following:

(i) Two-way communication.

(ii) For each member of the public body attending the meeting remotely, a public announcement at the outset of the meeting by that member, to be included in the meeting minutes, that the member is in fact attending the meeting remotely. If the member is attending the meeting remotely for a purpose other than for military duty, the member's announcement must further identify specifically the member's physical location by stating the county, city, township, or village and state from which he or she is attending the meeting remotely.

(b) Procedures by which the public is provided notice of the absence of the member and information about how to contact that member sufficiently in advance of a meeting of the public body to provide input on any business that will come before the public body.

(3) All deliberations of a public body constituting a quorum of its members must take place at a meeting open to the public except as provided in this section and sections 7 and 8.

(4) A person must not be required as a condition of attendance at a meeting of a public body to register or otherwise provide his or her name or other information or otherwise to fulfill a condition precedent to attendance.

(5) A person must be permitted to address a meeting of a public body under rules established and recorded by the public body. The legislature or a house of the legislature may provide by rule that the right to address may be limited to prescribed times at hearings and committee meetings only.

(6) A person must not be excluded from a meeting otherwise open to the public except for a breach of the peace actually committed at the meeting.

(7) This act does not apply to the following public bodies, but only when deliberating the merits of a case:

(a) The Michigan compensation appellate commission operating as described in either of the following:

(i) Section 274 of the worker's disability compensation act of 1969, 1969 PA 317, MCL 418.274.

(ii) Section 34 of the Michigan employment security act, 1936 (Ex Sess) PA 1, 421.34.

(b) The state tenure commission created in section 1 of article VII of 1937 (Ex Sess) PA 4, MCL 38.131, when acting as a board of review from the decision of a controlling board.

(c) The employment relations commission or an arbitrator or arbitration panel created or appointed under 1939 PA 176, MCL 423.1 to 423.30.

(d) The Michigan public service commission created under 1939 PA 3, MCL 460.1 to 460.11.

(8) This act does not apply to an association of insurers created under the insurance code of 1956, 1956 PA 218, MCL 500.100 to 500.8302, or other association or facility formed under that act as a nonprofit organization of insurer members.

(9) This act does not apply to a committee of a public body that adopts a nonpolicymaking resolution of tribute or memorial, if the resolution is not adopted at a meeting.

(10) This act does not apply to a meeting that is a social or chance gathering or conference not designed to avoid this act.

(11) This act does not apply to the Michigan veterans' trust fund board of trustees or a county or district committee created under 1946 (1st Ex Sess) PA 9, MCL 35.602 to 35.610, when the board of trustees or county or district committee is deliberating the merits of an emergent need. A decision of the board of trustees or county or district committee made under this subsection must be reconsidered by the board or committee at its next regular or special meeting consistent with the requirements of this act. "Emergent need" means a situation that the board of trustees, by rules promulgated under the administrative procedures act of 1969, 1969 PA 306, MCL 24.201 to 24.328, determines requires immediate action.

(12) As used in subsection (2):

(a) "Formal vote" means a vote on a bill, amendment, resolution, motion, proposal, recommendation, or any other measure on which a vote by members of a state legislative body is required and by which the state legislative body effectuates or formulates public policy.

(b) "Medical condition" means an illness, injury, disability, or other health-related condition.

Sec. 3a. (1) A meeting of a public body held, in whole or in part, electronically by telephonic or video conferencing in compliance with this section and, except as otherwise required in this section, all of the provisions of this act applicable to a nonelectronic meeting, is permitted by this act in the following circumstances:

(a) Before January 1, 2021 and retroactive to March 18, 2020, any circumstances, including, but not limited to, any of the circumstances requiring accommodation of absent members described in section 3(2).

(b) On and after January 1, 2021 through December 31, 2021, only those circumstances requiring accommodation of members absent due to military duty, a medical condition, or a statewide or local state of emergency or state of disaster as described in section 3(2). For the purpose of permitting an electronic meeting due to a local state of emergency or state of disaster, this subdivision applies only as follows:

(i) To permit the electronic attendance of a member of the public body who resides in the affected area.

(ii) To permit the electronic meeting of a public body that usually holds its meetings in the affected area.

(c) After December 31, 2021, only in the circumstances requiring accommodation of members absent due to military duty as described in section 3(2).

(2) A meeting of a public body held electronically under this section must be conducted in a manner that permits 2-way communication so that members of the public body can hear and be heard by other members of the public body, and so that public participants can hear members of the public body and can be heard by members of the public body and other participants during a public comment period. A public body may use technology to facilitate typed public comments during the meeting submitted by members of the public participating in the meeting that may be read to or shared with members of the public body and other participants to satisfy the requirement under this subsection that members of the public be heard by others during the electronic meeting and the requirement under section 3(5) that members of the public be permitted to address the electronic meeting.

(3) Except as otherwise provided in subsection (8), a physical place is not required for an electronic meeting held under this section, and members of a public body and members of the public participating electronically in a meeting held under this section that occurs in a physical place are to be considered present and in attendance at the meeting for all purposes.

(4) If a public body directly or indirectly maintains an official internet presence that includes monthly or more frequent updates of public meeting agendas or minutes, the public body shall, in addition to any other notices that may be required under this act, post advance notice of a meeting held electronically under this section on a portion of the public body's website that is fully accessible to the public. The public notice on the website must be included on either the homepage or on a separate webpage dedicated to public notices for nonregularly scheduled or electronic public meetings that is accessible through a prominent and conspicuous link on the website's homepage that clearly describes its purpose for public notification of nonregularly scheduled or electronic public meetings. Subject to the requirements of this section, any scheduled meeting of a public body may be held as an electronic meeting under this section if a notice consistent with this section is posted at least 18 hours before the meeting begins. Notice of a meeting of a public body held electronically must clearly explain all of the following:

(a) Why the public body is meeting electronically.

(b) How members of the public may participate in the meeting electronically. If a telephone number, internet address, or both are needed to participate, that information must be provided specifically.

(c) How members of the public may contact members of the public body to provide input or ask questions on any business that will come before the public body at the meeting.

(d) How persons with disabilities may participate in the meeting.


(5) Beginning on the effective date of the amendatory act that added this section, if an agenda exists for an electronic meeting held under this section by a public body that directly or indirectly maintains an official internet presence that includes monthly or more frequent updates of public meeting agendas or minutes, the public body shall, on a portion of the website that is fully accessible to the public, make the agenda available to the public at least 2 hours before the electronic meeting begins. This publication of the agenda does not prohibit subsequent amendment of the agenda at the meeting.

(6) A public body shall not, as a condition of participating in an electronic meeting of the public body held under this section, require a person to register or otherwise provide his or her name or other information or otherwise to fulfill a condition precedent to attendance, other than mechanisms established and required by the public body necessary to permit the person to participate in a public comment period of the meeting.


(7) Members of the general public otherwise participating in a meeting of a public body held electronically under this section are to be excluded from participation in a closed session of the public body held electronically during that meeting if the closed session is convened and held in compliance with the requirements of this act applicable to a closed session.

(8) At a meeting held under this section that accommodates members absent due to military duty or a medical condition, only those members absent due to military duty or a medical condition may participate remotely. Any member who is not on military duty or does not have a medical condition must be physically present at the meeting to participate.

This act is ordered to take immediate effect.

VILLAGE MANAGER'S REPORT
CHRIS D. WILSON
NOVEMBER 13, 2020

Village Millage Renewal – The Village's millage renewal measure that was on the November ballot has passed. Unofficial results from Oakland County indicate that Village voters approved this measure with just over 69% percent of votes cast in favor of the renewal. Over the last year, Village Administration has developed budget forecasts for FY 21 based on both a renewal of the millage and a sunset of the previous millage. Now that the millage has passed for another 10-year period we can begin implementing the millage renewal numbers in a projected two-year budget including a new Parks fund.

Local COVID Cases – Village Administration continues to monitor COVID cases locally. Per the Oakland County COVID Dashboard, there have been 345 reported cases of Coronavirus in the 48025 zip code since the onset of the pandemic roughly 9 months ago. 131 of those cases, roughly 38% have occurred in the last 30 days, as of November 13th. Village Administration has been preparing contingencies in the event that stay home or work from home orders are issued at the state or county level.

Liaison Assignments – Upon selection of a Village President at the Organizational meeting of Monday, November 16th, Village Administration will provide the President with the blank template that we use to keep track of Council Liaison assignments. With the late date of the Organizational Meeting relative to this meeting it is not anticipated that liaison assignments will be known at this time. As there have been some changes to the Council membership there may need to be temporary adjustments or fill ins until those assignments are finalized.

Planning Commission Meetings – Due to the Thanksgiving Holiday the November Planning Commission meeting will be held on Wednesday, November 18th. In December, the Planning Commission will be held on Wednesday, December 16th due to Christmas holidays.

Yard Waste Collection – Yard waste collection will be continuing through the week of December 14th. All bagged leaves and yard waste will need to be put to the curb by the week of the 14th to ensure curbside collection.

Village Offices Closed – Village Offices will be closed on Thursday and Friday November 26th and 27th in observance of Thanksgiving. Trash collection will not be interrupted this week.

Click it or Ticket campaign starts today

Michigan Office of Highway Safety Planning (OHSP) is launching a Click It or Ticket seat belt enforcement to remind everyone about the importance of buckling up. “Three out of four people ejected from a vehicle in a crash will die,” said OHSP Director Michael L. Prince. “Wearing a seat belt is the simplest thing you can do to reduce injuries and save lives. It’s the easiest decision you will ever make. Buckle up every trip, every time.”

During the three-week period, officers from police departments, sheriff’s offices and the Michigan State Police will be conducting seat belt enforcement across the state.

The campaign includes the Thanksgiving holiday weekend Nov. 26-29. In 2019, there were seven fatalities on Michigan roads during the holiday weekend. Four of the seven deaths involved drivers and passengers who were not wearing seat belts.

In Michigan, the seat belt usage rate stands at 94.4%. The national seat belt use rate in 2019 was 90.7%. Seat belts are the single most effective way to stay alive in a crash. According to the National Highway Traffic Safety Administration (NHTSA), buckling up can reduce the risk of serious injury or death in a crash by 45 percent.

According to the [State of Michigan’s website](#), seat belts have saved 344,448 lives since 1975, when the NHTSA first began recording data on seat belt use. An additional 381,787 lives could have been saved if everyone had been wearing a seat belt since.

The State encourages drivers and passengers to follow these guidelines when you buckle up: The lap belt and shoulder belt are secured across the hips and shoulder, which are more able to withstand crash forces than other parts of your body.

Place the shoulder belt across the middle of your chest and away from your neck.

The lap belt rests across your hips, not your stomach.

NEVER put the shoulder belt behind your back or under an arm.

Michigan law requires drivers, front-seat passengers and passengers 15 and younger in any seating position to be buckled up. The fine and associated costs for not wearing a seat belt is \$65. Children must be in a car seat or booster seat until they are 8 years old or 4'9" tall, and children under 4 years old must be in the back seat.

The campaign runs Nov. 9-29.



