PROCLAMATION DECLARING JUNE AS PRIDE MONTH IN THE VILLAGE OF BEVERLY HILLS

President George read the following proclamation declaring June 2021 as LGBTQ+ Pride Month:

WHEREAS, the Village of Beverly Hills, MI cherishes the value and dignity of each person and appreciates the importance of equality and freedom; and

THESE MINUTES ARE NOT OFFICIAL. THEY HAVE NOT BEEN APPROVED BY THE VILLAGE COUNCIL.

WHEREAS, all are welcome in the Village of Beverly Hills, MI to live, work, play, and every family, in any shape, deserves a place to call home where they are safe, happy, and supported by friends and neighbors; and

WHEREAS, the Village of Beverly Hills, MI denounces prejudice and unfair discrimination based on age, gender identity, gender expression, race, color, religion, marital status, national origin, sexual orientation, or physical attributes as an affront to our fundamental principles; and

WHEREAS, Pride month began in June of 1969 on the one-year anniversary of the Stonewall Uprising in New York City after LGBTQ+ and allied friends rose up and fought against the constant police harassment and discriminatory laws that have since been declared unconstitutional; and

WHEREAS, the Village of Beverly Hills, MI appreciate the cultural, civic, and economic contributions of lesbian, Gay, Bisexual, Transgender, Queer, plus (LGBTQ+) community which strengthen our social welfare; and

WHEREAS it is imperative that young people in our community, regardless of sexual orientation, gender identity, and expression, feel valued, safe, empowered, and supported by their peers and community leaders; and

WHEREAS, despite being marginalized, LGBTQ+ people continue to celebrate authenticity, acceptance, and love.

NOW THEREFORE I, John George, President of the Beverly Hills Village Council proclaim the month of June 2021 as LGBTQ Pride Month in the Village of Beverly Hills, MI and urge residents to recognize the contributions made by members of the LGBTQ+ community and to actively promote the principles of equality, liberty, and justice.

REVIEW AND CONSIDER REQUEST FROM NEXT TO HOST OKTOBERFEST EVENT AT THE BEVERLY PARK PAVILION ON SEPTEMBER 16, 2021

Administration received a request from Birmingham Next to hold their annual Oktoberfest event at the Beverly Park pavilion on Thursday, September 16, 2021 from 4:00 to 8:00 p.m. They requested that the rental fees be waived. Next has hosted this event at the pavilion in the past.

At their May 20, 2021 meeting, the Beverly Hills Parks & Recreation Board recommended the Village Council approve Next's request to host the Next Oktoberfest event at the Beverly Park pavilion on Thursday, September 16, 2021 from 4:00 to 8:00 p.m. and recommended that the Council waive the pavilion rental fees for the event. The Board also rescheduled their September meeting date from September 16th to September 15th to accommodate Next's requested use of the pavilion.

Motion by Abboud, second by Mooney, be it resolved, the Beverly Hills Village Council approves Next's request to host the Next Oktoberfest event at the Beverly Park pavilion on Thursday, September 16, 2021 from 4:00 to 8:00 p.m. and waives the pavilion rental fees for the event provided that a Certificate of Liability Insurance naming the Village of Beverly Hills as an additional insured is submitted to the Clerk's Office prior to the event. REVIEW AND CONSIDER REQUEST FROM BALDWIN PUBLIC LIBRARY TO HOST INTERACTIVE STORY BOOK TRAIL AT BEVERLY PARK IN JUNE, JULY, AND AUGUST 2021

The Village received a request from Baldwin Public Library to host an Interactive Story Book Trail Program at Beverly Park once a month during Summer 2021. The proposed dates/times are June 23, July 14, and August 4 from 1:00 to 4:00 p.m. Baldwin is proposing that a representative from the library set up a table at the beginning of the trail and pass out activity kits for families to complete while they are on the trail. They would require registration for a kit and would space the registration times out. For example, participants could register for 1:00 p.m., 1:30 p.m., or 2:00 p.m. etc. to space out visitors so they do not arrive all at once. Baldwin is requesting use of one table from the Village for this event. This request does not have a budget impact on the Village.

The Parks & Recreation Board is requesting Council's approval to host a second Concert in the Park on Friday, July 16, 2021 at Beverly Park beginning at 7:00 p.m. The Board held a successful concert event in June of 2019 and has a concert scheduled on June 4, 2021.

At their May 20, 2021 meeting, the Parks & Recreation Board passed a motion to recommend the Village Council approve their request to have a Concert in the Park on Friday, July 16, 2021 at 7:00 p.m. not to exceed \$1,500.00, with the performer(s) to be determined. Part of the expense would include a stage rental from Oakland County Parks in the amount of \$550.00. While COVID-19 mask and gathering restrictions are being relaxed, whatever safety protocols are in place at the time of the event will be followed.

REVIEW AND CONSIDER PARKS & RECREATION BOARD'S REQUEST TO HOST MOVIE IN THE PARK ON AUGUST 24, 2021

The Parks & Recreation Board is requesting Council's approval to host a Movie in the Park on Tuesday, August 24, 2021 at Beverly Park beginning at dusk. The Board held successful Movie in the Park events in the past. Last year the Board selected August 19, 2021 as the proposed date for the movie night in the Village calendar, but the screen is unavailable that date, so they have now requested August 24th instead.

At their May 20, 2021 meeting, the Parks & Recreation Board passed a motion to recommend the Village Council approve their request to have a Movie in the Park with expenses not to exceed \$1,500.00. However, after receiving the final prices from the Carey and Paul Group for the screen (\$1,400.00) and from Swank Motion Pictures for the license of *Raya and the Last Dragon* (\$685.00), Administration recommends Council approve the Movie in the Park with expenses not to exceed \$2,200.00.

While COVID-19 mask and gathering restrictions are being relaxed, whatever safety protocols are in place at the time of the event will be adhered to.

Motion by Peddie, second by Hrydziuszko, be it resolved, the Beverly Hills Village Council approves the Parks & Recreation Board's request to host Movie in the Park on Tuesday, August 24, 2021 at dusk at Beverly Park with expenses not to exceed \$2,200.00. Further, the Council authorizes administration to execute the movie screen agreement with Carey and Paul Group and the exhibition agreement with Swank Motion Pictures, Inc. Funds for this request are available in account 101-747-896.60.

REVIEW AND CONSIDER PARKS & RECREATION BOARD'S REQUEST TO WAIVE SALES RESTRICTIONS FOR VILLAGE SPONSORED EVENTS AT BEVERLY PARK IN 2021

Per Chapter 6.03 of the Municipal Code, "[n]o amusement for gain or for which a charge is made can be conducted in a park without consent of the Village Council. . ."

The Parks and Recreation Board would like to have food trucks and other vendors at upcoming events in Beverly Park and has requested the Village Council waive all sales restrictions at Beverly Park for Village sponsored events for calendar year 2021. These events include: the Concerts in the Park, Movie in the Park, Read in the Park, and Halloween Hoot.

Motion by Kecskemeti, second by Hrydziuszko, be it resolved, the Beverly Hills Village Council hereby waives sales restrictions at Beverly Park for Village sponsored events in calendar year 2021.

REVIEW AND CONSIDER LIGHTING REPAIRS AND UPGRADE IN PUBLIC SAFETY DEPARTMENT APPARATUS BAY

Beverly Hills Public Safety Apparatus Bay has twenty-five light fixtures that were installed when the building was built in 1989. Eleven of the light fixtures are no longer working. All of the light fixtures have some form of damage. The light fixtures were hung low in order to provide adequate light but the height has interfered with the operation of some tools. Moisture from washing the fire trucks has resulted in corrosion. Beverly Hills preferred vendor, Truline Electric indicated it would be cost prohibitive to repair or replace select fixtures. The current fluorescent bulbs are a custom size and expensive to purchase.

Truline Electric evaluated the space and recommended I-Beam IBE LED fixtures by Lithonia Lighting. The fixtures have a 5-year warranty and are corrosion resistant. Truline will be removing the old fixtures and rewiring the circuits with 12 new LED fixtures. Once the invoice is paid Administration will complete the DTE Energy Efficiency Program for Business application to capture grant funds provided by DTE. Funds for this project have been budgeted for in the 20/21 FY budget.

Motion by Abboud, second by Mooney, be it resolved, Village Council approve invoice 10057 in the amount of \$7,904.00 provided by Truline Inc., 21521 Statler, St. Clair Shores, MI 48081. Funds for this purchase are available in account 205-900-977.00.

REVIEW AND CONSIDER APPROVAL OF COST PARTICIPATION AGREEMENT WITH ROAD COMMISSION FOR OAKLAND COUNTY FOR TRAFFIC CONTROL DEVICE

Wilson provided an overview. The Village has received a proposal from the Road Commission for Oakland County (RCOC) for signal upgrades at the intersection of Southfield Road and Beverly Road. The proposed upgrades would modernize the traffic signals and pedestrian crossings to improve the functionality and safety of this intersection for motorists and pedestrians.

The total proposed cost of these upgrades would be \$230,000. The Village would be responsible for funding half of the costs of these upgrades, or \$115,000. Village Administration has met with RCOC staff regarding this intersection and has reviewed this proposal. While not a complete or total solution to the issues with traffic safety along the Southfield Rd. corridor, Village Administration feels that this proposal would increase traffic and pedestrian safety and is a worthy investment at this time.

Alex Rucinski, a representative from RCOC, was present at the meeting to discuss this matter and answered questions from Council about turning lanes, benefits of box span signals, vehicle and pedestrian safety, and the timeline.

Motion by Mooney, second by Abboud, be it resolved, the Village Council approves and authorizes the Village Manager to execute the Agreement for Traffic Control Device with the Road Commission for Oakland for the intersection of Southfield Rd. and Beverly Rd. in an amount not to exceed \$115,000. Funds for this expenditure are available in Fund # 202-474-934.02.

REVIEW AND CONSIDER FY 20-21 BUDGET AMENDMENTS

Proposed FY 2020-2021 Village of Beverly Hills Budget Amendments were provided to the Council for review.

There are General Fund amendments adjusting various revenue and expenditure accounts to estimated year end balances. Included in the amendments are property taxes adjusted to final actuals. Permit revenues and expenditures have been adjusted upward due to continued strong activity. Constitutional revenue has been adjusted upward to reflect increased money received from the State due to passthrough of Federal stimulus money. The effect of the amendments is a net of revenue and expenditure increase of \$151,049.

In Major Roads and Local Roads there are amendments adjusting various revenue and expenditure accounts to estimated year end balances. There are amendments increasing Act 51 revenue received from the State. The effect of the amendments is a net of revenue and expenditure increase of \$57,607 in Major Roads and a net of revenue and expenditure increase of \$65,000 in Local Roads.

In the Public Safety Fund there are various revenue and expenditure adjustments to expected actuals. Included in the amendments are property taxes adjusted to final actuals. Amendments are included for the final PSPHPR Cares Act Payroll Reimbursement Grant payment and South Oakland Fire Association revenue received in addition to the Risk Avoidance Grant expected to be received before year end. Various overtime accounts are adjusted upward as a result of manpower shortage and COVID-19. The effect of the amendments is a net of revenue and expenditure increase of \$96,989.

In the Library Fund there are amendments adjusting property taxes received and expenditures paid out to actuals. The effect of the amendments is a net of revenue and expenditure decrease of (\$3,420).

In the Capital Fund there are amendments decreasing interest income and decreasing capital vehicle purchases. The 2 police cars budgeted were not able to be purchased in this fiscal due to COVID-19. The effect of the amendments is a net of revenue and expenditure increase of \$71,100. These proposed FY 2020-2021 Budget Amendments have been reviewed by Village Administration and are recommended for approval.

Motion by O'Gorman, second by Hrydziuszko, be it resolved that the Village of Beverly Hills Council authorizes Village Administration to transfer or adjust monies reserved in the General, Major Roads, Local Roads, Public Safety Fund, Capital Fund and Library

fund as reflected in the May 28, 2021 memorandum from Finance Director, Sheila McCarthy.

Hrydziuszko gave an overview of a meeting at Park #5 with Peddie, Kecskemeti, and Parks & Recreation Board Chair Borgon. She commented on having a landscape architect complete the design for Park #5.

O'Gorman commented on speed bumps, street markings, and traffic signs.

PUBLIC COMMENTS

Scott Foret, Beverly Hills, commented on traffic signs and social media policies.

Tony Lott, Riverside, commented on traffic and safety improvements.

Karen Gilbert, Amherst, inquired about a roundabout at Greenfield and Beverly Roads.

Stephanie Jones, Beverly Road, commented about Facebook and inquired about an update on Beverly Park.

Dale Wolicki, Amherst, commented on the Code Enforcement report.

MANAGER'S REPORT

Public Meetings – Per the State of Michigan's new Gatherings and Face Mask Order, as of July 1 capacity for indoor gatherings will be the greater of 25 or 50% of the stated capacity. For the Village Council Chambers, that would be 27 persons, unless social distancing guidelines were enforced. Accounting for social distancing would lower the capacity to around 13. For indoor gatherings, masks would not be required for those who are fully vaccinated but would still be required for those who are not. Given the space limitations of the Council Chambers and general inability to determine who is fully vaccinated, it would seem best to maintain the current protocols of meeting remotely until July 1. After July 1, the Council Chambers can be returned to their original pre March 2020 orientation to accommodate all Board members and members of the

public. For Village Council meetings, Village Administration is working to retain our virtual capabilities post July 1.

Public Services Director Position – The Village accepted applications for the full time Public Services Director through May 21st. I have identified three qualified candidates and will be interviewing them the week of May 31st. Mr. Meszler will remain on staff through June 30th. I anticipate having the full-time position filled during the month of July.

Office Closed – Village Offices will be closed on Monday, May 31st in observance of Memorial Day. Trash and yard waste collection will be delayed by one day this week.

Office Reopening – Village Offices will be returning to being open to the public on regular business hours, 8:00 a.m. – 4:30 p.m. on Wednesday, June 2nd. We are still requesting that those coming into the Village Hall wear masks until the cessation of masking and gatherings regulations on July 1. Village staff is being required to wear masks while interacting with residents at the front counter through July 1.

Beverly and Greenfield Intersection – The Village will be participating in a meeting with the City of Royal Oak and the Road Commission to examine alternatives to the intersection at Beverly and Greenfield. HRC was selected by the Road Commission as the engineers to design alternatives to improve cross traffic and pedestrian safety at this intersection. I do anticipate that a roundabout design will be given serious consideration as one of the options. Any project going forward would be a collaboration between the Village, the City of Royal Oak and the Road Commission.

DWSRF Public Hearing – The Village will be conducting a Public Hearing at the meeting of Tuesday, June 15th for the purposes of taking comments on an application the Village has submitted to the Department of Environment, Great Lakes and Energy (EGLE) for funding through the Drinking Water State Revolving Fund (DWSRF). The Village has submitted an application for \$2 million in low interest loans through this program, a portion of which could eligible for loan forgiveness. The Village has received the preliminary scoring of all applications submitted for this year. Out of 124 applications, the Village's submission ranked 48. The top 45 were preapproved for funding, and we were just outside this list. However, of those 45 it is likely that not all will accept the funding if the loan forgiveness portion is not adequate. The Village is still in a good position to eventually qualify for funding. Submitting the application and holding the public hearing does not obligate the Village to participate should funding be approved. The Village is exploring the DWSRF process as one of our funding options for this project.

COUNCIL COMMENTS

O'Gorman congratulated Seniors on graduation. He commented on the Senior Awards and Convocation and said it is a great achievement.

Abboud gave updates on the SEMCOG, MML, Senior Advisory Committee, and Next meetings he recently attended. He congratulated Sam Mercer and Isabella Caza on receiving the Donald and Patricia Greening Scholarship. He thanked everyone who applied for the scholarship.

Mooney congratulated all of the Greening Scholarship applicants and recipients. He was very impressed with all of the applications received from Isabella Caza, Sam Mercer, Kendall Turk,

Storm Stephenson, and Xavier Turner. He congratulated Sam Mercer on his Eagle Scout achievement.

Hrydziuszko invited everyone to attend the Concert in the Park on Friday, June 4th at 7:00 p.m. She gave an update on the May 20th Parks & Recreation Board meeting. She thanked residents for attending the meetings.

George reminded everyone that the Concert in the Park and Wear Orange Friday were on June 4th. He thanked members Abboud, Mooney, and Peddie for reviewing the Greening Scholarship applications and congratulated Isabella Caza and Sam Mercer on the awards.


DWSRF LOAN PROGRAM

- The Michigan Department of Environmental, Great Lakes, and Energy (EGLE) provides low-interest loans (20, 30, or 40-year loans) to eligible water system to assist in satisfying the requirements of the Safe Drinking Water Act
 - Current 20-year loan rate is 1.875%
 - To qualify:
 - Prepare and submit an EGLE approvable Project Plan
 - Provide a Public Hearing and Comment Opportunity
 - Village of Beverly Hills Council must pass Resolution adopting the Project Plan
 - Submit final Project Plant to EGLE by July 1, 2021



PROJECT BACKGROUND

- Village of Beverly Hills's water distribution system is supplied by Great Lakes Water Authority (GLWA) via the Southeastern Oakland County Water Authority (SOCWA)
- Over 75% of the distribution system was installed before or during the 1950s
- Project Area: Between I 4 Mile to Beverly Road and between Southfield Road and Pierce Street
- Abandon approximately 16,360 feet of vintage 4-inch water main
- Install approximately 8,180 feet of 8-inch water main
- Reconnect approx. 305 water services to front yard
 8-inch water main to existing plumbing



PROJECT NEED

- Address areas of concern that have undersized and aging water mains with a high consequence of failure
- Improve system reliability and resiliency, strengthen and maintain system pressures and remove potential sources of service disruption







PROJECT PLAN ALTERNATIVES

- "No-Action"
- Regional Alternatives
- Optimizing Performance of Existing System
 - Abandon Backyard Water Mains
 - Replace Backyard Water Mains

ALTERNATIVE ANALYSIS

No Action

- Not a favorable option
- No Action will result in:
 - Prolonged use of aging and undersized infrastructure with high consequence of failure

Regional Alternatives

- The Village is already served by a regional water supply SOCWA with reliable and sufficient pressures
- The Village and SOCWA have built a strong bond throughout the years
- No alternative regional solutions evaluated for the source of drinking water

ALTERNATIVE ANALYSIS

Replace Existing System – (Replace Backyard Water Mains)

Includes replacing existing 4-inch backyard water mains with new 8-inch water mains in the same location utilizing trenchless technologies such as pipe bursting

Pros:

- Improves water supply system to comply with regulatory standards for water main
- Potentially minimizes disruption of project to residents

Cons:

- Water mains remain in same location
- Potential for impacts to fences, garages, sheds were constructed over the top of the existing water main
- Greater risk for costly unknowns and potential for damage to property
- Doesn't take advantage of existing infrastructure already in place
- Current easements too narrow for modern construction equipment and trench safety guidelines; recommended to obtain wider easements if water main is to be replaced in its existing location.



ALTERNATIVE ANALYSIS (SELECTED)

Upgrade Existing System – (Abandon Backyard Water Mains)

- Includes abandoning 4-inch rear yard water mains and installing new 8-inch water main within roadway rights-of-way to close loops in the existing distribution system
- Reconnect water service to water mains located at the front of the property
- Pros:
 - Removes aging and undersized 4-inch water main loops located in backyards
 - Improves water system redundancy and circulation, reduces likelihood for costly water main breaks and resident disturbance
 - Shift system operation and maintenance to public rights-of-way only
- Cons:
 - Complex and disruptive water service reconnections
 - Extensive coordination required with Village residents for reconnection of water services



TERMS AND CONDITIONS

1 Definitions

- 1.1 Company shall mean 123.Net, Inc., a corporation organized under the laws of the State of Michigan whose address is 24700 Northwestern Hwy. Ste. 700 Southfield, MI 48075.
- 1.2 Effective Date shall mean the date set forth in Part 13.
- 1.3 <u>Manager</u> shall mean Municipality's [Mayor/Manager/Supervisor/Village President] or his or her designee.
- 1.4 <u>METRO Act</u> shall mean the Metropolitan Extension Telecommunications Rights-of-Way Oversight Act, Act No. 48 of the Public Acts of 2002, as amended.
- 1.5 <u>Municipality</u> shall mean <u>Village of Beverly Hills</u>, a Michigan municipal corporation.
- 1.6 Permit shall mean this document.
- 1.7 <u>Public Right-of-Way</u> shall mean the area on, below, or above a public roadway, highway, street, alley, easement, or waterway, to the extent Municipality has the ability to grant the rights set forth herein. Public right-of-way does not include a federal, state, or private right-of-way.
- Telecommunication Facilities or Facilities shall mean the Company's equipment or personal property, such as copper and fiber cables, lines, wires, switches, conduits, pipes, and sheaths, which are used to or can generate, receive, transmit, carry, amplify, or provide telecommunication services or signals. Telecommunication Facilities or Facilities do not include antennas, supporting structures for antennas, equipment shelters or houses, and any ancillary equipment and miscellaneous hardware used to provide federally licensed commercial mobile service as defined in Section 332(d) of Part I of Title III of the Communications Act of 1934, Chapter 652, 48 Stat. 1064, 47 U.S.C. 332 and further defined as commercial mobile radio service in 47 CFR 20.3, and service provided by any wireless, 2-way communications device.
- 1.9 Term shall have the meaning set forth in Part 7.

2 Grant

- 2.1 Municipality hereby grants a permit under the METRO Act to Company for access to and ongoing use of the Public Right-of-Way to construct, install and maintain Telecommunication Facilities in those portions of the Public Right-of-Way identified on Exhibit A on the terms set forth herein.
 - 2.1.1 Exhibit A may be modified by written request by Company and approval by Manager.
 - 2.1.2 Manager shall not unreasonably condition or deny any request for a modification of Exhibit A. Any decision of Manager on a request for a modification may be appealed by Company to Municipality's legislative body.
- Overlashing. Company shall not allow the wires or any other facilities of a third party to be overlashed to the Telecommunication Facilities without Municipality's prior written consent. Municipality's right to withhold written consent is subject to the authority of the Michigan Public Service Commission under Section 361 of the Michigan Telecommunications Act, MCL § 484.2361.
- 2.3 <u>Nonexclusive</u>. The rights granted by this Permit are nonexclusive. Municipality reserves the right to approve, at any time, additional permits for access to and ongoing usage of the Public Right-of-Way by telecommunications providers and to enter into agreements for use of the Public Right-of-Way with and grant franchises for use of the Public Right-of-Way to telecommunications providers, cable companies, utilities and other providers.

- 3.1.6 The preceding information is accurate as of the Effective Date. Company shall notify Municipality in writing as set forth in Part 12 of any changes in the preceding information.
- 3.2 <u>Route Maps</u>. Within ninety (90) days after the substantial completion of construction of new Facilities in a Municipality, a provider shall submit route maps showing the location of the Telecommunication Facilities to both the Michigan Public Service Commission and to the Municipality, as required under Section 6(7) of the METRO Act, MCLA 484.3106(7).

As-Built Records. Company, without expense to Municipality, shall, upon forty-eight (48) hours notice, give Municipality access to all "as-built" maps, records, plans and specifications showing the Telecommunication Facilities or portions thereof in the Public Right-of-Way. Upon request by Municipality, Company shall inform Municipality as soon as reasonably possible of any changes from previously supplied maps, records, or plans and shall mark up maps provided by Municipality so as to show the location of the Telecommunication Facilities.

4 <u>Use of Public Right-of-Way</u>

- 4.1 No Burden on Public Right-of-Way. Company, its contractors, subcontractors, and the Telecommunication Facilities shall not unduly burden or interfere with the present or future use of any of the Public Right-of-Way. Company's aerial cables and wires shall be suspended so as to not endanger or injure persons or property in or about the Public Right-of-Way. If Municipality reasonably determines that any portion of the Telecommunication Facilities constitutes an undue burden or interference, due to changed circumstances, Company, at its sole expense, shall modify the Telecommunication Facilities or take such other actions as Municipality may determine is in the public interest to remove or alleviate the burden, and Company shall do so within a reasonable time period. Municipality shall attempt to require all occupants of a pole or conduit whose facilities are a burden to remove or alleviate the burden concurrently.
- 4.2 No Priority. This Permit does not establish any priority of use of the Public Right-of-Way by Company over any present or future permittees or parties having agreements with Municipality or franchises for such use. In the event of any dispute as to the priority of use of the Public Right-of-Way, the first priority shall be to the public generally, the second priority to Municipality, the third priority to the State of Michigan and its political subdivisions in the performance of their various functions, and thereafter as between other permit, agreement or franchise holders, as determined by Municipality in the exercise of its powers, including the police power and other powers reserved to and conferred on it by the State of Michigan.
- 4.3 Restoration of Property. Company, its contractors and subcontractors shall immediately (subject to seasonal work restrictions) restore, at Company's sole expense, in a manner approved by Municipality, any portion of the Public Right-of-Way that is in any way disturbed, damaged, or injured by the construction, installation, operation, maintenance or removal of the Telecommunication Facilities to a reasonably equivalent (or, at Company's option, better) condition as that which existed prior to the disturbance. In the event that Company, its contractors or subcontractors fail to make such repair within a reasonable time, Municipality may make the repair and Company shall pay the costs Municipality incurred for such repair.

- Marking. Company shall mark the Telecommunication Facilities as follows: 4.4 Aerial portions of the Telecommunication Facilities shall be marked with a marker on Company's lines on alternate poles which shall state Company's name and provide a toll-free number to call for assistance. Direct buried underground portions of the Telecommunication Facilities shall have (1) a conducting wire placed in the ground at least several inches above Company's cable (if such cable is nonconductive); (2) at least several inches above that, a continuous colored tape with a statement to the effect that there is buried cable beneath; and (3) stakes or other appropriate above ground markers with Company's name and a toll-free number indicating that there is buried telephone cable below. Bored underground portions of the Telecommunication Facilities shall have a conducting wire at the same depth as the cable and shall not be required to provide the continuous colored tape. Portions of the Telecommunication Facilities located in conduit, including conduit of others used by Company, shall be marked at its entrance into and exit from each manhole and handhole with Company's name and a toll-free telephone number.
- 4.5 Tree Trimming. Company may trim trees upon and overhanging the Public Right-of-Way so as to prevent the branches of such trees from coming into contact with the Telecommunication Facilities, consistent with any standards adopted by Municipality. Company shall dispose of all trimmed materials. Company shall minimize the trimming of trees to that essential to maintain the integrity of the Telecommunication Facilities. Except in emergencies, all trimming of trees in the Public Right-of-Way shall have the advance approval of Manager.
- 4.6 <u>Installation and Maintenance</u>. The construction and installation of the Telecommunication Facilities shall be performed pursuant to plans approved by Municipality. The open cut of any Public Right-of-Way shall be coordinated with the Manager or his designee. Company shall install and maintain the Telecommunication Facilities in a reasonably safe condition. If the existing poles in the Public Right-of-Way are overburdened or unavailable for Company's use, or the facilities of all users of the poles are required to go underground then Company shall, at its expense, place such portion of its Telecommunication Facilities underground, unless Municipality approves an alternate location. Company may perform maintenance on the Telecommunication Facilities without prior approval of Municipality, provided that Company shall obtain any and all permits required by Municipality in the event that any maintenance will disturb or block vehicular traffic or are otherwise required by Municipality.
- 4.7 <u>Pavement Cut Coordination</u>. Company shall coordinate its construction and all other work in the Public Right-of-Way with Municipality's program for street construction and rebuilding (collectively "Street Construction") and its program for street repaving and resurfacing (except seal coating and patching) (collectively, "Street Resurfacing").

- 4.7.1 The goals of such coordination shall be to encourage Company to conduct all work in the Public Right-of-Way in conjunction with or immediately prior to any Street Construction or Street Resurfacing planned by Municipality.
- Company shall comply with all laws, statutes, 4.8 Compliance with Laws. ordinances, rules and regulations regarding the construction, installation, and maintenance of its Telecommunication Facilities, whether federal, state or local, now in force or which hereafter may be promulgated. Before any installation is commenced, Company shall secure all necessary permits, licenses and approvals from Municipality or other governmental entity as may be required by law, including, without limitation, all utility line permits and highway permits. Municipality shall not unreasonably delay or deny issuance of any such permits, licenses or approvals. Company shall comply in all respects with applicable codes and industry standards, including but not limited to the National Electrical Safety Code (latest edition adopted by Michigan Public Service Commission) and the National Electric Code (latest edition). Company shall comply with all zoning and land use ordinances and historic preservation ordinances as may exist or may hereafter be amended. This section does not constitute a waiver of Company's right to challenge laws, statutes, ordinances, rules or regulations now in force or established in the future.
- 4.9 <u>Street Vacation</u>. If Municipality vacates or consents to the vacation of Public Right-of-Way within its jurisdiction, and such vacation necessitates the removal and relocation of Company's Facilities in the vacated Public Right-of-Way, Company shall, as a condition of this Permit, consent to the vacation and remove its Facilities at its sole cost and expense when ordered to do so by Municipality or a court of competent jurisdiction. Company shall relocate its Facilities to such alternate route as Municipality and Company mutually agree, applying reasonable engineering standards.
- 4.10 <u>Relocation</u>. If Municipality requests Company to relocate, protect, support, disconnect, or remove its Facilities because of street or utility work, or other public projects, Company shall relocate, protect, support, disconnect, or remove its Facilities, at its sole cost and expense, including where necessary to such alternate route as Municipality and Company mutually agree, applying reasonable engineering standards. The work shall be completed within a reasonable time period.
- 4.11 <u>Public Emergency</u>. Municipality shall have the right to sever, disrupt, dig-up or otherwise destroy Facilities of Company if such action is necessary because of a public emergency. If reasonable to do so under the circumstances, Municipality shall attempt to provide notice to Company. Public emergency shall be any condition which poses an immediate threat to life, health, or property caused by

any natural or man-made disaster, including, but not limited to, storms, floods, fire, accidents, explosions, water main breaks, hazardous material spills, etc. Company shall be responsible for repair at its sole cost and expense of any of its Facilities damaged pursuant to any such action taken by Municipality.

- 4.12 Miss Dig. If eligible to join, Company shall subscribe to and be a member of "MISS DIG," the association of utilities formed pursuant to Act 53 of the Public Acts of 1974, as amended, MCL § 460.701 et seq., and shall conduct its business in conformance with the statutory provisions and regulations promulgated thereunder.
- 4.13 <u>Underground Relocation</u>. If Company has its Facilities on poles of Consumers Energy, Detroit Edison or another electric or telecommunications provider and Consumers Energy, Detroit Edison or such other electric or telecommunications provider relocates its system underground, then Company shall relocate its Facilities underground in the same location at Company's sole cost and expense.
- 4.14 <u>Identification</u>. All personnel of Company and its contractors or subcontractors who have as part of their normal duties contact with the general public shall wear on their clothing a clearly visible identification card bearing Company's name, their name and photograph. Company shall account for all identification cards at all times. Every service vehicle of Company and its contractors or subcontractors shall be clearly identified as such to the public, such as by a magnetic sign with Company's name and telephone number.

5 <u>Indemnification</u>

- Indemnity. Company shall defend, indemnify, protect, and hold harmless Municipality, its officers, agents, employees, elected and appointed officials, departments, boards, and commissions from any and all claims, losses, liabilities, causes of action, demands, judgments, decrees, proceedings, and expenses of any nature (collectively "claim" for this Part 5) (including, without limitation, attorneys' fees) arising out of or resulting from the acts or omissions of Company, its officers, agents, employees, contractors, successors, or assigns, but only to the extent such acts or omissions are related to the Company's use of or installation of facilities in the Public Right-of-Way and only to the extent of the fault or responsibility of Company, its officers, agents, employees, contractors, successors and assigns.
- Notice, Cooperation. Municipality shall notify Company promptly in writing of any such claim and the method and means proposed by Municipality for defending or satisfying such claim. Municipality shall cooperate with Company in every reasonable way to facilitate the defense of any such claim. Municipality shall consult with Company respecting the defense and satisfaction of such claim, including the selection and direction of legal counsel.

5.3 <u>Settlement</u>. Municipality shall not settle any claim subject to indemnification under this Part 5 without the advance written consent of Company, which consent shall not be unreasonably withheld. Company shall have the right to defend or settle, at its own expense, any claim against Municipality for which Company is responsible hereunder.

6 Insurance

- 6.1 <u>Coverage Required</u>. Prior to beginning any construction in or installation of the Telecommunication Facilities in the Public Right-of-Way, Company shall obtain insurance as set forth below and file certificates evidencing same with Municipality. Such insurance shall be maintained in full force and effect until the end of the Term. In the alternative, Company may satisfy this requirement through a program of self-insurance, acceptable to Municipality, by providing reasonable evidence of its financial resources to Municipality. Municipality's acceptance of such self-insurance shall not be unreasonably withheld.
 - 6.1.1 Commercial general liability insurance, including Completed Operations Liability, Independent Contractors Liability, Contractual Liability coverage, railroad protective coverage and coverage for property damage from perils of explosion, collapse or damage to underground utilities, commonly known as XCU coverage, in an amount not less than Five Million Dollars (\$5,000,000).
 - 6.1.2 Liability insurance for sudden and accidental environmental contamination with minimum limits of Five Hundred Thousand Dollars (\$500,000) and providing coverage for claims discovered within three (3) years after the term of the policy.
 - 6.1.3 Automobile liability insurance in an amount not less than One Million Dollars (\$1,000,000).
 - 6.1.4 Workers' compensation and employer's liability insurance with statutory limits, and any applicable Federal insurance of a similar nature.
 - 6.1.5 The coverage amounts set forth above may be met by a combination of underlying (primary) and umbrella policies so long as in combination the limits equal or exceed those stated. If more than one insurance policy is purchased to provide the coverage amounts set forth above, then all policies providing coverage limits excess to the primary policy shall provide drop down coverage to the first dollar of coverage and other contractual obligations of the primary policy, should the primary policy carrier not be able to perform any of its contractual obligations or not be collectible for any of its coverages for any reason during the Term, or

(when longer) for as long as coverage could have been available pursuant to the terms and conditions of the primary policy.

- Additional Insured. Municipality shall be named as an additional insured on all policies (other than worker's compensation and employer's liability). All insurance policies shall provide that they shall not be canceled, modified or not renewed unless the insurance carrier provides thirty (30) days prior written notice to Municipality. Company shall annually provide Municipality with a certificate of insurance evidencing such coverage. All insurance policies (other than environmental contamination, workers' compensation and employer's liability insurance) shall be written on an occurrence basis and not on a claims made basis.
- Oualified Insurers. All insurance shall be issued by insurance carriers licensed to do business by the State of Michigan or by surplus line carriers on the Michigan Insurance Commission approved list of companies qualified to do business in Michigan. All insurance and surplus line carriers shall be rated A+ or better by A.M. Best Company.
- 6.4 <u>Deductibles</u>. If the insurance policies required by this Part 6 are written with retainages or deductibles in excess of \$50,000, they shall be approved by Manager in advance in writing. Company shall indemnify and save harmless Municipality from and against the payment of any deductible and from the payment of any premium on any insurance policy required to be furnished hereunder.
- 6.5 <u>Contractors</u>. Company's contractors and subcontractors working in the Public Right-of-Way shall carry in full force and effect commercial general liability, environmental contamination liability, automobile liability and workers' compensation and employer liability insurance which complies with all terms of this Part 6. In the alternative, Company, at its expense, may provide such coverages for any or all its contractors or subcontractors (such as by adding them to Company's policies).
- 6.6 <u>Insurance Primary</u>. Company's insurance coverage shall be primary insurance with respect to Municipality, its officers, agents, employees, elected and appointed officials, departments, boards, and commissions (collectively "them"). Any insurance or self-insurance maintained by any of them shall be in excess of Company's insurance and shall not contribute to it (where "insurance or self-insurance maintained by any of them" includes any contract or agreement providing any type of indemnification or defense obligation provided to, or for the benefit of them, from any source, and includes any self-insurance program or policy, or self-insured retention or deductible by, for or on behalf of them).

7 Term

7.1 Term. The term ("Term") of this Permit shall be until the earlier of:

- 7.1.1 Fifteen years (15) from the Effective Date; provided, however, that following such initial term there shall be three subsequent renewal terms of five (5) years. Each renewal term shall be automatic unless Municipality notifies Company in writing, at least twelve (12) months prior to the end of any term then in effect, that due to changed circumstances a need exists to negotiate the subsequent renewal with Company. Municipality shall not unreasonably deny a renewal term; or
- 7.1.2 When the Telecommunication Facilities have not been used to provide telecommunications services for a period of one hundred and eighty (180) days by the Company or a successor of an assign of the Company; or
- 7.1.3 When Company, at its election and with or without cause, delivers written notice of termination to Municipality at least one-hundred and eighty (180) days prior to the date of such termination; or
- 7.1.4 Upon either Company or Municipality giving written notice to the other of the occurrence or existence of a default by the other party under Sections 4.8, 6, 8 or 9 of this Permit and such defaulting party failing to cure, or commence good faith efforts to cure, such default within sixty (60) days (or such shorter period of time provided elsewhere in this Permit) after delivery of such notice; or
- 7.1.5 Unless Manager grants a written extension, one year from the Effective Date if prior thereto Company has not started the construction and installation of the Telecommunication Facilities within the Public Right-of-Way and two years from the Effective Date if by such time construction and installation of the Telecommunication Facilities is not complete.

8 Performance Bond or Letter of Credit

8.1 <u>Municipal Requirement</u>. Municipality may require Company to post a bond (or letter of credit) as provided in Section 15(3) of the METRO Act, as amended [MCL § 484.3115(3)].

9 Fees

9.1 <u>Establishment; Reservation</u>. The METRO Act shall control the establishment of right-of-way fees. The parties reserve their respective rights regarding the nature and amount of any fees which may be charged by Municipality in connection with the Public Right-of-Way.

10 Removal

- 10.1 Removal; Underground. As soon as practicable after the Term, Company or its successors and assigns shall remove any underground cable or other portions of the Telecommunication Facilities from the Public Right-of-Way which has been installed in such a manner that it can be removed without trenching or other opening of the Public Right-of-Way. Company shall not remove any underground cable or other portions of the Telecommunication Facilities which requires trenching or other opening of the Public Right-of-Way except with the prior written approval of Manager. All removals shall be at Company's sole cost and expense.
 - 10.1.1 For purposes of this Part 10, "cable" means any wire, coaxial cable, fiber optic cable, feed wire or pull wire.
- 10.2 <u>Removal; Above Ground.</u> As soon as practicable after the Term, Company, or its successor or assigns at its sole cost and expense, shall, unless waived in writing by Manager, remove from the Public Right-of-Way all above ground elements of its Telecommunication Facilities, including but not limited to poles, pedestal mounted terminal boxes, and lines attached to or suspended from poles.
- 10.3 Schedule. The schedule and timing of removal shall be subject to approval by Manager. Unless extended by Manager, removal shall be completed not later than twelve (12) months following the Term. Portions of the Telecommunication Facilities in the Public Right-of-Way which are not removed within such time period shall be deemed abandoned and, at the option of Municipality exercised by written notice to Company as set forth in Part 12, title to the portions described in such notice shall vest in Municipality.
- Assignment. Company may assign or transfer its rights under this Permit, or the persons or entities controlling Company may change, in whole or in part, voluntarily, involuntarily, or by operation of law, including by merger or consolidation, change in the ownership or control of Company's business, or by other means, subject to the following:
 - 11.1 No such transfer or assignment or change in the control of Company shall be effective under this Permit, without Municipality's prior approval (not to be unreasonably withheld), during the time period from the Effective Date until the completion of the construction of the Telecommunication Facilities in those portions of the Public Right-of-Way identified on Exhibit A.
 - 11.2 After the completion of such construction, Company must provide notice to Municipality of such transfer, assignment or change in control no later than thirty (30) days after such occurrence; provided, however,
 - 11.2.1 Any transferee or assignee of this Permit shall be qualified to perform under its terms and conditions and comply with applicable law; shall be subject to the obligations of this Permit, including responsibility for any

defaults which occurred prior to the transfer or assignment; shall supply Municipality with the information required under Section 3.1; and shall comply with any updated insurance and performance bond requirements under Sections 6 and 8 respectively, which Municipality reasonably deems necessary, and

- 11.2.2 In the event of a change in control, it shall not be to an entity lacking the qualifications to assure Company's ability to perform under the terms and conditions of this Permit and comply with applicable law; and Company shall comply with any updated insurance and performance bond requirements under Sections 6 and 8 respectively, which Municipality reasonably deems necessary.
- 11.3 Company may grant a security interest in this Permit, its rights thereunder or the Telecommunication Facilities at any time without notifying Municipality.

12 Notices

12.1 <u>Notices</u>. All notices under this Permit shall be given as follows:

- 12.2 <u>Change of Address</u>. Company and Municipality may change its address or personnel for the receipt of notices at any time by giving notice thereof to the other as set forth above.


13 Other items

- No Cable, OVS. This Permit does not authorize Company to provide commercial cable type services to the public, such as "cable service" or the services of an "open video system operator" (as such terms are defined in the Federal Communications Act of 1934 and implementing regulations, currently 47 U.S.C. §§ 522 (6), 573 and 47 CFR § 76.1500).
- 13.2 <u>Duties</u>. Company shall faithfully perform all duties required by this Permit.
- 13.3 <u>Effective Date</u>. This Permit shall become effective when issued by Municipality and Company has provided any insurance certificates and bonds required in Parts 6 and 8, and signed the acceptance of the Permit.

- 13.4 <u>Authority</u>. This Permit satisfies the requirement for a permit under Section 5 of the METRO Act [MCL 484.3105].
- 13.5 <u>Amendment</u>. Except as set forth in Section 2.1 this Permit may be amended by the written agreement of Municipality and Company.
- 13.6 <u>Interpretation and Severability</u>. The provisions of this Permit shall be liberally construed to protect and preserve the peace, health, safety and welfare of the public, and should any provision or section of this Permit be held unconstitutional, invalid, overbroad or otherwise unenforceable, such determination/holding shall not be construed as affecting the validity of any of the remaining conditions of this Permit. If any provision in this Permit is found to be partially overbroad, unenforceable, or invalid, Company and Municipality may nevertheless enforce such provision to the extent permitted under applicable law.
- 13.7 <u>Governing Law.</u> This Permit shall be governed by the laws of the State of Michigan.

Background

Ballistic vests have a 5-year service life. The Public Safety Department's ballistic vests have reached the end of its service life. Administration contacted our preferred uniform supplier, Nye Uniform to measure officers. Twenty-two officers required a replacement vest. Four officers require a replacement exterior carrier. Six pair of high caliber plates were replaced in the patrol vehicles.

Department policy require officers to wear a ballistic vest while serving the community. Administration will submit a request for grant funding through the Department of Justice (DOJ). The DOJ provides 50% reimbursement for each ballistic vest with a \$20,000.00 cap on the total purchase cost.

- A. **TIMING:** Any remaining balance on goods purchased under this Agreement and any related installation or other services will be invoiced upon delivery of the goods to the job site or, if installed by Seller, following substantial completion. Direct shipments from manufacturers will be invoiced upon shipment from the manufacturer. Any goods being held at Buyer's request, due to delays or otherwise, will be invoiced for product only upon Seller's receipt of same with separate invoicing for installation or other related services upon substantial completion.
- B. **PAYMENT TERMS:** Seller has the right to increase its prices at any time upon notice to Buyer to reflect any and all unusual or unforeseen increases in Seller cost, provided that any such increase shall be limited to the increase actually incurred by Seller. Buyer will not offset or recoup any claim against amounts due Seller. All invoices are due on the date noted on the related invoice. A monthly service charge of 1.5% (18% A.P.R.) will be assessed on all unpaid balances, including accrued but unpaid monthly service charges, after the invoice due date. A service charge of three percent (3%) of the invoice amount will be added to all invoices paid by credit card.
- C. **FREIGHT:** Buyer is solely responsible for any applicable freight and handling charges, including tariffs, for delivery from the manufacturer to Seller and is FOB origin. If not included in the proposal, such charges are not included in a price quotation and will be invoiced to Buyer separately after the Seller is invoiced by the carrier or manufacturer.
- D. TAXES: Buyer is solely responsible for any applicable sales, use, excise, or other taxes. If not included in the proposal, applicable taxes will be invoiced separately. If Buyer possesses tax-exempt status, a certificate of resale, or tax exemption is to be provided prior to order placement.

SELLER DISCLAIMS AND BUYER EXPRESSLY WAIVES AS TO SELLER, ALL WARRANTIES WITH RESPECT TO THE GOODS, INCLUDING BUT NOT LIMITED TO ALL EXPRESS OR IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, QUALITY, CAPACITY, OR WORKMANSHIP. NOTHING CONTAINED HEREIN SHALL DIMINISH THE RIGHT OF BUYER TO EXERCISE ALL RIGHTS AND REMEDIES AGAINST THE MANUFACTURER OF THE GOODS FOR MANUFACTURER WARRANTIES. DEFAULT: If Buyer fails to pay any amount herein provided within ten (10) days after the same is due and payable, or if Buyer fails to observe, keep, or perform any other provision of this Agreement, then Seller shall have the right to exercise any one or more of the following remedies without prejudice to such remedies as may otherwise exist at law or in equity: i) to declare the entire amount due hereunder immediately due and payable without notice or demand to Buyer; ii) to sue for and recover all payments, then accrued or thereafter accruing; iii) to take possession of the goods provided hereunder, without demand or notice wherever located, without any court order or other process of law. Buyer hereby grants free and full access to the premises and hereby waives any and all damages occasioned by such taking of possession.
- G. NO WAIVER: Seller's waiver of any right on one occasion shall not be a waiver of any future exercise of that right.
- H. **TIME FOR BRINGING ACTION:** Any action that Buyer brings against Seller that arises out of or relates to the goods and services provided by Seller to Buyer must be brought by Buyer within one year after the cause of action accrues.
- LAW: The Agreement shall be deemed entered into, and performed in substantial part, in Oakland County, Michigan. The Agreement shall be governed by and construed in accordance with the laws of the State of Michigan, without regard to its conflict of law provisions. The parties hereto agree to submit to the exclusive personal jurisdiction of the state or federal courts serving Oakland County, Michigan for the resolution of any claim or cause of action that arises from or related to this Agreement or the goods or services provided by Seller.

E. **DELAYS:** If Buyer is unable or unwilling to receive goods at the prescribed shipping site on the mutually agreed delivery date any goods thereafter stored by Seller will be at Buyer's expense until such time as Buyer is able to accept delivery. Seller shall have no obligation or liability to Buyer whatsoever for failure to ship goods by a particular date.

5. DELIVERY AND INSTALLATION

- A. **DELIVERY AND INSTALLATION:** Any contracted delivery and installation will be made during Seller's normal business hours of 7:00 a.m. to 3:30 p.m., Monday through Friday. Overtime delivery or installation performed at the Buyer's request will be subject to labor rates reflecting time-and-a-half for weekdays and double time for weekends and holidays. If applicable trade regulations require employing union tradesmen to complete the installation or delivery, any additional incremental costs will be invoiced to and paid by the Buyer. Seller shall not be liable for failure or delay in installation due to the installation site not being ready for installation. Any shipping, delivery, and performance dates are estimates only, and time is not of the essence. Seller may ship or direct shipments of all the goods at one time or in portions from time to time. Seller has the right, but not the obligation, to determine the method of shipment and routing of the goods, unless otherwise stated in Seller's delivery and installation proposal or acknowledgement.
- B. **SELLER'S RESPONSIBILITIES:** Unless received by Buyer or Buyer's agent directly, Seller will receive, inspect, stage, and if contracted, install Buyer's goods. All furnishings will be left clean and in working order. Carton and packing materials will be removed to the Buyer's waste disposal containers, and the premises will be left broom clean. At Seller's option, Seller may direct shipments directly to the job site.
- C. BUYER'S ACCEPTANCE: Buyer agrees to have an agent on the premises at the agreed upon time to accept goods, deliveries, installation, and completed work. All goods and services shall be considered accepted after Buyer or his agent has signed an acknowledgement document(s). All claims or exceptions must be made in writing the date the work is substantially complete.

 Notwithstanding the foregoing, if Buyer or Buyer's agent is unavailable or unwilling to sign acknowledgment document(s), Buyer shall be deemed to have accepted the goods and services "as is" or as otherwise noted by Seller on the acknowledgement document.
- D. **DROP SHIPMENTS:** In case of drop shipments where goods are delivered without installation, Buyer will receive, inspect, and install ordered goods. Buyer is also responsible for filing necessary freight claims in the event of damage. Buyer shall have no claims against Seller due to damage and may not withhold payment on account thereof.
- E. CONDITION OF JOB SITE: Buyer's job site shall be clean, clear of all obstructions, and free of debris prior to any Seller installation. Charges will be assessed to the Buyer for excessive handling, storage and transportation incurred because of site conditions, activity of other trades, or other reasons not specifically identified in the price quotation, at a standard hourly rate, or at actual charges plus fees, if labor is performed by a third party.
- F. JOB SITE SERVICES: Buyer will furnish electrical current, heating, lighting, trash disposal containers, hoisting and/or elevator services, and suitable unobstructed dock space and staging areas at the job site without charge to Seller if Seller is to provide installation. If Seller is required to remove or handle existing furniture, the additional cost of moving and transporting shall be billed to the Buyer on an hourly basis. Once installation has begun, Buyer agrees to assume any expense incurred by Seller due to changes made at the Buyer's request or for any reason beyond Seller's reasonable commercial control.
- G. **ELECTRICAL INSTALLATION:** A licensed electrician may be required to install electrical product including outlets, task lights, and hookups to base building power. If Seller determines that an electrician is required, Buyer will be responsible for contracting and paying the electrician.
- H. PROTECTION OF DELIVERED GOODS: Buyer is responsible for security and safekeeping of goods after delivery to Buyer's site, or into storage negotiated by Buyer if the job site is not ready on an agreed upon delivery date, and Buyer shall assume any risk of damage or loss thereof.
- CONCEALED DAMAGED GOODS: Buyer is required to report all concealed or damage packaged goods within seven (7) business days or receipt. In addition, Buyer is required to report all damage goods revealed upon unpackaging within seven (7) days of the same. Likewise, Buyer is required Buyer must send pictures of damaged goods, packages and labels to initiate any available warranty claim(s). Failure to report damages within the required reporting period with the required information may negate any warranty claims and Buyer shall accept responsibility for any and all costs associated with replacement or repairs of damaged goods.

Re: FY 2020-2021 Budget Amendments

Attached are proposed FY 2020-2021 Village of Beverly Hills final Budget Amendments.

There are General Fund amendments adjusting various revenue and expenditure accounts to estimated year end balances. Included in the amendments is an additional Local Community Stabilization Share payment received from the State and increased Constitutional State sales tax. Public Service salaries were decreased. Interfund transfers to the Capital Fund and Major Fund were increased to cover the additional accrued expenditures on the Federal Project and the additional expenditures for the Public Safety parking lot. The effect of the amendments is a net of revenue and expenditure decrease of \$77,418.

In Major Roads and Local Roads there are amendments adjusting various revenue and expenditure accounts to estimated year end balances. There are amendments increasing the contribution from General to Major and decreasing the contribution from Major to Local. Other amendments are to reflect the contribution that will be received in FY21 from the City of Southfield and the Road Commission of Oakland County on the 13 Mile Federal Road Project. The Project will be finalized and closed out in FY22. The effect of the amendments is a net of revenue and expenditure increase of \$248 in Major Roads and a net of revenue and expenditure decrease of \$107,171 in Local Roads.

In the Public Safety Fund there are various revenue and expenditure adjustments to expected actuals. Salaries and wages were adjusted downward due to unfilled positions throughout the year along with adjustments to benefits and various expenditures. Overtime was adjusted slightly upward for the continued effect of COVID and capital outlay was adjusted downward to reflect the difficulty in purchasing capital. The effect of the amendments is a net of revenue and expenditure increase of \$189,328.

In the Water Fund there are amendments adjusting capital equipment purchases and sewage and storm disposal charges to actuals. The effect of the amendments is a net of revenue and expenditure decrease of \$58,953.

In the Capital Fund there are amendments increasing the contribution from General and increasing the budget for an unanticipated repair along with site improvements at Public Safety that included the public safety parking lot. The effect of the amendments is a net of revenue and expenditure decrease of \$102,813.

These proposed FY 2020-2021 Budget Amendments have been reviewed by Village Administration and are recommended for approval.

Recommended Resolution

Be it resolved that the Village of Beverly Hills Council authorizes Village Administration to transfer or adjust monies reserved in the General, Major Roads, Local Roads, Public Safety Fund, Capital Fund and Library fund as reflected in the June 11, 2021 memorandum from Finance Director, Sheila McCarthy.

VILLAGE MANAGER'S REPORT CHRIS D. WILSON JUNE 11, 2021

Beverly Greenfield Intersection – Village Administration met with representatives from Royal Oak and the Road Commission this week to discuss preliminary design work for potential modifications to the intersection of Greenfield and Beverly/Normandy. Per the Road Commission, they are examining options to incorporate a compact or single lane roundabout at this intersection. It is their opinion that such a design could be incorporated in the existing right-of-way footprint at the intersection. The Village has requested that a storm drain outlet be incorporated into the design so that we could potentially use our adjacent land for storm retention/detention in the future. To the extent that we were waiting on potential impact on this project before proceeding with design of Park #5, I think it would be ok to proceed at this point. Any encroachment into the park area by this project would be minimal. It is anticipated that a full design and cost estimates will be ready by August or September of this year. Should all parties agree to move forward it is anticipated that construction would be in 2023.

14 Mile Rd. Funding – The Village received notification this week from the Office of Representative Andy Levin that our request for \$1.2 million in funding for 14 Mile had made it through the initial analysis and was going to committee markup. Representative Levin's office submitted twelve projects for funding and ours is one of five to make it to markup. Rep. Levin's office will keep us apprised of any further updates.

July 4th Trash Pickup – As the July 4th holiday is on a Sunday, Car Trucking has informed SOCRRA and the Village that they will continue with normal trash recycling and yard waste collection that week. Monday trash collection will occur as normal on **Monday**, **July 5th**, as will Tuesday collection on **Tuesday**, **July 6th**.

Cranbrook Rd. Construction – The Road Commission has announced that reconstruction on Cranbrook between 14 Mile and Maple will begin the week of June 14th with the road to be closed to through traffic on Thursday, June 17th. The official posted detour will be along 14 Mile to Lahser and back along Maple. Construction is expected to last through August.
