President George called the regular Village Council meeting to order at 7:37 p.m. in the Village Council Chambers located at 18500 W. Thirteen Mile Road, Beverly Hills, MI 48025. The Pledge of Allegiance was recited by those in attendance.

# SPECIAL ORDER OF BUSINESS: RECOGNITION OF PLANNING COMMISSION MEMBER, ROBERT STEMPIEN

George thanked outgoing Planning Commission Member Robert Stempien for 15 years of service on the Commission. He stated the community appreciates his experience and tenure.

Robert Stempien, Mayfair, stated that his time on the Commission went by quickly. He said the Commission has done great things over the years and he is leaving it in good hands. He said he did not seek reappointment in order to give other residents the opportunity to serve. He highlighted improvements made in Beverly Park, the Southfield Road corridor, and beautification.

George presented Stempien with a plaque from the Village.

Motion by Hrydziuszko, second by Mooney, the Beverly Hills Village Council adopts Ordinance 382 as read by the Village Attorney to take effect 20 days after publication in a newspaper circulated within the Village.

#### **REVIEW AND CONSIDER REQUEST TO PURCHASE TWO PATROL VEHICLES FOR THE PUBLIC SAFETY DEPARTMENT**

Campbell gave an overview of the request. The Public Safety Department is respectfully requesting that we replace two Patrol Tahoes with funds from the 2023 budget. The purchases would be made from Berger Chevrolet in Grand Rapids Michigan, which has the state of Michigan and Oakland County cooperative purchase bids awarded to them. The Village has purchased previously from Berger with very positive results. The cost of each vehicle is \$40,292.00 and the total bid amount would be \$80,584.00. Also included is the invoice to fit a Tahoe with the necessary equipment. The vehicle changeover cost is \$21,133.16 per vehicle, for a total cost of \$42,266.32. The funding for all costs with the purchase and associated equipment is available in Account 205-900-980.02 in FY 2023.

The new Tahoes would replace the two oldest Tahoes in the fleet which are nearing their life cycles and would be approaching 70,000. The two 2018 Tahoes to be replaced are Patrol Vehicle numbers 305 with 65,977 miles and 307 with 65,751 miles. The two decommissioned Tahoes would then be offered for sale via a used car selling and purchasing website that the department is currently utilizing to sell other decommissioned service vehicles. Resulting revenues would then be deposited into the vehicle fleet account for future vehicle purchases.

Motion by Peddie, second by Abboud, be it resolved, the Village of Beverly Hills Council awards the purchase of two (2) 2022 Chevrolet Tahoe 4WD PPV patrol vehicles in the amount of \$80,584.00 to Berger Chevrolet 2525 28th Street S.E. Grand Rapids, Michigan 49512. Village Council further approves the expenditure of up to \$42,266.32 for the vehicle changeover expenses, with the preferred vendor. Funds are available in Account #205-900-980.02.

## DISCUSSION ITEM – REQUEST FOR PROPOSALS FOR PROFESSIONAL SERVICES

- A. IT SUPPORT
- B. LEGAL

George provided an overview of the discussion item. He noted that it is a regular occurrence to publish requests for proposals for professional services. He said the personnel committee discussed this topic with the previous Village Manager and wanted to start the conversation again. He noted that all of the listed vendors/contracts have been in place for over a decade.

Mooney agreed with bidding out the services. He suggested directing Administration to research cyber security agreements and compare them with MML, the State of Michigan, the Department of Homeland Security, and neighboring communities. He stated that the legal services item should be referred to the personnel committee since the Village Attorney reports to the Council. He said that all of the current contractors are good professionals that have been serving the Village. He said that the Village Attorney and Auditors do an excellent job, but that the Village should shop around. He would like to obtain input from the Planning Commission regarding planning consultant services.

Peddie said that IT Support would be a great place to start with an emphasis on cyber security. She also noted that the auditing contract was set to expire, so that should be a priority. She cautioned against implementing too many changes at one time, especially with a new manager on board.

Hrydziuszko stated that it is important for the Council to be well educated on the services that the Village has now and what else is available. She would like to be responsible with tax payer dollars.

Abboud noted that the MML and SEMCOG often have professionals in these fields as guest speakers. He wants to be sure the Village is staying up to date on all of the required resolutions and mandates in these areas.

George commented on the RFP process and scope of services. He said that there are many templates out there, so they would not be starting from scratch.

Mooney agreed with Peddie's comment about not changing too much at once. He noted that they may not end up changing anything at all.

George and Mooney agreed that the Personnel Committee should come back to the Council with recommendations.

Motion by Mooney, second by Kecskemeti, the Beverly Hills Village Council directs Administration to research the Department of Homeland Security, State of Michigan, Michigan Municipal League, and neighboring communities' Information Technology policies for the purposes of outlining parameters for IT services and cyber security request

for proposals and to provide a comparison to the Village's current provider to the Village Council not later than September 20, 2022.

Motion passed.

Motion by Mooney, second by Abboud, the Beverly Hills Village Council directs the Personnel Committee to research and interview relevant staff, including the Public Safety Director, and any other entity it deems appropriate regarding Legal services; A Planning Commission subcommittee and other municipalities regarding Planning Consulting services; and the Finance Director, Treasurer, and Village Manager regarding auditing services, and report back a request for proposals outline to Council in a manner that the majority of the Personnel Committee deems appropriate.

#### **MANAGER'S REPORT**

Update on Village Hall Generator – Village Council approved the purchase of a generator for Village Hall in the fall of 2021. The contractor will begin setting up the necessary concrete pad and preparing the mechanical and electrical connections for the generator. That work will be completed in August. Due to supply chain issues, the generator will likely be arriving and installed this fall.

Update on DTE Outreach – Last year, Village Administration reached out to our Community Relations representative for a report on the recent storms and power outages experienced in the Village. DTE Engineers were asked to prepare a report and analysis that was to be shared with Council and the community as soon as it is available. After a recent conversation with the representative from DTE, the report should be completed in late August. The report shall cover DTE's tree trimming in the Village, upgrading the utility poles, and technologies being implemented to ensure better service to the residents of Beverly Hills.

Training Session – Department Heads will be undergoing a staff training on Thursday, August 11, 2022. The training will be from 9 a.m. to 3 p.m. Village Hall will remain open, and there will be coverage all day for any resident issues.

NEXT Survey – Next recently conducted an online survey with the public to gauge their satisfaction with Next's programming and services. The survey contained 15 questions. A synopsis of the survey results is attached to this report. The summary report specifically notes points of pride and areas that require improvements. A full copy of the survey can be obtained by calling Village offices and/or NEXT.

Mooney stated that DTE clear cuts branches away from their lines. He noted that the Pilgrim Oak at Beverly Park has been cut down and a large base remains and hopes that a sculptor or wood carver can create something with the remaining base. He inquired about the lily pads at Riverside Pond. He said he would not support dredging the pond. Campbell noted that the Interim DPW Director is looking into options regarding the pond.

Kecskemeti noted that the lily pads are native to Michigan, but their behavior is invasive. She asked about reports of theft. She asked for a summary of all auto related crimes in the Village. She said proactive outreach from the Public Safety Department would be appreciated by the community.

#### **COUNCIL COMMENTS**

Kecskemeti inquired about Riverside Pond and commented on resident opinions about lily pads and the dam. She stated that there are regulations that the Village is required to follow. She said that it is an issue that the Village will have to reckon with. She said the dam should be included in the Village's infrastructure plan.

Abboud said that he and Campbell attended SEMCOG's Water Infrastructure meeting. He said the MML Convention is coming up this fall. He reported that the Senior Advisory Committee received ARPA funding for the senior population in Oakland County. The Next meeting is next week and annual memberships cost \$45 for residents. He gave updates on the subcommittees he sits on including: infrastructure, branding/signs, police consulting, electronic signs, and short-term rentals. He stated that the office parking lot needs attention.

Mooney congratulated the new Southfield Township Treasurer, Kim Chalifoux, on her appointment. He congratulated Southfield Township Clerk Eileen Harryvan for running a successful Primary Election. He talked about Beverly Park and noted that people have different visions of what the park should be. He said Riverside Pond should be looked at and noted that the Village does not own the entire property. He commented on the buckthorn removal results and said they were less than optimal. He said buckthorn has grown back and he is not happy about it. He said the drinking fountain by the baseball fields at Beverly Park was not turned on. He asked why there are portable toilets at Beverly Park. He suggested adding more toilets, fixing the fence, improving the disc golf path, and putting in turf at Beverly Park. He said there were weeds and poison ivy at the park and he thinks it should look better.

Hrydziuszko agreed that the Village is in a tough spot regarding buckthorn removal. She said it is difficult to repopulate an area that is continually being sprayed. She said there is a lot of remaining seed base from what had been there for years. She suggested perhaps taking a step back and work on the invasive species removal in sections. She said she would take Mooney's concerns to the Parks & Recreation Board and that the Board is focused on a lot of things right now. She said there has been talk about improving the fields. She noted the Parks Board will be discussing the community survey results at their August meeting. The next Concert in the Park is on Friday, August 12<sup>th</sup> at Beverly Park. She thanked Council for a productive discussion regarding professional services at this meeting.

George said Council had a good conversation regarding RFPs and professional services and he appreciates that. He commented on job descriptions and said there is an opportunity for Administration to document tasks and responsibilities.

## <u>Contacted about a long-lost relative's</u> <u>inheritance? Hold on a minute</u>

The FTC has been getting reports of people getting letters in the mail from a law firm. They are, they say, looking for the heir of a multi-million-dollar inheritance. And they think it might be you. (Spoiler alert: it's not.)

Here's what they offer: they'll split the inheritance between you, their law firm, and some charities. One other thing: they say you have to keep this information secret and reach out to them by email — immediately.

So what's really happening? This is not a lawyer — it's a scammer. And if you email them, they'll probably try to get your personal information, like your Social Security or bank account numbers, your money — or both. And that inheritance? It doesn't exist.

#### Here's what to do if you get one of these letters:

\* Don't respond. Keep your money — and your information — to yourself. Never send money or information to a stranger who promises big rewards. That's always a scam.

\*Pass this information on to a friend. You probably throw away these kinds of letters. But you probably know someone who could use a friendly reminder.

\*Report it to the FTC at ReportFraud.ftc.gov.

#### Don't click on that random text. It's a scam

Sorry to burst your bubble. That unexpected text from the Postal Service (USPS), Costco, or The Home Depot telling you about an unclaimed package or a survey you can complete to claim a freebie is NOT from them. It's a scam.

The FTC has seen a spike in reports from people getting text messages that look like they're from well-known names like USPS, Costco, or The Home Depot and others. Spoiler alert: they're from impersonators. The details vary, but the scammers are after the same thing: your money and your personal information. You may get a text from scammers pretending to be USPS and asking you to confirm your debit card details so you can get an undelivered package. Or you might get texts about a chance to win a free gift card or a power tool. To claim your "reward," you're told to click on the link, answer some questions, and pay for shipping. Don't do it.

If you click on those links and submit your card information, you'll ending up with nothing — but you'll find unauthorized charges posted to your account.

No matter what the unexpected text says, the advice is the same.

\*Don't click on links or respond to unexpected texts including ones asking you to fill out surveys to get free items. If you think it could be legit, contact the company using a website or phone number you know is real. Don't use the information in the text message.

\*Don't pay to get a package redelivered. The real USPS won't contact you out of the blue about a delivery (unless you submitted a request first and give a tracking number) — and they'll never demand payment to redeliver a package.
