REVIEW AND CONSIDER SUBCOMMITTEES' RECOMMENDATIONS FOR APPOINTMENTS TO VARIOUS BOARDS/COMMISSION

Campbell gave an overview. Several board and commission members' terms expire on June 30, 2022. Announcements of these vacancies were made at the May 3rd and May 17th Council meetings as well as published on the Village website and in the weekly emails. Applications were due Wednesday, June 8, 2022.

Pursuant to Council policy, a subcommittee has been formed for each board/commission to review the new applicants and those members who wish to be considered for reappointment. Subcommittees met on Tuesday night prior to the regular Council meeting to meet with applicants.

The chair of each subcommittee offered a recommendation to Council for appointments.

Motion by Mooney, second by Kecskemeti, be it resolved, the Beverly Hills Village Council appoints Gilbert Gugni and Shane Henry to the Birmingham Area Cable Board for a full term beginning July 1, 2022 and ending June 30, 2025.

Motion by Kecskemeti, second by Mooney, be it resolved, the Beverly Hills Village Council appoints Sara Bresnahan to the Parks & Recreation Board for a full term beginning July 1, 2022 and ending June 30, 2025.

Motion by Peddie, second by Abboud, be it resolved, the Beverly Hills Village Council appoints Patrick Westerlund, Benjamin Wilensky, and Meagan Tessler to the Planning Commission for a full term beginning July 1, 2022 and ending June 30, 2025.

Motion passed.

Motion by O'Gorman, second by Mooney, be it resolved, the Beverly Hills Village Council appoints Susan Robbins, Jon Oen, and Christopher Michael to the Zoning Board of Appeals for a full term beginning July 1, 2022 and ending June 30, 2025.

Motion passed.

George thanked all the applicants for applying and thanked Council for reviewing the applications.

O'Gorman thanked the applicants who attended the subcommittee meetings and thanked them for sticking around for the regular meeting as well.

REVIEW AND CONSIDER FISCAL YEAR 21-22 BUDGET AMENDMENTS

Finance Director McCarthy provided an explanation for the proposed Fiscal Year 2022 Budget Amendments. In the General Fund there are revenue amendments adjusting to final property taxes received, \$12,000, amendments for building permits to adjust to a slower level of year end activity, (\$20,000), and an amendment to reflect a higher level of State Shared revenue, \$75,000, as well as other amendments adjusting to expected level of year end activity. There are expenditure adjustments to salaries, and benefits predominately relating to the open Public Service position, Interim Village Manager position and Interim Planning and Zoning position. The total salaries and related expenditure amendments are roughly \$100,000 decrease. Capital expenditures have been amended downward by \$11,000. No major General capital items were purchased in FY22. The effect of the amendments is a net of revenue and expenditure increase of \$259,027.

In the Major Road fund there are revenue amendments for additional State Shared revenue, \$25,000 and additional monies to be billed for work completed on the Federal 13-mile Road Project, \$55,000. There are also amendments to true up the estimated construction and engineering cost per HRC for final billing on 13-mile as well as engineering costs for the 14-mile Road Improvement Program. HRC is estimating we will incur (by June 30th of 2022) \$75,000 of the \$200,000 budgeted construction costs on the 14 Mile Road program. There is a \$125,000 budget amendment downward to reflect the revised construction cost estimate. There is a budget amendment to increase the 14-mile engineering cost of \$75,000 to the revised estimate of \$129,629. Other amendments adjust various line items to estimated actuals. The effect of the amendments is a net of revenue and expenditure increase of \$242,116 in Major Roads.

In the Local Road fund there is an amendment to adjust to a higher level of State Shared Revenue, \$10,000. There is an amendment to Concrete Replacement of \$26,000 for concrete work as well as an amendment of \$45,000 for engineering related to concrete projects. Winter maintenance has been decreased by roughly \$17,000 to adjust to final actuals. There are other expenditure line item amendments to adjust to estimated actuals at year end. The effect of the amendments is a net of revenue and expenditure decrease of \$10,817 in Local Roads.

In the Public Safety fund there are amendments adjusting to final property tax revenue, \$34,000, other revenue line items, (\$18,500) and an amendment for the Sale of 2 Police vehicles, \$19,000. There are amendments totaling \$230,000 reducing salaries and benefits for open positions and adjusting for forfeited terminated public safety employees Defined Contribution. Also, there are amendments to capital purchases adjusting expenditures downward by \$207,000. Due to supply issues, the budgeted capital was not able to be purchased in FY22. Capital will be purchased in FY23. The effect of the amendments is a net of revenue and expenditure increase of \$490,980 in the Public Safety Fund. In the Park Improvement fund there is an amendment to include engineering costs on the park pathway as well as Park landscaping. The effect of the amendment is a net of revenue and expenditure decrease of \$20,000.

In the Capital Fund there are amendments decreasing the budgeted capital for the generator for the administration building that will not be installed by year end and an amendment for Oakland County radio equipment that was unavailable to purchase in FY22. The net of revenue and expenditure increase is \$85,000.

These proposed FY 2022 Budget Amendments have been reviewed by Village Administration and are recommended for approval.

Council thanked McCarthy for her work preparing the budget amendments.

Motion by Mooney, second by Peddie, be it resolved that the Village of Beverly Hills Council authorizes Village Administration to transfer or adjust monies reserved in the General, Major Roads, Local Roads, Public Safety, Park Improvement Fund and Capital Fund as reflected in the June 17, 2022, memorandum from Finance Director, Sheila McCarthy for Fiscal Year 2021-2022 and the budget amendments will be posted on the Village website.

REVIEW AND CONSIDER PARKS & RECREATION BOARD'S RECOMMENDATION TO HOST A FOURTH OF JULY JAZZ EVENT AT BEVERLY PARK PAVILION

Administration received a request from Ryan Bills to add a Fourth of July Jazz performance from 6:00 to 8:00 p.m. on July 4, 2022 at the Beverly Park pavilion. Ryan Bills performs at the Java & Jazz series at Beverly Park pavilion on the third Sunday of the month from May to October. Like the others, this performance would cost \$600.00. Mr. Bills believes a jazz celebration of the 4th of July would be very appealing to residents, especially to those who regularly attend the Java & Jazz performances. It would also allow people who cannot attend the Sunday morning shows an opportunity to see an evening performance.

The Village does not take pavilion reservations on major holidays, so there is no scheduling conflict.

At their June 16, 2022 meeting, the Parks & Recreation Board recommended approval of this request.

Abboud clarified that this event would take place rain or shine.

Mooney stated that historically the Village does not reserve the pavilion for events on major holidays, but that he will support this request.

George encouraged everyone to attend the jazz events at the Beverly Park pavilion.

Motion by Abboud, second by O'Gorman, the Beverly Hills Village Council approves the request for a Fourth of July Jazz event featuring the Ryan Bills Trio at the Beverly Park pavilion from 6:00-8:00 p.m. in an amount not to exceed \$600.00. Funds are available in account #101-747-894.00 (Special Events).

MANAGER'S REPORT

Offices Closed and Trash Delay – Village offices will be closed on Monday, July 4th, in observance of Independence Day. Trash pickup will be delayed one day during the week of July 3rd. Monday trash pickup will happen on Tuesday, July 5th. Tuesday trash pickup will occur on Wednesday, July 6th.

Fireworks Regulation – As a reminder, fireworks can be legally used in Michigan on the day before, day of and day after recognized holidays until midnight. For this July 4th season, fireworks could be used on the days of Sunday, July 3rd, Monday, July 4th, or Tuesday, July 5th. Please be safe and considerate of your neighbors in the use of fireworks.

Construction Updates – Weather permitting, the Village offices have been informed that construction and traffic detours will begin on 14 Mile on next week. The estimated duration of the

project is approximately 4 months. The Pathway Project in Beverly Park work was completed last week.

New Schedule for Chipping Services - The Village started providing free curbside chipping services to residents on a trial basis beginning in May 2021. This program allows residents to place branches by the side of the road on their normal trash day. Branches are then picked up during that week by Village staff for chipping and removal. The program has been well-received, and the Village would like to continue providing this service. To prevent cost overruns, the Village will be right sizing the program. Curbside chipping will take place during the week of the 4th Monday of each month, beginning in July of 2022. The first week of curbside chipping will begin on July 25th. Please note that branches will not be chipped except on the scheduled weeks. The new schedule will be posted on the Village website, the Village Facebook page, and will also be included in the extra newsletter that is going out to residents in the next two weeks.

Street Sweeping – Street sweeping will occur on local roads this week on June 20th and June 21st.

Mooney asked if residents near 14 Mile Road were notified of the upcoming road closures. Campbell stated that they were notified.

Kecskemeti asked about right-sizing the chipping services and the street sweeping schedule.

COUNCIL COMMENTS

Peddie stated that the Planning Commission would be holding a meeting on Wednesday, June 22.

Abboud said SEMCOG's General Assembly meeting is coming up. He noted that the short term rental bill is sitting on the floor in a lame duck session. He thanked the infrastructure subcommittee for scheduling their upcoming meeting on Tuesday.

George thanked the residents who took time to apply for Boards/Commission openings. He also thanked those who sought reappointment and who continue to do the work.

The Village of Beverly Hills entered into an agreement with the Birmingham Bloomfield Community Coalition (BBCC) to provide substance abuse prevention services to its residents. The BBCC agrees to furnish such services and the Village agrees to contribute funds annually. The agreement automatically renews each fiscal year, with the amount of the annual contribution by the Village to be determined each year by Council. The BBCC has requested funding in the amount of \$1,800.00, which is the same amount as last year.

BBCC has several programs and offers many services to the community such as: Youth Action Board (YAB), Bi-annual Teen Substance Use Survey, Covey 7 Habits of Highly Effective Teens Training, Parent directed campaigns, Middle School Transitions Program, YAB 5k Event, and other substance-free community opportunities and activities.

Suggested Resolution:

Be it resolved, the Beverly Hills Village Council approves the funding request from the Birmingham Bloomfield Community Coalition in the amount of \$1,800.00 for the provision of substance abuse prevention services and authorizes Administration to sign the contract providing for this continuing community service. Please accept this letter as the Birmingham Bloomfield Community Coalition's (BBCC) funding request for substance abuse prevention services provided to the Village of Beverly Hill's residents. Our request is for \$1,800, the same amount as last year.

BBCC and its Youth Action Board are continuing to provide education, tools, activities, and support to help youth rise above life's challenges by making informed decisions about their safety, health and wellness, as well as encouraging adults to thoughtfully support them.

BBCC is continuing to focus on making inroads with the youth vaping epidemic (which has increased since school has gone back to in-person), alcohol reduction, marijuana education. We have increased our efforts to provide Narcan trainings to school personnel and community members to help aid in the knowledge of accidental overdoses, the role of fentanyl with overdoses, and how to assist a person experiencing one.

In addition, our May/June 2021 survey of 3,578 7th-11th grade students and our December 2021 survey of 3,300 8th-12th grade students in the Birmingham and Bloomfield Hills Public School Districts showed dramatically increased rates in five areas of mental health along with increased suicide ideation. Students' mental health and well-being continues to be an area of focus and concern. Overall, our goal is to be a resource that provides practical tools for our youth and families and provide programming to schools to assist them.

CONTRACT FOR YOUTH-FOCUSED SUBSTANCE ABUSE PREVENTION SERVICES

Agreement made and entered into this date _______ between Birmingham Bloomfield Community Coalition (hereinafter "the BBCC"), 1525 Covington Road, Bloomfield Hills, MI 48301 and the Village of Beverly Hills, 18500 W. 13 Mile Road, Beverly Hills, MI 48025 (hereinafter "the Village").

As a research-driven, evidenced-based, community-serving organization, the BBCC strives to provide timely, useful news, information, programs, activities, and events designed to keep parents, youth, schools, and other community members highly aware and provide opportunities to actively engage and participate in substance abuse prevention efforts.

In consideration of the premises and the covenants contained herein, the BBCC and the Village agree as follows:

- 1. The BBCC agrees to furnish to the residents of the Village of Bingham Farms (as well as residents of other communities within the Birmingham and Bloomfield Hills Public School Districts) services and programs, which, by way of illustration, currently include:
 - a. Substance-free community opportunities and activities specifically for 7th-12th grade students and their families
 - b. Youth Action Board and youth leadership development and training
 - c. Mid Action Board for 8th grade students
 - d. Parent directed campaigns, surveys, groups, and resources
 - e. Student directed campaigns, surveys, groups, and resources
 - f. Alcohol, Marijuana, Vaping, Prescription Drug, and Mental Healthy Campaigns developed by teens for teens
 - g. CHOICES Youth-led Dialogue Day for high school teens, parents and interested community members
 - h. Teen Transitions Program for 8th graders
 - i. An expanded focus on raising the awareness on teen stress, anxiety, depression, and other mental health issues
 - j. Tobacco and Alcohol Retailer Educational Visits and Synar Checks
 - k. Informational resources via the website and other social media
- 2. For such services and programs, the Village agrees to contribute the sum of \$1,800.00 to the BBCC for the July 1, 2022 to June 30, 2023 Fiscal Year.
- 3. The BBCC will furnish the Village, and the members of the Village Council, with an annual update.



- 4. This Agreement shall automatically renew each Fiscal Year, with the amount of the annual contribution by the Village to be determined each year by the Village of Beverly Hills Council, unless either party notifies the other in writing at least sixty (60) days prior to the anniversary date that it desires to modify or terminate this Agreement.
- 5. This Agreement sets forth the entire understanding between the BBCC and the Village of Beverly Hills, and cannot be changed except by a writing signed by both the BBCC and the Village. This Agreement shall inure to the benefit of and shall be governed by and construed under the laws of the State of Michigan. If any provision of this Agreement is held to be invalid or unenforceable, the validity and enforceability of the remaining provisions shall not in any way be affected thereby.

BIRMINGHAM BLOOMFIELD TEEN MENTAL HEALTH

The Mental Health, COVID, and Drug and Alcohol surveys were administered in May/June 2021 to 3,548 7th through 11th graders in Birmingham & Bloomfield Hills Public Schools (BB) to capture an accurate and timely representation of what is happening with students, identify potential mental health and substance use behaviors and beliefs, as well as track the progress of prevention efforts.

<u>Females</u> are **3.8 times more likely** to state they have <u>felt nervous, anxious, or scared</u> during the past 30 days compared to males.

High school students who reported feeling sad or depressed for several hours most or all of the time in the past 30 days were 2 times more likely to report using substances in the past 30 days than those who never or only some of the time felt sad or depressed for several hours.



Former Michigan State Police breathalyzer technician sentenced for falsifying records

A former Michigan State Police technician has been sentenced to three years of probation, with the first nine months to be served in jail, for falsifying records that showed whether police breathalyzers were giving accurate readings on blood alcohol content.

Andrew Clark, of Oxford, was convicted of two counts each of forgery of a public document, uttering and publishing and using a computer to commit a crime.

He was one of two technicians charged in 2020 with falsifying service records for diagnostics testing on DataMaster DMT instruments, also known as breathalyzers. Their company, Missouri-based Intoximeters, was contracted by Michigan State Police to test the machines to make sure they gave accurate readings.

He was convicted by a jury May 12.

Charges against Clark were initially dismissed in December 2020 by Eaton County District Court Judge Julie O'Neill, who said there was not enough evidence for the case to proceed to trial. But visiting Eaton County Circuit Court Judge David Jordon reversed O'Neill's ruling and reinstated the charges.

Police aware of issues: MSP knew of issues with breathalyzer calibrations months before fraud investigation began

Michigan State Police said they found problems with machine maintenance as early as 2019. Errors or the possibility of errors led to the dismissal of some intoxicated driving cases, including six cases in Wayne County because of unreliable evidence after Clark did not notice a Datamaster failed testing and left the machine in service for three days, according to Michigan State Police records.

"Our public integrity team continues to demonstrate the great importance of pursuing bad actors who subvert the criminal justice system and threaten the integrity of our judicial process," Michigan Attorney General Dana Nessel said in a statement. "We must show that those who undermine the public trust risk jail time in doing so."

The **other technician**, **David John**, pleaded guilty to all nine charges he faced and was sentenced to 36 months' probation, with the first nine months served in the Kalamazoo County Jail.
