President George called the regular Village Council meeting to order at 7:30 p.m. in the Village Council Chambers located at 18500 W. Thirteen Mile Road, Beverly Hills, MI 48025. The Pledge of Allegiance was recited by those in attendance.

REVIEW AND CONSIDER PARKS & RECREATION BOARD'S RECOMMENDATION TO CONTINUE SCULPTURES IN THE PARKS PROGRAM IN 2023

Campbell provided an overview. 2022 marked the inaugural year for the Sculptures in the Parks Program. The program has received a great deal of positive feedback. The Sculptures in the Park program also came in under budget. At the August 25, 2022 Parks & Recreation Board meeting, the Board discussed the 2022 program. It was noted in the recent survey conduct by the Parks & Recreation Board that 77% of people responded "yes" or "maybe" when asked if they would seek

out sculptures in the park. The Board voted to recommend that the Village Council approve its request to continue the Sculptures in the Park program in 2023 in an amount not to exceed \$7,000.

Janice Hausman, Parks & Recreation Board member, was in attendance and provided a recap of the 2022 Sculptures Program. She talked about the five sculptures currently on display. She noted that someone already expressed interest in purchasing one of the sculptures. She said that she reached out to many artists directly to participate in the program and she thinks that was a good motivator for them to apply. She does not think it will be necessary next year to pay to advertise online to recruit artists. She stated that each sculpture has a sign with a QR code that links to the Village website, so people can learn more about the sculptures and artists.

Mooney said he was impressed with the program. He asked if there was any thought to include Beverly Green as a location. Hausman confirmed that Beverly Green will be included as a site for a sculpture in the future.

Abboud stated that Hausman and the Board did a wonderful job. He thanked Hausman for her efforts. He said he was in favor of more pieces and asked if the current artists would be able to resubmit next year. Hausman stated that current artists would be able to submit additional applications.

O'Gorman complimented Hausman for getting this project off the ground. He said it exceeded his expectations. He said the Village should socialize the sculptures' availability for purchase.

George said he was a huge fan of the Kestrel sculpture at Beverly Park.

Mooney stated that a \$7,000.00 budget might be too light.

Motion by Hrydziuszko, second by Mooney, be it resolved, the Beverly Hills Village Council approves the Parks and Recreation Board's request to continue the Sculptures in the Park program in 2023 in an amount not to exceed \$7,000.00. Funds for this request are available in 208-900-985.00 (Capital Park Improvement Fund)

DISCUSS POTENTIAL SCOPE OF CYBER SECURITY SERVICES AND ASSESSMENT TO BE PROVIDED TO THE VILLAGE OF BEVERLY HILLS

Campbell provided an overview. At its August 2, 2022 meeting, the Village Council requested that the Administration do research on cyber security measures recommended and/or used by neighboring jurisdictions, the Department of Homeland Security, and other local governments prior to the Village of Beverly Hills going forward for an Request for Proposal (RFP). Data breaches are more costly than ever. Approximately 51% of organizations reported a significant business disruption in 2019-2020. Cyber security is up 600% due to COVID-19. The average time to identify and contain a breach is 287 days. It is not a question of will we have a breach, it is a question of when. Currently, Robert Ferkel, of Enterprise Computer Solutions, manages the Village of Beverly Hills IT department. Campbell went over the basic inventory of the Village's existing system.

After doing the research Council requested, the Administration believes there are two viable options when creating an RFP for the cyber security services to be provided to the Village of Beverly Hills:

- 1) Independently move forward with an RFP that the Village creates using resources provided by our insurance provider and other potential resources;
- 2) Utilize a preapproved State vendor that provides core cybersecurity services or create an RFP that tailors these core cyber services to the Village of Beverly Hills.

Campbell went over the options and vendors in more detail as outlined in his September 15th memo to Council. He noted that MMRMA has various articles on what types of threats that local governments should consider when developing a cyber security RFP and protocol. MMRMA's Technology and Cyber Security Risk Control Advisory Committee developed a framework for best practices that could be added to a potential RFP or Request for Qualifications. MMRMA also has grants available to offset the cost.

Peddie commented on tailoring the services to fit Beverly Hills.

Kecskemeti thanked Campbell for the research on this topic. She clarified that the recommendations would be in addition to the current vendor. She asked if the distance or location of the vendor is a factor in the decision making.

Mooney stated that the Village should not nickel and dime on this selection. He suggested Southfield Township defray some of the costs and that the Village Manager should talk with the Township Supervisor, Clerk, and Treasurer. He said cyber security is a priority and the Council should move quickly on this. He said training and vetting should take place for any Village employee or contractor that uses the system. He suggested that the Council instruct Administration to move forward with the suggestions he outlined.

O'Gorman suggested the Village collaborate with Southfield Township, Bingham Farms, and Franklin. He agreed with Mooney's suggestion regarding employee training.

Abboud agreed that better cyber security is needed. He asked if the Village's insurance covers cyber crimes and Campbell said that MMRMA covers some.

George stated that he is not concerned about where the vendor is located since most of the work is done remotely, but understands the benefit of the vendor having a Michigan presence. He spoke about the assessment procedure as outlined in Exhibit A in the Council meeting packet. He requested that Administration ask for sample work plans from the vendors.

It was the sense of Council to proceed quickly with increasing the cyber security for the Village.

Motion by Mooney, second by Hrydziuszko, the Beverly Hills Village Council instructs Administration to move swiftly and meet with Southfield Township, Bingham Farms, and Franklin to discuss collaborating to implement a cyber security plan. If the neighboring communities are not interested in collaborating, Administration is instructed to proceed in order to protect the Village of Beverly Hills. Further, the Council instructs Administration to obtain samples of workplans from cyber security vendors, look into grant opportunities

from MMRMA, plan to provide training for Village staff and contractors, and report back to Council by the second meeting in October.

Motion passed.

DISCUSS THE VILLAGE OF BEVERLY HILLS' POTENTIAL ENGAGEMENT WITH THE MICHIGAN ECONOMIC DEVELOPMENT CORPORATION'S REDEVELOPMENT READY COMMUNITIES PROGRAM

Campbell provided an overview of MEDC's Redevelopment Ready Communities Program. He had a conversation with Elizabeth King, the Region 10 Planner with Michigan Economic Development Corporation (MEDC), who oversees the Redevelopment Ready Communities program for the MEDC. The Village of Beverly Hills previously started to begin the engagement process to become certified as a RRC community. Due to various staff turnover in the process, the Village did not complete the engagement process.

The Redevelopment Ready Communities (RRC) program is available to communities across the state. It is a voluntary, no-cost certification program designed to promote effective redevelopment strategies through a set of best practices.

The program measures and then certifies communities that integrate transparency, predictability, and efficiency into their daily development practices. The RRC certification is a formal recognition that your community has a vision for the future - and the fundamental practices in place to get there.

The four-step process to begin engagement is as follows: 1) Education – there are best practice trainings. Campbell has already attended all the RRC courses. To assist the Administration, the newly appointed Planning and Zoning Administrator would attend these classes. Council and Board members can now take the courses online as well. 2) Pass a resolution of intent – see attached sample resolution from Mount Clemens. 3) Send the Resolution to the Region 10 Planner 4) Enter a Memorandum of Understanding provided by the MEDC.

Administration is inquiring as to whether Council wants the Administration to engage in the RRC program and present a resolution of intent at a future meeting.

George stated that it would be beneficial to get assistance with planning and developing the Southfield Road Corridor and have that be advertised to developers.

Mooney asked if there were any costs to the Village to participate. Campbell stated that there are no up-front costs to join. Mooney clarified that any additional expenses would come before Council for approval.

Hrydziuszko said the RRC Program would provide the opportunity for networking and to grow the community. She was in favor of continuing forward.

George stated that it was the sense of Council to have Administration prepare the necessary resolution to be voted on at an upcoming meeting.

PUBLIC COMMENTS

Karen Gilbert, Amherst, suggested obtaining an RFP from Plante Moran for cyber security services.

MANAGER'S REPORT

Public Meeting on Greenfield and Beverly Road Roundabout – Prior to finalizing its plans for the roundabout the Road Commission of Oakland County is planning at Greenfield and Beverly Road, the Road Commission just informed us they are scheduling neighborhood meeting on Tuesday, October 18, 2022 from 4 p.m. to 7 p.m. The meeting will be held at the Royal Oak Senior Center. The Road Commission will be producing an informational flyer about the project/meeting. The flyer will also be sent out to residents in the next few weeks. The Village will post the flyer on its website and Facebook page. The Royal Oak Senior Center is located at 3500 Marais Ave, Royal Oak, MI 48073. Interim Director Tom Trice and Director Neil Johnston will be attending.

ARPA Project Going Out to Bid – Earlier this year, the Village approved an infrastructure project to replace water main at Marguerite Street and Hummel. The funding for the project is to come from the American Rescue Plan Act funding awarded to the Village of Beverly Hills in the amount of \$1,085,09.09. The estimated cost of the project is \$490,350.00. The engineers, HRC, do not anticipate that the project will be much more than the estimated cost. The project is scheduled to go out to bid this week and will be published on BidNet/MITN as well as the Birmingham Eccentric.

Hrydziuszko asked that the address and a map to the RCOC meeting be posted before the October 18th meeting.

O'Gorman asked for an update on the 14 Mile Road construction project. Campbell stated that it is unlikely that the contractors will be finished by September 27 despite hiring additional crew members. Since it will go beyond the expected completion date, the damage clause of the contract will be implemented.

Mooney commented about the Beverly Park pavilion chimney, Code Enforcement's budget, and posted permits for construction projects.

Kecskemeti clarified that the RCOC meeting would be an open house style meeting and asked about the notification for the meeting. Campbell confirmed this information will be shared once it becomes available.

COUNCIL COMMENTS

Abboud will be attending SEMCOG's upcoming infrastructure meeting. The Senior Advisory Committee is working on a blueprint for aging. He encouraged everyone to attend Next's fundraising event on October 20, 2022. He noted that the Next golf outing netted \$26,000 to go toward senior services.

Mooney stated that he and Abboud played in the Next golf outing. He stated it is not appropriate to be communicating electronically during public meetings.

Hrydziuszko stated that the Parks & Recreation Board is wrapping up their work on the 5-Year Recreation Plan and the draft will be made available soon.

George attended the last Parks & Recreation Board meeting and said that the community survey results indicated that people would like the baseball fields at Beverly Park improved. A representative from the Beverly Hills Little League attended the meeting as well and said a complete upgrade would cost between \$5-6 million, which was a lot more than George expected. The Parks Board will continue to have a conversation with BHLL. He applauded their enthusiasm but does not think it the upgrades would be to that scale. He said the Council had a good discussion at tonight's meeting.

Dear President George,

On behalf of the Three Flags Chapter of the DAR, I would like to request that as you so kindly did in 2021, a proclamation be made by the Village of Beverly Hills for the celebration of Constitution Week, September 17th through the 23rd 2022.

2022 marks the two hundred and thirty-fifth anniversary of the drafting of the Constitution of the United States, our nation's foundation document. In 1955, the Daughters of the American Revolution petitioned the United States Congress for the establishment of a week long observance of the September 17, 1787 signing of the Constitution by the delegates to the Philadelphia Convention. This observance was signed into law by President Eisenhower in 1956. HVAC Replacement at Department of Public Works Building

Background – The Department of Public Works office, breakroom, and restroom are heated separately from the main areas of the DPW building. The week of September 19, 2022 the electrical system had a major failure which caused the aged heating system to overload, nearly causing a fire in the structure.

Proposal - We have been in contact with Johnson Thermol Temp, Inc. and asked for a proposal (see attached) to replace the damaged HVAC and electrical systems.

Johnson Thermol has proposed to remove the existing heat and air conditioning units and install one Mitsubishi heat pump system, two 9,000 btu system heads, one 6,000 btu system head, and all the electrical and plumbing necessary to make these upgrades to the DPW office, breakroom, and restroom. The price of this project is \$14,750.00, with 50% due as a deposit and 50% due upon completion.

Recommendation – With temperatures dropping we find this project a priority and would like to complete it before the winter months. Funds are available in account 101-900-982.00. It is staff's recommendation to approve the agreement as proposed.

Recommended Resolution:

Be It Resolved that the Beverly Hills Village Council approves the proposal from Johnson Thermol Temp, Inc. To install the agreed upon heating and cooling system at the Village of Beverly Hills Department of Public Works Building. The cost totaling \$14,750.00.

Funds are available in 101-900-982.00.

Street Sweeping Contract Extension

Background - Street seeping is an essential service in the Village of Beverly Hills. The Clean Water Act (CWA) requires that municipalities meet minimum standards of sweeping to reduce the debris that enters the stormwater system from the streets. A sweeping program is also required by the Stormwater Pollution Prevention Initiative (SWPPI) through the State. The Village is in an even more precarious situation in that the majority of the curbed streets are in the combined sewer area.

In reviewing the operations of the Village, I noted that the current contract to sweep the Village streets is set up to meet the bare minimum requirements of the CWA of two sweeps per year of its local streets, 31.35 curb miles. However, the major streets receive 4 sweeps per year, 3.25 curb miles.

The current contract with G&M was first bid in 2014 and has been extended through 2024. It was extended twice, most recently in 2019. See attached.

Proposal - I have been in contact with the owner of G&M Enterprise LTD. and asked for a proposal (see attached) to increase the local street sweeping to match the major street sweeping in an effort to keep as much debris out of the combined sewer system in an effort to reduce basement flooding in the future. Granted, this is a minor debris removal from the combined sewer system, but the effort will help to improve the system and decrease the pollution in the environment.

G&M has proposed to increase their sweeps on local roads by two annually, or a total of four sweeps, this will match what they do on the major roads. The price per sweep will not increase and will match the price they have been doing the sweeping for since 2017, \$2,978.75/sweep. No unit price increase. The total increase in the agreement will be \$5,956.50.

Currently our annual cost for sweeping is \$5,956.50 for locals plus \$3,718.50 for majors which equals \$9,675.00/year.

The proposed annual cost for sweeping is \$11,913.00 for locals plus \$3,718.50 for majors which equals \$15,631.50/year. An increase of \$5,956.50.

This will provide a spring sweep in April, a sweep in June, a sweep August and a fall sweep prior to October 15.

The proposal also extends the contract through the 2030 sweeping season at the unit current prices.

Recommendation - A street sweeping program is required by the approved SWPPI permit, and the CWA, and must be performed to be in compliance with the permit. Increasing the number of sweeps will reduce the debris in the stormwater system improving the environment and working to curb flooding in the combined sewer area. Funds are available in 202-463-932.01 and 203-463-932.01. It is staff's recommendation to approve the additional sweeps and extend the agreement as proposed.

Recommended Resolution:

Be It Resolved that the Beverly Hills Village Council approves the proposal from G&M Enterprises LTD. To increase the Local Street sweeping in the Village of Beverly Hills from two per year to four per year utilizing the same unit prices that were approved in 2017. The additional sweeps will increase the total costs by \$5,956.50 annually. For a total cost of \$15,631.50/year.

Be It Further Resolved that the Beverly Hills Village Council approves the proposal from G&M Enterprises LTD. to extend the current agreement for street sweeping through the season of 2030.

Funds are available in 202-463-932.01 and 203-463-932.01.

On Wednesday, April 2, 2014, the Village opened sealed bids for the annual major and local street sweeping needs. Bidders were asked to quote on a three-year program for 2014, 2015 and 2016. Present at the bid opening were the Village Manager and the Assistant Manager/Village Clerk. Attached are the bid specifications and a copy of the bids received.

Also attached is the bid tabulation for the 2014, 2015 and 2016 seasons. Two contractors bid on this service, G & M Enterprises from Southfield and Brock Sweeping, Inc. from Riverview. G & M was the low bidder at \$3,225 for each year and a total contract cost of \$9,675. Comparatively, Brock Sweeping quoted \$7,140 for each year and a total contract cost of \$21,420. Brock has provided the Village's street sweeping services for the past eight seasons.

A street sweeping program is required through the Village's state approved Storm Water Pollution Prevention Initiative (SWPPI), therefore it must be performed in order to be in compliance with the permit. Funds are available in the proposed FY 2014/15 budget in account numbers 202-463-776.70 and 203-463-932.01.

Recommended Motion:

The Beverly Hills Village Council awards the 2014, 2015 and 2016 street sweeping contract to G & M Enterprises, 19614 W. Eight Mile Rd., Southfield, Michigan for a total contract cost of \$9,675.00.

Explanations desired by bidders shall be requested of the Engineer in writing and, if explanations are necessary, a reply will be made in the form of a bulletin, a copy of which will be forwarded to each bidder whose work is affected.

Bulletins issued to bidders prior to date of receipt of proposals shall become a part of the specifications, and all proposals shall include the work described in the bulletins.

No inquiry received within four (4) days of the date fixed for the opening of bids will be given consideration.

Failure of the Engineer to send, or of the bidder to receive, any such interpretations shall not relieve the bidder from obligation under his bid as submitted.

RIGHT TO ACCEPT, TO REJECT, AND TO WAIVE DEFECTS

The Owner reserves the right to accept any proposal, to reject any or all proposals, and to waive any defects or irregularity in the proposal if it appears advantageous to the Owner to do so.

Each bidder agrees to waive any claim it has or may have against the Owner, the Architect/Engineer, and their respective employees, arising out of or in connection with the administration, evaluation or recommendation of any bid.

TIME OF COMPLETION

The Owner and individual citizens of the municipality affected by this work are vitally concerned with the prompt completion of the work together with the cleanup and restoration.

The Contractor shall use sufficient labor and equipment to complete and place in service all of the work being constructed within this contract within the time specified in the proposal. The surface cleanup shall follow closely behind construction with spoil removed from lawns.

If the Contractor shall be unavoidably delayed in beginning or fulfilling this Contract by reason of excessive storms or floods, or by Acts of Providence, or by strikes, or by court injunction, or by stopping of the work by the Owner because of any emergency or public necessity, or by reason of alterations ordered by the Owner, the Contractor shall have no valid claim for damages on account of any cause or delay; but he shall in such case be entitled to such an extension of the above time limit herein, as the Engineer shall adjudge to be just and reasonable; provided, however, that formal claim for such extension shall be made in writing by the Contractor within a week after the date upon which such alleged cause or delay shall have occurred.

HOLD HARMLESS

The successful bidder shall save harmless, represent, defend and indemnify the Village of Beverly Hills, County of Oakland and its officers and employees, against any and all claims for damages to public or private property, for injuries to person, or other claims arising out of the performance or non-performance of the contracted work whether during the progress or after the completion thereof.

FAIR EMPLOYMENT PRACTICES

Section 4 of the Fair Employment Practices Act PA 1955, No. 251, provides:

Section 4. Every contract to which the State or any of its political or civil subdivisions is a party shall contain a provision requiring the Contractor and his subcontractors not to discriminate

against any employee or applicant for employment, to be employed in the performance of said contract, with respect to his hire, tenure, terms, conditions, or privileges or employment, or any matter directly or indirectly related to employment, because of his race, color, religion, national origin or ancestry. Breach of this covenant may be regarded as a material breach of the contract.

Section 4A of the Act provides:

Section 4A. Every contract with the State or any of its political or civil subdivisions is a party shall contain a provision requiring the Contractor and his subcontractors not to discriminate against any employee or applicant for employment to be employed in the performance of such contract with respect to his hire, tenure, terms, conditions or privileges of employment because of his age or sex, except where based on a bona fide occupation qualification.

ASSIGNMENT OR SUBLETTING OF CONTRACT

In the execution of the Contract it may be necessary for the Contractor to sublet part of the work to others, however, the Contractor shall not award any work to any subcontractor without prior written approval of the Village, which approval shall not be given until the Contractor submits to the Village a written statement concerning the proposed award to the subcontractor, which statement shall contain such information as the Village may require.

The Contractor shall be fully responsible to the Village for the acts and omissions of his subcontractors and of persons either directly or indirectly employed by them, as he is for the acts and omissions of persons directly employed by him.

Nothing contained in this Contract shall create any contractual relation between the subcontractor and the Village.

The Contractor shall not assign, transfer, convey or otherwise dispose of this Contract or any part thereof, or his right, title or interest in the same of any part thereof, without the previous consent in writing of the Village. The Contractor shall not assign by power-of-attorney, or otherwise, any of the monies due or to become due and payable under this Contract, without the previous consent in writing of the Village.

CONTRACTOR INSURANCE REQUIREMENTS

The Contractor shall not commence work under this Contract until he has obtained the insurance required under this paragraph, nor shall the Contractor permit any subcontractors to commence work on the subcontract until the insurance required of the Subcontractor has been so obtained. Contractor shall submit, to the Village, one original and two (2) copies of Certificate of Insurance and/or Policy as proof of coverage with carriers acceptable to the Village.

The following shall be procured and maintained during the life of this Contract:

Worker's Compensation Insurance. The Contractor shall procure and maintain during the life of this contract, Worker's Compensation Insurance, including Employer's Liability Coverage, in accordance with all applicable Statutes of the State of Michigan.

INSUFFIECIENCY OF SURETIES

Should the Village at any time deem the Sureties under the contract to be unsatisfactory, and they so notify the Contractor, the contractor shall furnish forthwith in substitution new Sureties acceptable to the Village. No further payment shall be deemed due or shall be made until the new Sureties shall qualify and be accepted by the Village.

SERVICE OF NOTICE

The address given by the Contractor in the Proposal is hereby designated as the place where all notices, including letters and other communications shall be served, mailed or delivered. This place may be changed at any time by the Contractor by written notice to the DPS Director. Nothing herein contained shall preclude or render inoperative service of any notice upon the Contractor, by delivering it to him personally or by serving notice to his agents or representative

When, in the opinion of the DPS Director the work or any part of the work to be done under this Contract has been abandoned, is unnecessarily delayed, or cannot be completed at the rate of progress, or within the time specified, or the Contractor is willfully violating any of the covenants of this Contract or is carrying it out in bad faith, or has been adjudged as bankrupt, or if he should make a general assignment for the benefit of his creators, then the Engineer shall so certify in writing to the Village, and the Village in writing may declare the Contractor in default and so notify him to discontinue the work. The Village may then call upon the Sureties to complete the work, or any complete it by other means. The Village may take over and use materials and equipment at the site of the work, and other materials and equipment used elsewhere for the work at the time of default, and may procure other materials, equipment and all else necessary for the completion of the work. How Your New Smart TV is Affecting Your Privacy

September 7, 2022

Summary: Smart TVs may be convenient, but it's likely that they are harvesting personal information. The good news is there are ways you can limit the data they collect.

Smart TVs are collecting your personal data through means you may not be aware of.

It may be well known that many smart devices are recording personal data as you use them throughout the house, but one device that seems to be overlooked is your smart TV. While they are not obtaining information in the same sense as devices that are able to listen to your conversations or record your internet search activity, this hasn't stopped them from collecting plenty of data points.

One example: In 2017, Vizio was caught recording data on their customers without their consent or knowledge, leading to a \$2.2 million settlement. Although that case may have been more extreme than most, there are still legal ways in which smart TVs are collecting data, some of which can be quite invasive.

Smarter than you think

The primary method of Smart TV data collection is through a built-in technology called ACR (Automatic Content Recognition), which extracts information about your viewing habits. This technology can access what you're watching, when you're watching it, and your provider information. If you use your smart TV to access services outside of cable TV such as the internet, it can collect information from those sources as well.

Any personal information that TV companies collect can then be sold to companies to tailor content and personalize ads. This is no different than other smart devices selling your information to third parties and data brokers, but because TVs can record data that other devices can't, such as viewing habits, it further increases the invasion upon your privacy.

How to outsmart them

You don't have to go find a used TV from the 90s to take back your privacy. The first thing you can do is disable ACR, which can usually be done in the setting of your TV. This will only limit the amount of data being collected, not stop the collection all together.

Smart TVs connect to the Internet through the same Wi-Fi connection as your computers and mobile devices, so the best protection is to have good security on your home network. If you are still concerned about giving your smart TV access to your information, you can connect other devices that are easier to secure, such as a laptop with a VPN or gaming console to your TV to stream shows and movies. Small steps such as these allow you to regain some control over your data privacy, while still allowing you to access the streaming services you love.

As companies continue to come up with new ways to harvest your data, it's important to protect your data when you can. Safe practices such as the ones listed, coupled with a privacy protection plan, remain the best way to protect your personal information from companies and bad actors.

Geo tracking Puts Your Privacy at Risk. Here's How You Can Protect Yourself

Summary: Using your phone or other digital devices can reveal your physical location via a practice called geo tracking. It can be a serious privacy-protection issue. Not only can your location and similar data be sold to advertisers and other third parties through data brokers, it can wind up for sale on the dark web. Take steps to minimize the risks to your geo data.

Your physical location is a data point that can be sold to advertisers, or exploited by scammers and stalkers

Did you know that apps, websites, and devices have "eyes" on the exact spot you're occupying right now? And that your specific physical location and history, known as geo data, are part of a personal data profile that's not only being sold to advertisers, but are potentially being exposed to scammers and other malicious actors?

It's a practice called geo tracking, in which third parties trace your precise location using your device's IP address, your Wi-Fi or cellular signal, and more. Depending on the level of privacy protection you've got in place, its likely happening in the background whenever you visit various websites, use popular apps, or simply have your device open. Make sure you're protecting yourself against this potential risk to your privacy and identity.

How geo tracking can be helpful

To be clear, geo tracking is in some ways useful to our daily lives. For example, it enables certain apps to deliver necessary services, such as ride-share apps using your location to help their drivers find you. Similarly, your device's operating system can employ location tracking to deliver its own important services—think of the "Find My Phone" feature—or improve your experience when using the device manufacturer's products.

How geo tracking is used for unwanted purposes

The privacy risks with geo tracking, however, are real. Many websites and apps record your location and other personal data to create a profile of you, which can then be sold to advertisers and other third parties via so-called data brokers or "people search" sites. The stated purpose of this datagathering is to bring you targeted advertising—it's why, for example, you might see online ads for banks or restaurants in your neighborhood.

You may or may not find this type of pinpoint targeting to be intrusive. The bigger privacy issue is that some untrustworthy apps may be utilizing geo tracking for nefarious means, like spying on your activities and movements. Scammers and stalkers may be using geo tracking to determine your precise location for the purpose of stealing your identity, or worse.

Different groups face varying kinds of geo tracking risks. For instance, people who use the same devices to connect to both their home and work networks must manage the privacy risks to both themselves and their employer. Children, meanwhile, face risks when they or their parents post geo-tagged videos or images of the child on social media, potentially allowing the child's activities to be tracked, or revealing the child's location to those who wish them harm.

How to limit the amount of geo data that's collected on you

The good news is that you can take practical steps to improve your privacy protection and limit the amount of personal geo data being recorded and sold. A few quick tips:

On your phone, go to your privacy settings and deactivate location services for any app that doesn't absolutely need it.

If you do allow an app to track your location, change the settings if possible so that the tracking can only occur when you have the app open.

To avoid spyware and other forms of malware, download apps only from trustworthy sources.

For social media, choose the strictest privacy settings that you feel comfortable with. Also, before you take pictures or videos that you plan to post to social media, turn off any geotag settings on your phone.

How to get comprehensive data protection

The best way to minimize the risks of geo tracking and other data-tracking practices is to consider a comprehensive privacy and identity protection plan like the ones offered by IDX. 4) Think before you click.

How Much Privacy Protection Do Internet Browsers Offer?

Summary: Here's an overview of the four most popular internet browsers and some of the privacy protection features they offer. Regardless of which browser you use, note that you still face the risk of having your personal information placed for sale on data broker sites, or compromised and sold on the dark web. The best way to safeguard your personal data is to establish a privacy protection plan.

Chrome, Edge, Safari, and Firefox each offer unique privacy and security features. Is it enough?

When you're browsing the web on your desktop or mobile device, chances are you're using one of the "big four" browsers. Ranked in order by their number of total active users, they are: Google Chrome, Microsoft Edge, Apple Safari, and Mozilla Firefox.

The parent companies of the "big four" recognize how concerned you are about protecting your privacy and identity,

which is why they've been offering new features designed to protect your personal information and limit the amount of data captured when you browse the web.

But no matter how seriously these browsers are taking your privacy, know that no web browsing can truly be considered 100% private. In general, the big browsers aren't able to provide all of the protections you need, especially if your data winds up for sale on so-called data broker sites, or if your information becomes compromised and is placed for sale on the dark web where cybercriminals lurk.

Let's take a look at the four most popular internet browsers to see what they offer in terms of protecting your data, including key privacy settings. And we'll examine what you can do to help fill in any privacy gaps when using them.

Google Chrome

According to Stat Counter, Google's Chrome is by far the most popular desktop web browser. While Chrome doesn't have a particularly robust suite of built-in privacy features, it does offer some data protections, such as Safe Browsing, in which you're alerted if the website you're visiting could be harmful to your device or data. Additionally, Chrome uses open-source architecture; this makes it easier for third-party developers to offer extensions that can be added by users for enhanced privacy.

Be aware of tracking cookies, which currently underpin digital advertising, when using Chrome. In 2020, Google had announced a plan to phase out third-party cookies in Chrome, but that plan has been pushed to 2024.

Microsoft Edge

Microsoft Edge comes standard for Windows users, and is compatible with Windows 10 and above, as well as Mac OS and Linux. It receives mixed reviews in terms of user privacy. However, Edge is continually adding new features, and it currently offers safeguards such as a tool called Windows Defender SmartScreen, which automatically blocks suspicious websites and downloads.

While Edge offers the ability to send Do Not Track requests to websites, it can't guarantee that those sites won't track your activities even after the Do Not Track request is sent.

Apple Safari

Apple's native browser, Safari, gets generally good reviews when it comes to user privacy. For example, it offers a tool called Intelligent Tracking Prevention, designed to prevent third-party providers from tracking you across the web. It also offers the ability to hide your device's IP address from trackers, and gives you the option to manually delete cookies.

Among Safari's potential drawbacks: It offers only a limited number of third-party extensions, giving you fewer options for privacy add-ons. Also, Apple no longer makes Safari compatible with operating systems outside of its own, so if you run Windows or Android, you can only download an outdated, unsupported version of Safari, which is not ideal for security reasons.

Mozilla Firefox

Firefox gets strong reviews overall for its privacy features, including Enhanced Tracking Protection. According to its parent company Mozilla, Enhanced Tracking Protection "blocks trackers that follow you around online to collect information about your browsing habits and interests without breaking site functionality."

Should your data wind up on "people search" (data broker) sites, Mozilla does offer a tool that allows you to request data removal. However, unlike IDX's Forget Me tool, which removes users' data profiles from more than 100 data broker sites automatically and continuously, Mozilla's data-removal tool does not automatically keep removing your data if or when it reappears on those sites; you'll need to make a new removal request each time this happens.

How to enhance your protection, regardless of browser

The bottom line: Each of the four major browsers offers at least some basic level of privacy protection. However, if you're serious about your privacy, and want to take extra measures to ensure that your data profile doesn't end up in the wrong hands, consider adding a comprehensive privacy protection

plan like the options available through IDX. These plans include features built around the early detection of breached information as well as continuous removal of data from unwanted websites. Designed for compatibility with all major desktop and mobile browsers, the IDX tools include:

CONNECTING OAKLAND COUNTY THROUGH LOCAL TRANSIT SOLUTIONS

On Nov. 8, 2022, voters will be asked to consider a 10-year, .95 mill measure to maintain and expand public transit services, connecting people and communities across Oakland County.

WHAT IS OAKLAND TRANSIT?

- The Oakland Transit millage will expand and maintain existing public transit services, including transportation provided by the SMART bus system, Western Oakland Transportation Authority, North Oakland Transportation Authority and Older Persons Commission in the Rochester area.
- The millage funds new service to key areas, including major employment centers, healthcare campuses and local colleges and universities.
- The millage will expand reservation-based service – flexible transportation for seniors, people with disabilities, and veterans who need to make essential trips, such as doctor's appointments and grocery shopping.
- The millage will expand app-based service on-demand transportation open to the general public, using small vehicles.
- Funds from the millage will support transit services that specifically benefit Oakland County residents and businesses.
- Local service details will be developed collaboratively with members of the public, community organizations, transit providers, local governments and county leadership.

SERVING OAKLAND COUNTY

The Oakland Transit millage will connect residents to jobs, medical care, schools, shopping, and other essential destinations.

Millage funds will be distributed to **local transit providers in Oakland County** to continue existing services and expand transportation options, including:

- SMART
- North Oakland Transportation Authority (NOTA)
- Western Oakland Transportation Authority (WOTA)
- Older Persons Commission (OPC) in the Rochester area



The Oakland Transit millage will appear on all Oakland County ballots on Nov. 8 and will serve as the replacement for the SMART millage levied in 24 communities across Oakland County.
