#### ROLL CALL/CALL TO ORDER/PLEDGE OF ALLEGIANCE

President George called the regular Village Council meeting to order at 7:30 p.m. in the Village Council Chambers located at 18500 W. Thirteen Mile Road, Beverly Hills, MI 48025. The Pledge of Allegiance was recited by those in attendance.

#### AMENDMENTS TO AGENDA/APPROVE AGENDA

Motion by Mooney, second by Abboud, to amend the agenda to add item 9a to discuss protocol for the Special Meeting and item 9b to discuss criteria to consider for the Council applicants.

Motion passed.

Motion by Mooney, second by Hrydziuszko, to approve the agenda as amended.

Motion passed.

#### **COMMUNITY ANNOUNCEMENTS**

None.

#### **PUBLIC COMMENTS**

Matthew Kent, Allerton, stated that the Beverly Park portable toilets were moved near the baseball fields across the street from his house. He said they are not being used as much and asked that they be relocated.

Tim Luke, Nixon, said that his daughter is in a forestry program and they conducted a tree inventory of Beverly Park. He provided a handout to Council of 644 trees and went over their observations. He also passed out a handout about Freedom of Information Act, social media, and the Open Meetings Act.

David Tobaben, Orchard Way, said he would like to see Council address the health of the forest at Beverly Park. He would like to see a plan for plantings and the forest. He said he hopes GEI can come back to Beverly Park this year to continue buckthorn removal. He said there is untouched buckthorn at Hidden Rivers that could spread to Riverside Park.

Tom Maxwell, Lauderdale, commented on Village communication and limited feedback. He noted that Mooney did respond to his email. He said the Village should not move forward with Wendbrook without a plan. He commented on power outages and aging DTE infrastructure.

## PUBLIC HEARING TO RECEIVE COMMENTS ON PROPOSED ORDINANCE 386, AMENDING VILLAGE ZONING ORDINANCE, CHAPTER 22, SECTION 22.32.120 NONCONFORMING SIGNS

Stec provided an overview. The proposed Zoning Ordinance amendments to Chapter 22, Section 22.32.120 "Nonconforming Signs" of the Municipal Code were provided. The proposed ordinance revisions amend the standards for continuance of existing legal nonconforming signs contained in subparagraph 2 of Section 22.32.120 as follows:

- Amend existing Item c. to reduce the allowed cost of repairs to a damaged nonconforming sign from 60% to 50% of the cost of an identical new sign, excluding the cost of the sign foundation.
- Add new item d. to require that the owner of a nonconforming sign that is removed due to damage must submit a sign permit application to the Village within 30 days of the sign being damaged in order to be eligible to re-erect the sign.

George opened the public hearing at 7:54 p.m.

Mike Garvey, Amherst, asked about the comparison to other communities.

Borden clarified that most municipalities' replacement cost is set at 50%, while the Village's current Ordinance is at 60%, so the amendment would reduce this from 60% to 50%.

There were no other comments, so George closed the public hearing at 7:56 p.m.

### FIRST READING OF PROPOSED ORDINANCE 386 TO AMEND VILLAGE ZONING ORDINANCE, CHAPTER 22, SECTION 22.32.120 NONCONFORMING SIGNS

Ryan gave the first reading of proposed Ordinance 386, amending the Village Zoning Ordinance Chapter 22, Section 22.32.120, Nonconforming Signs.

## PUBLIC HEARING TO RECEIVE COMMENTS ON PROPOSED ORDINANCE 387, AMENDING VILLAGE ZONING ORDINANCE, CHAPTER 22, SECTION 22.08.150 FENCE, WALL, AND PRIVACY SCREEN REGULATIONS

Stec provided an overview. Proposed zoning ordinance amendments to Chapter 22, Section 22.08.150 "Fence, Wall, and Privacy Screen Regulations" were provided to the Village Council. The proposed ordinance revisions amend the approval standards for fences greater than 4-feet in height and/or greater than 35% opacity. Specifically, the proposed amendment will remove the following two standards from Section 22.08.150.2.a. allowing for administrative approval of permits for such fences:

- The subject site cannot support vegetative screening in lieu of the proposed fencing. The applicant shall provide supporting documentation of this from a licensed landscape architect or certified arborist.
- At least one residential parcel within 200' of the subject site on that side of the street in that block or at least one abutting residential parcel contains permitted fencing of similar height and/or opacity. To document this, the applicant shall prepare a neighborhood lot study that includes a map of the study area and photograph(s) of existing fencing. An existing privacy screen as allowed in Section 3 Privacy Screens shall not be used as consideration for compliance with this standard.

The Ordinance amendment, reviewed and prepared by the Village Attorney, shows the two remaining standards to allow for administrative review and approval of fences greater than 4-feet in height and or greater than 35% opacity.

Kecskemeti asked about adjacent vs. abutting and the conditions that the Planning Commission can apply. She thinks that this leaves a lot of discretion to the Planning Commission and that the safety/privacy concern provision is up to interpretation.

Hrydziuszko commented on the 200' rule and she does not think that it should be a merit that the Planning Commission considers. She said she does not personally have a problem with the 200' rule. She thinks that property owners should be able to decide how to use their property and that the people should be able to decide on the character of the community.

Mooney asked if this would allow Administration to approve more permits than they are now. Borden said no.

Abboud stated that fences have been an issue for a decade. He said every case should be reviewed on its own merits. He encouraged everyone to be cognizant of the residents.

George said that the challenge is that this is still subjective for Planning Commission to decide on fences.

There was discussion about the term "adjacent" and whether 6' fences would be allowed on properties whose side or rear yard is across the street from non-single-family residences.

Borden suggested adding "across the street of non-residential" properties to the Ordinance amendment.

The Council discussed the character of the community and having consistent aesthetics in the Village.

The Council agreed to add the following language: "directly across the street from . . ."

George opened the public hearing at 8:34 p.m.

Luke Litwinowicz, Pierce, said he was in favor of removing the 200' rule. He said he had experience with the Planning Commission and would have preferred that that not come up in their consideration and instead have it based on the merits of each individual application.

No one else wished to be heard, so George closed the public hearing at 8:37 p.m.

## FIRST READING OF PROPOSED ORDINANCE 387, AMENDING VILLAGE ZONING ORDINANCE, CHAPTER 22, SECTION 22.08.150 FENCE, WALL, AND PRIVACY SCREEN REGULATIONS

Ryan gave the first reading of proposed Ordinance 387, amending the Village Zoning Ordinance, Chapter 22, Section 22.08.150, Fence, Wall, and Privacy Screen Regulations.

## PUBLIC HEARING TO RECEIVE COMMENTS ON PROPOSED ORDINANCE 388, AMENDING VILLAGE MUNICIPAL CODE, CHAPTER 42, SECTION 42.12, GAMES IN STREETS

Campbell gave an overview. When the Village decided to place its charter and ordinances on Municode, there was some discussion about ordinances that needed to be updated. At that time, Ordinance 42.12, Games in Streets, was an ordinance that was mentioned by members of Council as an ordinance that could be updated. In addition, during conversations with the attorney for Municode while reviewing the Village ordinances, the attorney asked if Games in Streets had been updated or removed.

Further, recently, there has been some debate or concern regarding basketball hoops located at the end of driveways, in the right of way. Based on these factors, the Administration scheduled a public hearing for September 5, 2023 to address these matters. The Administration has proposed suggested changes to the Games in Streets ordinance for Council consideration in a First Reading. The proposed ordinance was provided for first reading, consideration, and is open to discussion.

Campbell stated that another option would be to eliminate this section altogether and create an Ordinance to address basketball apparatus.

Kecskemeti said she was more in favor of eliminating this section and addressing the issue.

George said he would be ok with eliminating this provision.

Abboud asked about basketball hoop placements.

Mooney said the Ordinance should address basketball hoops. He said he was not in support of the changes as presented.

Motion by Mooney, second by Abboud, the Beverly Hills Village Council tables the public hearing and first reading of proposed Ordinance 388, amending Section 42.12 and instructs Administration to bring back changes as discussed at the next meeting.

Motion passed.

### FIRST READING OF PROPOSED ORDINANCE 388, AMENDING VILLAGE MUNICIPAL CODE, CHAPTER 42, SECTION 42.12, GAMES IN STREETS

This item was tabled until the next Regular Village Council meeting to be held on September 19, 2023, as indicated in the previous motion.

#### REVIEW AND CONSIDER METRO ACT PERMIT APPLICATION FROM EXTENET

Campbell and Ryan provided an overview. On August 3, 2023, Clerk Rutkowski received a Metro Permit application from ExteNet Systems, LCC. The application is to place a small cell wireless device on an existing utility pole on Beverly Road. This Permit anticipates additional aerial wires that will be placed on existing utility poles in the Village. This application is for access and ongoing use of public ways as regulated by the Telecommunications Providers under Metropolitan Extension Telecommunications right-of-way oversight ACT 202 PA 48, MCLA sections 484.3101 to 484.3120. (Metro Act) and the Small Wireless Communications Facilities Deployment Act, MCLA Sections 460.1301 to 460.1339.

Ryan reviewed the application and the application is complete. The Five Hundred (\$500.00) Dollar application fee as required by the statute has been provided as well as the Certificate of Insurance naming the Village on the insurance policy. A route map showing the existing underground cable and existing aerial within the Village limits is also included, as required. The permit is valid for an initial period of 15 years. The permit may be revoked for six months of inactivity on the part of the permitee, upon notice from the permitee, and a default of the application by either party that is not cured within 60 days.

Under the Metro Act, the Village has 45 days to either approve or deny the request and Ryan found the application and attachments in order and would recommend approval by Village Council. Under the statute the Village has to render a decision on or about September 13, 2023.

Motion by O'Gorman, second by Hrydziuszko, be it resolved, the Beverly Hills Village Council approves the Metro Act Permit Application submitted by ExteNet Systems, LLC dated August 3, 2023, and authorizes the Village Manager to sign the Right-of-Way Telecommunications Permit.

#### SECOND NOTICE OF A VACANCY ON THE BEVERLY HILLS VILLAGE COUNCIL

Campbell gave the second notice of a vacancy on the Beverly Hills Village Council. Michael White submitted his resignation from the Beverly Hills Village Council effective August 10, 2023. The Village Council accepted his resignation at the August 15, 2023 regular meeting and the first announcement of the vacancy was made.

Per the Village Charter: Vacancies in Councilmember offices shall, within 60 days after such vacancy occurs, be filled by appointment of the Village Council by a majority vote of the members of council then in office. The person appointed shall possess the qualifications for the office of councilperson and shall hold office until the next regular village election.

Applications to fill the vacancy for a term ending November 2024 will be accepted until 4:30 p.m. on Monday, September 11, 2023. Interested and eligible residents of Beverly Hills may submit an application to the Village Clerk at 18500 W. 13 Mile Road, Beverly Hills, MI 48025 or via email: krutkowski@villagebeverlyhills.com. Applications are available on the Village website, at the Village Office, and a copy was included in the meeting packet.

This constitutes the second announcement of a vacancy on the Beverly Hills Village Council.

### SET SPECIAL MEETING DATE FOR MONDAY, SEPTEMBER 18, 2023 AT 6:30 PM TO INTERVIEW VILLAGE COUNCIL APPLICANTS

A Special Village Council meeting was scheduled for Monday, September 18, 2023 at 6:30 p.m. in the Village Council Chambers located at 18500 W. 13 Mile Road for the purpose of reviewing applications and interviewing Council candidates.

#### DISCUSS PROTOCOL FOR SPECIAL MEETING

The Council discussed protocol for the September 18<sup>th</sup> Special meeting.

George read minutes from previous special meetings where a Council vacancy was involved as a guideline.

Hrydziuszko asked if Council could receive the applications ahead of time in order to reach out the candidates. The Council agreed with this request.

The Council discussed parameters around candidate speaking time and Council questions.

Ryan stated that procedurally, Council shall hear all nominations and then vote in the order they were nominated. The first candidate who receives four or more votes will be appointed to the Village Council.

#### DISCUSS CRITERIA TO CONSIDER FOR VILLAGE COUNCIL APPLICANTS

Mooney asked what Council is looking for in a candidate.

O'Gorman stated that beyond the Charter criteria, preferences are individual.

Ryan stated that in order to be appointed, candidates must be eligible to be elected.

Members of Council discussed criteria and preferences.

Mooney said that an ideal candidate should have experience with local government and the Village of Beverly Hills.

Abboud said he would like to see someone who knows what is going on in the Village and someone who can pick up the baton and govern.

### REVIEW AND CONSIDER APPROVAL OF TRAFFIC CONTROL DEVICES AND PROPOSAL FOR PILOT PROGRAM

The Administration is requesting that Council review and consider the purchase of speed humps for a pilot program and approve the HRC proposal associated with the pilot. The Administration is also requesting that the Council approve the purchase and location of a separate speed traffic control device to assist in the reduction of speeds in the Village of Beverly Hills.

Speed Humps - At the July 18, 2023 Council meeting, the Administration proposed introducing a pilot program to introduce speed humps at two different locations on residential roads in Beverly Hills to help control speeds within the neighborhood. A removable type of hump was discussed at the meeting. Below are the hump specs, proposed locations.

Specs for Speed Humps - Each speed hump assembly will be comprised of ten-speed hump middle sections and two end caps. The heavy-duty rubber speed humps and end caps weigh 36 pounds each, are 2.1" Tall x 35.5" Long x 19.5" Wide and fastened to the road surface with 12" galvanized steel spikes.

Cost - According the to the Public Services Department, the total cost for 20 Heavy Duty Rubber Speed Hump Middle Sections, 2 Heavy Duty Rubber Speed Hump End Kits, and 4 'Speed Humps Ahead' Signs is \$4,305.42.

Liability - Administration has reached out to our insurer, MMRMA, and others to comment on liability concerns related to the installation of speed bumps. That information will be provided prior to the meeting.

Locations and Length of Pilot - For the pilot program, the Administration is proposing to place the speed humps on both sides of Saxon, west of Balmoral and east of Wentworth. In addition, the Administration is also proposing placing speed humps on Weston Drive just south of Warwick. Residents on these two streets have requested street humps continuously over the last year. A map of the proposed locations was included in the meeting packet. The pilot project may have to be delayed until spring, depending on how long it will take for the Village to receive the humps.

Necessary Engineering and Data - The Administration is proposing the pilot be at least 60 days in length. An engineering analysis and short speed study will need to be done to ensure the effectiveness of the speed humps. A proposal from HRC to do unmanned measurements of the speed humps prior to the installation of the humps and after the installation of the humps was provided. This data will help show whether the pilot and speed humps are an effective traffic control device. The cost for the study is \$9,800.

Speed Control Device - The Administration is also requesting that the Council approve the purchase and location of three speed control devices for roads that may not be eligible for a speed hump. Attached to this memorandum are specs and design for the location of the proposed device.

THESE MINUTES ARE NOT OFFICIAL. THEY HAVE NOT BEEN APPROVED BY THE VILLAGE COUNCIL.

It is a flashing solar device that alerts drivers how fast they are going down a residential street. The device is the Carmanah Speedcheck-12 sign. A spec sheet is attached for reference, along with a cost estimate. This device is recommended by the Road Commission of Oakland County and is like devices located on Beverly Road near Beverly Park. The cost of a device has been estimated at \$4,501. There might be a slight increase if a different solar panel is recommended. The Administration seeks Council's approval of the proposed locations on Pierce Road between Beverly Road and 14 Mile Road near Our Lady Queen of Martyrs. One is to be placed on the east side of Pierce Road between Beechwood and Locherbie. Another would be placed on the west side of Pierce between Birwood and Buckingham. The last sign is proposed to go between and on the east side of Riverside Drive between Inglewood and Sylvan. Both Public Safety and Public Services were consulted for the placement of the signs.

There was discussion about the cost, timeframe, and weather conditions.

Motion by Hrydziuszko, second by Kecskemeti, be it resolved that the Village Council approves the Village of Beverly Hills' Speed Hump Pilot Program and the Associated Engineering Proposal from HRC in the amount not to exceed \$14,106 and the purchase of three (3) Carmanah Speedcheck-12 signs in an amount not to exceed \$15,000 with two signs to be installed on Pierce Road between Beverly Road and 14 Mile Road and on the east side of Riverside between Inglewood and Sylvan. Funds for the program and devices are available in Account No. 205-900-985.00.

## REVIEW AND CONSIDER AUTHORIZING LOAN FROM THE GENERAL FUND TO THE PARKS CAPITAL FUND FOR THE BEVERLY PARK PLAYGROUND EQUIPMENT AND SURFACE RENOVATION

Campbell gave an overview. As discussed at the August 15, 2023 Council meeting, the Administration is presenting a Temporary Interfund Loan between the General Fund (Lender) and the Park Improvement Fund (Borrower) to help finance the cost of the new playground equipment and surface to be installed at Beverly Park in October/November of 2023. The total cost of the project is \$686,000. As a down payment for the new surface, the Village of Beverly Hills remitted \$90,812 to "landscape structures," the approved contractor. A balance of \$595,440 is owed to the contractor for the remainder of the project.

Campbell noted that the Village also received a grant of \$100,000 from Oakland County toward the installation and improvement of Beverly Park's playground. It is a matching grant; thus, when the Village expends another \$10,000, which will likely occur by the end of September or early October, we will be eligible to obtain the grant funds.

After discussing the matter thoroughly with the Finance Director, we are presenting a five-year temporary loan from the Village's General Fund to the Village's Park Improvement Fund in the amount of \$450,000. That amount will be reduced to \$350,000 upon receipt of the grant funding. This will ensure that over \$125,000 remains in the Park Improvement Fund at all times. This includes other budgeted improvements and liabilities.

The Village is proposing a reasonable interest rate of 4.25% for the loan. The Village came to this rate using an approximate average between the rate provided to municipalities by the State of Michigan for Infrastructure loans and the yield the Village receives from our pooled funds with Comerica Bank. Village Administration discussed the interest rate with the Village Auditor, Plante Moran, who stated this is a reasonable interest rate for the loan. The Auditors also stated that the temporary loan term should be five years. The Temporary Loan Agreement and the schedule of repayments was included in the meeting packet.

Abboud suggested scaling back the playground purchase.

Mooney said that he thinks this was poorly handled, but is committed to a new playground.

O'Gorman stated that the interest, which would amount to about \$39,000, could be reallocated back to park purchases down the road. He said the Village would not be paying interest to an outside bank or third party.

Kecskemeti noted that the cost of the project jumped from when the Parks & Recreation Board started planning and when it was approved. She said the Parks & Recreation Board acted in good faith.

George said the General Fund can transfer monies to other funds. He said that before there was a dedicated parks millage, parks expenses came from the General Fund. He would prefer an interfund loan rather than taking an outside loan.

Motion by Kecskemeti, second by Mooney, be it Resolved that the Village Council authorizes the Village Manager to sign the Temporary Interfund Loan Agreement, allowing the Village's Park Improvement Fund, Fund 208, to borrow funds from the Village General Fund, Fund 101, to finance the purchase and installation of playground equipment at Beverly Park.

Roll Call Vote: Motion passed (6-0)

#### **PUBLIC COMMENTS**

Suzanne Grimm, Vernon, talked about the comments around Mr. White's resignation and the inference that the timing was convenient. She clarified that Mr. White had a stroke and has been recuperating, and she wanted the public to know that.

#### **MANAGER'S REPORT**

Roundabout Construction Update - The roundabout on Greenfield and Beverly Road is open to the public. In addition, all other roads that were closed due to construction have been reopened as well. Some restoration work is still ongoing. The streetlights surrounding the roundabout are scheduled to be operational on September 1, 2023. The Village wants to thank the residents of Beverly Hills, particularly the residents in direct proximity to the project, for their patience. Recent Heavy Rainstorms - On August 23<sup>rd</sup> and August 24<sup>th</sup>, the Metro Detroit Area experienced heavy rainfall over a short period of time. While most Village residents did not experience extensive property damage from flooding, there were residents who did suffer damage to their property. The Village will continue to look at cost effective ways to address these heavy rainfalls and their effect on the Beverly Hills system. Fire Hydrant Maintenance - The Department of Public Safety will be conducting routine maintenance on the Village's fire hydrants beginning the week of September 4<sup>th</sup>. Hydrants to the west of Evergreen Road will be inspected to see if any routine repairs are needed. They will also be flushed. Hydrants to the east of Evergreen Road will just be inspected. Flushing is done to remove sediment and water that builds up near hydrants and other locations in the water lines. It also makes certain the hydrants are in working order. Flushing will not begin until 9:00 a.m., allowing residents in the nearby area to utilize water in the morning. Water can still be used while hydrants are being flushed, but nearby residents may experience low water presession and discoloration of their water. If you do experience this, you can clear out the water by running your cold water at the lowest point in your house for 20 minutes. All flushing and inspections will take approximately 2 months to complete. Local schools will not be affected during the week. Village staff will coordinate with each individual school to find a weekend suitable for their schedule.

Park Events in September - Movie in the Park scheduled for August 17, 2023 was cancelled due to inclement weather. Movie in the Park will occur on Wednesday, September 13, 2023 at dusk. The film being shown is the *Super Mario Bros. Movie*. The next Java & Jazz performance will take place on September 17, 2023 at the Beverly Park Pavilion. That show starts at 9 a.m. and wraps up at 12:00 p.m. Thank you to the Beverly Hills Lions Club for sponsoring the coffee for the September Java & Jazz. Read in the Park will take place on Saturday, September 30<sup>th</sup> at Beverly Park. Thank you to Baldwin Public Library for helping organize this annual event.

Summer Tax Bills - Summer tax bills are due back to Southfield Twp. by September 14, 2023 without penalties. Both bills are payable to Southfield Township.

2023 Village Audit - Last week the Village Auditors finished conducting their on-site portion of the 2023 Village Audit. The Audit report will likely be presented to Council at the first November meeting of 2023.

Kecskemeti asked about basement flooding.

O'Gorman asked how to property inventory damages.

Mooney asked about several items including sidewalks, roads, infrastructure, the Riverside bridge, pocket parks, debris in Beverly Park, Riverside Pond, Wendbrook, Next, digital signs, professional services RFPs, and Board/Commission appointment procedures.

George asked for an update on the Consumers project. Campbell said that their work will continue through November and there will be restoration work performed in the spring.

#### COUNCIL COMMENTS

O'Gorman said he was keeping Mr. White in his thoughts and prayers. He commented on the Open Meetings Act requirements. He said a lot of time was spent being negative. He noted that the new roundabout is getting a lot of positive feedback. He appreciates Luke's and Tobaben's work on the canopy study at Beverly Park. He said he held a family reunion at the Beverly Park pavilion and received a lot of positive feedback about the park.

Kecskemeti thanked O'Gorman for focusing on the positive. She said that the conversation about flooding and backflow preventers lost momentum, but that she is meeting with Administration on Friday about those items.

Abboud said that Council members are elected officials and public servants. He commented on citizen participation and encouraged more of it.

Mooney sent his condolences to the wife and children of former Zoning Board of Appeals member, Larry Needham, who recently passed away.

Hrydziuszko stated that the Parks & Recreation Board discussed a general planting plan at their last meeting. She said that the buckthorn had really set Beverly Park back. She said the buckthorn was very dense and not initially removed effectively. She said it will be a long process to rehabilitate the sick ecosystem. She suggested having a list of criteria so people and non-profits can request to waive pavilion rental fees. She said that the Planning Commission should not be considering the 200' rule in their decision making. She said there are very old trees in the Village that can destroy property, so it is worth starting an inventory.

George said the Greenfield/Beverly roundabout turned out well. He said that Mike White made his health issue public and he appreciates his time serving on the Council. He commented on the infrastructure priorities and would like to sit down and create a list. He said he appreciates Administration and recognizes that they do not have the staff to tackle every single concern at one time.

#### **ADJOURNMENT**

Motion by Mooney, second by Abboud, to adjourn the meeting at 10:50 p.m.

Motion passed.

**Subject:** Ordinance 386

Date: September 15, 2023

Attached for the second reading and possible adoption is proposed Ordinance 386, amending the Zoning Ordinance. The proposed ordinance revisions amend the standards for continuance of existing legal nonconforming signs contained in subparagraph 2 of Section 22.32.120 as follows:

- Amend existing item c. to reduce the allowed cost of repairs to a damaged nonconforming sign from 60% to 50% of the cost of an identical new sign, excluding the cost of the sign foundation.
- Add new item d. to require that the owner of a nonconforming sign that is removed due to damage must submit a sign permit application to the Village within 30 days of the sign being damaged in order to be eligible to re-erect the sign.

The Planning Commission held a public hearing prior to passing a motion to recommend approval of the proposed amendments at its July 26, 2023 meeting. The Council held a public hearing and conducted the first reading at the September 5, 2023 meeting.

#### **Suggested Motion:**

Be it ordained, the Beverly Hills Village Council adopts Ordinance 386, amending Zoning Ordinance Section 22.32.120 "Nonconforming Signs."

#### VILLAGE OF BEVERLY HILLS ORDINANCE NO. 386

## AN ORDINANCE TO AMEND THE VILLAGE ZONING ORDINANCE, CHAPTER 22, SECTION 22.32.120 NONCONFORMING SIGNS FOR THE VILLAGE OF BEVERLY HILLS

The Village of Beverly Hills Ordains:

<u>Section 1.01.</u> That Village of Beverly Hills Zoning Ordinance, Chapter 22, Section 22.32.120 Nonconforming Signs for the Village of Beverly Hills is hereby amended to read as follows:

#### 22.32.120 NONCONFORMING SIGNS.

- 1. Lawful Existing Signs: Any sign lawfully existing at the time of adoption of this Section which does not fully comply with all provisions shall be considered a legal nonconforming sign and may be permitted to remain as long as the sign is properly maintained and not detrimental to the health, safety and welfare of the community except as hereafter provided.
  - 2. Continuance: A nonconforming sign shall not:
  - a. be expanded, change type, or change to another nonconforming sign;
  - b. be relocated or structurally altered so as to prolong the life of the sign, or so as to change the shape, size, type, placement, or design of the sign's structural parts;
  - c. Be repaired after being damaged if the repair of the sign would cost more than 50 percent of the cost of an identical new sign, excluding the foundation;
  - d. Be re-erected after being damaged if the sign has been removed from the property and if a sign permit application to re-erect/repair the sign has not been submitted to the Village within 30 days of the sign being damaged.

<u>Section 2.01.</u> SEVERABILITY. If any section, clause or provision of this Ordinance shall be declared to be inconsistent with the Constitution and laws of the State of Michigan and voided by any court of competent jurisdiction, said section, clause or provision declared to be unconstitutional and void shall thereby cease to be a part of this Ordinance, but the remainder of this Ordinance shall stand and be in full force.

<u>Section 3.01.</u> SAVING CLAUSE. All proceedings pending and all rights and liabilities existing, acquired or incurred at the time this Ordinance takes effect are saved and may be consummated according to the law when they were commenced.

<u>Section 4.01.</u>	REPEALER.	Any	Ordinance	conflicting	with	this	Ordinance	be	and	the
same is hereby repeale	ed.									

<u>Section 5.01.</u> EFFECTIVE DATE. A public hearing having been held by the Planning Commission on July 26, 2023, and the Village Council on September 5, 2023, the provision of this Ordinance shall become effective 20 days following its publication in The Birmingham-Bloomfield Eagle, a newspaper circulated within said Village.

Based on the input received from the Village Council on proposed amendments to the zoning regulations on fences greater than four (4) feet in height and/or greater than 35% opacity in single-family residential districts received at the September 5, 2023, meeting, the following revised amendments to the administrative approval standards for such fences are provided for consideration by Village Council:

- The subject site directly abuts a non-single family residential land use, zone district, single-family cluster development, or residential PUD development. In which case the installation of the fence shall be limited to the property lines abutting such use or zone district.
- The fence would obstruct the view of an adjacent non-single family residential land use, single-family cluster development, or residential PUD development. Photographic evidence shall be provided documenting that such use is visible from the property. The installation of the fence shall be limited to those property lines from which such use is visible.

The removal of the following standards for administrative approval remains unchanged from what was proposed at the 9/5/23 meeting:

- The subject site cannot support vegetative screening in lieu of the proposed fencing. The
  applicant shall provide supporting documentation of this from a licensed landscape architect or
  certified arborist.
- At least one residential parcel within 200' of the subject site on that side of the street in that block
  or at least one abutting residential parcel contains permitted fencing of similar height and/or
  opacity. To document this, the applicant shall prepare a neighborhood lot study that includes a
  map of the study area and photograph(s) of existing fencing. An existing privacy screen as allowed
  in Section 3 Privacy Screens shall not be used as consideration for compliance with this standard.

The complete proposed revised Section 22.08.150.B.2., reviewed and prepared by the Village Attorney, outlining the administrative review standards for fences over four (4) feet in height (up to a maximum of six (6) feet in height), and/or up to 100% opacity is attached.

#### **Action Requested**

Conduct the second reading of and consider a resolution to approve the proposed zoning ordinance text amendment.

#### **Suggested Motion**

Be it ordained, that the Beverly Hills Village Council hereby adopts Ordinance 387 to amend the Village Zoning Ordinance, Chapter 22, Section 22.08.150 Fence, Wall, and Privacy Screen Regulations.

## AN ORDINANCE TO AMEND THE VILLAGE ZONING ORDINANCE, CHAPTER 22, SECTION 22.08.150 FENCE, WALL, AND PRIVACY SCREEN REGULATIONS FOR THE VILLAGE OF BEVERLY HILLS

The Village of Beverly Hills Ordains:

<u>Section 1.01.</u> That Village of Beverly Hills Zoning Ordinance, Chapter 22, Section 22.08.150 Fence, Wall, and Privacy Screen Regulations for the Village of Beverly Hills is hereby amended to read as follows:

#### 22.08.150 FENCE, WALL, AND PRIVACY SCREEN REGULATIONS.

- B. Requirements in Single Family Residential Districts:
- 2. Fences: Fences up to six (6) feet in height and/or up to 100% solid vertical surface area are permitted subject to Administrative or Planning Commission approval as follows.
  - a. Approval Standards:

Applicant must demonstrate that at least one of the following conditions is met for Administrative approval. Administration has the discretion to require review by the Planning Commission when there is a question of interpretation for consistency with the intent of this ordinance.

- Spacing between residences is less than that required by Section 22.08.080 or 22.24 of the Zoning Ordinance, whichever is acceptable.
- The subject site directly abuts a non-single family residential land use, zone district, single-family cluster development, or residential PUD development. In which case the installation of the fence shall be limited to the property lines abutting such use or zone district.
- The fence would obstruct the view of an adjacent non-single family residential land use, single-family cluster development, or residential PUD development. Photographic evidence shall be provided documenting that such use is visible from the property. The installation of the fence shall be limited to those property lines from which such use is visible.

In the event applicant does not meet the above criteria, applicant must demonstrate that at least one of the following conditions is met for Planning approval. The property owner or occupant of any parcel(s) abutting the subject site shall be given fifteen (15) day notification of the date and time of the meeting at which the request shall be reviewed.

<u>Section 2.01.</u> SEVERABILITY. If any section, clause or provision of this Ordinance shall be declared to be inconsistent with the Constitution and laws of the State of Michigan and voided by any court of competent jurisdiction, said section, clause or provision declared to be unconstitutional and void shall thereby cease to be a part of this Ordinance, but the remainder of this Ordinance shall stand and be in full force.

<u>Section 3.01.</u> SAVING CLAUSE. All proceedings pending and all rights and liabilities existing, acquired or incurred at the time this Ordinance takes effect are saved and may be consummated according to the law when they were commenced.

<u>Section 4.01.</u> REPEALER. Any Ordinance conflicting with this Ordinance be and the same is hereby repealed.

Section 5.01. EFFECTIVE DATE. A public hearing having been held by the Planning Commission on July 26, 2023, and the Village Council on September 5, 2023, the provision of this Ordinance shall become effective 20 days following its publication in Birmingham-Bloomfield Eagle, a newspaper circulated within said Village.

Subject: Ordinance 42.12

When the Village decided to place its charter and ordinances on Municode, there was some discussion about ordinances that needed to be updated. At that time, Ordinance 42.12, Games in Streets, was an ordinance that was mentioned by members of Council as an ordinance that could be updated. In addition, during conversations with the attorney for Municode while reviewing the Village ordinances, the attorney asked if Games in Streets had been updated or removed.

Based on these factors, the Administration scheduled a public hearing for September 5, 2023 to address these matters. The public hearing and first reading were tabled at the September 5, 2023 meeting. The Administration has proposed suggested changes to the Games in Streets ordinance for Council consideration in a First Reading. The First Reading is attached for consideration and is open to discussion.

- 42.12 GAMES IN STREETS. No person shall affix or leave a sports apparatus, including, but not limited to, a basketball hoop, hockey net, or soccer goal ten (10) feet from where a drive approach abuts a street. No apparatus shall obstruct any Village sidewalk.
  - (a) PENALTIES. Any person, firm or corporation violating any of the provisions of this Ordinance shall be responsible for a civil infraction, and upon conviction thereof, shall be fined no less than five hundred dollars (\$500.00) for each such offense, or such fine in the discretion of the court, together with the costs of such prosecution. Each day that a violation of this Ordinance continues shall be a separate offense.
    - 1. Enforcement. In addition to ordering the defendant determined to be responsible for a civil infraction to pay a civil fine, costs, damages and expenses, the judge or magistrate shall be authorized to issue any judgment, writ or order necessary to enforce, or enjoin violation of this Chapter.
- <u>Section 2.01.</u> SEVERABILITY. If any section, clause or provision of this Ordinance shall be declared to be inconsistent with the Constitution and laws of the State of Michigan and voided by any court of competent jurisdiction, said section, clause or provision declared to be unconstitutional and void shall thereby cease to be a part of this Ordinance, but the remainder of this Ordinance shall stand and be in full force.
- <u>Section 3.01.</u> SAVING CLAUSE. All proceedings pending and all rights and liabilities existing, acquired or incurred at the time this Ordinance takes effect are saved and may be consummated according to the law when they were commenced.

#### Hot Mix Asphalt (HMA) Project Update

On September 11, 2023, Administrative staff held a pre-construction meeting with Hutch paving who is performing the Village's 2023 HMA Project. The work is scheduled to begin on September 25, 2023. Weather permitting, it is anticipated the work will be done by October 14, 2023. Written notice will be provided to those streets that will be undergoing repairs.

#### **ARPA Update**

As of September 14, 2023, all interior water line verifications in the Village of Beverly Hills have been completed. Currently, 208 outside verifications have been completed. The Village's goal is to complete all exterior verifications by the fall of 2023. Per State requirements, the Village of Beverly Hills is required to provide the State with an updated inventory of all water service line (WSL) pipe materials to verify if the pipe is lead, copper, or another material for the purpose of ensuring said water quality and safety. The Village will publish the verification results upon completion of the project. The majority of this project if being funded by the American Rescue Plan Act funds received by the Village. There is no cost to Village residents.

On Tuesday, September 19, 2023, the Village will be going out to bid for improvements to several Beverly Hills pump stations. Specifically, the bids will address repairs at the following pump stations:

- Pump Station No. 6 (13 Mile Rd., West of Lahser)
- Pump Station No. 7 (13 Mile Rd, East of Lahser)
- Pump Station No. 8 (Lahser Rd, South of 13 Mile Rd)

The improvements were identified during inspections conducted in January 2022 by the Oakland County Water Resources Commissioner's Office (WRC). Again, this project is funded by ARPA at no cost to Village residents. It is anticipated the work will be completed in the summer of 2024.

#### **SOCRRA and SOCWA Update**

Please be advised that SOCRRA's General Manager, Jeff McKeen, is retiring. Mr. McKeen has been SOCRRA's General Manager for approximately 21 years. The SOCRRA and SOCWA Board are in the process of beginning interviews for Mr. McKeen's replacement. The first round of interviews will begin the last week of September and early October. Mr. McKeen is currently scheduled to remain with SOCRRA and SOCWA until January 1, 2023. Depending on when a replacement is hired, that date may be subject to change. I personally want to thank Mr. McKeen for his service and work with SOCRRA and SOCWA over the last 21 years. He will be missed.

#### **How to Avoid Sports and Concert Ticket Scams**

Taylor Swift fans are just the latest victims of criminals selling bogus tickets online by Patrick Kiger.

Suburban Detroit resident Lisa Turner, 47, is a veteran concertgoer who's been to more than 1,000 shows over the past few decades — somehow managing to find tickets to performances by wildly popular artists like Billy Joel, Elton John and the Rolling Stones. So when her teenage daughter was eager to see the hottest tour of the summer, Taylor Swift, Turner was sure she could score a few seats to one of the star's two Detroit shows.

First, she tried using her credit card's presale access to tickets — usually a dependable method. But with so many Swifties also on the hunt, she had no luck, even after spending hours on the website. "It was so stressful," she recalls.

Next, she talked to various people offering tickets on Facebook, but she was not convinced they were legit, so she kept looking.

Finally, as the shows neared, Turner found a seller on Craigslist. When she talked to him on the phone, she says, "He sounded very trustworthy, and nice and personable. He didn't give me any kind of weird vibes or anything."

Kevin, as he called himself, even offered to send Turner a digital ticket in advance before she paid him, so she could check it out. Sure enough, she soon got a notification on her husband's iPhone, and downloaded "a very realistic-looking ticket" into the Apple Wallet app — which Kevin claimed he needed to use because he got error messages when he used the Ticketmaster app, the usual method.

Satisfied, Turner sent the man a total of \$1,200 on an online payment app for four tickets — for her daughter and three friends — for the Friday concert.

But then, on the day of the show, she suddenly started wondering if the deal had been too good to be true. After trying unsuccessfully to verify the tickets online, she finally drove to the stadium box office. That's where she got the bad news. "Unfortunately, these are not real," one of the workers there told her, while also noting that the fakes were "the best we have seen."

Meanwhile, Kevin suddenly vanished, his phone number disconnected.

#### A growth in ticket scams

It's the sort of misfortune that many fans of live events are experiencing these days. While comprehensive statistics are elusive, reports of ticket scams (sports, concerts, and other events) to the Better Business Bureau (BBB) increased from 13,168 in 2020 to 17,941 in 2021 and then slipped just slightly to 16,762 in 2022, according to BBB spokesperson Josh Planos. He notes that the reports represent only a fraction of the actual scams.

The scammers take advantage of the fact that paper tickets are being increasingly replaced by digital tickets, which are purchased online, downloaded into a phone app and then presented for scanning at the arena gate.

While digital ticketing makes it easier for fans, it's also a convenience for criminals. Instead of having to print counterfeit tickets and peddle them on a dark street corner, the scammers can sit at home and post ads for nonexistent tickets on online marketplaces. And it's relatively easy for scammers, using consumer-grade graphic design software, to

create a fake digital ticket with convincing-looking graphics, says Teresa Murray, head of the Consumer Watchdog office for the U.S. PIRG Education Fund.

They also know that many fans are not yet familiar with the technology. If a person hasn't bought tickets from an online site before, and a seller provides them with a QR code, they may not realize that "there's really no way to test it until you're at the gate," Planos explains.

#### How do ticket scams work?

With stars such as Swift, Beyoncé and Aerosmith going on major tours this year, high demand for seats makes it tempting for people to look in unusual places for tickets and to suspend their suspicions. Those conditions create a perfect situation for scammers, experts say.

You see somebody selling tickets to this concert that's sold out, "and your mind starts going in overdrive. You are like, 'Oh boy, I can buy tickets!'" explains Murray. "We've seen case after case of perfectly intelligent, normally skeptical people who fall for the scam because they get caught up in this euphoria."

Anti-fraud experts say that ticket scammers often ply their trade on social media and online marketplaces such as Craigslist, which have become last-resort options for would-be concertgoers. But some brazen scammers even create entire fake ticket-selling websites of their own.

"There's a certain portion of reports coming from folks who thought they were buying a ticket from Ticketmaster, because it was a site that looked like Ticketmaster," Planos says. "But they didn't double-check that URL, and it was a lookalike site."

Once a ticket scammer convinces a person to purchase a concert ticket, they'll usually ask the target to send money

through a peer-to-peer payment app such as Zelle or Venmo rather than using a credit card, according to Steve Baker, a former Federal Trade Commission official who now publishes the Baker Fraud Newsletter.

That is when the bad stuff starts to happen. The scammer may send a counterfeit replica of the ticket, or simply disappear without sending anything at all — "a straight theft kind of deal," as Baker explains.

#### How to protect yourself from ticket scammers

Some experts recommend that music fans stick to getting their tickets from name-brand sellers such as Ticketmaster, or if they're going to venture into the resale market, only do business with sellers who belong to the National Association of Ticket Brokers (NATB), an industry group that requires members to follow a code of ethics.

"If you're dealing with a NATB member, it's guaranteed, and if they failed to deliver that ticket, it's not just a refund, you get 200 percent," explains Gary Adler, NATB's executive director and counsel.

You can get a list of members at natb.org or at verifiedticketsource.com.

Here are some additional safety tips from Teresa Murray at U.S. PIRG.


- Always treat someone selling tickets to a hot concert or big sports event with skepticism, since these events are likely to be sellouts.
- If you do buy from an individual, it should be someone whom you know personally, such as a relative, close friend or coworker.

- Unless you know a seller personally, never pay for tickets with a peer-to-peer payment service such as Zelle, Venmo, PayPal, CashApp or a wire transfer. If the person turns out to be a scammer, you won't be able to get your money back (these apps don't have the same consumer protections that credit cards do). When you're buying tickets, check a floor chart to make sure that the section and seat number actually exist.
- If you're buying tickets from a name-brand site such as Ticketmaster or StubHub, make sure that the URL is the correct one, and not for a look-alike site created by a scammer.

In Michigan, Lisa Turner says that her ticket scam experience had an unexpectedly happy ending. After a local TV station aired a news story about the girls having to miss the Friday concert, she got a call from the company managing Swift's tour, informing her that an anonymous benefactor was willing to give them four free tickets to the Saturday show.
