BUSINESS AGENDA

PUBLIC HEARING TO RECEIVE COMMENTS ON PC CASE 23-07-07, SPECIAL LAND USE REQUEST AT 19400 W. 13 MILE ROAD, APOSTOLIC CHRISTIAN CHURCH (NAZAREAN)

Campbell provided an overview of the Special Land Use request. In July 2023, the Planning Office received an application for consideration of special land use approval for a 1,600 square foot expansion to the existing parking lot at the Apostolic Christian Church (Nazarean) Beverly Hills located at 19400 W. Thirteen Mile Road. The plans also include the removal and replacement of approximately 11,000 square feet of existing parking lot pavement, removal and replacement of four (4) trees, and the addition of one (1) new pole mounted light fixture in the parking lot.

The Planning Commission held a public hearing and considered this application at their August 23, 2023, meeting. Ultimately, a motion was passed to postpone a recommendation to the Village Council to allow the applicant time to revise the plans. Revised plans were subsequently considered at the March 27, 2024, Planning Commission meeting. A motion was passed recommending that Village Council approve the Special Land Use Request. Further, the following items were to be addressed by the applicant prior to final approval:

- Stormwater management plan must be submitted
- Removal of the 6' screening wall requirement in favor of vegetative screening
- Approval from the Public Services, Public Safety, and Engineering Departments
- Landscape varieties be native and non-invasive

The applicant has submitted revised plans reflecting the above required changes and they are pursuing the required departmental approvals.

George opened the public hearing at 7:47 p.m.

Sam Cipkar, minister representing the church on 13 Mile Road appeared. He stated that the church and neighbors approved of the vegetative screening. He stated that the Church has been working on the project for quite a while and took the Planning Commission's comments under consideration and proposed a revised plan that was approved.

No one else wished to be heard, so the public hearing was closed at 7:49 p.m.

REVIEW AND CONSIDER PC CASE 23-07-07, SPECIAL LAND USE REQUEST AT 19400 W. 13 MILE ROAD, APOSTOLIC CHRISTIAN CHURCH (NAZAREAN)

REVIEW AND CONSIDER SUBCOMMITTEES' RECOMMENDATIONS FOR VARIOUS BOARDS AND COMMISSION APPOINTMENTS

Several board and commission members' terms expire on June 30, 2024. Announcements of these vacancies were made at the May 7th and May 21st Village Council meetings as well as published on the Village website, Facebook page, and in the weekly emails. Applications were due Monday, June 10, 2024.

Pursuant to Council policy, a subcommittee has been formed for each board/commission to review the new applicants and those members who wish to be considered for reappointment. Subcommittees met on Tuesday night prior to the regular Council meeting to interview applicants.

PRESENTATION OF CYBERSECURITY ASSESSMENT BY UHY CONSULTANTS

Norman Comstock of UHY Consultants presented a cybersecurity assessment for the Village of Beverly Hills. A copy of the presentation was included in the Council meeting packet.

REVIEW AND CONSIDER PURCHASE OF SOFTWARE APPLICATIONS TO ENHANCE THE VILLAGE OF BEVERLY HILLS' CYBERSECURITY CAPABILITIES

Blenkhorn gave an overview. In April of 2023, Village Council approved a bid by UHY Consulting, Inc. to conduct a cyber security assessment for the Village to determine our general cyber security posture, risk level, and possible ways of improving our overall security. UHY began conducting the assessment that summer, which included multiple staff interviews, reviews of

policies and procedures, as well as external and remote internal penetration testing at both Village Hall and the Public Safety Department.

The Village's overall assessment has been positive. The testing did identify some vulnerabilities within our networks, most of which have already been actively resolved by our IT provider, Robert Ferkel of Enterprise Computer Solutions, Inc. There are further steps required to get the Village at an increased security posture. UHY has provided Administration with a tiered list of recommendations to improve our security and Administration has consulted with our IT provider to form solutions that would address UHY's recommendations. These solutions include additional software, establishing a hardware refresh schedule, implementing cyber security training for staff, and implementing additional cyber security policies.

The estimated cost of these solutions is \$17,310. For a more detailed breakdown, please refer to the cost estimate enclosed. Funding is available in the 2024-2025 budget in account 101-248-948.06 (\$10,000) and account 205-345-948.06 (\$10,000), totaling \$20,000. Administration would like to thank Robert Ferkel for all of his hard work during this assessment. The process has left us pleased with the IT services we have been receiving.

Motion by Drummond, second by Mooney, the Beverly Hills Village Council authorizes Administration to procure the proposed software, hardware, and training as outlined in the enclosed cost estimate for the purpose of improving our cyber security posture, not to exceed \$20,000. Funding is available in the General Fund and the Public Safety Fund.

REVIEW AND CONSIDER AWARDING RIVERSIDE BRIDGE REHABILITATION PROJECT TO RAM CONSTRUCTION SERVICES

Campbell provided an overview. The Village Council approved a proposal from HRC, the Village Engineer, to perform rehabilitation work on the Riverside Bridge on January 16, 2024. The Village went out to bid for these services with the bids closing on April 16, 2024. The Village received sealed bids from three reputable companies to perform the rehabilitation work on the Riverside Bridge. Attached for your review is a recommendation from HRC along with a corresponding bid sheet. The lowest bid was submitted by RAM Construction Services in the amount of \$173,597.00. Based on HRC's recommendation and the fact that RAM submitted the lowest bid, the Administration is recommending that Council award the contract for the Riverside Bridge Rehabilitation Project to RAM Construction services in the amount of \$173,597.00.

Motion by O'Gorman, second by Mooney, be it resolved, the Beverly Hills Village Council awards the contract for the Riverside Rehabilitation Project to RAM Construction Services in the amount of \$173,597.00. Funds for this project are available in account #202-900-988.75.

REVIEW AND CONSIDER CHANGE ORDER WITH SCODELLER CONSTRUCTION FOR FY 2024 CRACK SEALING PROJECT

THESE MINUTES ARE NOT OFFICIAL. THEY HAVE NOT BEEN APPROVED BY THE VILLAGE COUNCIL.

Campbell provided an overview. The Village is continuing its crack sealing program for the Village of Beverly Hills. Sealing cracks in asphalt and concrete is a low-cost pavement preservation treatment. Cracks in pavement are inevitable and are going to develop as the pavement continues to oxidize and deteriorate. Approximately 75% cracks in pavement form into potholes within 3 years if they are not sealed. Crack sealing will extend the life of your asphalt pavement and prevent cracks from turning into larger cracks, craters, and dangerous potholes.

Previously, the Village received a substantial cost savings by utilizing and extending unit prices from those obtained in a bid process from a neighboring community, Keego Harbor. The contractor utilized by Keego Harbor and Beverly Hills is Scodeller Construction. The work will likely begin in late June and be completed by June 30, 2024, weather permitting.

A copy of the change order with Scodeller Construction to continue with the crack sealing at the same prices from 2023 was provided for review. Additional crack sealing will occur in this summer is FY 2025. A separate change order will be presented for the work in FY 2025. Funds are available in accounts 202-463-943.00 and 203-463-943.00 for crack sealing in FY 2024.

Motion by Abboud, second by Hrydziuszko, be it Resolved that the Beverly Hills Village Council approves the proposed Change Order with Scodeller Construction for Crack Sealing Program in the Village of Beverly Hills for FY 2024 with a total project cost of no more than \$50,000. Funds are available in accounts 202-463-943.00 and 203-463-943.00.

REVIEW AND CONSIDER APPROVAL OF IT SERVICES AGREEMENT WITH OAKLAND COUNTY

Campbell gave an overview. The Village's five (5) year Intergovernmental Agreement with Oakland County for certain IT services is set to expire and needs to be renewed. Accordingly, a revised agreement for Information Technology (IT) Services between Oakland County and the Village has been provided for our review and consideration. The Village and Oakland County work collaboratively on many IT functions. The Courts and Law Enforcement Management Information Systems (CLEMIS) is a vital law enforcement tool operated by Oakland County allowing local agencies to share and access data. The Public Safety Department is a CLEMIS agency and uses this information daily in police operations. The Village Building Department also utilizes Geographic Information Systems (GIS) services through Oakland County for mapping, assessing, planning and zoning, and infrastructure records. Oakland County maintains ESRI software licensing that the Village also utilizes on a daily basis.

Village Administration and the Village Attorney have reviewed the agreement provided by Oakland County and find that the Agreement does a good and thorough job of memorializing the current state of IT services between the Village and County.

Motion by O'Gorman, second by Abboud, be it resolved, the Beverly Hills Village Council approves and authorizes the Village Manager to execute the Interlocal Agreement for Information Technology Services between Oakland County and the Village of Beverly Hills as submitted.

REVIEW AND CONSIDER PARKS & RECREATION BOARD'S RECOMMENDATION TO CONTRACT WITH JH HART TO REMOVE TREES AND STUMPS FROM BEVERLY GREEN

Campbell and Johnston provided an overview. Over the last several months, the Parks & Recreation Board has been discussing the development of Beverly Green. They have agreed that it will require a phased approach, the first of which includes pruning trees, removing dead trees, and grinding stumps in the park.

Public Services Director Johnston obtained several quotes from reputable contractors, all of whom could provide the services for around \$14,000.00 and presented the options to the Parks & Recreation Board at their May meeting. The Board recommended that the Village Council award the project to JH Hart. The Village currently has an agreement with JH Hart in place, so they will honor their hourly rate to perform the work in an amount not to exceed \$14,000.00.

There was discussion about the different phases of the project.

Motion by Hrydziuszko, second by O'Gorman, be it resolved, the Beverly Hills Village Council awards the contract for tree pruning, tree removal, and stump grinding at Beverly Green to JH Hart in an amount not to exceed \$14,000.00. Funds are available in the FY 24-25 budget from Account 208-900-974.02.

REVIEW AND CONSIDER APPROVAL OF VILLAGE OF BEVERLY HILLS GENERAL INVESTMENT POLICY

Campbell provided an overview. A General Investment Policy is a written investment policy and serves as a working document that directs the investment activities of a Village and attempts to protect the Village from potential losses stemming from unsuitable investment practices. This investment policy will apply to all financial assets of the Village and any new fund established by the Village. Investment objectives shall meet the following criteria: safety, diversification, liquidity and return on investment.

The following resolution was offered by Drummond, and seconded by Abboud:

WHEREAS, as a requirement of provisions of Public Act 196 of the Public Acts of Michigan of 1997, which required governing bodies of local governmental units to adopt investment policies in accordance with Public Act 20 of the Public Acts of 1943 (the "Act").

WHEREAS, the Council deems it in the Village's best interest to create a policy to invest the Organization's funds in a manner which will ensure the preservation of principal while providing the highest investment return with maximum security, meeting the daily cash flow requirements of the Organization and conforming to all federal and state statutes governing the investment of funds.

NOW THEREFORE, BE IT RESOLVED, that the policy attached to this resolution as Exhibit A shall govern the Village's General Investment Policy.

REVIEW AND CONSIDER APPROVAL OF BUDGET AMENDMENTS FOR FY 2024

Campbell provided an overview of the proposed budget amendments. In the General Fund there are various revenue and expenditure amendments adjusting to projected actuals. The net effect of the amendments is a net fund increase of \$62,010.

In the Major Road Fund there is an amendment decreasing the village wide Asphalt resurfacing budget from \$700,000 to \$635,000 after consulting with HRC. There are amendments in both the Major Road Fund and Local Road fund adjusting to projected actuals. The net effect of the amendments is a net fund increase of \$24,300 in Major Roads and a net fund decrease of \$7,000 in Local Roads.

In the Public Safety Fund there are amendments for final delinquent property taxes to be received. There are various amendments to decrease expenditures because of the open PSO positions throughout the year. The budget for 2 cars was removed. The cars will be purchased in FY25. The budget for building improvements was decreased. Spending will also occur in FY25. The net effect of the amendments is a net fund increase of \$382,602.

In the Park Improvement fund there is an amendment adjusting the budget for a transfer in of \$350,000 down to -0-. There are also amendments adjusting the level of capital spending to actuals. There will be no further spending beyond current year to date totals. Any additional expenditure on the park playground equipment will occur in FY25. The net effect of the amendments is a net fund decrease of \$26,354.

In the Capital Fund there is an amendment increasing the budget for the TAP grant sidewalks. This \$30,000 increase is due to additional design engineering. The effect of the amendment is a net fund decrease of \$30,000.

These proposed FY 2024 Budget Amendments have been reviewed by the Village Administration and are recommended for approval.

Motion by Hrydziuszko, second by Abboud, be it resolved that the Village of Beverly Hills Council authorizes Village Administration to transfer or adjust monies reserved in the General, Major Roads, Local Roads, Public Safety Fund, Park Improvement Fund and Capital Fund as reflected in the June 13, 2024 memorandum from Finance Director, Sheila McCarthy.

Members must decide whether or not a physical hardship or practical difficulty exists, which justifies the granting of a variance.

Community Discussion for the Beverly Park Master Plan 2050 - Earlier this year, the Village retained SmithGroup, a professional planning and design firm, to serve as the Village's consultant in preparing a long-term plan for Beverly Park. SmithGroup led a community discussion about the future of Beverly Park. The agenda included a presentation of an assessment of existing park facilities and some preliminary ideas, and an opportunity for the public to provide input on how to improve the park. The discussion was well attended. The Administration would like to thank the residents who came to the pavilion and participated. Your input will be important in crafting the plan going forward.

Concert in the Park - Our Concert in the Park series returns on Friday, June 14, 2024! Each show begins at 7:00 p.m. at Beverly Park and a food truck will be on site during the performance! COUNCIL COMMENTS

O'Gorman thanked Board and Commission members for their service to the community.

Abboud said he will be attending SEMCOG's General Assembly meeting on June 27th. He said he is currently working on his Level 4 Ambassador training for MML. The MML Convention registration is now open. He reported that Next will be having a Golf Classic Fundraiser in September. He congratulated everyone who was appointed or reappointed to a Board or Commission. He said it was nice seeing the volunteers at the Volunteer Appreciation Dinner last month.

Mooney thanked the Board and Commission members for their dedication to the Village. He also recognized volunteers Matt Roberts, Karen Gilbert, Mike Garvey, and Mr. and Mrs. Tobaben, who volunteer at Beverly Park. He said Administration should always be understanding of residents. He said he is in favor of making Beverly Hills a walkable community.

Hrydziuszko said she has heard a lot of positive feedback about the speed humps in the Village. She thanked the volunteers who applied for Board and Commission terms. She thanked everyone who came to the last Java & Jazz event at Beverly Park. She suggested that the lawn maintenance crew use a weed whacker along the Beverly Park fence line instead of a mower to prevent damage.

George suggested native planting along the fence line once the fence at Beverly Park is replaced. He congratulated the parents whose children recently graduated from Berkshire Middle School. He noted that the June 4, 2024 Council meeting was canceled due to a lack of quorum because 3 members were at the graduation and 1 member was out of town. He said the Memorial Day Parade was great. He said there was a great turn out at both the Concert in the Park and the last Java & Jazz. He thanked the volunteers who serve on Boards and Commissions. He noted the Beverly Park 2050 Vision subcommittee is working with the SmithGroup to gather feedback from residents. He said he attended the Groves Convocation to hand out the Greening Scholarships. He thanked Congresswoman Tlaib for attending the meeting and delivering a check for a future water project. He would like a quarterly update on the sidewalk project soon. He thanked Administration for their hard work.

Re: Update on Storm Damage and Emergency Declaration

Synopsis of the Storm Damage and the Actions by the Village of Beverly Hills over the last 10 days.

On June 19, 2024, a thunderstorm cell with incredibly strong winds went through the Village of Beverly Hills, causing a staggering amount of damage to the Village. Almost immediately after the winds ceased, Public Safety and the Administration were informed of the widespread power outages throughout the Village and that there were trees, limbs and branches down throughout the Village. Public Safety responded immediately and the DPW crew responded within 30 minutes after the storm passed.

The storm resulted in trees down throughout the Village, making at least a dozen streets impassable throughout the Village. The hardest hit area in the Village were the neighborhoods east of Evergreen. Streets including, but not limited to, Devonshire, Beechwood, Beverly, and Locherbie had several trees blocking the road. Through that night, DPW crews worked to make some roads passable. DTE dispatched crews to assess damage and start restoring power at 12:00 a.m. that evening. Due to utility poles and lines snapping, 13 Mile Road was closed between Southfield and Evergreen.

Early on the morning of June 20, 2024, the Administration was better able to assess the incredible amount of damage to the Village. At that point, the Administration secured three crews from JH Hart Urban Forestry and two crews from Davey Tree Service to assist the Village in the clearing of roads and removing dangerous limbs from trees. These crews worked all day to open roads. In addition, two local landscaping companies were able to offer crews and equipment to assist the Village. Jason's Outdoor Services began work in Beverly Park. Many trees fell in Beverly Park, and the trail had to be closed for the public's protection. Johnson Landscaping also sent crews to assist in the cleanup efforts.

Throughout the day, Village residents began moving branches to the curb, helping their neighbors and contacting tree services to deal with private trees that came down in their yards. There was a great sense of community spirit, the patience and cooperation demonstrated by the Village of Beverly Hills residents should be commended.

On Friday, June 21, 2024, the Village brought in an additional crew from Davey. 13 Mile Road opened that evening as well. On Friday, the Administration also secured a large chipper to help chip trees, limbs and branches that could not be chipped by any normal chipper. By the end of the day, most roads were passable.

The crews worked on Saturday as well, opening all roads and continuing to remove dangerous limbs from the trees. DTE restored power to most Village residents by Saturday evening.

On Monday, June 24, 2024, the large chipper showed up and began chipping in the southeast portion of the Village. The additional crews and landscapers continued to chip throughout other sections of the Village and removing additional hanging limbs.

That same day, after consultation with neighboring communities and the Oakland County Emergency Management Team, the Village of Beverly Hills declared an official State of Emergency with Oakland County. Late that afternoon, County Executive Dave Coulter declared a State of Emergency for the Village of Beverly Hills. The reason for the declaration is to make all resources available and funding to the Village from the State of Michigan. More specifically, following a state emergency or disaster declaration, the governor may authorize financial reimbursement to municipalities for some disaster related response and recovery costs from the Disaster and Emergency Contingency Fund (Section 19 of Public Act 390 of 1976 as amended). It is completely within the Governor's discretion whether she would declare a state emergency for Beverly Hills. The Village Administration reached out to our State Representatives and State Senators to garner support for said declaration. Everyone indicated they would support the Governor issuing a declaration. Under Section 19, the Village may be eligible to reimburse public funding in an amount of up to \$250,000 for the Village.

All crews continued to work on chipping and limbs throughout the Village.

On Wednesday, June 26, the large chipper had a minor mechanical issue and had to undergo repairs. It delayed the chipping by two days, at least. The hope is that the large chipper will begin work on Friday and work through Saturday and Sunday.

Fortunately, the Village has not received any reports of bodily injuries as a result of the storm.

Declaration

As of the writing of this memorandum/synopsis, the Governor has not made a determination as to whether she will offer financial reimbursement to the Village.

Cleanup Expectations

The Village is doing everything possible to expedite the cleanup of the trees, branches and limbs throughout the Village. After trees, trunks, limbs and branches are removed, the Village streets will be swept to get up loose debris.

The Village will also need to cut and/or remove damaged trees throughout the Village. The Council and public will be notified of what that will entail or require once the cleanup is near completion.

This cleanup will likely continue through the end of July.

Costs

At this time, we have very few hard numbers. The invoices for the work are just starting to be submitted. However, we estimate we will be spending at least \$250,000 for the cleanup effort between all the overtime, contractors and equipment needed to clean up this disaster.

Conclusion

I am proud of the response by the community, Council, the Administration and workers who have aided us throughout the cleanup project. Everyone pulled together to help each other, and that is indicative of a strong community.

• Gun safety laws help to reduce gun violence, advocates say

- Last week, Gov. Gretchen Whitmer created a Gun Violence Prevention Task Force with the goal of decreasing gun-related incidents in Michigan. But what are the limitations groups like this face when it comes to gun violence?
- Just this month, the U.S. Supreme Court issued a ruling prohibiting the ban on bump stocks, attachments that allow semi-automatic rifles to fire bullets at rates

- similar to fully automatic machine guns. It is the latest example of how the court's interpretation of the Second Amendment can have a chilling effect on state and local governments.
- Michigan had over 1,500 firearm deaths in 2022, according to the Center for Disease Control. The CDC also reports unintentional injury is the fourth leading cause of death among infants in the U.S. and is the top cause of death among children and adolescents aged 1–17 years; with firearms the leading cause of injuries.
- Last year two months after the shooting at Michigan State University and two years after the mass shooting at Oxford High School, Michigan lawmakers passed sweeping legislation to combat gun violence. The 11bill package requires all people purchasing guns to undergo a background check and require safe storage.
- Esther Sanchez-Gomez, litigation director for Giffords Law Center to Prevent Gun Violence, joined The Metro on Tuesday to discuss how much leeway states have when it comes to regulating guns and the laws and policies that make the biggest impact on gun violence in our communities.
- Lt. Mike Shaw, public information officer for the Michigan State Police, also joined the conversation to provide insight regarding the legislation passed in Michigan to limit gun violence.
- While gun safety is important to limit mass gun violence, Sanchez-Gomez says, mass violence incidents are actually an exceedingly small percentage of the gun violence incidents we see in the country every day.
- "Community violence intervention programs target communities most affected by day-to-day gun violence, and they do not implicate the Second Amendment at all." Sanchez-Gomez said, "So that funding that goes to these programs is hugely important that interrupting cycles of violence that we've seen day-to-day and is hugely impactful for reducing the kind of gun violence that maybe doesn't make news, but it is contributing to the gun violence epidemic that we see in this country."
- Shaw brought attention to the state storage law, which will prosecute a gun owner if there are gun injuries due to a gun owner not locking up a gun safely.
- "Those are tough decisions, tough conversations to have," he said. "But those are things that you need to

really think about. Because after it happens, it is too late. And you either lost your child or they are severely injured or something else happened and it is too late for that conversation."

- Shaw also mentioned the Red Flag Law, which is an extreme risk protection order act that allows certain people to request a restriction on an individual from buying or possessing a firearm. This law will continue to ensure people will have the ability to restrict people who should not have access to guns and will have them seized if it proves to be a danger.

• State Police Launch Awareness Campaign to Help Prevent Targeted Acts of Violence

- Recognizing warning signs and taking action to report suspicious behavior are the key messages of the Michigan State Police's new public awareness campaign aimed at educating people on how to potentially "Stop a Plot."
- "While no single law or initiative can prevent all violence, we must act if we can save even one life," said Col. James F. Grady II, Director of the Michigan State Police (MSP). "My top priority is the safety of all Michiganders. We know more than half of all mass shootings show warning signs beforehand. I encourage everyone to do the right thing. We encourage everyone to speak up when they see something suspicious even a simple tip reported to authorities can prevent tragedy and save lives."
- The "Stop a Plot" campaign includes a new webpage that details the warning signs and risk factors to look for, as well as ways to submit confidential tips and resources to help someone who might be at risk.
- A video public service announcement can be found on the webpage and will be shared through a paid social media campaign that started this week and will run through September 8. "Oftentimes, family members, friends and co-workers are most likely to first notice concerning behavior," said Insp. Brian Budde, acting commander of the MSP Intelligence Operations Division, which house's Michigan's fusion center, the Michigan Intelligence Operations Center. "If you believe someone may be on the pathway to violence, speak up. Knowing the behavioral clues outlined in this

- program could detect a threat and prevent a mass casualty incident."
- If you have information that could prevent an act of violence, Stop a Plot. Speak up. Tips can be reported online or by calling 1-800-MICHTIP at any time. Reporting a tip is safe and confidential. Criminal activities or potential harm directed at students, school employees or schools can be reported using OK2SAY.
