President Mooney called the regular Council meeting to order at 7:30 p.m. in the Village of Beverly Hills municipal building at 18500 W. Thirteen Mile Road. The Pledge of Allegiance was led by Josh Ziegele from Boy Scout Troop 1024, and recited by those in attendance.

PUBLIC COMMENTS

Lisa Napolitan, Kirkshire, is pleased that the public hearing for amendments to Chapter 22, Section 22.24 was being set for December.

Jon Everly, Lincolnshire and John Fafth, Lincolnshire, each spoke about the frustration with the current proposal before the Planning Commission regarding the playground and sports court built at Detroit Country Day School (DCD). These items have already been constructed, and this construction was not approved with the middle school site plan submission, or permitted with the approvals provided by the Planning Commission and Village Council in 2016. They contend that DCD was not working with the neighbors, and had no intention of doing so. Each cited the high levels of noise multiple times a day, the height and expanse of the equipment, the lack of green screen as previously promised, the violation of the DEQ flood plain requirements, lights in the evenings on the property, and the continued events creating traffic and noise in the evenings.

REVIEW AND CONSIDER REQUEST FOR FUNDING FOR EAGLE SCOUT PROJECT BY JOSH ZIEGELE

Boy Scout, Josh Ziegele presented his idea for an Eagle Scout project at Beverly Park. His plan is to create a Butterfly Garden, the garden would be approximately 15x15 feet. He would have planting assistance from fellow Troop members, and hopes to secure donations from nearby nurseries. The Parks & Recreation Board unanimously recommended Council's approval of the proposed project.

Motion by Muller, second by Abboud, be it resolved that the Village of Beverly Hills Council authorizes Josh Ziegele to create and plant a butterfly garden in Beverly Park for his Eagle Scout project. Also that the Village provide the necessary financial contributions not to exceed \$525.

REVIEW AND CONSIDER AWARDING BID FOR 2018-19 BUCKTHORN ERADICATION PROJECT

The Village received bids on Sept. 19, 2018 at 2:00PM for Invasive Species Eradication. The Village received four bids for this project ranging from a high bid of \$70,925.00 to a low bid of \$34,999.00 submitted by Natural Community Services (NCS). Village Administration and Public Services Director, Tom Meszler, have reviewed this proposal and it is in compliance with all the requirements for the project as set forth by the Village in the bid proposal. NCS submitted references, which have been checked and good recommendations were received from other municipalities they have completed work for. This bid was reviewed by the Parks and Recreation Board and they agreed with the recommendation, with the request that Triclopyr be used as the treatment chemical. Administration recommends that the Village of Beverly Hills award this project to the low bidder, NCS, for the 2019 Invasive Species Eradication.

Motion by Mueller, second by Nunez, be it resolved that the Beverly Hills Village Council award the 2019 Invasive Species Eradication to NCS for the amount of \$34,999.00. The Village will be named as an additional party insured on the liability certificate.

PUBLIC HEARING TO RECEIVE COMMENTS ON SPECIAL LAND USE REQUEST BY WOODSIDE ATHLETIC CLUB, 22440 W THIRTEEN MILE ROAD

Woodside Athletic Club, 22440 W Thirteen Mile Road, has submitted a proposal for site plan review and special land use approval. The proposed changes include a new play structure north of the existing pool, relocating the existing kiddie pool, improvements to the patio and outside grill area including landscaping and ADA upgrades, and a new court on the east side of the property.

The property is zoned R-1, Single Family Residential and as a private club the use is permitted by special land use approval. Per Section 22.08.300 j, any modifications to a site plan after approval requires a new special land use approval.

The Planning Commission held a public hearing on Wednesday, September 26, 2018 regarding the special land use in accordance with Section 22.08.300. At that meeting they recommended approval of the special land use contingent upon approval of the site plan. The Planning Commission also recommended approval of the site plan with the following conditions:

- Temporary dumpster be emptied no earlier than 8:00 am,
- Fence south of walkway on sheet C-105 be modified to a compliant fence, and
- Sidewalk be installed along 13 Mile frontage per Section 22.08.410.

The applicant has submitted revised plans which show they met the requirement for dumpster maintenance. Regarding the fencing standard, the applicant contends the fencing should be considered "athletic field" fencing which is permitted to be as high as seven (7) feet. The proposed fence will be six (6) feet in height and enclose the interior walkway that connects the tennis courts and proposed sports court. This is in addition to the approved ten (10) foot fencing around the existing tennis courts. Village Council will need to determine whether this fencing should be regulated as athletic field fencing, in which case the proposed fencing is compliant. Otherwise, the applicant will need a variance as the property is zoned Single Family Residential which limits front yard fencing to three (3) feet in height.

For all projects that require site plan approval, Village Ordinance, Section 22.08.140 Sidewalks or Bikeways, requires a sidewalk to be installed along the perimeter of the lot that abuts a major, intermediate, or collector street. Administration met with the applicant to discuss this requirement and potential options to assist in the efforts to connect the sidewalks in this area. The applicant is proposing to install a partial sidewalk to connect pedestrians from the western subdivision and to connect across 13 Mile Road for members who utilize the parking lot at Detroit Country Day School (the two organizations have a shared parking agreement). The applicant has proactively petitioned the Zoning Board of Appeals for a variance from full compliance to request approval of the proposed partial sidewalk as they believe there are practical difficulties unique to their site that would limit their ability to fully comply with that standard. That case will be heard on Tuesday, November 13th at 7:30 pm in the Southfield Township Office.

Mooney opened the public hearing at 7:59 p.m.

A letter from Shannon Niedzinski, Riverbank, was submitted. She was in support of the project at the Woodside Swim Club, and believes there is a high need for sidewalk installation on 13 Mile east of Lasher.

Toni Grinnan, Riverbank and Holly Hudson-Hott, Riverbank, spoke in support of the project, but expressed their concern for the safety of pedestrians where there is no available sidewalk on 13 Mile Rd.

Rick Hightine, Old Stage Road, would be opposed to a full traffic light at the crossing from Detroit Country Day, believing it would impede traffic.

Steve Paul, Old Stage Road, believes that sidewalks connecting from Lasher east on 13 Mile should be a Village priority.

No one else wished to be heard therefore Mooney closed the public hearing at 8:09 p.m.

REVIEW AND CONSIDER APPROVAL OF SPECIAL LAND USE REQUEST BY WOODSIDE ATHLETIC CLUB, 22440 W THIRTEEN MILE ROAD

All of Council agreed that installing safe sidewalks along 13 Mile is important, however, there were limits on what could be done by Woodside within reasonable cost parameters.

Motion by Nunez, second by Oen, be it resolved that the Village Council approves the site plan contingent upon the applicant being granted a variance for the fence and partial sidewalk compliance.

REVIEW AND CONSIDER TRAFFIC CONTROL ORDERS #042-SS-18 AND #258-NP-18 Administration provided copies of two Traffic Control Orders which have been in effect for 90 days. It is recommended that they now be made permanent.

Traffic Control Order 042-SS-18 calls for the placement of a stop sign on northbound Madison at Birwood making this a three-way stop intersection. There existed a stop sign for eastbound and westbound Birwood. Several residents reported issues at this intersection because Madison traffic did not stop for traffic leaving the stop on eastbound and westbound Birwood. This Traffic Control Order resolves this issue by making the intersection a three-way stop.

Traffic Control Order 285-NP-18 places no parking signs on Sheridan between Madoline and Elizabeth in the curve. Vehicles parked along this curve of Sheridan created sight distance issues for both northbound and southbound traffic. Posting no parking signs has resolved this issue.

Motion by Nunez, second by Oen, be it resolved that the Village Council approves both Traffic Control Orders #042-SS-18 and #258-NP-18. Be it resolved that the Beverly Hills Village Council approves Traffic Control Order #042-SS-18 to install a stop sign on northbound Madison at Birwood and #258-NP-18to install a no parking sign on Sheridan between Madoline and Elizabeth in the curve.

REVIEW AND CONSIDER RESOLUTION TO ADOPT THE OAKLAND COUNTY HAZARD MITIGATION

WHEREAS, the mission of the Village of Beverly Hills includes the charge to protect the health, safety, and general welfare of the people of the Village of Beverly Hills; and

WHEREAS, the Village of Beverly Hills, Michigan is subject to flooding, tornadoes, winter storms, and other natural, technological, and human hazards; and

WHEREAS, the Oakland County Homeland Security Division and the Oakland County Local Emergency Planning Committee, comprised of representatives from the County, municipalities, and stakeholder organizations, have prepared a recommended Hazard Mitigation Plan that reviews the options to protect people and reduce damage from these hazards; and

WHEREAS, the Village of Beverly Hills has participated in the planning process for development of this Plan, providing information specific to local hazard priorities, encouraging public participation, identifying desired hazard mitigation strategies, and reviewing the draft Plan; and

WHEREAS, the Oakland County Homeland Security Division (HSD), with the Oakland County Local Emergency Planning Committee (LEPC), has developed the OAKLAND COUNTY HAZARD MITIGATION PLAN (the "Plan") as an official document of the County and stablishing a County Hazard Mitigation Coordinating Committee, pursuant to the Disaster Mitigation Act of 2000 (PL-106- 390) and associated regulations (44 CFR 210.6); and

WHEREAS, the Plan has been widely circulated for review by the County's residents, municipal officials, and state, federal, and local review agencies and has been revised to reflect their concerns; and

NOW THEREFORE BE IT RESOLVED by the Beverly Hills Village Council that:

- 1. The Oakland County Hazard Mitigation Plan is hereby adopted as an official plan of the Village of Beverly Hills.
- 2. The Director of Public Safety is charged with supervising the implementation of the Plan's recommendations, as they pertain to the Village of Beverly Hills and within the funding limitations as provided by the Beverly Hills Village Council or other sources.

MANAGER'S REPORT

Organizational Meeting – The Village Council will have a tentatively scheduled special meeting on Tuesday, November 13th at 7:30 p.m. for the purpose of swearing in the four (4) members elected on November 6th to their terms. In addition, the new Council will select a President and President Pro-Tem for the upcoming two-year term.

Village Water Testing -- Water testing was first conducted in June of 2018, all of the homes tested then will be tested again in December. In addition to the 148 homes tested, anyone who has called since then to have their water tested will also be added to the list. At this time, the Village will test the water at a total of 166 homes in December. Calls will be made by staff the last two weeks in November to schedule dates to drop off and pick up sample containers in December. The schedule will be as follows:

Wed., Dec. 12th

Wed., Dec. 19th

Thurs., Dec. 13th

Thurs., Dec. 20th

Samples are taken to Paragon Laboratories on the Friday following each pick-up date. Results are typically emailed to the Director of Public Services within 10 days. Results are then mailed to the resident within the week.

14 Mile and Evergreen Gas Line Replacement – Consumers Energy will begin working on a gas line replacement project at the intersection of 14 Mile and Evergreen on Wednesday, November 7th. The Village was able to work with Consumers to modify the lane closures so that traffic will be maintained northbound on Evergreen to westbound 14 Mile throughout the duration of the project. Eastbound 14 Mile and southbound Evergreen/Cranbrook traffic will be detoured before the intersection. The Village has reached out the neighboring HOA's and Birmingham Public Schools to coordinate this disruption to traffic.

Background and Findings

Beverly Hills has participated in the federally funded Community Development Block Grant (CDBG) program for more than 25 years. We are currently in a three-year contract (2018, 2019 and 2020) with Oakland County to participate in this program which is administered through Oakland County's Community & Home Improvement Division. Each year's CDBG allocation is based on a formula that uses several objective measures of community needs. Those include the extent of population, low to moderate population and population in relationship to other metropolitan areas.

The Village's estimated allocation for Program Year 2019 is \$15,139. We must comply with several rules that include limiting our allocation for public service activities to a maximum of 30% of the total 2019 allocation and allocating a minimum of \$3,500 for each project.

This year Council is being asked to consider allocating funds for minor home repair services for low to moderate income citizens and public services (HAVEN). A description of each service is attached. This year we are recommending allocating \$10,598 for minor home repair and \$4,541 for HAVEN through the CDBG program.

While there are a number of other "eligible projects" that fall under the CDBG program, the village does not meet the low to moderate income criteria for expending funds on most of those types of projects.

NO-TALK PHONE SCAMS:

Dialing Deceivers Don't Need You To Say Anything To Rip You Off Most telephone scammers rely on talk, getting you to pick up the phone so they can give their impersonations of IRS agents, noble fundraisers, tech-support saviors or grandkids in need. But with a new breed of telephone fraudsters, sometimes you don't even need to say "Hello" to get ripped off. Here's how some of these crooks may target you.

Call Center Fraud There are scam artists who spend hours calling the customer service centers of banks, insurance companies and other institutions, posing as people like you, to try to access accounts. These crimes have more than doubled in the past year. "That's because reps only ask a couple of simple authentication questions — maybe your mother's maiden name or your Social Security number — before you can transfer money or do whatever," explains Ken Shuman of Pin drop, a company that provides antifraud services to call centers. Scammers start by assembling information on you, stolen in data breaches, purchased on the "dark web" or gleaned with a simple Google search. Then, working from boiler rooms (often overseas), they spend all day phoning different call centers to determine if you have accounts with those companies. With your data in hand, they can often answer the authentication questions that call centers ask. ATM PINs are especially prized — and vulnerable, adds Shuman. He notes that there are only 10,000 possible combinations for a four-digit PIN. Unless a bank's system blocks calls after several tries — and some don't — there are scammers who call back 150 times a day, trying different PINs until they get it right. Then they immediately log in as you, change your PIN and take over your account.

Smartphone Swindles

An ever-growing segment of the 20 billion text messages sent each day are attempts at defrauding people through "smishing" (a word that combines the SMS technology that sends text messages and phishing, a ploy to coax confidential information out of you). Typically, a scam texter will fake a problem with one of your financial accounts and ask you for data. Or they might pitch low-

cost mortgages or credit cards, or promise free gift cards. If you respond by texting back confidential personal information, your identity may be stolen. Millions of these smishing texts can be launched simultaneously.

Your best defense is to be stingy with your phone number. Scam texts may result if you provide it to contests, say, or businesses. Mobile apps can also be to blame. When you install them, the fine print in the user agreement may grant permission to the app's developer to use or sell your phone number and sometimes even the numbers of your contacts. In one recently popular scheme, scammers get your contacts from mobile apps, then text you posing as people you know to seek money or ID-theft-worthy information, says Jonathan Sasse, marketing executive at First Orion, a digital security firm that provides the mobile app Privacy Star.

One more important tip: Never follow a text's instructions to push a designated key to opt out of future messages. Instead, forward the questionable text to short code 7726, so cellphone carriers can block that sender. You can further bolster defenses against mobile scams — which have quadrupled in the past two years — with call-blocking apps such as Hiya, Truecaller, NoMoRobo and Privacy Star.

Curiosity Cons

Knowing that you are likely to ignore unrecognized or private numbers on caller ID, today's crooks use software that allows them to display fake numbers that are hard to resist. Here are some variations.

The neighbor ploy. Your area code and prefix are displayed, so the call appears to be from a neighbor or nearby business. "Fewer people are comfortable blocking local numbers, increasing scammers' success rates," notes Jonathan Nelson of Hiya. And the fake number makes it hard for law enforcement to track.

"Hey, there's a call from my own phone number" scam It's hard to resist answering a call from your own number, which scammers can simulate. And they are able to get around any call blocking that you've set up.

The one-ring rip-off. Criminals sometimes program auto-dialers to make repeated calls to you, each disconnecting after just one ring. They know this might spur you into calling back the displayed number to complain. There's double trouble if you call area codes such as 268, 664 and 876. These are for Caribbean countries and other places that have high per-minute phone charges. One scam involves getting you to call one of those numbers, then getting you to hold through transfers that rack up your bill until a scammer gets on the line and starts a fraudulent pitch. Beware.

There were 157 total rentals for the 2018 season. There were 79 resident rentals, and 39 non-resident rentals, this includes 15 Scout Troop rentals.

Combined rental and deposit fees total to \$40,145; \$3,500 allocated to Park Opener Fee, \$25,000 in refundable Damage Deposits, and \$11,645 to the Park Improvement/Usage Fee.

Scout Troops only pay damage deposit of \$100 which is returned, no net cost to them. VBH pays the \$25 park opener fee.

In total the Park Opener was paid \$3,575.

At their September 4, 2018 meeting, the Village of Beverly Hills Council approved an increase the Beverly Park pavilion rental fee by \$15 for all rentals beginning with the 2019 season. The additional amount will be paid to the park opener.

Attached is a copy of the 2019 fee schedule. Park rentals will open for residents on March 6, 2019 and April 3, 2019 for non-residents.

In the spring of 2019, the Park Opener job will be posted and candidates will be interviewed.

McLain called the meeting to order at 7:48 AM in the Village of Beverly Hills Municipal Building at 18500 W. Thirteen Mile Road.

McLain welcomed the newest member of the Cable Board, Sara Bresnahan, Beverly Hills resident. Borgon shared a few personal words about Sara, whom he has known all her life, as she and his daughter spent a lot of time together. He welcomed the next generation to the Cable Board. Sara stated she was eager to become involved in the community.

APPROVE MINUTES OF CABLE BOARD MEETING HELD SEPTEMBER 19, 2018.

Motion by Borgon, seconded by Gugni to approve the minutes of the Regular Cable Board Meeting on September 19, 2018, as presented.

COMMITTEE REPORTS

Cable Action Committee

Eick reported that the website was very close to completion. The new color and layout have been approved. He thanked everyone on the committee for their tireless contributions. McLain added her thanks to all the vendors for their assistance. White announced the next CAC meeting will be Thursday, November 1 at 4:30 PM at the Baldwin Library.

PEG Committee

Borgon reported there would be a meeting immediately following this meeting. There are a couple of grants to look at and consider: Baldwin Public Library and the Birmingham Public Schools, among others. He invited anyone interested to stay and participate.

EXECUTIVE DIRECTOR'S REPORT

White referred to her monthly report dated October 10, 2018. There were two (2) new complaints since the September meeting. The first (1st) complaint was from a Beverly Hills resident who had been having several problems with his WOW service, including pixilation, audio glitches and frequent loss of service. After complaining about ten (10) times directly to the

company without any success and four (4) separate service appointments which were of no avail, he filled out a complaint on the Cable Board website. White submitted it to WOW and a service technician came out to his house to resolve the problems. This compliant is closed. The second complaint was from a Beverly Hills resident who had problems with her AT&T service. This resident had come to a Board meeting several months ago asking for help with her AT&T problems which had been resolved. Unfortunately, she was now experiencing more service problems and AT&T informed her that a technician could not service her home for several days. The delay was unacceptable so she submitted a complaint and a technician came to her house that next day. She called to thank White and let her know that service had been restored. This complaint is closed. In White's opinion both WOW and AT&T should be congratulated because both were very responsive and prompt.

Replying to Ettenson inquiry, White stated that WOW was in Beverly Hills and Birmingham, not in Franklin or Bingham Farms. AT&T was in Beverly Hills and Birmingham and part of Franklin and Bingham Farms. Comcast was in all four communities. She has reached out to WOW but was told that it was not in their business plan to expand its footprint at the current time.

The account balances for the MBS, BBCU and Beverly Hills accounts as of September 30, 2018 were provided to the Board. If a Board Member has a question about the reports, please let White know.

Since the last meeting White has written three (3) checks on behalf of the BACB to the Charter Township of Bloomfield for BCTV's filming of two (2) sports events in September, to the Charter Township of Bloomfield for July-September Comcast internet costs and for necessary truck equipment repair.

Additional Notes

The Wall Street Journal has reported that cord cutters need to be aware that streaming TV prices were increasing. TV Technology reported that AT&T has asked the US Appeals Court to uphold the approval of its acquisition of Time Warner.

As requested the following is the paragraph White provided the Board in its monthly packet:

The Michigan Chapter of NATOA has issued a press release setting forth their opposition to the most recent FCC rule making proceeding on cable franchising which negatively impacts government transparency, local authority and longstanding local revenue in exchange for use of taxpayer supported Rights of Way (ROW). The proposed rule would potentially allow cable/video service providers to claim the value of their PEG channels as a credit against franchise feed, which could exceed the franchise fees currently paid and this could mean the end of either franchise fees or PEG channels. Franchise and PEG fees for Michigan communities currently stand at approximately \$100 million dollars annually. These fees are now at substantial risk. The proposed order, if adopted, will allow cable companies to decide what local benefits are now to be credited against franchise fees and deduct it from the percentage of gross revenues owed. Cable companies have now apparently convinced the FCC that they need the same chap or free ROW access as the telecom industry has for wire lines (Metro Act) and are currently

engaged in giving to the wireless industry under Michigan Senate Bill 637. Michigan NATOA is asking member communities and residents to contact their local and state representatives to urge them to VOTE NO on SB637 and tell them you want to keep YOUR local channel and YOUR public ROW fees that support government transparency.

Currier reported that MML and MTA remain neutral on this matter. He added that the FCC has a proposed rulemaking which would preempt SB637 and would be even worse than SB637. Currier_advised the Cable Board what other communities were doing in response. White added that the costs of lobbying efforts are huge on the state and federal level. Shand pointed out the consequences to the communities if such federal action was approved and McLain, who is on the Michigan NATOA Board, gave background information, purpose and advantages of having the Birmingham Area Cable Board. Referencing the proposed legislation, White explained to the public and the newest member of the Board that the right-of-ways are important and valuable assets to the local communities. She continued by saying this was a very important issue and a great concern that the funding for the communities might disappear. McLain stated that this has been a Board concern for a very long time and prompted it to have a conservative and cautious approach to spending those funds and to be very transparent with that. She re-iterated the Cable Board's responsibilities and it being financially accountable to the four (4) communities which created it.

McLain advised the public to call the Cable phone with questions, 248-336-9445 or go to the website, www.birminghamareacableboard.org, and submit a criticism, comment or feedback on the comments/complaints tab.

Borgon requested White to provide a new list of the Board Members for next month's meeting.

a. Comcast

There was no representative present.

b. AT&T/Uverse/Direct TV

c. WOW

There was no representative present.

White always invites the representatives to attend the Cable Board's monthly meeting. Kyle Mazurek, Comcast representative contacted her and shared information about its Internet Essentials Program and the news that Comcast and Amazon have announced a partnership to launch Amazon Prime Video on Xfinity X1 later this year which will be available to all Comcast customers.

Borgon spoke to his personal frustration with his cable provider, WOW, about service to one of his TVs. Not happy with the response that a technician could be out to his house later in the week, he called Leslie Bowman, the new WOW representative, directly, who then arranged for someone to be at his house the following day. He encouraged all residents to go to the website

and contact White with their frustrations about service because that process works and reduces a lot of anxiety. McLain requested that Board members who have problems to submit written complaints. These are then reported to Lansing about what the Board does and also creates a written document which can be referenced.

McLain explained to the public the purpose of the Escalation Team and its responsibilities in the process of handling complaints. White added that every year, by state law, the Michigan Public Service Commission does a survey of the providers and of local units of government, asking specific questions. Every year the BACB participates in this survey. She also pointed out that the Board is cognizant of the privacy issue with regards to complaints. Therefore, in her report of complaints to the Board at these Board meetings she will never mention specific names. McLain emphasized that those names are not put on the website and only provided to the Board members.

BAPA/BAMA REPORT

Rota referred to his memo to BACB dated October 11, 2018. He listed the completed **BAMA** Programs which were five (5) regularly scheduled municipal meetings, the BACB Meeting, the Parks and Rec Board Meeting, the Multi Modal Meeting, the Zoning Board Meeting, Advisory Parking Committee Meeting, the Baldwin Public Library Board and Trust Meeting and a Special Birmingham Point Meeting.

For the **BAPA** Programs, from the BACB area individual producers and organizations, twenty-four (24) programs were taped, all of which he listed.

The Baldwin Upgrade and the Drone Coverage will be covered in the PEG meeting following this meeting. As White reported, the truck cables were repaired. The last two (2) sporting events consisting of Volleyball at Seaholm and Football at Groves will be coming up this week. Weather concerns were discussed relating to equipment and TV coverage.

Delaney inquired about the ability to broadcast live a meeting which was held in other locations other that this particular building (referring to the Beverly Hills Council Chambers). Rota stated that the Evergreen Room in the Birmingham Public Schools Administrative Building on Evergreen has a room equipped for live broadcasts. The schools are in charge of the equipment and, if available, they would cover any meeting and it would go live. BCTV would get the file and would be able to re-broadcast it. Dwight Levens, Executive Director of Technology Services for the schools, stated that it would depend on the availability of that room. The live broadcast would be on Channel 17, not 15.

Copies of the bid request, bid tabulation, and all submitted bids were provided to the Board.

Wilson and Tom Meszler, Director of Public Works, reviewed this proposal and NCS has complied with all the requirements for the project set forth by the Village bid proposal. NCS submitted references, which have been checked and good recommendations were received from other municipalities they have completed work for. Administration recommends that the Village of Beverly Hills award this project to the low bidder, NCS, for the 2019 Invasive Species Eradication.

Dave Wolicki, Amherst, thanked Saur, Code Enforcement Officer Dan Gosselin, and Village Attorney Tom Ryan for their assistance with resolving chickens being kept on a neighboring property.

Wilensky arrived at 7:39 pm.

PUBLIC HEARING ON REQUEST FROM DETROIT COUNTRY DAY (DCD) SCHOOL, 22305 W 13 MILE ROAD, FOR SPECIAL LAND USE APPROVAL TO ADD A PLAYGROUND AND SPORTS COURT AT THE MIDDLE SCHOOL GROUNDS

Borden reviewed the submittal from Detroit Country Day School for a playground and sport court associated with the Middle School (plans dated 9/18/18). The proposed outdoor recreation facilities are located in the southwestern portion of the DCDS property and west/southwest of the recently expanded Middle School building, which was approved in 2016. Private schools and accessory elements are permitted with special land use approval in the R-1 District. In accordance with Section 22.08.300, modifications to the site after approval require a new special land use approval, as well as site plan review/approval.

Special use review. Section 22.08.300(h) provides the following standards for consideration by the Commission in its review of uses permitted after special approval:

Be compatible with the natural environment and conserve natural resources and energy.

The project area is not within a flood plain or wetland. Inclusion of these structures resulted in some modifications to the most recently approved landscape plan (2016). As such, a revised landscape plan is required with this submittal. Any trees that were removed to accommodate the structures, must also be identified.

Protect the public health, safety, and welfare as well as the social and economic well-being of those who will use the land use, activity, residents, businesses and landowners immediately adjacent and the Village as the whole.

The primary concerns related to outdoor recreation facilities are light intrusion and noise generation. The proposal does not depict any new lighting beyond what was approved along the emergency access drive in 2016; however, the applicant must confirm that neither facility will be lit. Additionally, given the proximity of the facilities to the adjacent residences, screening is another important element of the project. The submittal does not include a landscape plan, which is required for this project. The applicant should provide for additional screening (landscaping, walls or fencing) in the project area to help protect the nearby residences from excessive noise generation. Lastly, the applicant must provide an operational description of how and when these structures will be used.

Be of such design and impact that the location and height of buildings, the location, nature and height of walls, fences and the nature and extent of landscaping on the site shall not hinder or discourage the appropriate development and use of adjacent land and buildings or impair the value thereof.

Additional information is needed with respect to existing and proposed screening. Additionally, both facilities include chain link fencing; however, no details are provided.

Site plan review. Section 22.08.290 identifies the process and review standards applicable to site plans. The proposal has been reviewed for compliance with the applicable Ordinance standards:

The plans include several elements that were part of the 2016 special land use/site plan approval for the Middle School addition that are already constructed. In order to ensure clarity and consistency, the applicant must amend the plans such that these items are identified/depicted as existing, as opposed to new or reconfigured.

Lighting

The submittal does not identify any exterior lighting proposed in conjunction with the playground or sport court. The applicant must confirm that no new lighting is proposed as part of this project.

Landscaping and Screening

The submittal does not identify existing or proposed landscaping/screening within the project area. This information must be provided to determine the impacts of the request, as well as compliance with current Ordinance standards.

Fencing

Fencing is proposed as part of this project, but details are not provided. Depending on the specific details, Section 22.08.150(E) requires Planning Commission authorization for fencing taller than 7 feet that encloses an institutional playground, athletic field or similar use.

Engineering

The review of site grading, drainage and utilities is deferred to the Director of Public Services and Village Engineer.

Ostrowski opened the Public hearing at 7:51 p.m.

The following residents spoke against the approval of the playground and sports court on the middle school property.

Each of the residents explained that the playground and sports court were already constructed, and this construction was not approved with the middle school site plan submission, or permitted with the approvals provided by the Planning Commission and Village Council in 2016. They contend that DCD was not working with the neighbors, and had no intention of doing so. Each cited the high levels of noise multiple times a day, the height and expanse of the equipment, the lack of green screen as previously promised, the violation of the DEQ flood plain requirements, lights in the evenings on the property, and the continued events creating traffic and noise in the evenings.

A letter was submitted signed by the residents listed outlining their opposition to the proposed site plan deviation. Cited in the letter was the lack of conversation with neighbors related to the proposed site plan, noise concerns, that an agreed upon good faith compromised was reached between themselves and DCD, which was approved by the Planning Commission and Village Council in 2016. Despite that DCD constructed two retaining walls in the sloping area that had been previously deemed too steep for a play area, erected a large playscape and full sized basketball court closely behind and adjacent to the Georgetown neighborhood homes in a portion of the land that on the Village approved original site plan called for the installation of a landscaped sloping greenbelt buffer between the school and its Georgetown neighbors.

REVIEW AND CONSIDER RECOMMENDATION ON SPECIAL LAND USE APPROVAL AND AN AMENDMENT TO A SITE PLAN TO ADD A PLAYGROUND AND SPORTS COURT AT THE MIDDLE SCHOOL GROUNDS AT DETROIT COUNTRY DAY SCHOOL, 22305 W 13 MILE ROAD.

Sam Ashley, Cunningham-Limp, spoke representing DCD, he explained that the residents, representatives from DCD and his company, and a landscape architect reviewed and verified all plantings and plans for plantings. Scrub trees and bushes were removed, per homeowners' request, and before the completion of the project the intention is to complete all the plantings in compliance with the original site plan. The only deviation from the original plan is the construction of the playscape and sports courts. He explained that final inspections by the DEQ have not been performed as construction continues and the permits remain open.

Borowski, Drummond, Wilensky, Grinnan, and Westerlund all questioned the decision by DCD to violate their initial site plan. They expressed disappointment that DCD would build, without permission, structures not represented on the approved site plans.

Ruprich requested that Administration review all past motions related to construction and site plan approval to verify compliance by DCD. He requested that DCD submit a landscape plan, as well as documents from the DEQ related to compliance.

Motion by Borowski, second by Grinnan, to table the discussion until further information can be provided by Detroit Country Day.

Westerlund requested further consideration on regulations related to attached garages; particularly related to prohibiting them as accessory structures in front yards, as well as setback requirements and door size ratios.

Motion by Westerlund, second by Grinnan, to postpone recommendation pending discussion of language focused on attached garages.

PUBLIC HEARING ON DRAFT LANGUAGE AMENDING VILLAGE MUNICIPAL CODE, CHAPTER 22, SECTION 22.24 AREA, HEIGHT, BULK, AND PLACEMENT REQUIREMENTS, SCHEDULE OF REGULATIONS.

Borden explained that an updated draft based on subcommittee work and Commission feedback is what is being reviewed. The amendment contains opportunity for a resident to receive additional coverage allowance based on meeting conditions of using low impact design practices, or the ratio does not exceed the mean average coverage ratio for properties within 300 feet.

Ostrowski opened the public hearing at 9:34 p.m.

Kay Michel, Kirkshire, spoke on behalf of the Concerned Owners of Kirkshire, expressing their support of the low impact design principals. She suggested that the homeowners be required to meet both stipulations not just one. She also would like to see long term stainability and that there is controls in place to ensure continued compliance over time. She believes that the 35% allowance on R3 properties should be set at 25%.

Tracy Breen, Riverside Drive, suggested in 22.24.010.q it read "The Building Official OR PLANNING COMMISSION OR ADMINISTRATION..."

No one else wished to be heard; therefore Ostrowski closed the Public Hearing at 9:41 p.m.

REVIEW AND CONSIDER RECOMMENDATION ON DRAFT LANGUAGE AMENDING VILLAGE MUNICIPAL CODE, CHAPTER 22, SECTION 22.24 AREA, HEIGHT, BULK, AND PLACEMENT REQUIREMENTS, SCHEDULE OF REGULATIONS.

Westerlund questioned the intent of 22.24.010.q, and it was clarified that a homeowner can only have a maximum of 5% increase contingent on meeting one of the requirements. It was agreed that only the Building Official was qualified to make the assessment for Section 22.24.010.q.

All plans submitted by a homeowner are reviewed by Engineering for compliance. The Village does not currently have guidelines for low impact design, but may want to consider doing so in the future.

Motion by Westerlund, second by Wilensky, that the Planning Commission recommends the Village of Beverly Hills Council approve language amending Village Municipal Code, Chapter 22, Section 22.24 Area, Height, Bulk, and Placement Requirements, Schedule of Regulations, with the (Sq. Ft) in the header of the "Lot Minimums Area Width" Colum only listed as (Sq. Ft. and Feet).

Roll Call Vote: Motion passed (8-0)

SUBCOMMITTEE UPDATE - RECREATIONAL MARIJUANA.

Wilensky provided a summary of the proposed ballot initiative and potential impacts to the Village if passed. He reported that if approved a municipality can opt out by enacting a total prohibition, or can make regulations that limit the total number of licenses available.

Copeland noted that there is potential that Village Zoning Ordinances could prohibit certain types of businesses.
