#### CHARTER AMENDMENTS TO BE ON THE NOVEMBER BALLOT

Every so often, the Village reviews its Charter to make sure it complies with State law and also reflects to-days economic realities.

This review has just been completed and the Village Council has authorized a number of charter amendments to be placed on the November ballot.

The following is a synopsis of the proposed amendments.

- 1. Chapter II Powers in General Change the value of personal property the Village is allowed to acquire by purchase, gift or lease personal property without prior approval of the voters to not exceed \$20,000 (previously \$10,000). The cost of the office copier is approaching the \$10,000 limit
- 2. Chapter III Plan of Government Section 8 (2) this entire paragraph is changed from authorizing a Village Marshall position to clarifying the Village's ability to contract for police services and provide the authority for them to enforce Village ordinances and powers to preserve peace and safety in the community. The Village has hired police services and has not had a Village Marshal for many years.
- 3. Chapter III Section 8 (3) removes reference to removal of Village Mar-

shall.

- 4. Chapter IV Registration Section 21 clarifies that State law controls over any Charter election law provision which conflicts.
- 5. Chapter VI Ordinances Section 5 rewrites this section to provide for a fine not to exceed \$500 for an ordinance violations (was previously \$100.) and allows the Village to consider an ordinance violation as a civil infraction rather than a misdemeanor.
- 6. Chapter IX General Finance Section 7 - Eliminates wording tying financial reporting to annual Village elections (which no longer occur at the time set out in the current provision). Instead it now states the Village will provide such financial reporting as required by State law.
- 7. Chapter XVI Miscellaneous Section 11 Wording amended to be similar to that in Chapter VI Ordinances Section 5.

#### A Senior Must Have

They are called Vial of Life. The vials contain pertinent medical information to which emergency personnel can have immediate access.

The vial contains a medical sheet that identifies medical history and current medications. Fold the sheets and place them in the vial. Seal the vial and place it in your freezer, making sure the vial remains easily visible when the freezer door is opened.

Place a magnet on your refrigerator door and place the sticker adjacent to the entrance door of your home.

When emergency personnel see the stickers, they know you have a vial of life in your freezer and can immediately access the information.



#### State Fireworks Law

With more municipalities veering away from fireworks celebrations, some folks may increase their private celebrations. The State changed its fireworks regulations over the years, so here are some reminders about the sale and use of fireworks in Michigan:

The Michigan Fireworks Safety Act permits the sale and use of flying and exploding fireworks. The Act requires that licensed vendors verify that all purchasers of the exploding and flying fireworks are at least 18 years of age; however, there is no age restriction on the user of the fireworks.

Some of the fireworks that are now legal under the Michigan Fireworks Safety Act



Other fireworks remain illegal and cannot be sold or used in Michigan, including Cherry Bombs and M-80's. In addition, fireworks cannot be used on public property (schools, roadways, etc.), and the user of fireworks cannot be under the influence of intoxicants.

State law allows fireworks to be used any time, day or night, the day before a national holiday, the day of a national holiday, and the day after the holi-The Village prohibits excessive noise after 11:00 p.m.

If you plan to light fireworks during the holiday season, have a charged garden hose or some other water supply nearby just in case there's an accidental small fire.

If you have any complaints about fireworks displays, call the police department at the non-emergency number 248-626-5444. Bingham Farms has been fortunate that residents have been considerate of their neighbors. Thank you.

#### The President's Letter

This is a tough letter to write. What can I say about a Village official who has served Bingham Farms for more than 30 years and been my indispensable right hand for as long as I have been President?

Kathryn Hagaman, our Village Clerk/Administrator, made clear years ago that she would not work forever. We had a contingency plan on file. A few months ago she gave Council official notice of her retirement, effective August 31, 2018.

What a leader, what a career! Kathy started running for Village Council as a new resident back in 1984 and lost that election by 6 votes. Council, however, realized she had a lot to contribute and soon appointed her to fill a vacant Trustee seat. In 1989 she was appointed President to fill that vacancy. In 1991 she relinquished the Presidency to accommodate the Village's urgent need for a replacement Clerk/Administrator.

As President, Kathy was instrumental in reworking a contract with the Village of Franklin for police services, creating a formula to determine equitable costs and eliminating the need for annual negotiations. She also renegotiated the contract with the Baldwin Public Library,

again developing a formula basis to determine cost for services. These contracts continue today.

Her accomplishments as Clerk/Administrator have been many. Kathy spearheaded the first recycling program in the Village and continued building it through the years. Council adopted its first recycling ordinance in October 1991. Back in the day, the Village relied on the business expertise of its Council members in finding resources for DPW services. When those members retired from office, new resources were needed. In 2007 Kathy negotiated an Interlocal Agreement with Beverly Hills to provide DPW and Engineering Services on an as needed basis. This Agreement has provided the Village with a cost effective rapid response capability. She also negotiated the first ever contract with SOCRRA (South Oakland County Resource Recovery Assoc.) to allow Village residents to bring their household hazardous waste services to that facility. Up until that time, only SOCRRA members had this service. It took years to accomplish. Since then, other municipalities have entered into similar contracts.

The latest of Kathy's accomplishments was working with MDOT and the Road Commission for Oakland County to install seasonal sidewalks at minimal cost to the Village along major roads within the Village limits. The construction of these sidewalks was in conjunction with the Telegraph Rd. Reconstruction and the Bridge Reconstruction on 13 Mile Rd. projects. Further, Kathy secured grants from state and local entities to replace the high number of trees lost to the Emerald Ash Borer disease.

All this while running the daily operations of the Village, working with the Village's attorney and engineers, enforcing ordinances and handling complaints.

What can the Village President say to someone who has worked for the residents so diligently for so long, who did the heavy lifting and shaped the character of the Village? Words seem inadequate but, Kathy, please know how deeply we appreciate all that you have done.

## Friends of the Rouge

The Friends of the Rouge recently established the Friends of the Rouge Endowment Fund with the Community Foundation for Southeast Michigan. The Fund will provide perpetual support for the organization's mission to promote the restoration and stewardship of the Rouge River ecosystem for the purpose of improving the quality of life for the people, plants, and animals of the watershed.

FOTR is currently working with local partners to develop a water trail on 25 miles of the Lower Rouge from Canton to the Detroit River. Much of the river corridor is protected within Wayne County Parks, making it ideal for the development of launches and amenities. Downstream paddling highlights the unique industrial history of the Rouge River with the massive Ford Rouge complex, suspension bridges and a freighter or two.

#### Keep Your Lawn Healthy

Your lawn so far has survived a very dry spring. Now take steps to keep the lawn healthy by following these fertilizer tips.

- Mulch your grass clippings. Let short clips fall back on the lawn. Clippings are a source of nitrogen.
- Cut high. Leave 3 inches on the grass blade after cutting. Tall grass promotes root growth and shades out weeds.
- Rake compost into the lawn.
   Rake 1/2 inch of compost into an established lawn to build soil fertility.

Water the lawn to minimize

stress. A green lawn in Michigan needs .5 to 1.5 inches of water per week. Don't soak your lawn; watering should not pro-



duce puddles. Lawn dormancy is a natural response to drought. However, some water may be necessary during an extended drought of more than a month.

## When To Pull A Permit?

It's great to see all the activity in the Village with people working on landscaping, or making changes to the exterior of their home.

So, when are permits necessary and what work needs Village approval?

New homes and additions need Village approval before getting a



permit. Any significant changes to the exterior of a home may also require Village approval.

## Don't Feed the Deer

Cute to look at, but not when they're feasting on your hostas and other flowers. The Village receives complaints constantly, but there's not much the Village can do. Because we are in a populated area, it is not safe to cull the growing herds.

Making matters worse, some neighbors are actually feeding the deer. That is not a recommended activity for several reasons.



- Deer need to keep their foraging skills. This is how they survive.
- Having food out for them just draws more deer into the area.

There are a few products on the market that might detract the deer from eating your plants, products like Liquid Fence or Deer Off among others. One of the drawbacks for these products is that one has to rotate with different spray products because deer and rabbits will get used to the scent.


#### Kindly Pick Up After Your Dog

#### Water Rates Down Sewer Rates Up

The Oakland County water Resources Commissioner (WRC) has set the water and sewer rates for Bingham Farms residents. These rates include the cost to purchase water from the Southeast Oakland County Water Authority, the cost for WRC to operate and maintain the water supply system and establish a major maintenance reserve.

Water rates, beginning July 1, will decrease from \$26.17 to \$25.16 per Mcf, just under a 4% reduction.

On the sewer side, the increase is \$0.17 from \$25.65 to \$25.82 per Mcf.

For homes still on well water, the flat rate quarterly sewer charge will be \$129.10 up from \$128.25 last year.

## Rules for Cutting Down Trees

In an effort to protect the significant forestation in the Village, a Trees & Woodlands Protection Ordinance was enacted more than 10 years ago.

No more than three regulated trees may be removed from a site within a two year period without first obtaining a tree removal permit from the Village office.



No tree removal permit may be issued for an activity that results in the removal of more than 20% of the

#### Rubbish Pick Up Tips

The Village is seeing a few problems surfacing relative to what is considered a normal amount of trash on the regular Thursday pick up.

A weekly trash pick up should consist of one or two trash cans and maybe one or two other items.

If you are moving or have a large item to be thrown out, call Car Trucking and make special arrangements. They do not have the manpower to haul away large amounts of trash without prior notice.

Be advised, Car can invoice a property owner who places excessive amounts of trash out for a weekly pick

If you have a special item like tubs or sinks, hot tubs etc. call Car Trucking at 586-791-8480 and get pricing.

Or call another company for a trailer dumpster that can be dropped off right on your property.

#### Youth Group Set to Solicit in Village

Once again, a group of young people from the Michigan Conference of Seventh Day Adventists will be doing "door-to-door missionary work" in the months of July and August.

They will be asking to place Christian literature in each home that will accept it and enable residents to give a donation to help further their missionary training.

Religious organizations are protected by the First Amendment. However, they are subject to reasonable restrictions and must solicit during the day. They must obey any "No Solicitation" signs visible from the main door of a private residence.

As required by Village ordinance, the Michigan Conference of Seventh Day Adventists have fulfilled all the requirements necessary to "solicit" in the Village.

## Woody Debris Management on the River

Municipalities for decades have been working on cleaning up the Rouge River and its tributaries. This was done with municipal funding and millions of dollars of grants.

That program has been very successful

Unfortunately there are not similar programs for that portion of the wa-

terway that flows through private property. There are no grants at this point available to assist homeowners in remov-



ing debris from that portion of the river that runs through their property.

It means the cost of clean up is borne by that particular property owner.

The best recommendation that can be offered is for the property owner to contact a local tree removal company to see if they handle this type of work.

Plus there are other requirements imposed by the MDEQ (Michigan Dept. of Environmental Quality).

Local governments have no authority to regulate these waterways which are know as waterways of the state. The sole entity that does have this authority is the MDEO.

There are a few ways property owners can prevent pollutants to enter the waterway.

- Do not fertilize plants or lawn near water source.
- Preserve a "Buffer strip" of at least 10-feet of dense, preferably natural vegetation to grow along the water's edge and stream bank. This allows pollutants to filter out and the bank to stabilize.
- Never mow to the edge of a stream bank or pond. Leave a buffer of at least several feet for root development.
- Never mow grass shorter than 2.5 inches. The height allows for larger and deeper root system, a strong defense against weeds and drought.

#### Garbage Pick Up

- It's best in the summer to keep your grass at 3" as this prevents it from drying out.
- Do not let grass/weeds get to 8" or more as this will cause the Village to issue a violation.

#### **Construction Work**

Construction should not begin before 7:00 a.m. and should stop by dusk. Construction equipment should not start before 7:00 a.m.



#### **Contractor Signs**

Do not allow any contractor doing work on your property to put up their signs. This is considered advertising and is prohibited by Village ordinance.

#### Tree Removal

If you are taking down more than three trees, call the Village office to check whether a permit is needed. The village has a Tree and Woodlands Protection Ordinance.



#### **Summer Storms**

If the power goes out, call DTE at 800.477.4747. Call, even if your neighbor has already called it in. It helps DTE estimate how many customers are out of power.

#### Police Hold Cyber-Crime Seminar For Bingham Farms Residents

Cyber Crime continues to be a major problem not only in the U.S. but abroad.

Recently, Detective Sgt. Michael Bastianelli from the Franklin-Bingham Farms Police Department and Detective Jonathan Elges from the Oakland County Sheriff's Office gave a presentation to the Bingham Farms Mobile Watch and local residents on the topics of Identity Fraud and Cyber Security Awareness. It was held at the Bingham Woods Condominiums Clubhouse and attended by more than 40 people.

Beginning the presentation, Sgt. Bastianelli asked the attendees how many were victims of identity About 10 people raised their hands. Then he asked the remaining folks to raise their hands. They did and then were told it was more than likely they too would become a victim at some point.

Identity theft targets anyone and everyone.

Det. Bastianelli then covered the various areas of identity theft, prevention and proper course of action if you have or become a victim of identity fraud. It is imperative that everyone routinely check their credit reports and watch for unusual activity on credit cards.


He then covered other fraud scams ranging from phone fraud to phishing schemes. He also pointed out that in today's day and age everyone is susceptible to identity fraud and that all of our information is likely already on

the internet primarily due to all the corporate security breaches which have been seen in the media.

Detective Jonathan Elges of the Computer Crimes Unit has been a Deputy with the Oakland County Sheriff's Office for over 18 years and is a Certified Forensic Computer Examiner with Certification in Smart Phone Forensics.

Deputy Elges gave instruction on several computer related topics such as computer security maintenance tips, simple online identity theft prevention tactics, securing your personal data, safe internet use, ways to monitor credit, email security, and practices online thieves use to gain access to your personal information.

## Village Balances Its Budget Once Again

The Village Council recently approved a balanced Fiscal Year 2018/2019 Budget in the amount of \$1,998,915 and was able to maintain the 8.4 mill rate.

This was accomplished with just receiving a minor increase in state funding, and some savings in the rubbish category.

The total taxable value of properties in the Village this fiscal year is \$172,911,900, an increase of just 3.5% over last year, attributed to three new homes added to the tax roll in 2017. This total is less than the total taxable value of properties in **2001.** 

Given the constraints of both the Headlee Amendment and Proposal A, both controlling the annual increases in property taxes, the Village probably will never recover from the real estate recession of 2008.

This is the result of these two amendments combined with the bottom dropping out of the real estate market in 2009.


Local municipalities are searching for other means to keep current levels of service. For Bingham Farms, that is through its millage rate.


People believe that when a property is sold, it is uncapped and the

municipality benefits. But that's not correct as that gain is spread across all the taxpayers. The taxpayers benefit; the Village does not.

The only time the Village sees a bump is when a new home is built and only then does that assessed value become an addition to the tax base.

Adding up the impact and restrictions with Headlee and Proposal A, the loss of statutory state revenue sharing and the significant reduction in property values; hence the reason the Village must rely on its millage rates to provide necessary, quality services to its residents.





#### **Budget Highlights**

The Village Budget for FY 2018-2019 is \$1,998,915, a 5% increase compared to last year's budget.

There were two major categories with significant increases; Baldwin Library is up almost 4%. Rubbish is down 17% due to the elimination of the one-time charge for the new recycling carts.

As the graph depicts, 56% of the budget goes to public safety, which includes the purchase of services from the Franklin Police Dept. and the Franklin/Bingham Fire Dept.

The Village purchases library services from the Birmingham Baldwin Library. The cost this year is \$113,173, up about \$4,000.

Administrative expenses are \$430,411, up \$25,837. This category includes costs for office rent, rubbish collection, audit, planning, salaries, benefits etc.

The Village has concentrated on road maintenance projects. However, some of the roads now will need major reconstruction and the Village has established funding for these projects to avoid financing them.

#### Keep Fighting the West Nile Virus This Summer

Summer just started but the State's testing for West Nile Virus is ongoing and they've found the first mosquitoe testing positive. The virus develops more quickly as the summer heat progresses.

Last year, 40 Michigan residents were diagnosed with West Nile Virus and one death was reported. There were 2,002 cases and 121 deaths nationwide.

For most people the virus is just

a slight nuisance.
Many don't even realize they've been infected. It's another story for older adults and very young children. The virus could cause major problems.



The Oakland County Health Department believes that the low numbers of human infections is directly related to the prevention methods people are taking. The best advice — keep doing what you are doing.

- Reduce areas where mosquitoes breed,
- Repel to protect against mosquitoes, and
- Report potential mosquito breeding areas.

Other measures that can reduce the risk of contracting the virus include:

- Repair all holes in windows and screens to keep mosquitoes out of your home.
- Empty water from mosquito breeding sites such as buckets, barrels, cans, old tires etc.
- Avoid being outdoors when mosquitoes are most active (dawn and dusk).
- Wear light colored, long-sleeved shirts and long pants when outdoors.
- Apply insect repellants that contain the active ingredient DEET to exposed skin or clothing. Always follow the manufacturer's direc-

tions for use. (Avoid applying repellent containing DEET on children less than two years of age.)

The state and the county still monitor the situation by recording the number of dead birds. This often is an indicator that the bird was infected.

If you find a dead bird, report your finding to the Oakland County Health Division Hotline at 1-877-377-3641. Then, properly dispose of the bird and wear gloves to protect yourself from direct contact.

At this point, no Zika virus infections have been reported in Michigan.



## How to Safely Dispose of Household Hazardous Waste

It's convenient, easy and available all year long. Best yet, NO AP-

POINTMENT NEED-ED. Bingham Farms' residents can drop off their household hazardous waste products at the SOCRRA facility on Coolidge Highway in



Royal Oak. The contract between the Village and SOCRRA also allows residents to drop off electronic equipment, such as televisions (no consoles) and computer equipment.

Put the items in your car, drive to the facility, drive up to the little building in the back. Just show proof of residency (driver's license will do). The SOCRRA staff will do the rest. They

will remove all the items from your vehicle.

The whole experience should take less than an hour and that's door to door.

Remember the contract covers just household hazardous waste and electronics. It does **not** cover business hazardous waste. Federal and state environmental laws prohibit the facility from accepting this type of waste.

regulated trees on a site, unless a tree replacement plan is submitted and approved.

This does not apply to dead, dying or diseased trees. However, it is strongly recommended that anyone taking down any trees, call the Village to inform us of the project, the # of trees involved etc. This will prevent unnecessary follow up by the Village.

Additionally, dead trees on private property can become an issue especially if they are located in an area where they are a danger to the public or adjoining property. These should be removed. Otherwise, the Village may notify the property owner to remove said trees.

If they are not removed, the property owner is subject to a civil infractions ticket.

A simple call to the Village office makes the process much easier for everyone.
