Instructions

- You must complete a Net Profit Extension Request to extend a Net Profit Return beyond its original due date (105 days from the end of the fiscal year).
- Each business account **must remit a minimum of \$25.00 per location** with an extension request for the Annual Business License Renewal. The business license is set to expire upon the original due date of the Net Profit Return.
- Each account has a minimum of one (1) business location and/or performs a service in Boone County. In the case of multi-location entities within Boone County, each location must remit a \$25.00 fee PER location.
- Please insure that any overpayment claimed from a prior year return has not already been refunded by Boone County to the business.
- Please attach a copy of this completed extension request to the actual Boone County, Kentucky, Net Profit Tax Return upon filing of the return.
- Once approved your extension request is for 6 months from the original filing due date.
- This extension form extends the filing of the return but does not extend the time for paying the tax due.
- Any tax not paid by the original due date will be subject to interest fees.**
