#### **ELECTION DRAWING NEAR**

As 2016 draws to a close, some of our Officers and Board members will have completed their terms. The current President (Betsy Conrad) and Vice President (Virginia Lainhart) are currently serving their second terms, and may not be re-elected to those positions according to the organization's By-Laws. Therefore the **positions of President and Vice President will have to be filled in January 2017**. If you would be willing to serve in either of these positions, please contact one of the Officers or Board members so that we may place your name on the ballot that will be presented to the members in January.

The Treasurer (Steve Conrad) and Secretary (Pat Yannarella), whose current terms will be completed by our January 2017 meeting, may serve an unlimited number of two-year terms if re-elected by the membership. Both have agreed to continue in these posts should the members concur.

Board members may serve an unlimited number of three-year terms if re-elected by the membership. Betty Poole and Brent Johansen are currently serving the second year of their three-year terms. Ron Buckley is currently serving the first of his three-year term as Board member. Thus no election is required for a Board member position.

#### EAGLE SCOUT PROJECT NEEDS FUNDING

**Life Scout Joseph Kiely**, a member of Troop 727, has proposed a project that involves improving the Graves-Duncan Cemetery in Hebron. Joseph believes there are approximately 9 graves, including those of John Graves, captain of the Culpepper Militia in the Revolutionary War, and who just happens to be his Sixth Great Grandfather!

Joseph states that the overall condition of the cemetery has been in decline for years, that the surrounding fence is rusted and broken, and that at least two headstones are missing (John Graves and his wife Ann Rice). He has received permission from the current property owner to conduct the project.



Joseph is working with the local DAR chapter to apply for a marker, and he is seeking funding for materials, tools and supplies. After removing the old fencing, he hopes to erect a new fence with a gate in front. He has recruited fellow scouts as well as his extended family members to assist with the project. The projected time for completing the project is this November. Joseph has requested and received assistance and advice from **Matt Becher and Bridget Striker**.

The Boone County Historical Society has been asked to donate to the funding of this Life Scout's project. The estimated cost of the fence is \$480, concrete is estimated at \$35, Weed Killer \$75, DAR marker \$300...

## UPDATE ON HISTORIC MARKER FOR C.C.C. SITE IN WALTON

Betsy & Steve drove to Frankfort on August 30 to deliver the application for the CCC marker to the Kentucky Historical Society (KHS). The application included letters of support from Senator John Schickel, Representative Sal Santoro, Boone County Judge Executive Gary Moore, Walton Mayor Mark Carnahan, Walton-Verona School Superintendent Robert Storer. Thanks to each of those officials who prepared the letters.

Our deepest gratitude goes to **Matt Becher** who wrote the application and to **Bridget Striker** who helped in gathering and verifying the documentation that was needed to prepare the application.

Our thanks to **Boone County Historic Marker**Chairman Dennis Vesper who added his signature to the application. Once approval is received from KHS, Dennis and Steve will meet with School Superintendent and the Department of Highways official to determine the exact spot for the placement of the marker.

We should be notified by November 1st whether the application has been approved. The dedication would be held sometime next spring.
