## OUR ANNUAL OUT AND ABOUT AT DINSMORE HOMESTEAD AT 6:30 PM ON THURSDAY, JULY 20.



**Dinsmore Homestead is located at 5656 Burlington Pike (KY 18) about 6 miles west of Burlington, KY.**

The Dinsmore Homestead museum is a living documentation of several generations of a successful & cultured Boone County, Kentucky family and the men and women who labored for them. The farm is now a beautifully preserved site where visitors can step back in time and experience life as it was in nineteenth-century Boone County.

We plan to meet at the Homestead where Cathy Collopy will do a presentation about the people and times that made this place such a historic treasure.

## OUR MUSEUM

Our museum, located in the Old County Clerk's Office behind the Administration building in Burlington, has not been open for several years. This was caused partly to the pandemic and the water damage to the inside of the building.

We met last week with the Boone County Director of Property Maintenance, Mike Albrecht, at the museum and he is aware of the condition issues. The water damage was largely due to leaks from the box-gutters. New liners were installed in all gutters and tuck pointing was finished on the west-facing wall, but the plaster on the inside has not been repaired. There is also an issue with the air conditioner unit throwing the breaker. He has set a goal of 3 weeks to get necessary repairs going:

1. identify any existing moisture using infra-red technology
2. repair damaged plaster/paint
3. move dehumidifier to crawl space so trap-door can be closed (once no moisture is confirmed)
4. check/repair electrical issue with A/C unit throwing breaker

During the last several months, Ron Buckley, Pat Yannarella and Steve Conrad have been labeling and carding all the books by number. They will continue to catalog the artifacts, furniture and documents.

There is a need to rearrange displays, secure artifacts and do basic cleanup before opening to the public. This will have to be done once the repairs are finished.

When the building is ready, the Historical Society would like to begin to offer regular hours to be open to the public and for special events. We will need volunteers to staff it.

We hope to have our Museum open for the Community Yard Sale at the Administration's parking lot from 8 am—1 pm, October 7, 2023.

## THE ANNE FITZGERALD COLLECTION

Anne Fitzgerald volunteered for many years in the old records department of the Boone County Clerks office. She was the "go to" person for anyone searching the older records of the county. She also made records of older documents that she feared would be lost and kept them in her home.

When Mrs. Fitzgerald passed away, her heirs gave this collection of records to the Boone County Public Library. At that time, the History department of the Library reviewed the documents, kept what they wanted and gave the remainder of the collection to us. We hauled them from the basement of the Walton library and stored them in our museum. This collection consisted of 80 boxes of documents. Needless to say, the collection was overwhelming. We found that the collection could be donated to the NKU library but they wanted a detailed inventory of what was in the boxes. Several of our members tried to make this inventory but the task was overwhelming. Then, the museum was off limits to us while the Old Court House was being renovated and the judges' records had to be stored in our museum. After that the water problem occurred and everything was moved to hard to reach places so we could not do anything about this collection.

In late 2021, the Borderland Archival and History Center was created by the Boone County Judge Executive and would be housed at the main office of the Boone County Public Library. This organization would house all of the older records of the county. So, they now have the 80 box Anne Fitzgerald collection and will house them in a very secure and protected environment.

Since this collection of 80 boxes was removed from our museum, we now have room to set up our museum and make it available to the public.

## RE-OPENING OUR MUSEUM

Our museum houses collections that we have received over the years since 2007 when we opened it. We are purchasing a set of Barrister bookcases from the estate of Gail Ruef to store a great deal of our book collections. We have display cases to display much of our collection and we have two fire proof cabinets to store our most valuable items. The vault contains about 50 unsold copies of *Mastodons to the Millennium* books that were published for Boone County's Bicentennial in 1998.

In the past, we have been open for special exhibits that were centered around a theme. We have asked our membership to loan us items to display that was centered on that theme. We also opened for special events that were being held in the Administration's parking lot, such as the Chalkfest and Christmas events in Burlington.

Now that we are inventorying and restoring the museum, we would like to hear from our membership. What would you like the museum to look like and provide?
