CALL TO ORDER

A. Judge Gary W. Moore called to Order the meeting of the Boone County Fiscal Court. B. Commissioner Charles Kenner presented the Invocation and the Pledge to the Flag.

Judge Moore shared with the Court that he had attended the Swearing In Ceremony in Frankfort which is a historic day for the Commonwealth. Jeff Hoover was sworn in as the new Speaker of the House and new members of the State Legislature were also sworn in. Judge Moore commented, we will keep doing our part for Boone County.

Commissioner Flaig moved, seconded by Commissioner Kenner, to approve the Resolution. Judge Moore called for a vote on the motion, ALL PRESENT VOTING AYE 4-0. Clerk Kenny Brown thanked his Staff for all their work and acknowledged the great staff he has and thanked other departments that participate in elections. Judge Moore thanked Kenny Brown for all the work they do and stated the Court appreciates your cooperation in working with us. Commissioner Flaig commented she has been told the staff is very kind in helping with genealogy.

A. There were no Personnel Resolutions to present.

ITEM V.

ORDINANCES

A. Judge Moore asked the Fiscal Court Clerk to read into the record the First Reading of Item V. A: AN ORDINANCE RELATING TO THE BOONE COUNTY FISCAL COURT, KENTUCKY, PROVIDING A CREDIT OF ITS OCCUPATIONAL LICENSE FEE FOR NEW EMPLOYEES AS PART OF AN ECONOMIC DEVELOPMENT PROJECT BY BONFIGLIOLI USA. UNDER THE KENTUCKY BUSINESS INVESTMENT PROGRAM (KRS 154.32-010-KRS 154.32-100). Jeff Earlywine, County Administrator explained this company is located on the west side of 237; they have been at this location for ten (10) years. They are a global company and they are ready to activate their project, doubling the size of the interior space and investing \$7.7 M. They will be hiring forty-eight (48) new employees with an average yearly salary of \$46,000. The County will be giving the 50% credit Occupational License fee. Judge Moore commented this is an Italian Company and the Bonfiglioli family supports the U.S. operation here, they attended the ribbon cutting and are very supportive. Judge Moore asked if there were any questions and stated the second reading will be February 7th, 2017.

ITEM VI.

JUDGE'S REPORT

- A. Judge Moore asked the Fiscal Court Clerk to read into the record Item VI. A: A RESOLUTION RELATING TO THE BOONE COUNTY FISCAL COURT AUTHORIZING THE APPOINTMENT OF DOLF ALLESCH, BY GARY W. MOORE, COUNTY JUDGE/EXECUTIVE, TO THE SANITATION DISTRICT NO. 1 BOARD OF DIRECTORS. Judge Moore stated that Commissioner Walton had recommended Mr. Allesch for the Board appointment. Adam Chaney who was our Boone County appointment is now the new Executive Director for SD1. Mr. Allesch is a talented person and will serve a full term. Commissioner Walton moved, seconded by Commissioner Kenner, to approve the Resolution. Judge Moore called for a vote on the motion, ALL PRESENT VOTING AYE 4-0.
- B. Judge Moore asked the Fiscal Court Clerk to read into the record Item VI. B: A RESOLUTION RELATING TO THE BOONE COUNTY FISCAL COURT AUTHORIZING THE RE-APPOINTMENTS OF GREG BREETZ, DAVID BROWN, HARVEY RICHARDSON AND JESSE SHIPP BY GARY W. MOORE, COUNTY JUDGE/EXECUTIVE, TO THE AVIATION NOISE ABATEMENT COMMITTEE. Judge Moore explained these are re-appointments; we might have calls on noise due to construction at the airport. This Committee meets as needed. Commissioner Kenner moved, seconded by Commissioner Flaig, to approve the Resolution. Judge Moore called for a vote on the motion, ALL PRESENT VOTING AYE 4-0.
- C. Judge Moore asked the Fiscal Court Clerk to read into the record Item VI. C: A RESOLUTION RELATING TO THE BOONE COUNTY FISCAL COURT AUTHORIZING THE APPOINTMENT OF BRAD SHIPE, BY GARY W. MOORE, COUNTY JUDGE/EXECUTIVE, TO FILL THE UNEXPIRED TERM OF MIKE FORD ON THE BOONE COUNTY PLANNING COMMISSION. Judge Moore stated this appointment is to fill a vacancy. Mike Ford asked us to find someone to finish his term. Mr. Shipe is on the Board of Adjustments now and this will be a good move for him. Commissioner Kenner moved, seconded by Commissioner Walton, to approve the Resolution. Judge Moore called for a vote on the motion, ALL PRESENT VOTING AYE 4-0.

ITEM VII.

ADMINISTRATIVE MATTERS

B. Judge Moore asked the Fiscal Court Clerk to read into the record Item VII. B: A RESOLUTION RELATING TO THE BOONE COUNTY FISCAL COURT RECOGNIZING A CORPORATE NAME CHANGE BY SOUTHERN AIR INCORPORATED AS PART OF A RESTRUCTURING AND STRATEGIC AFFILIATION PURSUANT TO AN ECONOMNIC DEVELOPMENT PROJECT WITH WORLDWIDE AIR LOGISTICS GROUP, INC., UNDER THE KENTUCKY BUSINESS INVESTMENT (KBI) PROGRAM. Jeff Earlywine, County Administrator, explained this is a housekeeping matter. Southern Air had an incentive to make a corporate name change; nothing changes, just acknowledging a name change. Commissioner Flaig moved, seconded by Commissioner Walton, to approve the Resolution. Judge Moore called for a vote on the motion, ALL PRESENT VOTING AYE 4-0.

C. Judge Moore asked the Fiscal Court Clerk to read into the record Item VII. C: A RESOLUTION RELATING TO THE BOONE COUNTY FISCAL COURT APPROVING A PROPOSAL FOR SERVICES FROM H. W. LOCHNER, INC., RELATING TO THE ACQUISITION OF PUBLIC RIGHT-OF-WAY FOR THE VETERAN'S WAY CONNECTOR PROJECT. Jeff Earlywine, County Administrator, explained this is the next step in the Veteran's Way extension that will allow us to accept bids for the contactors. Federal funds are involved. Price of the project and the timeline are important facts. We met with Lochner and the engineers from District #6, they are well qualified. The fee of \$32,800 is fair and reasonable. Commissioner Flaig asked how many parcels of land are involved, Jeff Earlywine responded, three parcels and the businesses -YMCA and Huntington Bank. Commissioner Walton moved, seconded by Commissioner Kenner, to approve the Resolution. Judge Moore called for a vote on the motion, ALL PRESENT VOTING AYE 4-0.

- A. Judge Moore presented the Invoice Report dated January 3rd, 2017 and the pre-paid Invoice Reports dated December 22nd and December 28th, 2016. Judge Moore added the Clerk's Office was closed Friday and Monday by the State, not the Boone County Clerk's office. Kenny Brown responded the Motor Vehicle Department shuts down and updates the computers with the new tax numbers. Kenny Brown also stated in the future the County will be splitting some precincts
