- A. Commissioner Kenner asked the Fiscal Court Clerk to read into the record Item VII. A: A RESOLUTION RELATING TO THE BOONE COUNTY FISCAL COURT ADOPTING THE BOONE COUNTY JAIL POLICIES AND PROCEDURES MANUAL, THE BOONE COUNTY JAIL PERSONNEL POLICIES AND THE BOONE COUNTY JAIL INMATE RULES AND REGULATIONS. Jeff Earlywine, County Administrator, explained the documents are required by the Department of Corrections. It is a review of the written rules. One change is video visitation is now available. Commissioner Kenner moved, seconded by Commissioner Flaig, to approve the Resolution. Commissioner Kenner called for a vote on the motion, ALL PRESENT VOTING AYE 3-0.
- B. Commissioner Kenner asked the Fiscal Court Clerk to read into the record Item VII. B: A RESOLUTION RELATING TO THE BOONE COUNTY FISCAL COURT ADOPTING THE BOONE COUNTY JAIL WORK CAMP INMATE RULES AND REGUALTIONS. Jeff Earlywine, County Administrator, explained this document is the same as before. Commissioner Walton moved, seconded by Commissioner Kenner, to approve the Resolution. Commissioner Kenner called for a vote on the motion, ALL PRESENT VOTING AYE 3-0.
- C. Commissioner Kenner asked the Fiscal Court Clerk to read into the record Item VII. C: A RESOLUTION RELATING TO THE BOONE COUNTY FISCAL COURT AWARDING THE BID FOR 15,000 TONS OF ROAD SALT FOR THE BOONE COUNTY FISCAL COURT AND 5,000 TONS OF ROAD SALT FOR THE CITY OF FLORENCE TO MORTON SALT THROUGH THE KACO REVERSE ONLINE SALT AUCTION. Scott Pennington, County Engineer, explained the County awards salt bids each year. We received good prices this year due to the mild winter. The price was down to \$58/Ton. Commissioner Flaig asked how much salt we have stored from last year; Scott Pennington responded and mentioned the new salt storage building at Lassing will be a great asset. Jeff Earlywine, County Administrator, added the County underspent the line item from last year due to the mild winter. The newly installed conveyor also helps with managing the salt. Commissioner Flaig moved, seconded by Commissioner Kenner, to approve the Resolution. Commissioner Kenner called for a vote on the motion, ALL PRESENT VOTING AYE 3-0.
- D. Commissioner Kenner asked the Fiscal Court Clerk to read into the record Item VII. D A RESOLUTION RELATING TO THE BOONE COUNTY FISCAL COURT AWARDING THE ANNUAL BIDS FOR THE PUBLIC WORKS DEPARTMENT. Scott Pennington, County Engineer, stated these bids are for routine maintenance and materials. Commissioner Flaig moved, seconded by Commissioner Walton, to approve the Resolution. Commissioner Kenner called for a vote on the motion, ALL PRESENT VOTING AYE 3-0.
- E. Commissioner Kenner asked the Fiscal Court Clerk to read into the record Item VII. E. A RESOLUTION RELATING TO THE BOONE COUNTY FISCAL COURT AWARDING THE BID FOR STOP LOSS COVERAGE TO PAN AMERICAN INSURANCE COMPANY. Lori Zombek, Director of Human Resources, stated the County is self-funded, the stop loss bid is submitted every year. We suggest staying with our current carrier due to the excellent service. The quote from our current carrier is the second lowest quote, received however, the Staff upon recommendation from our insurance broker, S.D. Morgan, believes this is the best quote and will position the County for price stability for future periods. Jumping to the low quote each year is not always the best practice for the County. Commissioner Walton asked how many bids were received, Lori Zombek responded, 7 bids. Commissioner Walton asked about the annual premium, Jeff Earlywine, County Administrator, responded, \$409,000. Discussion on quality of service. Lori Zombek state organ transplant coverage was included this year. Commissioner Walton moved, seconded by Commissioner Kenner, to approve the Resolution. Commissioner Kenner called for a vote on the motion, ALL PRESENT VOTING AYE 3-0.
