#### ITEM III.

#### **PRESENTATIONS**

A. Introductory Remarks – Gary W. Moore, Judge/Executive.
Judge Moore stated our goal is to refocus on the Parks Master Plan, which was delayed during the pandemic. We have a final report from the Consultant, which will be discussed during the meeting. The County wants to hear from members of the community regarding their thoughts and opinions relating to the findings from the report. The Court will use the findings, as well as feedback and other information to begin establishing priorities that will guide the future expenditures and investments by the Fiscal Court. The County wants to focus on resources with the highest priority with the budget we have available. Judge Moore requested that there is one spokesperson for each group that speaks.

Jeff Earlywine reported this process began in the Fall of 2019 with Brandstetter and Carroll being selected as the Project Consultant with a contract awarded. A steering committee, made up of twelve community members was established to guide master plan work with staff, the pandemic slowed down the progress, however continued with virtual meetings. months to complete, there were surveys sent to over 700 community members, online surveys, focus groups and six open houses with over 200 attendees. Project was presented upon completion in April 2021 and tonight is the official restart.

David Whitehouse, Parks Director, thanked residents during pandemic, the parks were heavily used.

B. Boone County Parks 2030 Master Plan – Pat Hoagland and Keith Rodenhauser, Brandstetter and Carroll.

Pat Hoagland presented report via PowerPoint, commenting that a lot of the information in the report is based on the community feedback. Commissioner Brewer asked a question, Pat answered.

Judge Moore commented on the multi-use paths, particularly around the airport, which will connect communities to activities.
