

ORDINANCE NO. 2023 - 09

AN ORDINANCE RELATING TO THE BOONE COUNTY FISCAL COURT, KENTUCKY, AMENDING ORDINANCE NO. 2019-17, ENACTED ON JULY 23, 2019, AND LAST AMENDED ORDINANCE NO. 2022-06 ON FEBRUARY 22, 2022, RELATING TO THE USE OF GOLF CARTS ON CERTAIN DESIGNATED COUNTY STREETS AND ROADWAYS IN THE LINKS SUBDIVISION.

WHEREAS, the Boone County Fiscal Court previously enacted Ordinance No. 2019-17 enacted on July 23, 2019, and Ordinance No. 2020-19 amended on August 25, 2020, and Ordinance No. 2021-06 amended on January 26, 2021, and Ordinance No. 2022-26 amended on February 22, 2022; to allow operation of golf carts on certain designated streets and roadways within the County; and

WHEREAS, it is necessary to periodically add newly approved County roads to a Master Schedule of Designated County Roadways; and

WHEREAS, the Boone County Fiscal Court deems it necessary to amend Ordinance 2019-17 to identify newly approved Designated County Roadways pursuant to the Fiscal Court's authority under KRS 189.286.

NOW, THEREFORE BE IT ORDAINED BY THE FISCAL COURT OF COUNTY OF BOONE, COMMONWEALTH OF KENTUCKY:

Section One

The Boone County Fiscal Court hereby amends Ordinance 2019-17, adopted on July 23, 2019, and Ordinance No. 2020-19 amended on August 25, 2020, and Ordinance No. 2021-06 amended on January 26, 2021, and Ordinance No. 2022-06 amended on February 22, 2022, by adding the following streets and roadways as approved roadways for operation of golf carts to the County's Schedule of Designated Roadways listed in Section 8 of Ordinance 2019-17.

Glenn Arbor Drive (from Boone Aire Drive to Par Four Court)
Trophy Court
Caddie Circle
Putting Green Drive
Nine Iron Court

Section Two

If any section or part of any section or any provision of this Ordinance shall be declared invalid by a Court of appropriate jurisdiction, for any reason, such declaration shall not invalidate, or adversely affect, the remainder of this Ordinance. All Ordinances or parts of Ordinances in conflict with this Ordinance are hereby repealed to the extent of said conflict.

Section Three


This Ordinance shall be in effect and in full force from and after its passage, publication and adoption, according to law.
