This Public Hearing is to consider the following project: ORDINANCE NO. 383 – AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BRADBURY, CALIFORNIA AMENDING VARIOUS PROVISIONS OF TITLE IX (DEVELOPMENT CODE) OF THE BRADBURY MUNICIPAL CODE RELATING TO SENATE BILL 9 AND SECONDARY LIVING QUARTERS

Proposed Ordinance No. 383 is to replace Urgency Ordinance No. 380 that was adopted on December 21, 2021.

Project Location: City of Bradbury – City wide

Environmental Determination: Not a Project and Exemption – The Senate Bill 9 (SB 9) provisions of the Ordinance are not a project under the California Environmental Quality Act (CEQA) pursuant to SB 9. Provisions of the Ordinance amending other aspects of the Development Code are for clarification and consistency purposes and the City of Bradbury Planning Department is recommending that those aspects of the Ordinance are exempt pursuant to the common sense exemption set forth in CEQA Guidelines Section 15061(b)(3) that CEQA only applies to projects that have the potential for causing a significant effect on the environment.

The City of Bradbury City Council is seeking input from residents, property owners and any interested individuals or groups regarding the above-mentioned, proposed ordinance. Any persons favoring or opposing the ordinance are invited to present their views at this Public Hearing. If you challenge the action taken on the ordinance in court, you may be limited to raising only those issues you or someone else raised at the Public Hearing described in this notice, or in written correspondence delivered to the City during or prior to the Public Hearing.
