

June 27, 2022

The Bremer County Board of Supervisors met in session on Monday, June 27, 2022 in the Courthouse, Waverly, Iowa, at 9:00 a.m. Hildebrandt, Neil, Kammeyer present. Unless otherwise noted all actions were approved unanimously. Following the Pledge of Allegiance, the meeting was called to order by Chairman Hildebrandt. Kammeyer moved/Neil second to approve the agenda.

Board met with Andy Hockenson, Conservation Director, for a department update.

Kammeyer moved/Neil second to approve the 6/20/22 minutes.

Board met with Lindley Sharp, Public Health Administrator & Angela Miller, Deputy Public Health Administrator, for a department update.

Neil moved/Kammeyer second to adopt RESOLUTION #22-59 Fund Transfer. WHEREAS, Section 331.432 of the Code of Iowa requires the Board of Supervisors of Bremer County, Iowa to authorize the transfer of funds by resolution; BE IT RESOLVED, that the Board of Supervisors authorizes the following transfer per FY22 Budget: From General Basic Fund to Health Department Fund \$107,000.00. So passed and adopted this 27th day of June, 2022.

Kammeyer moved/Neil second to approve claims as listed below and authorize Auditor to issue checks.

Kammeyer moved/Neil second to table until 7/6/22 considering corrected FY23 wage sheets for Operator I and Operator II classifications for Secondary Roads.

Kammeyer moved/Neil second to adopt RESOLUTION #22-60 Fund Transfer. WHEREAS, Section 331.432 of the Code of Iowa requires the Board of Supervisors of Bremer County, Iowa to authorize the transfer of funds by resolution; BE IT RESOLVED, that the Board of Supervisors authorizes the following transfer per FY22 Budget: From General Basic Fund to General Supplemental \$450,000.00. So passed and adopted this 27th day of June, 2022.

Neil moved/Kammeyer second to adopt RESOLUTION #22-61 Fund Transfer. WHEREAS, Section 331.432 of the Code of Iowa requires the Board of Supervisors of Bremer County, Iowa to authorize the transfer of funds by resolution; BE IT RESOLVED, that the Board of Supervisors authorizes the following transfer per FY22 Budget: From General Basic to Co. Conservation Land Acquisition \$55,000.00. Transferring camp receipts to land acquisition fund. So passed and adopted this 27th day of June 2022.

Neil moved/Kammeyer second to accept the County Auditor’s audit Report & Certification of the June 7, 2022 Primary Election.

Neil moved/Kammeyer second to authorize the Board Chair to sign a \$10,000 Help America Vote Act Cybersecurity Grant agreement between Bremer County and Iowa Secretary of State.

Board met with Dan Pickett, Sheriff.

Kammeyer moved/Neil second to authorize Board Chair to sign a Letter of Release Agreement officially retiring and releasing K-9 Mo to the care of Glenn Beenblossom.

Neil moved/Kammeyer second to approve Sheriff Pickett’s request to make an exception to Bremer County Handbook Policy #3.1 Exempt Employees, Non-Exempt Employees and Overtime to allow compensatory balances above 25 hours to be carried over to FY23 for Dario Gamino, and Caleb Peshel, Jailers, to be used by 12/31/22.

Dimitrova exited.

Kammeyer moved/Neil second to authorize Board Chair to sign the IDNR Citizen Convenience Center Renewal Permit Application Form 50C.

Kammeyer moved/Neil second to approve five Utility Permits for Butler-Bremer Communications for installation of fiber optic cable along various roads in Jackson and Jefferson Townships.

Neil moved/Kammeyer second to adopt RESOLUTION NO. 22-62. Whereas, under the laws of the State of Iowa, the Bremer County Board of Supervisors is charged with the duty and responsibility of construction and maintaining the Secondary Roads of Bremer County. Whereas, the Bremer County Board of Supervisors has the responsibility to assure safe passage of vehicles on the Secondary Road System, and Whereas, the Bremer County Board of Supervisors under Section 321.474 of the 2022 Code of Iowa may, by resolution, impose load limits on Secondary Roads, and Whereas, it has been determined that the following bridges are not structurally adequate to carry legal loads:
