SOLID WASTE MANAGEMENT

E.J. Harrison Disposal & Diversion Tonnage for October 2020:

Disposal: 4,923 tons Diversion: 2,564 tons

The City's diversion rate for calendar year 2018 was approximately 67%, which exceeds the 50% state requirement. The 2019 diversion rate for calendar year 2019 is under review by CalRecycle.

<u>City Hall Paper Diversion</u>: The City Hall onsite paper recycling/shred program, offered by ACCESS, continues to divert paper materials from the landfill.

<u>City Household Hazardous Waste (HHW) Event</u>: A total of 282 participants attended the monthly event held November 13 and 14 at Clean Harbors Environmental. A total of 7.41 tons of electronic waste, universal waste, batteries, and HHW was diverted from the landfill.

<u>Pharmaceutical Drop-off Program</u>: Expired, unwanted, or unused pharmaceuticals collected from the secure drop-box at the Camarillo Police Station during the month of November totaled 369.1 pounds, bringing this year's total to 1,597.8 pounds.

<u>Battery Recycling</u>: Staff continues to collect mixed batteries from City Hall, the Library, and the Senior Center for proper disposal to Gold Coast Recycling.







- Created address list and web map for 2021 refuse pickup schedule.

- Completed outdoor dining online map with pictures of seating configuration.
- Continued assisting Public Works to display and analyze Roadrunner Shuttle trip data.

City Marquee

• In November, there was one request submitted via our website, and twelve by the City Manager's Office, for a total of thirteen messages approved and scheduled. The Marquee has messages scheduled through June 30, 2021.

Information Systems - General

- Received and installed five computers for evaluation in support of Library computer replacement project.
- Upgraded library software including Integrated Library System (ILS), and customer self-service and self-checkout systems.
- Replaced failed Secure Socket Layer Virtual Private Network (SSL VPN) device, which provides employees working remotely with secure access to City computer network resources.
- Opened six new support cases, and closed five support cases, for the City Enterprise Resource Planning (ERP) system. One case remains open.

- Installed new receipt printer and cash drawer, and configured Customer Service users, for second cashier workstation.
- Fulfilled public records requests for Building Permits and Purchase Orders.
- Provided analysis of delinquent utility accounts by zip code and amount owed, in support of State of California COVID-19 Financial Impact Survey.
- Completed development of new Agreements tracking application for Public Works, which facilitates collection and reporting of Agreement, Amendment, and Invoice data, and combines this data with existing Project, Vendor, and Purchase Order data from other sources.
- Scheduled, setup, and hosted Zoom webinars for City Council and Planning Commission.

Website

- Numerous updates to the City website related to COVID-19 (resources and business re-opening), City Manager (government channel television and CitySceneTV), and many others.
- Continued process of updating and modernizing the City website, with review of first draft showing proposed new design created by our website host.
- There were a total of 27,613 user sessions interacting with the City website for an average of 64 seconds, and viewing an average of 1.78 pages, each.
- 64% of these sessions originated from search engines, 30% was direct website access and 6% from links including social media (Facebook, etc.), other web sites, and email.
- 42% of our website traffic originated from Camarillo, and another 12% from other regions within Ventura County.
- Desktop users accounted for 56% of these sessions, with another 41% from mobile users, and 3% from tablet users.
- There were a total of 49,078 individual page views in October. Two pages, Utility Billing Online Payments and the Coronavirus news item, tied for most visited this month, each accounting for 7% of the total. This is somewhat noteworthy, as after months of declining popularity, the Coronavirus news item nearly doubled its number of page views from last month. The Employment page attracted 3% of total page views.

CAMARILLO PUBLIC LIBRARY

Library & RFBC Activity Report November 2020

City of Camarillo Public Library is where discovery leads. We are a choice destination, offering signature events and information resources that nurture learning and strengthen the community. Each month, the library presents a dynamic schedule of ongoing events, such as storytimes and book clubs, highlighted by these special activities:

Curbside Pickup

Throughout November the library continued to offer curbside pickup Tuesday through Saturday 10 a.m. to 6 p.m. as a safe and easy way to check out materials. An average of 146 pickups were filled each day the library was open in November. A total of 10,098 items were checked out or renewed. Tuesday, November 17 was the single busiest day with 205 pickups. Visit www.camarillolibrary.org for more information.

Adult Literacy Center

In November, 23 volunteer literacy tutors and adult learners practiced reading and writing skills and attended one tutor training workshop and one networking meeting.

Two tutors attended Tutor Ready Reading Webinar hosted by ProLiteracy. New Adult Literacy Coordinator Mara Neuron attended orientation for new Library Literacy Program Coordinators and Library Directors. Mara also attended the following webinars: "How a Nonprofit Achieved Efficiency with a Tailored Volunteer Management Solution," "Books That Motivate ESL Students to Read and Develop Fluency." She is completing Basic Literacy Tutor Training through ProLiteracy.

RUSSELL FISCHER BUSINESS COLLECTION

Operating within the Camarillo Public Library, the Russell Fischer Business Collection (RFBC) is embedded in the Camarillo business community and greater entrepreneur ecosystem. The RFBC provides professional and business development opportunities through special events and a curated collection of top business resources.

In November, Business Coordinator Nicole Valdivia fielded twelve phone calls from patrons, who continue to ask when the library will be opening to the public. Several requests were for access to a quiet work space or stable internet connection for work. Ms. Valdivia assisted patrons with access to the library's online databases, some of which had technical issues after the server migration in late November. Specifically, patrons needed help with navigating the features of BrainFuse JobNow, Lynda.com, First Research and Morningstar.

Ms. Valdivia addressed four emails from patrons that joined or had interest in the Business Book Club. Two emails were from people interested in working with the RFBC on virtual programming in January or February 2021. Ms. Valdivia assisted one patron with getting a new library card and accessing OverDrive for checking out eBooks, and she also instructed the patron on using other online databases.



RFBC Events - November

Mind Masters Meeting 11/3: Tracking Equity in Business and the Power of Follow Up – Discussed with ten attendees what business equity means and how to recognize its value. Presented tools to help increase business equity and write powerful follow up notes. Also discussed when to send a card or thank you referral gift and when just to send an email.

Mind Masters Meeting 11/17: 7 Metrics to Measure the Health of Your Business – Eleven attendees discussed seven metrics for measuring the health of a business, covering topics such as ROI, Operating Margin, Net Profit and Cash Burn Rate in depth for an increased understanding of how to spot shortages and pivot to save your business.

Mind Masters Meeting 11/24: Networking, To Cold Call or Not - Shared in discussion with nine attendees of how to properly reach out to potential clients. Discussed cold call scripts, reaching out by email and the power of a true business network referral.

Coffee Talk with Nicole 11/16: Discussed RFBC databases with seven patrons, resulting in seven new library cards for patrons.

Business Book Club: *The 4-Hour Workweek* by Timothy Ferriss. Eight patrons registered, four actively read the book and engaged in discussion throughout the month. Hosted five book club meeting sessions with a total of eleven patrons participating. Discussed relevant topics such as filling your day with busy work vs. getting important tasks done; hiring virtual assistants; delegating and how proper delegation can lead to growth in your business; identifying fear and overcoming it so you don't load your day with unimportant tasks; virtual and remote work environments; auto response and removing your work email from your cell phone.


The number of customers at the counter, number of plan checks, number of permits issued, number of inspections and permits issued online decreased in the month of November compared to the previous month.

November showed 60.5% of inspections were requested online and 10.5% of the 209 total permits were issued online.





The following is a summary of the activities within the Department of Community Development for the month of November 2020.

> Planning Commission Reviews

o EIR 2017-4, GPA 2017-1, and CZ-331, Camino Ruiz, LLC & ZDI, Inc.

On November 10, 2020, the Planning Commission recommended certification of an Environmental Impact Report (EIR), and approval of a General Plan Amendment (GPA) and a Change of Zone (CZ) to the City Council. The EIR analyzed the impacts of the proposed future development of a 385-unit apartment complex on the subject site at the southeast corner of Verdugo Way and Camino Ruiz, currently in review under RPD-201. The GPA would change the General Plan land use designation from Industrial to High Density Residential (18.1 to 30 units per acre), and the CZ would change the zoning from Limited Manufacturing (L-M) to Residential Planned Development, 30 units per acre maximum (RPD-30U). The EIR, GPA, and CZ are to be evaluated by the City Council on December 9th. If the City Council approves the EIR, GPA, and CZ requests, the RPD is anticipated to be reviewed by the Planning Commission the first quarter of 2021.

o SUP-9M(3), Boys and Girls Club of Camarillo

On November 10, 2020, the Planning Commission approved a Special Use Permit modification (SUP-9M(3)) for a 6,330-square-foot expansion to the existing 26,474-square-foot Boys and Girls Club facility, located at 1500 Temple Avenue in the Single-Family Residential (R-1) Zone. The expansion included a 6,062-square-foot addition within the footprint of the existing basketball court located on the north side of the facility, and a 268-square-foot addition to the main entry located on the west side of the facility. The project includes architectural updates to the existing facility and outdoor landscape and hardscape improvements.

> Community Development Director (CDD) Approvals

TUP-30, Collection Sites

On November 12, 2020, the Director of Community Development approved a Temporary Use Permit for the use of 900 square feet (5 parking spaces) of the

Camarillo Premium Outlets' parking lot located at 740 E. Ventura Boulevard in the Commercial Planned Development (CPD) Zone for the placement of a modular structure for walk-up COVID-19 testing.

o CPD-138M(28), Donahue Schriber

On November 23, 2020, the Director of Community Development approved a request for an administrative modification for the demolition of an existing 3,222-square-foot stick frame building and construction of a replacement concrete masonry building of approximately 4,165 square feet and façade modifications. The subject project is located at 2400B Las Posas Road within the Camarillo Village Square Shopping Center. The Camarillo General Plan Land Use Map designates the property for Commercial use and is zoned Commercial Planned Development (CPD).

o CUP-171M(13), T-Mobile

On November 23, 2020, the Director of Community Development approved an administrative modification to change the equipment on an existing monopole wireless communications facility, located at 333 Dawson Drive. The subject property is approximately 2.62 acres, is designated Industrial in the General Plan, and is zoned Light Manufacturing (M-1).

o IPD-401M(2), Institution Ale Company

On November 24, 2020, the Director of Community Development approved an administrative modification to add an approximately 1,549-cubic-foot grain silo with a height of approximately 22 feet and 3 inches on the west side of the existing industrial building, reconfigure a portion of the parking lot, and provide additional landscaping surrounding the proposed grain silo, located at 3841 Mission Oaks Boulevard . The property is approximately 1.05 acres, is designated Industrial in the General Plan, and is zoned Limited Manufacturing (L-M).

o PR-716M(2), Perez Residence

On November 30, 2020, the Director of Community Development approved a plan review of a new detached pool pavilion with bathroom, gas fire pit, and covered outdoor kitchen area on an existing legal lot developed with a single family residence and pool, located at 5329 Calarosa Ranch Road . The 0.47-acre subject property is designated Rural Density Residential (2.5 dwelling units per acre maximum) in the General Plan and is zoned Rural Exclusive 30,000-square-foot average lot size (RE-30AV).

1. CODE COMPLIANCE

- ➤ There was an increase in the number of building violations from last month. Staff addressed all violations. All cases are in the process of being corrected.
- Staff conducted 3 separate citywide Recreational Vehicle surveys. Staff inspected for encroachment on to the public right of ways, leaking of grey water, trash & debris and any other violations. Staff was able to assess how many RVs were being used for habitation purposes and how many appeared to just be stored on city streets.
- Staff obtained and executed an abatement warrant for an abandoned property. The front window and rear slider were broken and unsecured, the landscape was overgrown, and there was a significant amount of trash and debris. The property was not secure and appeared to have squatters using it for shelter. The property has been boarded up, weeds abated, trash removed and is currently secured. Staff is working on a permanent fix for this property.

- > Staff completed the final clearing of all political signs that remained 7 days after the election. This election year kept staff busy with illegally placed signs and informational calls.
- ➤ Animal Control Citations Animal Control issued 50 citations during the month of November. Staff is in contact with citizens who are submitting proof of compliance prior to citations being issued and requested the County update the appropriate database. After administrative review, two citation dismissals were processed.

> FY 2020/21 Action Plan

- HUD completed review of the FY 2020-2024 Regional Consolidated Plan (RCP), Analysis of Impediments (AI), FY 2020/21 Action Plan, and Citizen Participation Plan (CPP). HUD/City funding agreement was executed on September 9, 2020. City/Subrecipient agreements were executed September – October 2020.
- On September 23, 2020, the City Council approved the FY 2020/21 Action Plan Amendment to incorporate the CDBG-CV funding and to allocate \$43,094 of unspent funding from FY 2019/20 into FY 2020/21 programs. HUD has approved the amendment and the City has signed the funding agreement. Staff is preparing the subrecipient agreements for the CDBG-CV allocation.

> FY 2019/20 CAPER

- Staff completed the final FY 2019/20 draw-down of funds from HUD's Integrated Disbursements Information System (IDIS), closed out FY 2019/20 activities in IDIS, and prepared the FY 2019/20 CAPER on program activities for submittal to HUD. Per HUD regulations, the CAPER is made available for public review from September 29 to October 14, 2020. Staff submitted CAPER to HUD on October 19, 2020.
- Affordable Housing Preservation Program (City program) Mulberry Place Unit:
 - On June 15, 2020, an owner of a moderate-income unit within Mulberry Place subdivision notified the City of intent to sell their unit. The sale of the unit will correct an ongoing owner-occupancy violation. City staff calculated the owner's maximum sale price, evaluated City's position to purchase the property, opened escrow for the purchase on August 7, 2020, and presented the item at the August 26, 2020 City Council closed session. City Council authorized the purchase on September 23, 2020 and escrow closed on September 30, 2020.
 - The City purchased the unit for \$533,755.98, including closing costs. CDBG, Housing Bonds, and General Fund (fully repayable upon resale) were used for the purchase. Because CDBG funds were used to partially fund the purchase, staff completed the required NEPA review required by HUD.
 - The City is in the process of searching for a qualified buyer via the City's interested parties list. The resale will allow the City to update and extend the affordability covenant.

➤ CARES Act made available \$5 billion to HUD in supplemental CDBG funding for grants to prevent, prepare for, and respond to coronavirus (CDBG-CV). The City of Camarillo is eligible for a CDBG-CV allocation of \$192,347. The City advertised the availability of CDBG-CV funding for food support, grocery delivery, and rent/utility assistance. 3. AFFORDABLE HOUSING

- ➤ 2021-2029 Housing Element Update/ 6th Cycle Regional Housing Needs Assessment (RHNA):
 - o City staff began working with the consultant team (Rincon; Veronica Tam & Associates) in April 2020. To-date, progress includes developing project website, drafting of the Community Outreach Plan, preparing a draft land inventory, reviewing and updating the Housing Element document including the housing assessment and needs analysis, the analysis of constraints to development of housing, and goals/policies/programs.
 - On August 27, 2020, staff conducted the Public Workshop via Zoom webinar to introduce the Housing Element update process, introduce the draft land inventory, and solicit public input. Staff provided an update on the first workshop to the City Council and the Planning Commission at their October 14, 2020 meeting.
 - o On October 28, 2020, staff presented initial draft goals, policies, and programs to the City Council for feedback prior to the public workshop, anticipated in Winter 2020/21.
 - 2021-2029 Housing Element update is due to HCD by October 15, 2021. (Housing Element 8-year planning period is October 15, 2021 – October 15, 2029; 6th RHNA 8.3year projection period is June 30, 2021 – October 15, 2029).
- ➤ ParkWest Townhomes New Construction of 9 Moderate-Income For-Sale Units:
 - Staff approved the developer's sales/marking materials and sale prices on August 14, 2020. The developer began advertising and accepting applications for the units on August 27. Each application will be forwarded to City staff for review for compliance with the affordable housing program and for final approval.
 - o In October, staff verified eligibility of one applicant for a 2-BR unit. The buyer is currently in escrow and staff is working with the City Attorney on the preparation of the affordable housing agreement. The agreement will be executed by the buyer and the City, and then recorded at the time of close of escrow.
- Camarillo Village Homes New Construction of 29 Moderate-Income For-Sale Units and 3 Rental Low-Income Units:
 - Per developer's request, City Attorney is in the process of preparing first drafts of the Master Agreements for the moderate- and low-income units.
- Former Stock Lumber Site (2800 Barry Street):
 - City-owned property is anticipated to be developed with an affordable housing project by the Area Housing Authority of the County of Ventura and Many Mansions.
 - On December 11, 2019, the City Council approved the Term Sheet between the City of Camarillo and a joint venture between the Ventura County Area Housing Authority and Many Mansions for the potential sale and development of an affordable housing project.

The Term Sheet was executed by all parties. City Attorney is in the process of drafting the sale and development agreement.

- Draft MND was released for a public comment period from September 4 to October 5, 2020.
- The application for entitlements package was deemed complete, and the Development Advisory Committee (DAC) meeting was held on September 24, 2020.
- The Planning Commission recommended approval to the City Council at their meeting on December 1, 2020.
- o The project is anticipated to be scheduled for a City Council public hearing early 2021.
- Arneill Road Mixed-Use Project (five vacant parcels):
 - City-owned property is anticipated to be developed with a mixed-use affordable housing project. RRM Design Group was retained by the City to design the project and prepare the entitlements application.
 - The application was temporarily on hold while the City applied for the SB 2 Planning Grants Program. The City was awarded the grant, which may be used to cover the entitlements application fees. Incompleteness comments on the applications were provided to RRM Design Group on May 4, 2020 and November 4, 2020.
- Existing Rental Units:
 - o Staff verified income eligibility of four households for rental of affordable units.
- Refinancing of Affordable Units:
 - The City executed subordination agreements for the purpose of refinancing the first mortgage of two single-family units. The City subordinated the recording positions of an affordable housing agreement and a rehabilitation loan recorded on the titles of the properties.

BUSINESS TAX DIVISION

The Business Tax Division collected \$113,556 in November 2020. This reflects a 8.79% increase when compared to \$104,385 recorded for the same month in 2019.

For the month ending November 30, 2020, Camarillo has 4,831 In-Town businesses and 3,118 Out-of-Town businesses, totaling 7,929 active business tax accounts.

Hotel Transient Occupancy Taxes

The Transient Occupancy Taxes (TOT) remitted in November 2020 for stays in the month of October 2020 totaled \$193,703, a decrease of 21.08%, compared to \$245,444 recorded for the same period last year. Overall, year-to-date TOT collected decreased 30.30% compared to the same period in the prior fiscal year (Attachment 2).

- Hotel Rooms Occupied October occupied rooms were reported at 67.23% a 12.35% decrease compared to 79.58% in October 2019. Year-to-date hotel room occupancy has decreased by 15.63%, from 80.46% to 64.83%.



WATER DIVISION

- Water Division Customers achieved a 8.1% reduction in water use compared to November 2013, with a cumulative reduction of 20.0% for the calendar year to date compared to the same months of 2013, the baseline year used by the California Department of Water Resources to compare water conservation efforts.
- WaterWise Consulting conducted 8 residential landscape and irrigation surveys in November and installed 547 high-efficiency sprinkler nozzles.

STREETS DIVISION

- There were 240 work orders completed by the Streets Division.
- The cost of graffiti abatement for November was \$1,285 and there were 11 graffiti incidents reported.

- The Street Division's concrete crew continues to perform concrete grinding in the western portion of the City. The sign and pavement marking crew continues to refresh faded pavement markings and replace damaged raised pavement markers in the eastern portion of the City. This crew supports the Traffic Division by replacing, removing, raising, and upgrading City signage as necessary. This crew also performs monthly inspections of the Old Town area, and if necessary, subsequent repairs. Their inspections include signage, pavement markings, bollards, streetlights, street furniture, and statues.
- The in-house tree trimming crew is trimming trees in the western portion of the City and completes work requests as necessary city-wide. This crew also has personnel assigned to focus on small tree care, city-wide on-going weed abatement spraying, and mulch spreading as necessary.
- During the month of November, the City experienced several wind events that caused downed trees and excessive tree debris and trash to blown into the City right-of-way. City staff worked with contract services following each wind event to quickly clean up the City.

- Staff conditioned 4 new projects, conducted 5 plan checks, and coordinated with developers, contractors, and homeowners to review stormwater quality mitigation requirements.
- Staff virtually attended the Ventura County Stormwater Management Committee Meeting, Calleguas Creek TMDL MOA Meeting, Business Outreach and Illicit Discharge Subcommittee, Public Agency and Construction Subcommittee, and continued to virtually meet with and coordinate with developers for the Shea Homes Project.

INVESTIGATIONS

The Camarillo Investigations Bureau reviewed a total of 187 cases (101 felonies, 77 misdemeanors, 3 other crimes), of which 164 occurred in the City of Camarillo.

The 164 cases fell into the following crime categories:

- 87 property crimes: 10 of which were burglaries (2 residential, 4 vehicle, 4 commercial)
- ➤ 68 Crimes Against People (6 domestic violence)
- 9 Fraud/forgery type cases

Search Warrants/Probation Searches:

- Detectives wrote/served 9 search warrants
- Detectives conducted 0 probation searches

Case Closures:

➤ The Camarillo Investigations Bureau closed 104 cases, 72 of which were closed by arrests made by detectives, Special Enforcement Detail, or patrol.

Crime Trends:

▶ 6 commercial burglaries and 5 vehicle burglaries

> 6 stolen vehicles

➤ 13 grand thefts, 6 of them being catalytic converters

^{*}The Camarillo Special Enforcement Detail (SED) counts one arrest for each separate instance in which a person is arrested or cited & released. The arrests may have been the result of independent SED activity and/or SED's direct involvement with planned operations such as search or arrest warrants, probation or parole searches, surveillances, and/or any other support the unit may have provided during joint operations. These arrests may also be the result of any significant support provided for patrol or other agencies. Additionally, individual arrest totals for any given month will, on occasion, vary significantly (+/-) based on numerous factors such as surges in enforcement activity, availability of personnel, demands/complexity of investigative follow-up, and time spent on surveillances.

Summary of SED Activity for November:

- SED is currently working with the Sheriff's Major Crimes Bureau regarding an assault with a deadly weapon investigation. The case is ongoing and additional arrests are expected.
- ➤ SED concluded a month-long investigation reference organized retail theft. The suspect was committing thefts at major retails stores throughout Southern California. As a result of this investigation, SED detectives arrested five subjects in Camarillo that were involved in the thefts. This investigation is ongoing while

- detectives work with other law enforcement agencies to link the suspects to additional criminal activity.
- > SED conducted several training days in November for various law enforcement related topics

Note: A majority of contact with the homeless population has been via phone as a result of Covid-19.

TRAFFIC

Collisions

- ➤ 43 traffic collisions, 40 in October = 7.50% increase
- ≥ 21 injury collisions, 26 in October = 19.23% decrease
- > 0 fatal collisions, 0 in October = no change
- ➤ 3 private property collisions, 5 in October = 40.00% decrease
- ➤ 5 "hit and run" collisions, 4 in October = 25.00% increase
- ➤ 5 "hit and run" collisions solved. 4 in October = 25.00% increase

DUI

- ➤ 18 DUI arrests, 13 in October = 38.46% increase
- > 6 DUI collisions, 6 in October = no change

Traffic Citations

- ➤ 342 hazard violation citations, 435 in October = 21.38% decrease
- ➤ 501 total citations. 543 in October = 7.73% decrease

Parking Citations

- ➤ 236 issued, 240 in October = 1.67% decrease
- ➤ 50 vehicles red tagged, 84 in October = 40.48% decrease

Radar Trailer/LPR Trailer

➤ Five trailers were deployed throughout the city for a total of 2,568 hours. Two trailers were deployed in the city for detectives totaling 1,320 hours. Two trailers were deployed around the Camarillo Premium Outlets totaling 936 hours. The

remaining trailer was deployed at various locations in the city for traffic enforcement/education totaling 312 hours.

Towed vehicles

- ➤ 42 vehicles were stored, 53 in October = 20.75% decrease
- > 12 vehicles were impounded, 7 in October = 71.43% decrease

NOTES

During November, overall collisions went up slightly, but injury collisions were down. We are still looking at a 27% year over year decline in overall collisions and a 23% decline in injury collisions. This can be attributed to increased enforcement and fewer vehicles on the roadway due to Covid-19.

Parking citations and enforcement remained high this month. We actively worked with City Code Enforcement to remove numerous trailers that were illegally parked on city streets throughout our community. We are working with City Code Enforcement to create a special permit to allow recreational vehicles to be parked on the public roadways for the purpose of Covid-19 patients self-isolating.

Through the Office of Transportation Safety (OTS) grant, we were able to complete one DUI Saturation Operation. We are getting bids for the building of our new OTS DUI Trailer. We have also started outfitting the newly purchased Camarillo Traffic Investigation van and we hope to deploy it at the beginning of next year.

An employment meeting was conducted with the current crossing guards on 11/2 to finalize all the necessary paperwork. The school year began several crossing guards short due to medical disqualifications, retirements, and the abrupt beginning to this school year. Applications are currently being accepted and seven replacement crossing guards will ultimately need to be hired for this school year

Reserve Deputies: The two reserve deputies assigned to Camarillo PD logged 3 hours for the month of November, including 0 hours of patrol partnered with a full-time deputy.
