# Thirsty trees need a drink amid winter drought

Without the melting snow they rely on for moisture during the winter, trees and scrubs are thirsty. To help them survive the drought, homeowners should be watering once or twice a month if their water providers allow it.

“People tend to water too much in the summer and not enough in the winter,” says Robert Cox, horticulturist with the Jefferson County office of Colorado State University Cooperative Extension.

He recommends watering perennial beds and shrubs, such as roses and raspberries, as well as trees. Municipalities have banned lawn watering, and it’s not necessary during the winter, anyway.

Follow the advice from the CSU Cooperative Extension and Denver Water:

- Watering deeply and slowly is the best method, as you want the moisture to sink a foot into the soil. Use a deep root needle, a deep root fork or soaker hose for the best results.
- Water should be applied in a number of areas around the tree’s drip line, or the area from the trunk to the tree’s outermost branches.
- Water only when the temperatures are above 40 degrees and there is no snow.
- Apply 10 gallons of water for each inch of tree diameter. For example, using a deep- root fork or soaker hose that delivers 2 gallons of water per minute, a tree that measures 4 inches in diameter should be watered for 20 minutes. Using a soft-spray wand delivering 4 gallons per minute on the same tree, you’d only need to water for 10 minutes.
