ARTICLE 7 Parks and Recreation Commission

Sec. 2-7-10. Establishment; membership.

There is hereby created a Parks and Recreation Commission for the Town, consisting of seven voting members, and one alternate member with voting rights only in the absence of a regular member. Three voting members may be residents of the area served by the Recreation Department, but need not reside within the Town limits. One of the members shall be a Youth Commissioner, under 18 years of age at the time of appointment, who shall serve a term of two years. The Recreation Director shall be an ex officio, nonvoting member of the Parks and Recreation Commission.

Sec. 2-7-20. Powers and duties.

The Parks and Recreation Commission shall have the power and duty to

- (1) Act in an advisory capacity to the Board of Trustees in all matters pertaining to parks and recreation.
- (2) Review the preliminary budget prepared by the Recreation Director and provide input as needed before submission to the Town Manager and Board of Trustees.
- (3) Assist in the planning of a recreation program for the inhabitants of the Town and surrounding area, promote and stimulate public interest therein and, to that end, solicit to the fullest extent possible the cooperation of the school authorities and other public and private agencies interested therein.
- (4) Advise the Board of Trustees with respect to the acceptance of money, personal property or real estate donated or offered to the Town for recreational or park purposes.
- (5) Create and recommend to the Board of Trustees for approval a parks and recreation master plan and review such plan annually prior to the budget process, for the purposes of updating the contents.
- (6) Review all proposed subdivision plats for conformance with the parks and recreation plan and make suggestions and recommendations to the Board of Trustees with respect to the conformance to the Town's standards of proposed park and open space improvements contained in such plats.
- (7) Offer recommendations to the Town Manager for selection of the Recreation Director.
- (8) Perform such other duties not inconsistent with this Article as may be requested by the Board of Trustees, Town Manager or other Town departments or agencies.

Sec. 2-7-30. Appointment; terms.

- (a) Appointments to the Parks and Recreation Commission shall be made by the Board of Trustees. Persons interested in serving on the Parks and Recreation Commission shall complete an application expressing their interest in serving on the Parks and Recreation Commission and responding to representative questions as approved by the Parks and Recreation Commission.
- (b) Members of the Parks and Recreation Commission shall be appointed as outlined in this Section. Nothing shall preclude a member from serving succeeding terms if so appointed.

Commented [HS1]: Proposed code revision:

There is hereby created a Parks and Recreation Commission for the Town, consisting of seven voting members and up to two alternate members with voting rights only in the absence of a regular member. Two alternate members are allowed if one of the alternate members is a Youth Commissioner, under 18 years of age at the time of appointment. The Parks and Recreation Director shall be an ex officio, nonvoting member of the Parks and Recreation Commission.

Three members of the Commission, whether voting members or alternate members, may be residents of the area served by the Recreation Department, but need not reside within the Town limits.

Remarks: The length of terms is listed below in Sec. 2-7-30 (e) so there is no need to list the Youth Commissioner's term here.

- (c) Upon receipt of the application, Town staff will schedule with the Parks and Recreation Commission an interview of prospective candidates at a special meeting. The interview committee shall consist of a Board of Trustees liaison and the full Parks and Recreation Commission. Upon completion of the interview, the Board of Trustees shall then make the appointment.
- (d) In the event a regular member of the Parks and Recreation Commission resigns his or her position, the alternate, if interested in filling that position, will be required to submit an application, respond to the aforementioned questions and participate in the interview process.
- (e) The terms of the members, except for the Youth Commissioner, shall be for a period of three years. The Town shall be responsible for advertising for positions that need to be filled. Application forms shall be available at Town Hall. All applications shall be delivered to Town Hall.
- (f) If and when there is a vacancy on the Parks and Recreation Commission due to a resignation or other reason, the Chair, acting Chair or Recreation Director shall be responsible for notifying the Town Manager within two weeks of the vacancy.
- (g) The Parks and Recreation Commission shall formulate an appropriate application form for prospective members. The terms of office of the Parks and Recreation Commission members shall begin and end on August 31.

Sec. 2-7-40. Meetings, officers.

- (a) As soon as practicable following the first day of September every year, the Parks and Recreation Commission shall organize by electing three of its members to serve as Chair, Vice Chair and Secretary, respectively, to serve at the pleasure of the Parks and Recreation Commission.
- (b) The Parks and Recreation Commission shall hold such regular and special meetings as may be required. All proceedings shall be open to the public. The affirmative vote of a majority of the entire membership of the Parks and Recreation Commission shall be necessary for it to take any action except to adjourn. A member of the Parks and Recreation Commission shall serve as Secretary for the recording of minutes for the Parks and Recreation Commission, who shall keep a record of its proceedings and transactions. The Secretary may request a member of the Town administration to keep such minutes and records if he or she so desires. The Parks and Recreation Commission may prescribe regulations for the conduct of its internal affairs, which shall be consistent with this Article and other provisions of this Code. Copies of such regulations shall be kept on file in the office of the Town Clerk, where they shall be available for public inspection.

Sec. 2-7-50. Compensation.

The members of the Parks and Recreation Commission shall serve without compensation for their services as such, but may receive reimbursement for necessary travel and other expenses incurred on official duty when such expenditures have received prior authorization within the municipal budget.

Remarks: Do we need to state a length of term for the Youth Commissioner and why does it need to be different from the other Commissioners? Why can't the youth position be fluid and either there is one or there isn't? They could serve a full 3 years if they would like, otherwise they resign when their Capstone project is complete, they graduate, they don't want to do it anymore, etc. If they want to remain on the Commission, they can always apply for a voting or alternate member position once they are past the age of 18.

Sec. 2-7-60. Vacancies.

- (a) Any vacancies in the Parks and Recreation Commission, from whatever cause, shall be filled as required by Section 2-7-30 of this Article.
- (b) The office of Parks and Recreation Commission members shall become vacant, and shall be so declared by the Board of Trustees, under the following conditions:
 - (1) If a member is absent from three consecutive regular meetings of the Parks and Recreation Commission without first having notified the Parks and Recreation Commission or Recreation Director, the notification to be expressed in the minutes of the Parks and Recreation Commission's meetings.
 - (2) If a member is convicted of a crime involving moral turpitude.
- (c) The Board of Trustees may remove any member of the Parks and Recreation Commission for cause. The Board of Trustees shall consider removal of any member of the Parks and Recreation Commission for cause upon recommendation by a majority vote of the Parks and Recreation Commission.

BACKGROUND: This is an updated summary of the work plan budget goals that have been used in developing our FY-2021 budget specific to maintenance needs, potential grants and master plan goals.

Parks & Recreation Administration

- 1. Planned to Submit two Garfield County Federal Mineral Lease District mini-grants for a park improvement project that dovetails with our master plan recommendations but this opportunity is diminishing. The Police Department will have better luck in applying so we have taken this funding opportunity off the table for now. We still have two playgrounds in our inventory that need replacement. . Colorado Meadows and Hendricks. Managing the fiscal aspect of the Youth Art Park GOCO Mini-Grant with Carbondale Arts for implementation of this new playground-art park. (\$35,000)
- 2. Aquatics Facility Master Plan: FYI- fiscal year for GOCO is July 1 to June 30. Additional granting options will be available in June of 2022 and in 2023 for implementation of the Aquatics Facility Master Plan recommendations, specifically with the *Community Impact Grants*. This grant program replaced the *LPOR (Local Parks & Outdoor Recreation)* grant cycle.
- 3. Manage a Federal Fishing is Fun Grant offered by Colorado Parks & Wildlife (\$30,000 promised) after review and acceptance of the US Fish and Wildlife Service (USFWS) for the Crystal River Restoration project at Riverfront Park. This grant will partially fund ADA access from the road to the property. Collaborate with stakeholders on a phased approach with other grant opportunities. This would include the Aspen Valley Land Trust grant of \$55,000 awarded from the GOCO Resilient Communities Grant Cycle. The Town has entered as a grant partner and will be fiscally responsible for this reimbursable grant expenditures and contractual relationships. This grant is also earmarked for river access and classroom landscaping at the entrance to the project as a potential phase 1 of the Crystal River Restoration and Weaver Ditch Efficiency project

- 4. RESTORE GOCO grant opportunity, which is a new strategic partnership among Great Outdoors Colorado, the National Fish and Wildlife Foundation, Gates Family Foundation, Colorado Department of Natural Resources, Colorado Parks and Wildlife, and the Colorado Water Conservation Board, was applied for but not accepted in March. This was a \$200,000. ask with up to \$40,000 in matching funds. (Park Improvements 75-4800-9360)
- 5. Gateway RV Park Improvements. Continue work for the phased project process of adapting all rv sites to 50 amp power pedestals. Sites 1-14 now have 50 and 30 amp power. The final phase will be conducted next year to hook up sites 15-19 to 50 7 30 amp power. (RV Park improvements/equipment 01-4525-9360 \$32,000)

Parks Department

- 1. Utilized the Conservation Trust Fund to replace existing trash cans with bear proof trash cans and recycling specific bear proof cans in Town Parks. We placed these in Thompson Park (2) and RVR Triangle park (2). The next parks slated to receive bear proof trash cans will be Colorado Meadows (2) Rodeo Grounds and Ice Rink at the picnic shade pavilion (2). Total of 4 needed. (Trash Maintenance in Conservation Trust Fund 10-4800-3600 \$6,500 will fund 4 for 2022),
- 2. Red Hill Trails Maintenance and progress. Trailhead amenities project will utilize the endowment to complete phase one of the project. (Trail Maintenance 01-4520-3684 \$15,000 and Refund of Expenditures 01-36-42) Aspen Valley Land Trust received a GOCO Resiliency Grant for \$55,000, and the Phase 2 picnic shade shelter and outdoor classroom space at the Red Hill trailhead will be funded by this grant. Sign design and production is in progress.
- 3. New Variable Frequency Drive Pump for Miners Park irrigation system on order. This will allow us to irrigate this park with ditch water from the Rockford ditch vs. potable municipal water. Park Improvements/Equipment 01-4520-9360 \$50,000)
- 4. Starting the fence project at Hillcrest (White Hill) Cemetery (Cemetery Improvements/Maintenance 01-4520-9370 \$30,000)
- 5. Weed Management Plan Information: The comprehensive plan can be found on the Carbondale Recreation Center website: https://www.carbondalerec.com/rec-misc/parks/. 1. Starting the Ball Park Batting Cage installation at the Bill Hanks Baseball Field. (Baseball/Soccer Field Maintenance 01-4500-3652 \$3,500)

2. Replacing the archery Targets at the Nature Park

Recreation Center:

- 1. The CRCC has been hit hard on the revenue side due to the Covid-19 emergency. For 2021 we have decreased our budgeted expenditures by 13% but the projected revenue is projected to decrease by 71%. The CRCC has averaged a cost recovery for the last 13 years of our operations of 62%. Our cost recovery for 2021 is budgeted at only 21%. We will work to maximize recreation center use in the coming year but will do this in a secondary manner with public health and employee health and safety being priority number one.
- 2. **CRCC:** Open Monday through Thursday 6am-5:30pm, Fridays 6am to 4pm, and Saturdays 9am-1pm. Reservable time slots are in 60 minute increments to provide more access to more people with reservation-based time slots for a fee of \$4. Reserve on our website, https://carbondalerec.activityreg.com/selectactivity_t2.wcs
- 3. Fitness classes: Fitness classes are still taking place in half of the gym, with social distancing protocols and mask use. CRCC Fitness Classes. The following indoor classes are available. Must register in advance. \$4 drop-in fee per class. MASKS REQUIRED AT ALL TIMES!

- 5. Active Energy Management Plan Covid-19 Responses: Utilizing our new HVAC software upgrade to a cloud-based control system we will take the recommendations from the industry and CDC to enhance our air ventilation and filtration. This will include supplying fresh outdoor air through the systems air exchange options that will reduce re-circulation. We will also decrease the filter time frames and replace our box filters more frequently. We are using the Merv-13 and Merv-14 filter ratings recommended by CDC. Replaced Box filters (Recreation Center Building Maintenance 75-4500-3660 \$2,600)
- 6. Retrofitted the south entrance doors to be automatic to upgrade our ADA accessibility. (Building Maintenance Line Item 75-4500-3660 -\$9,000) Solar plant annual maintenance contract with Sol Energy and solar water heater maintenance contract with Solar Flair Thermal Systems (Building Maintenance 75-4500-3660 \$6,000)
- 7. Climbing Wall has been Inspected (Equipment Maintenance /Repair 75-4500-3530 \$3,000)

Swimming Pool:

- 1. Repair/Replace 2nd Main Pool Heater (Pool Equipment 75-4512-9360 \$8,325)
 Purchase two additional picnic tables. (Pool Equipment 75-4512-9360 \$3,000)
 Replace faucet, toilet and shower hardware in bathrooms (Building Maintenance 75-4512-3660 \$1,000)
- 2. Plan is to operate a reservation based pool use system but to expand the offerings and numbers of time slots available with higher capacities in accordance with the public health recommendations at that time.

Recreation Programming:

- 1. Produced two sheets of ice for public use and some youth recreation "Learn to Play Hockey" programming. (Gus Darien and 4th St. Plaza Park)
- 2. Our self-produced Special Events are moving forward, but will adapt to match the public health recommendations at the time of the event. For now we do plan on conducting the following events. 4th of July Parade, Light-Up Carbondale, First Friday Events, Bonedale Bike Week Bike Jam and Bike Rodeo, Easter 5K Scavenger Hunt, Spring into Fun Family Block Party (in September), the Turkey Cross Trot 5K Running Race & Full Moon Tri in January. We will maintain our managerial role for both Our Town, One Table and Potato Day. Cancelled events include Celtic Fest and Oktoberfest, Skateboard Competition, Festival Las Americas, and the Pedaleando. New events include a 5 Point Popup Drive in Show in April, the Tri for the Sun Triathlon in June and the O2 Festival in September and some concert and dance series taking place at the Thompson Park.
- 3. Classes available for registration:
 Skateboard Lessons (June-September), Early Release Tennis and Pickleball (May)
 Hikes (Summer), Tennis (June-August)
 Climbing classes and Dinky Dunkers Basketball programs are full for April.
- 4. Continue to be involved with the Garfield County Healthy Community Coalition with Margaret serving as a board member. Continuation of the local HEAL committee and collaboration with Roaring Fork Food Alliance, Cooking Matters, Garfield County Public Health, and the Colorado State University extension programs and instructors. Am Introduction to Gardening Class will also be offered with instruction from the Colorado State Extension this summer.
