PURPOSE:

Resolution # 13 Series of 2019 adopted the Town of Carbondale Integrated Weed Management Plan (CIWMP). The management techniques prioritized in this plan include prevention, cultural, mechanical, biological strategies and as a last resort, chemicals. This plan includes consult with area Natural Land Management Specialists to exhaust all strategies named above before resorting to chemical control. Before using any chemical on town managed land in Carbondale, it is necessary to get approval from the Board of Trustees, because Carbondale pursues an herbicide and pesticide free policy whenever possible.

On an annual basis an assessment, well in advance of the growing season, will take place of the weed mitigation methods used per park and on other Town owned lands. The effectiveness assessment will utilize data compiled on the Parks Department & Public Works Department Weed Management Plan spreadsheets, which detail the methods, techniques, timing, and effectiveness of the efforts of weed management presently being used. These documents also provide data on species of non-desirable plants not responding to the non-chemical treatment efforts.

If necessary, at this time a plan for the following growing season will be presented to the Environmental Board and to the Weed Advisory Board (Board of Trustees) for the use of an approved chemical treatment for the eradication of the weed in question, which will be identified by type, location, size of infestation, methods of chemical use, details of chemical used and the use regimen per location. Anytime chemicals are recommended for weed management to the Weed Advisory Board, the E-Board will have first reviewed the "Logs and Archive" of integral strategies pursued by staff, including the report from the Natural Land Management specialists to confirm that integral (chemical-free) management techniques have been exhausted, or are not realistic with budget limitations and staff availability. Town staff will consult with a Natural Land Management Specialist to determine the most beneficial and effective chemical management technique.

BACKGROUND:

The State of Colorado Noxious Weed Act (C.R.S. 35-5.5) was signed into law in 1990 and amended in 1996. Now known as the Colorado Noxious Weed Act (Act), it states that noxious weeds pose a threat to

the natural resource of Colorado. The Act also directs that the governing body of each municipality shall adopt a Noxious Weed Management Plan for all lands within the municipality. The Mayor and Board of Trustees shall provide for the administration of the Noxious Weed Management Plan authorized by the Act. In October of 2015, the Board of Trustees appointed a Citizens Weed Advisory Task Force to develop a noxious weed management plan. This citizen group produced a base plan that saw numerous revisions and was adopted last year. The *Integrated Weed Management Plan* that we are now using is the product of continuing refinement of the document by the Citizens Task Force, the Public Works Department, the Parks & Recreation Department, the E-board and the Parks & Recreation Commission.

DISCUSSION:

Reviewing the park specific management plans from 2019-2021, many of the techniques for weed eradication will remain the same and chemical free as we have seen progress in the success of these efforts. In addition, the steam machine equipment was purchased and used successfully for certain weed eradication efforts in 2020-21. The site-specific plans did expose some problem areas that are not responding well to our existing techniques. The following locations are problem areas that we are closely monitoring. These locations are not presently recommended for any chemical weed treatment.

- For the description of the public and at first growth we will increase our efforts to eradicate the weeds established in the gravel camp sites. We will continue to use avenger, a natural burn down herbicide, manual extraction and/or weed burning techniques, and continue to test the effectiveness of the steam machine weed control methods. We used the steamer multiple times on the Goathead (puncturevine) before and during flowering, prior to the bur seeds developing. Other weeds that are present on site include Scotch Thistle & Canada Thistle (B-List) which our manual extraction before they go to seed has been slowly diminishing the infestation and their annual regrowth.
- At the North Bridge Riverfront Park an infiltration of *Wild Parsnip* has established itself along the south side of the public access trail on the property. This is sometimes miss-identified as *Poison Hemlock*, a B-list weed. The plant leaves and stems can cause burns and blisters on the skin after touching, so due to the location our only option is to manually eradicate this plant with proper PPE. This did not take place in 2021 and the plant colony has grown and is now prominent along the ditch in this area and seems to be propagating up the ditch towards another ditch intersection, which will have the ability to spread the seed even faster throughout Town.

Our largest and most difficult weed management challenge is at our 2 acre irrigated dirt area at the North Face Bike Park. The Nature Park, the baseball infields and the roundabout parks each have unique weed issues also. The following parklands are recommended for chemical weed control subject to the Integrated Weed Management Plan guidelines for 2022.

➤ Nature Park- Last year we identified some patches of Common Burdock (C-list) and Hounds Tongue (B-list). There is also Canada Thistle (B-list) and Plumeless Thistle (B-list). We burned the park in the spring and organized another Friends of the Nature Park volunteer clean-up effort. We fenced off two experimental test plot area where we have identified the common burdock and the two thistles to the north and north west of the cabin and on a south east portion of the park that had disturbed soil (please see map). We cut the area in thirds and sprayed one section with Avenger, a burn down contact non-selective herbicide, one section with Tenacity, a

selective systemic herbicide, and a third section with Alpha Naturals organic product. This was conducted in a post emergent situation on established weeds for a one-time application trial to test the three techniques. Then we returned at two and then four weeks to assess the efficacy of the products.

Although the techniques revealed quite different initial weed responses the long term effect on the problem areas appeared to have no effect. There is enough of an embedded seed bed in the soil that our efforts did not produce a diminishing noxious weed infestation. The shady moist conditions around the cabin site would need a concerted effort and a revisit on a bi-weekly basis to see any progress here regardless of the product used. The meadow site, with the disturbed soil, and an abundance of Canada Thistle, displayed the same non-conclusive results at the 4 week mark.

Avenger: This produce seemed to work the best at the two week mark due to the burn down and non-selective nature of the product, but it left more opportunity for the Canada Thistle to come back because it had a detrimental effect on the native grasses. It did not effect the seed bed in the ground and would need to be reapplied every two weeks

Tenacity: Did not display worthiness for a chemical based herbicide and the selective nature was not specific enough for the three species of weeds we were experimenting on.

Alpha Natural Proprietary Product: We did not see any results different from the Tenacity test plots. A small reduction in the heights of the weeds but not a significant reduction in the number of weeds, and not an obvious weed damage provided by the Avenger product.

2022 - We will continue manual weed extraction around the cabin and the solar panels and burn what we can in the spring.

We will continue to monitor and will try to propagate the rust fungus that is working on *the Canada Thistle*.

- ➤ Baseball field infields- A perennial rhizomes bind weed Field Bindweed (C-list) and other weeds were manually removed in the fall of 2019 to a depth of 6" on Triangle, Bill Hanks and Tiny Nightingale infields. The steam machine was also used on Tiny Nightingale field to see if a deeper root steam technique would work. Monitoring the infields last spring during the growing period it appeared that these previous methods did not have a beneficial effect on these well-established weeds on any of these infields. Taproots of the bindweed can be 2-10 feet deep, seed can remain viable for 50+ years and shallow tillage only increases the number of plants. This rendered the steam machine an ineffective tool to deal with this weed. Since the fields were not being used and the daily field prep was not being conducted due to covid, the bind weed took over the infields. We used our "bolt drag" to try and pull the weeds in the infields and then handpicked the remnants, but this weed is established in the soil and we are not getting ahead of it with these techniques. Other weeds identified in the infields are Purslane, Prostate Knotweed, Common Mallow, Prostate Pigweed, Khakiweed.
 - **2022-** The Alpha Natural Proprietary Product showed promise on the bind weed in our experimental plot at the North Face Bike Park on the Rhizomes. We will test this product out on the infields this spring prior to use and then cap with additional infield soil .
- ➤ At the North Face Bike Park we are proposing a spot spray application to attempt to eradicate weeds on the Colorado Noxious Weed B list, Common Tansy, Hoary Cress (White Top) and

Canada Thistle. Common Tansy is a List B that requires elimination by 2022. We have been weed whacking and hand pulling the Canada Thistle and are keeping it from expanding, but mowing is not effective on the Tansy and Hoary Cress and may cause the plant to develop perennial characteristics. Both weeds have not responded favorably to our existing techniques for weed mitigation and have established themselves in specific areas adjacent to the riding surfaces in the bike park. In 2021 we continued with our techniques of weed whacking growth and we re-established the pea gravel on top of the weed barrier on the non-rideable surfaces within the park. The Parks Department is requesting the use of a spot application on the B-list noxious weed Common Tansy, Hoary Cress and Canada Thistle of the herbicide Escort XP with a non-ionic surfactant and to apply it when the plant is bolting to the bud growth stage.

The Public Works Department used a combination of weed steaming and a spot spray application of *Tenacity Herbicide* in the roundabout garden areas in 2021. Michael Callas, our Town Arborist, would like to continue this technique in the roundabout because there is no public access through that area and it would allow him to get a better handle on the bindweed and thistle. Mike believes that this may be our best alternative to other herbicides with higher toxicity ratings, and by using it in conjunction with the steamer he thinks he was finally able to make some headway. Tenacity Herbicide is a systemic pre-emergence and post-emergence herbicide for the selective contact and residual control of weeds. When used as a post-emergent, Tenacity weed killer is absorbed by susceptible weeds through foliar contact and soil absorption. Foliage of treated weeds cease growth after application, then turn white (loss of chlorophyll) and death may take up to three weeks. A repeat application is required after two to three weeks for improved post-emergence weed control. Its active ingredient, mesotrione, is based on a naturally occurring compound produced by the bottlebrush plant (Callistemon citrinus) that inhibits photosynthesis in susceptible plant species. It is absorbed by plants through the roots, shoots and leaves and distributed throughout the plant by both xylem and phloem translocation.

Town staff would follow the public notification rules stated in the CIWMP regards to use of herbicides on Town owned land:

Notification of Herbicide Use

- 1. Public Registry- town staff will establish a program for the registration of all pesticide sensitive (interested) residents so they may be informed, at minimum, within a 48 hour window before the application of an airborne herbicide.
- 2. On-site Posted Notification- Any town staff that uses any herbicides should comply with the following on-site notification procedure: Signs should be posted at all usual public and employee points of entry to the treated area and pursuant to State or Federal law, regulation and by product label instructions. Signs should be posted two (2) days in advance of application and remain in place for the re-entry interval as determined by the product label or regulation. Signs should contain the name and active ingredient of the herbicide product, the target plant, the actual date of application, the re-entry interval as determined by the product label or regulation, and the name and contact number for the town department responsible for the application. Signs should be of a standardized design that are easily recognizable to the public and workers.
- 3. Posted Notification on Town of Carbondale website of herbicide application on town property.

RECOMMENDATION:

The noxious weed management method selected should be the least environmentally damaging, yet practical and reasonable in achieving the desired results. In making these decisions all factors including budget implications, materials costs, training and availability of labor need to be considered. The challenge for the Parks & Recreation and Public Works Department is the total square acreage of parklands and gardens in the Town right of ways that require ongoing maintenance. The goal is to to develop the most feasible and time efficient means of noxious weed control.


It is the County's and the Town of Carbondale's philosophy to minimize the use of herbicides and impacts to desirable vegetation. However, for some species of noxious weeds, herbicide application is the most efficient and effective method of control. It is extremely important to treat small infestation of certain weeds (List A and B species mandated to be eradicated) as soon as possible. To ensure that small infestations of noxious weeds are controlled or eradicated effectively, it is extremely important to take immediate action on certain weed patches.

Parks & Recreation Department staff is seeking approval from the Parks & Recreation Commission, the E-Board and the Board of Trustees to use a spot spray application of a chemical based herbicides to eradicate the Type A and Type B Colorado Noxious Weed species from the Town owned land mentioned above. This recommendation would be presented to the Environment Board for additional review and to the Trustees for the final decision. The CIWMP states:

In this manner Town staff, whom have been trained in the application of the herbicide, receive permission from the Board of Trustees acting as the Weed Advisory Board, to use an approved herbicide for the eradication of a noxious weed on Town lands. This plan uses the expertise of land managers for a long-term strategy that has the goal of long-term eradication and/or control of noxious weeds without uncontrolled proliferation. Any permission obtained to use herbicides from the board of Trustees must follow the label instructions. Any use of a herbicide inconsistent with the label's directions is illegal.

Nature Park. The Friends of the Nature Park and the Roaring Fork Outdoor Volunteers joined forces in September 2021 to conduct a weed map of the property and to manual pull the known noxious weeds. We have identified some patches of Common Burdock (C-list) and Hounds Tongue (B-list). There is also Canada Thistie (B-list) and Plumeless Thistie (B-list). We burned the park in the spring 2021 and will try in 2022, and organize another Friends of the Nature Park volunteer clean-up effort. We fenced off 2 experimental test plot areas where we have identified the common burdock and the two thisties to the north and north west of the cabin and a disturbed portion of the meadow. We cut the area into test plots and sprayed them with Avenger, a burn down contact non-selective herbicide, some with Tenacity, a selective systemic herbicide, and some with a proprietary natural product developed by John Buerger, a Natural Land Specialist. This was conducted in a post emergent situation on established weeds for a one time application trial to test the three techniques. We then returned in two weeks and then in four weeks to assess the efficacy of the products. We will continue to monitor and will try to propagate the rust fungus that is working on the Canada Thistie.

The bind weed is taking over and needs to be dealt with. Covid caused a re-growth of the weed due to lack of use of the field and lack of machinge dragging. The root system grows horizontally about 6-10 inches below the surface sending off shoots of new plants. Just hand picking the foliage only makes the weed stronger and bigger. I want to see if digging the root systems will slow down the spread. We will try Alpha Naturals in 2022, and a infield material top dress. If the bind weed is unaffected from these new techniques, I will recommend spraying in either or both the fall and spring of 2023.

At the North Face Bike Park we are proposing a spot spray application to attempt to eradicate weeds on the Colorado Noxious Weed B list, Common Tansy, Hoary Cress (White Top) and Canada Thistle. Common tansy is a List B that requires elimination by 2022. We have been weed whacking and hand pulling the Canada Thistle and are keeping if from expanding, but mowing is not effective on the Tansey and Hoary Cress and may cause the plant to develop perennial characteristics. Both weeds have not responded favorably to our existing techniques for weed mitigation and have established themselves in specific areas adjacent to the riding surfaces in the bike park. The plan for 2022 is a burn the park in the spring and to continue with, weed whacking growth and re-establishing the pea gravel on top of the weed barrier on the non-rideable surfaces within the park. The Parks Department is requesting the use of a spot application on the B-list noxious weed Common Tansy, Hoary Cress and Canada Thistle of the herbicide Escort XP or Tenacity with a non-ionic surfactant and to apply it when the plant is botting to the bud growth stage.

BACKGROUND:

The Special Events Task Force met in person with a virtual option on November 30th and December 15th to review, recap, and discuss 2021 special events and the rules and regulations for special event use of Town property. The Task Force also discussed the 2022 special events and street closures, and due to the omicron variant of Covid-19, the proposed calendar of events will depend upon the public health orders at the time and is subject to change. The calendar represents all public special events on Town land, streets, parks and facilities.

STREET CLOSURES & SPECIAL EVENT RECOMMENDATIONS:

Moved events:

Wilderness Workshop Community Party from September to June First Friday

Garden Concert Series from Thompson Park to Bonnie Fisher Park

Festival Las Americas from May to June 26th in Sopris Park.

Potato Day will be first Saturday in October (October 1st, 2022) not the day after First

Friday, October 7th.

New Events: Gymkhanas-One per month in June, July, August, September and one on Potato Day in October.

Carbondale Fall Festival- October 14-16 at the 4th street Plaza Park.

Cancelled Historical Events: Green is the New Black Fashion Show-Carbondale Arts

Easter Egg Hunt- Town Parks & Recreation Department

Celtic Fest & Octoberfest -Town Parks & Recreation Department

First Friday: The Task Force recommended the continuation of the road closures between Weant Blvd. and 3rd Street every month throughout the year on First Friday from 5 to 9 pm to safely accommodate the large numbers of adults and children navigating Main Street. During the months of May, June, July, August and September, Main Street closures would extend to Snowmass Drive to accommodate businesses on the east end of main street and to provide additional space between Snowmass Drive and 3rd Street on Main Street for farmers market booths and local artisan booths. All First Friday Main Street Closures require overtime hours for

staff to close and open the roads. The larger main street closures require 3 Public Works or Parks Department staff members to be on duty to manually control a crosswalk at 3rd Street and Main Street to allow for north to south vehicle traffic. This effort allows vehicle access across main street in the east part of town. Town staff will continue to have the discretion to open up Main Street earlier than 9:00 pm if inclement weather and/or light pedestrian traffic warrants it.

Mountain Fair: Continue to extend Friday hours for music to 9:30 pm, but to have the music on Sunday evening end at 7:00 pm. This has allowed for an earlier Sunday evening Fair breakdown that proved to be less disturbing to the neighbors. Saturday evening schedule will remain the same with live music ending at 9:30pm and Fire Show performance ending by 10:00pm. Sopris Park neighbors in attendance were in support of maintaining these Mountain Fair hour changes that have been tested in 2018-2021. The task force felt the new Sopris park configuration and use of Weant Boulevard and the block of main street to 4th street should continue for artisan vendors, as would the use of 579 Main Street park.under a lease agreement with the park owners signed by the Town of Carbondale.

Parades:

Dandelion Day Parade will use the 2nd Street staging but then turn south onto Weant Blvd. for their parade route and allow the RFTA bus stops on Main Street and 6th street to keep the regular bus stop locations and schedules.

3nd Annual Pride Parade would take place during the First Friday in May when the Family Block Party is occupying the 4th street plaza park and street area. The request is to add an additional large street closure (Snowmass Drive to Weant Blvd.) for this May First Friday allowing the Pride Parade to conduct staging on Weant Blvd. and then head east on Main Street and to travel the traditional parade route to 2nd Street then back to 4th street Plaza Park.

Potato Day and 4th of July parades will stage on 2nd Street and Main Street and continue on Main Street to then turn south at the corner of 7th Street. The RFTA bus stop in front of the pool and the one on 6th street in front of the recreation center will have to be temporarily moved to the south west corner of 7th and Main St.

Dia De Los Muertos Parade travels from the 3rd Street Center to Main Street on the First Friday in November with volunteers providing traffic control on the side streets until they reach Main Street which is already closed for First Friday.

ANALYSIS

To accommodate and schedule a community calendar for event organizer's requested dates, staff is requesting BOT consideration to approve these events, the use of town facilities and the listed street closures. This will allow staff to begin working and outlining with event organizers the Town requirements, policies and procedures for them to sponsor and stage these events on Town property. (See attached timeline and flow chart) An Event Management Plan and/or Facility Use Agreement will be required of these events by the event organizers. Events that serve alcohol also require event organizers to appear before the BOT for their authorization to obtain a "Special Event Liquor License" from the Town Clerk. Events that utilize food vendors must prove that all vendors at their event have obtained a current vendor's license from Garfield County Public Health, as well as have a current Town of Carbondale Sales Tax License. All non-food vendors would also need to have a current TOC sales tax license.







Resolution No. 3, Series of 2022

PURPOSE:

Review authorization through the attached resolution for a TABOR election on April 5, 2022. The ballot question would ask voters to increase the Town of Carbondale debt up to \$8 million for the purpose of replacing the aging municipal pool. The ballot question language also shares with the voter that this increase in debt will be conducted without any increase in tax rates and without imposing any new taxes.

BACKGROUND:

Staff has been working with Hilltop Securities, our municipal bond financial advisors, to determine and detail the future cost of the Aquatics Facility bond. With their fiduciary responsibility to the Town of Carbondale they will also negotiate with bond underwriting. Hilltop Securities works with Butler Snow for their legal bond council and Butler Snow produced the resolution and ballot language.

ANALYSIS:

To set the ballot parameters Hilltop Securities recommended that \$8 million of Par with a 5% coupon scenario which would provide the most flexibility in the project fund size, structuring and interest rate movement. This will have a net interest cost of 4.241% with a total debt service (or a maximum repayment cost not to exceed amount) of \$14,433 million for a 25-year term. Consultants recommend this conservative approach so that the Par amount authorized in the question be equal to the anticipated cost of the project to be able to fully fund the project if market rates change. The maximum annual debt service at these numbers would be \$595,250. The average debt service over the 25 year term would be \$577,480/year. This assumes market rates as of November 11, 2021 plus 150 base points for interest rate. This means interest rates can move up by 1.50% and would remain within these projections. They are also assuming interest only payments for the first two years (2023 and 2024) due to the loan payment needs for the recreation center (\$200,000/per year) which will then be paid off in December of 2024.

DISCUSSION:

Representatives from Hilltop Securities and Butler Snow participated in the Trustee meeting on January 11, 2022 virtually to answer any questions. The consultants provided more detail on the election process and the other options for the maximum bond repayment costs.

RESOLUTION NO. 3 SERIES OF 2022

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE TOWN OF CARBONDALE, COLORADO, SETTING THE TITLE AND CONTENT OF A BALLOT ISSUE FOR A DEBT OBLIGATION TO BE SUBMITTED TO THE ELECTORATE OF THE TOWN OF CARBONDALE AND SETTING FORTH OTHER DETAILS RELATING THERETO AT THE REGULAR MUNICIPAL ELECTION TO BE HELD ON TUESDAY APRIL 5, 2022.

WHEREAS, the Town of Carbondale (the "Town"), is a duly organized and existing home rule municipality of the State of Colorado, created and operating pursuant to Article XX of the Constitution of the State of Colorado and the home rule charter of the Town (the "Charter"); and

WHEREAS, the members of the Board of Trustees of the Town (the "Board") have been duly elected and qualified; and

WHEREAS, Article X, Section 20 of the Colorado Constitution ("TABOR") requires voter approval for any new tax, the creation of any debt and for spending certain moneys above limits established by TABOR; and

WHEREAS, TABOR requires the Town to submit ballot issues (as defined in TABOR) to the Town's electors on limited election days before action can be taken on such ballot issues; and

WHEREAS, April 5, 2022, is one of the dates on which ballot issues may be submitted to the eligible electors of the Town pursuant to TABOR; and

WHEREAS, the Board hereby determines that it is necessary to submit to the electors of the Town, at the regular municipal election to be held on April 5, 2022, the question of increasing debt to finance the construction, installation and maintenance of park and recreation facilities including an aquatic center (the "Project"); and

WHEREAS, the electors of the Town previously approved a ballot issue authorizing the Town to collect a 0.5% sales and use tax to be used for the acquisition of land and the development and implementation of parks and recreational facilities and programs for the Town; and

WHEREAS, pursuant to Section 6-1 of the Town Charter, all elections of the Town are governed by the Colorado Municipal Election Code (defined below) unless otherwise provided in the Charter or by ordinance; and

WHEREAS, the Board now determines that it is necessary to submit to the electors of the Town, at the election on April 5, 2022, a ballot issue increasing debt to finance the Project; and

WHEREAS, it is necessary to set forth certain procedures concerning the conduct of the election.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF CARBONDALE, COLORADO, AS FOLLOWS:

Section 1. All action heretofore taken (not inconsistent with the provisions of this resolution) by the Town and the officers thereof, directed towards the election and the objects and purposes herein stated is hereby ratified, approved and confirmed.

Section 2. Unless otherwise defined herein, all terms used herein shall have the meanings defined in the Uniform Election Code of 1992, Title 1, Articles 1 through 13, C.R.S., as amended (the "Uniform Election Code") and Title 31, Article 10, C.R.S., as amended (the "Municipal Election Code").

Section 3. Pursuant to the Charter, TABOR and the Municipal Election Code, and all laws amendatory thereof and supplemental thereto, the Board hereby determines that a regular election shall be held within the Town on April 5, 2022 (the "election"), and that there shall be submitted to the eligible electors of the Town the question set forth in Section 4 hereof. The election will be held as a mail ballot election, and the Board hereby determines that the Town Clerk shall conduct the election on behalf of the Town.

Section 4. The following ballot issue, certified in substantially the form set forth below, is hereby referred to the registered electors of the Town and shall appear on the ballot of the Town at the election with the following ballot title which is set pursuant to Section 31-11-111, C.R.S.:

SHALL THE TOWN OF CARBONDALE DEBT BE INCREASED UP TO \$8 MILLION, WITH A MAXIMUM REPAYMENT COST NOT TO EXCEED \$14.437 MILLION, WITHOUT ANY INCREASE IN TAX RATES AND WITHOUT IMPOSING ANY NEW TAXES, SUBJECT TO THE FOLLOWING:

- THE PROCEEDS OF SUCH DEBT TO BE USED FOR THE CONSTRUCTION, INSTALLATION, OPERATION AND MAINTENANCE OF PARK AND RECREATION FACILITIES INCLUDING AN AQUATIC CENTER;
- SUCH DEBT TO BE EVIDENCED BY BONDS, NOTES, CONTRACTS OR LOAN AGREEMENTS AND SHALL BE PAYABLE FROM THE TOWN'S EXISTING ONE-HALF OF ONE PERCENT SALES AND USE TAX DEDICATED TO PARK AND RECREATION PURPOSES AND FROM OTHER AVAILABLE REVENUE OF THE TOWN IF SO DETERMINED BY THE TRUSTEES;
- SUCH DEBT SHALL BE SOLD IN ONE OR MORE SERIES, ON TERMS AND CONDITIONS AND WITH SUCH MATURITIES AS PERMITTED BY LAW AND AS THE TOWN MAY DETERMINE, INCLUDING PROVISIONS FOR SALE OF THE BONDS AT A PRICE ABOVE OR BELOW PAR, AND FOR REDEMPTION OR PREPAYMENT PRIOR TO MATURITY, WITH OR WITHOUT PAYMENT OF A PREMIUM?

Section 5. The Town Clerk is hereby appointed as the designated election official of the Town for purposes of performing acts required or permitted by law in connection with the election.

Section 6. If a majority of the votes cast on the question to authorize indebtedness payable from the Town's sales and use tax dedicated to park and recreation purposes and from other available revenue of the Town shall be in favor of incurring such indebtedness as provided in such question, the Town, acting through the Board, shall be authorized to proceed with the necessary action to incur indebtedness payable from the Town's sales and use tax dedicated to park and recreation purposes and from other available revenue of the Town in accordance with such question.

Any authority to contract indebtedness payable from the Town's sales and use tax dedicated to park and recreation purposes and from other available revenue of the Town, if conferred by the results of the election, shall be deemed and considered a continuing authority to contract the indebtedness payable from the Town's sales and use tax dedicated to park and recreation purposes and from other available revenue of the Town so authorized at any one time, or from time to time, and neither the partial exercise of the authority so conferred, nor any lapse of time, shall be considered as exhausting or limiting the full authority so conferred.

Section 7. If a majority of the votes cast on the question to authorize indebtedness payable from the Town's sales and use tax dedicated to park and recreation purposes and from other available revenue of the Town as described above are in favor of such indebtedness, the Town intends to issue such indebtedness in the approximate aggregate principal amount of \$8 million to pay the costs of the Project, including the reimbursement of certain costs incurred by the Town prior to the execution and delivery of such bonds, upon terms acceptable to the Town, as authorized in an ordinance to be hereafter adopted, and to take all further action which is necessary or desirable in connection therewith. The officers, employees and agents of the Town shall take all action necessary or reasonably required to carry out, give effect to and consummate the transactions contemplated hereby and shall take all action necessary or desirable to finance the Project and to otherwise carry out the transactions contemplated by the resolution. The Town shall not use reimbursed moneys for purposes prohibited by Treasury Regulation §1.150-2(h). This resolution is intended to be a declaration of "official intent" to reimburse expenditures within the meaning of Treasury Regulation §1.150-2.

Section 8. Pursuant to Section 31-10-1308(2), C.R.S. and Section 1-11-203.5, C.R.S., any election contest arising out of a ballot issue or ballot question election concerning the order of the ballot or the form or content of the ballot title shall be commenced by petition filed with the proper court within five days after the title of the ballot issue or ballot question is set.

Section 9. The officers of the Town are hereby authorized and directed to take all action necessary and appropriate to effectuate the provisions of this resolution.

Section 10. If any section, paragraph, clause or provision of this resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall in no manner affect any remaining provisions of this resolution.

Section 11. All resolutions or parts of resolutions inconsistent herewith are hereby repealed only to the extent of such inconsistency. This repealer shall not be construed to revive any resolution or part of any resolution heretofore repealed.

Section 12. The effective date of this resolution shall be immediately upon adoption.

THE FAIR CAMPAIGN PRACTICES ACT: SPENDING PUBLIC MONEY SUPPORTING OR OPPOSING A BALLOT MEASURE

As the election approaches, it is important for governments, elected officials, and government employees to remember the limitations imposed by the Fair Campaign Practices Act (the "FCPA") on the spending of public funds in connection with election campaigns. The FCPA establishes the following general rules: a government may not (1) make a contribution in a campaign involving the nomination, retention, or election of any person or (2) expend moneys from any source, or make contributions, to urge electors to vote in favor of or against most ballot measures. This summary focuses on the expenditure of public moneys to urge a vote in favor of or against ballot measures. While this summary will generally describe the FCPA rules applicable to ballot measures, governments should consult with legal counsel regarding the specific application of these rules.

What ballot measures are covered?

Ballot measures to which the FCPA limits apply include:

- A statewide ballot issue submitted for the purpose of having a title set pursuant to Section 1-40-106(1), C.R.S. or which has had a title set. This includes constitutional amendments or statutes initiated by citizen petition.
- A local ballot issue submitted for the purpose of having a title set pursuant to Section 31-11-111, C.R.S. or which has had a title set pursuant to that section. This will cover most local ballot issues.
- A measure referred by the general assembly or the governing body of any political subdivision to the eligible electors of the state or political subdivision.
- A measure for the recall of any officer that has been certified for submission to electors.

When do the FCPA restrictions commence?

Although the FCPA does not state a date on which its restrictions commence, many judicial decisions have held that the FCPA restrictions commence when a ballot title is set and the measure is submitted to the voters. For local governments, this typically occurs when the governing body adopts a resolution or ordinance calling the election and setting or "fixing" the ballot title. However, a recent Administrative Law Judge decision held that although a board actually fixed a ballot question when it adopted a resolution calling the election and approving the ballot question, it had, at a prior meeting, considered the ballot question "for the purpose of having a title fixed." The Administrative Law Judge held that this earlier date was the date upon which the FCPA restrictions commenced, and not the later date on which the election resolution was formally adopted. This should be a consideration for cities and/or towns that approve ballot questions by ordinance and consider a ballot question on first reading. It is also a consideration

for governments who may present a ballot question to its governing body for consideration and discussion prior to its actual approval.

What are permitted activities for elected officials and employees?

The FCPA does permit certain activities by elected officials and government employees (collectively, "Covered Officials") including:

- A Covered Official may respond to unsolicited questions.
- A Covered Official with policy making responsibilities may spend no more than \$50 of public moneys for letters, telephone calls, or other activities incidental to expressing an opinion. For example, an elected official or government manager may spend up to \$50 to send a letter to constituents expressing her or his opinion on a ballot issue.
- Elected officials may express a personal opinion on an issue.
- Covered Officials may spend personal funds, make contributions, or spend personal time to urge electors to vote for or against a measure.
- A governing body may adopt a resolution supporting or opposing an issue. The passage of the resolution may be reported through regular, established means (other than paid advertising). For example, if a government regularly sends out a newsletter reporting the actions of the governing body at its last meeting, the newsletter may report that the governing body has adopted a resolution supporting the passage of a ballot measure.

What materials may a government distribute?

Governments may spend public moneys to distribute a factual summary of a ballot measure which summary <u>must</u> include arguments both for and against the proposal. The summary shall not contain a conclusion in favor of or against the issue. Under the case law, the summary must be facially neutral, balanced and even-handed.

Many governments wish to distribute materials which describe the ballot measure and what it will accomplish without including arguments for and against. While there are some judicial decisions which conclude that such materials do not "urge" a voter to cast a vote in favor of or against a measure, most recent decisions have determined that if such materials are too positive or negative they do, in fact, urge the voters to cast a vote for or against a measure even if they do not say "vote yes" or "vote no." Governments should have such materials reviewed by legal counsel before spending public funds to distribute such materials to voters.

How are FCPA restrictions enforced?

The FCPA provides that its limitations on spending public moneys may be enforced by the filing of a written complaint with the Secretary of State ("Secretary") within 180 days of the date on which the complainant either knew or should have known of the alleged violation. The Elections Division of the Secretary of State ("Elections Division") conducts an initial review to determine

whether the complaint (i) was timely filed, (ii) specifically identifies one or more violations of Colorado campaign finance law, and (iii) alleges sufficient facts to support a factual and legal basis for the violations of law alleged in the compliant. The Elections Division will either make a motion to the Deputy Secretary of State ("Deputy Secretary") to dismiss the complaint for failure to satisfy one of the three complaint criteria, provide the respondent an opportunity to cure any curable violations, or conduct additional review to determine whether to file the complaint with an administrative law judge ("ALJ"). If the Elections Division determines that the respondent failed to cure an alleged curable deficiency, it will conduct additional review to determine whether to file the compliant with an ALJ. After conducting additional review of any non-dismissed complaint, the Elections Division will either make a motion to the Deputy Secretary to dismiss the complaint or it will refer the complaint to an ALJ. An ALJ may impose any appropriate order, sanction or relief and may impose a civil penalty of at least double and up to five times the amount contributed. In a recent case, an ALJ fined a county commissioner \$1,000 personally for a violation of the FCPA.

A government may seek guidance on the application of the FCPA by requesting that the Secretary issue an advisory opinion regarding the government's specific activity. The Secretary may issue an opinion, at the Secretary's discretion, and the government may rely on the Secretary's advisory opinion as an affirmative defense to any complaint that is filed with the Secretary.

However, the FCPA requires any complaint arising out of a municipal campaign finance matter to be exclusively filed with the clerk of the applicable municipality. "Municipal campaign finance matter" is defined to include any campaign finance matter exclusively related to a municipal campaign, including a municipal ballot issue or ballot question. Complaints filed with the clerk of the applicable municipality must be filed in conformity with local campaign finance enforcement regulations. Therefore, each municipality should consider adopting an ordinance or resolution setting forth the enforcement procedures for municipal campaign finance matters that must be filed with the clerk.

May a government spend money to advocate for or against a measure if the FCPA does not apply?

As noted previously, the FCPA restrictions do not apply to all ballot measure elections. However, courts in Colorado and elsewhere have held that the use of public funds must reflect a balanced portrayal of the ballot measure.

Conclusion

A government should consider periodic training of elected officials and employees to assure that there are not violations of the FCPA in connection with ballot measures submitted by the government or by the state or other local governments. Not only is there the potential for the government to be subject to a civil penalty or other sanctions but government officials and employees may be personally liable for civil penalties. It is also sometimes the case that the negative press resulting from the filing of a complaint alleging an FCPA violation may influence the results of the election regardless of the ultimate disposition of the complaint.

E-mail chain in-regards to the Fair Campaign Practices Act advisory commissions questions:

Our Parks & Recreation Commission had a few questions about the Fair Campaign Practices Act in regards to the pool bond ballot question. The commission is an advisory group that is appointed by the Board of Trustees to advise on all things Parks & Recreation related. They do not have a separate budget for their activities. They meet monthly, have by-laws and the majority must be voting citizens in the Town. They are not a publicly elected body and do not have policy making responsibilities or the final say in the outcome when they provide advice to the Board of Trustees. We realize that if the public perceives this group to be supported by tax dollars and their collective message is for or against a ballot issue, we are in a grey area that could ultimately damage the campaign. So, looking for some guidance on this issue. Here are some questions we would like answered.

- Do they fall under the same rules as staff and the elected officials during a bond campaign?
- Are they able to solicit funds and fundraise during the campaign? As private citizens? As a group?
- Since they are appointed to their positions by the Board of Trustees, does that make them too close to the process, even though the law does not explicitly provide them with guidance on the parameters of their actions?

Hi Eric – thank you for reaching out. The Fair Campaign Practices act prohibits spending public funds to advocate for an election. So if they are not spending public funds, then there is no violation. I understand your concern with public perception. Because that is of course real. However, as an appointed board, not paid, not elected, they do not fall under staff or trustees.

They could certainly advocate as private citizens. They could send letters to the editor as a group. . . they could raise funds. But if they raise funds they would likely need to report what they collect and spend as a "campaign committee" or "issue committee" under the constitution.

That being said, if politically you all think there should be some distance, you could find ways to "work around" any perceived issues, like speaking out individually. Trustees can do that as well. So can staff/employees.

Kim Crawford Butler Snow LLP

I generally concur with Kim's advice and would prefer not to have an official Town committee involved in any fundraising efforts. So, if there is going to be any "campaign committee," I would prefer that be a private effort separate and apart from the parks and recreation commission's official functions. But, having commission members speak out individually, or send letters to the paper, etc, would be fine, so long as no public funds are expended.
