## Angie Mendenhall, Treasurer:

Angie requested a tax cancellation for a parcel MH92850 for a mobile home that has been
destroyed and removed from the property. Somehow the taxes were left on the books for the
2019-2020 tax year at a total of \$92.50. The subsequent year's taxes have not been charged.
Angie requested that the board make a motion to cancel the \$92.50 which includes taxes, late
charges, and interest.

Commissioner Somsen made a motion to cancel the taxes for parcel MH92850 for a total of \$92.50. Commissioner McCullough seconded the motion. Motion passed.

## Aaron Cook, Republican Central Committee Chairman:

 Aaron Cook informed the board that the Republican Central Committee had just met to interview interested parties in the vacated coroner position in Caribou County.
