If you make marks on the ballot besides filling in the oval, your votes may not be counted.

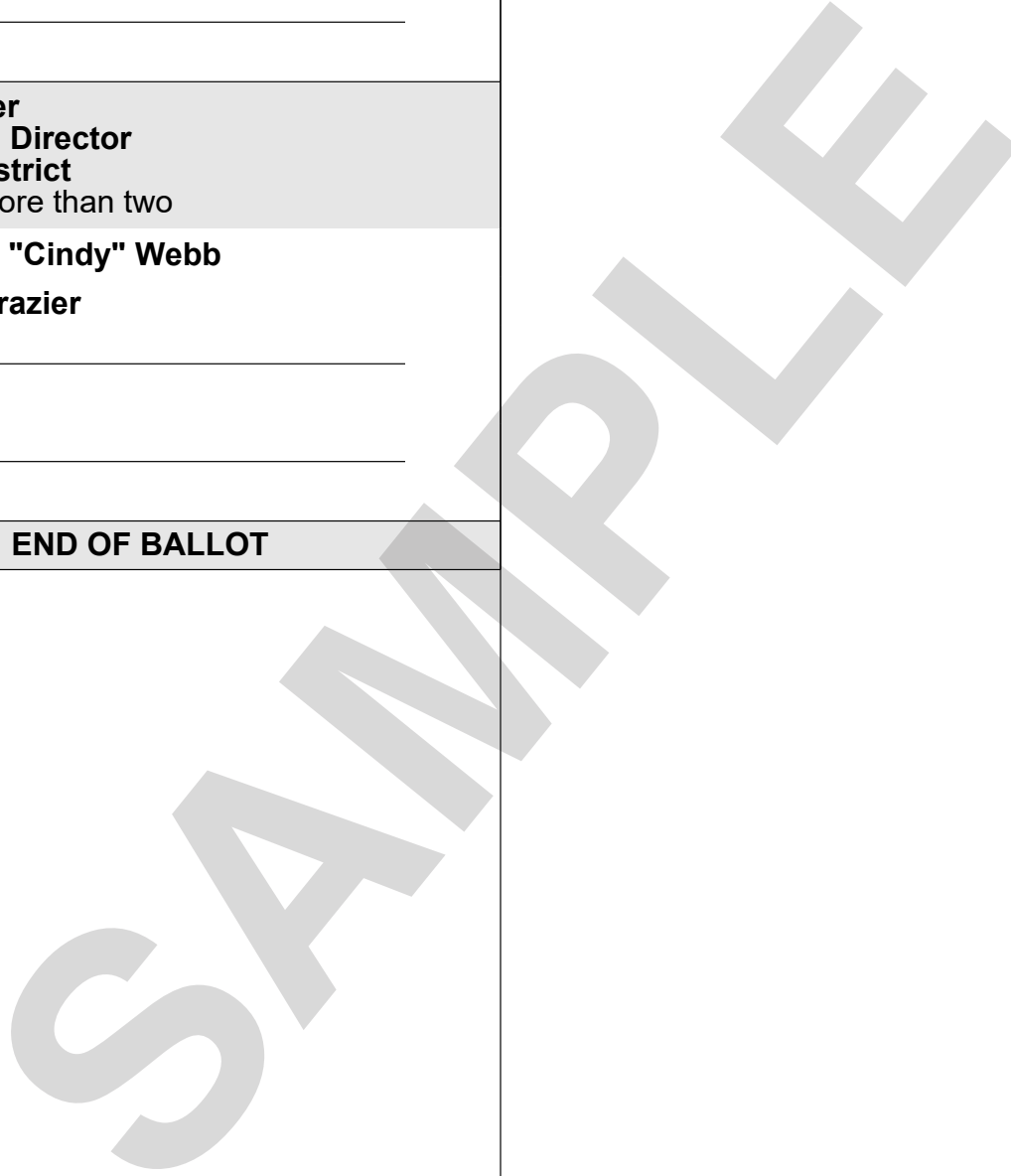
