Motion by Mongan, seconded by Miller to approve Resolution #2021-10 to Determine Dakota Access Pipeline Construction Completed in Cherokee County. Roll call vote: Mongan-aye, Petersen-aye, Mummert-aye, Miller-aye, Lundquist-aye. Motion carried and resolution adopted.

Gary Goebel, Construction Manager, presented construction applications on county right of way for consideration.

Motion by Petersen, seconded by Mummert to approve an underground construction on county right of way application for CML Telephone in Section 15 of Cherokee Township. Motion carried.

Motion by Mongan, seconded by Miller to approve an underground construction on county right of way application for WesTel Systems including six projects in Section 23 of Silver Township; Sections 19, 20, 29, 30 of Rock Township; Sections 15, 16, 17, 22, 23, 24, 26 of Rock Township; Sections 15, 16, 17, 22, 23, 24, 26 of Rock Township; Sections 31, 32, 33 of Rock Township and Sections 4, 5, 6, 7, 8, 9, 16, 17, 18 of Sheridan Township; Sections 25, 26 of Rock Township; and Sections 10,11,15 of Rock Township. Motion carried.

Kelly Puhrmann, Assistant Engineer, presented documents to close out a construction project so that retainage can be paid back to the contractor.

Motion by Mongan, seconded by Mummert to authorize the chairman to sign a final zero pay voucher to close out the C66 project #FM-CO18(67)--55-18 which was completed in 2018. Motion carried.

Sarah Tracy, County Engineer, reviewed details in an ordinance for vendors during the RAGBRAI event when it travels through Cherokee County.

Chairman Lundquist read a summary of a proposed RAGBRAI Ordinance as published with full copies of the ordinance available to those in attendance.

Motion by Mummert, seconded by Mongan to approve the first reading of Ordinance #2021-03 Sale of Food and Other Merchandise During RAGBRAI. Roll call vote: Mongan-aye, Petersen-aye, Mummert-aye, Miller-aye, Lundquist-aye. Motion carried.

Motion by Mongan, seconded by Petersen to waive the second and third readings of Ordinance #2021-03 Sale of Food and Other Merchandise During RAGBRAI. Roll call vote: Mongan-aye, Petersen-aye, Mummert-aye, Miller-aye, Lundquist-aye. Motion carried.

Motion by Mummert, seconded by Miller to adopt Ordinance #2021-03 Sale of Food and Other Merchandise During RAGBRAI as written. Roll call vote: Mongan-aye, Petersen-aye, Mummert-aye, Miller-aye, Lundquist-aye. Motion carried and ordinance adopted.

Hedgie Brandt, County Treasurer, presented a wage authorization for consideration and asked for the tax assignment to be tabled until proper documents are prepared.

Motion by Mummert, seconded by Mongan to approve an \$18.34 per hour wage authorization for Araceli Castaneda-Johnson, Treasurer's Office Clerk, effective July 1, 2021. Motion carried. Lundquist asked for

clarification if the new hourly rate included the standard cost of living increase given on July 1st. Brandt stated that a 2.5% increase would be given in addition to this wage rate on July 1, 2021.

Rick Angell and Becky Bloom, Wellmark Blue Cross and Blue Shield Representatives, presented Cherokee County's annual health insurance renewal and discussed benefit changes in the policy.

Motion by Mongan, seconded by Petersen to approve the July 1, 2021 renewal of Wellmark Plan SVL/TJ2-N (\$4,000/\$8,000 deductible; \$8,000/\$16,000 out of pocket maximum; \$30 office visit co-pay; \$25/\$50/\$100 with \$225 specialty/\$275 np specialty RX) including a 3.48% premium increase. Motion carried.

In an effort to reduce annual premium increases and to maintain affordable health benefits for employees; Cherokee County purchases a higher deductible health insurance plan and partially self-funds a buy down of deductibles to \$1,000/\$2,000 and out of pocket maximums of \$2,000/\$4,000. RX prescriptions will be bought down to \$15/\$45/\$75. Employees choose between a single or family policy and pay 25% of monthly premium costs while Cherokee County pays 75% of premium costs. Employees hired prior to 1991 are provided family coverage for 25% of the cost of a single policy. Premium costs for fiscal year 2021/2022 will be: \$873.60 per month for Single Policy (\$218.40 employee/\$655.20 employer) and \$2,158.81 per month for Family Policy (\$539.70 employee/\$1,619.11 employer).

Tom Kohn, Veteran Affairs Director, reported on CEU's and certification hours that he has completed and presented two wage authorizations as agreed upon by the Veteran Affairs Commission at the time of his hire.

Motion by Mummert, seconded by Miller to approve a \$21.00 per hour wage authorization for Tom Kohn, Veteran Affairs Director, effective March 12, 2021. Motion carried with Mongan abstaining.

Motion by Petersen, seconded by Mummert to approve a \$22.00 per hour wage authorization for Tom Kohn, Veteran Affairs Director, effective April 19, 2021. Motion carried with Mongan abstaining.

Motion by Mongan, seconded by Petersen to approve a Revocable License for Use of Property Granted to U.S. Department of Veteran Affairs for use of one room in the Cherokee County Courthouse for the purpose of providing eligible Veterans and their families no cost readjustment counseling services and case management support. Motion carried.

Motion by Mummert, seconded by Mongan to approve Resolution #2021-11 "Approval of Waiver of Cherokee County's Right to Appeal Issuance of Final Construction Permit for Ben Erdman, Erdman Farms Site #3, Facility #71693 in Section 26 of Tilden Township" and to authorize the chairman to sign a letter to the DNR requesting that a final construction permit be issued immediately. Roll call vote: Mongan-aye, Petersen-aye, Mummert-aye, Miller-aye, Lundquist-aye. Motion carried and resolution adopted.

Motion by Petersen, seconded by Mummert to authorize the chairman to sign an application to the U.S. Department of The Treasury for Coronavirus Local Fiscal Recovery Funds. Motion carried.

The supervisors provided committee reports and reviewed meeting schedules.

Lundquist asked for comments from the public and none were offered.

There being no further business, Chairman Lundquist adjourned the meeting at 10:50 a.m.
