LEGISLATION:

1. THIRD READING:

An Ordinance appropriating \$25, 000.00 for payment of invoices relating to elevator and tornado siren repairs and declaring an emergency.

2. THIRD READING:

An Ordinance appropriating \$31, 500.00 for budgeted 2022 engineering services and declaring an emergency.

3. THIRD READING:

An Ordinance authorizing the Ohio Department of Transportation (ODOT) to complete the ROS-159-0.41 Project (PID 113013), establishing the City as Local Public Agency (LPA) and confirming the City's cooperation and agreement to maintain the project.

4. THIRD READING:

An Ordinance accepting and appropriation \$1,091.34 received from the Ross County Auditor's Office for the City's share of drug fines in Ross County, Ohio, and declaring an emergency.

5. THIRD READING:

A Resolution authorizing the appropriate City Officials to apply for and enter into an agreement with the Ohio Public Works Commission (OPWC) grant funds program for the Year 2025, accepting grant funds if awarded, and declaring an emergency.

6. SECOND READING:

An Ordinance accepting and appropriating \$163.80 received from Rumpke and declaring an emergency.

7. SECOND READING:

An Ordinance authorizing the renewal of a fifteen-year-term easement for the City of Chillicothe to maintain the City's storm drainage facilities located on the property at Adena Mansion and Gardens.

8: SECOND READING:

An Ordinance amending the "Rules of Council" for the City of Chillicothe, Ohio.

9. SECOND READING:

A Resolution approving the 911 Plan for Ross County and the City of Chillicothe and declaring an emergency.

10. FIRST READING:

An Ordinance establishing rates of pay and other economic benefits for classified, non-classified, and management level employees of the City of Chillicothe, Ohio and declaring an emergency.

11. FIRST READING:

An Ordinance amending Chillicothe Codified Ordinance 917.19 with regard to refuse collection fees and requiring the Service Director, City Auditor and Mayor's office to provide Council an annual recommendation on rate changes not later than March 31 of each calendar year.

12. FIRST READING:

An Ordinance amending Chillicothe Codified Ordinance 917.06 with regard to recycling collection fees and requiring the Service Director, City Auditor and Mayor's office to provide Council an annual recommendation on rate changes not later than March 31 of each calendar year.

13. FIRST READING:

An Ordinance appropriating \$5,200.00 for repairs to the wooden caboose located at West Water Street near Yoctangee Park and declaring an emergency.

14. FIRST READING:

An Ordinance appropriating funds in the amount of forty thousand dollars (\$40,000.00) for computer-related expenses for the Chillicothe Municipal Court.
