LEGISLATION

1. SECOND READING:

An Ordinance allowing the City Auditor to transfer appropriated dollars between salaries and fringes within the same fund if needed on an emergency basis for the remainder of the year 2022.

2. SECOND READING:

An Ordinance appropriating \$35, 000.00 to complete the purchase of a lawn mower for the Parks and Recreation Department.

3. SECOND READING:

An Ordinance appropriating \$50, 000.00 for city income tax refunds, transferring funds back to the general fund to support the proportionate share of the income tax refunds, and declaring an emergency.

4. FIRST READING:

An Ordinance accepting and appropriating \$492.31 received from the Chillicothe Country Club as payment for having a City Fire Inspector and fire truck in attendance at their members only fireworks display.
